Preface

The Sun Cluster 3.0-3.1 With SCSI JBOD Storage Device Manual for Solaris OS provides procedures specific to SCSI JBOD storage devices in a SunTM Cluster environment. Use this manual with any version of Sun Cluster 3.0 and 3.1 software on SPARC[®] based systems and with any supported versions of Sun Cluster 3.1 software on x86 based systems.

Note – In this document, the term "x86" refers to the Intel 32-bit family of microprocessor chips and compatible microprocessor chips made by AMD.

Sun Cluster software runs on two platforms, SPARC[®] and x86. The information in this document pertains to both platforms unless otherwise specified in a special chapter, section, note, bulleted item, figure, table, or example.

SPARC only – In this document, references to Oracle Real Application Clusters also apply to Oracle Parallel Server, unless otherwise stated.

Who Should Use This Book

This book is for Sun representatives who are performing the initial installation of a Sun Cluster configuration and for system administrators who are responsible for maintaining the system.

This document is intended for experienced system administrators with extensive knowledge of Sun software and hardware. Do not use this document as a planning or presales guide. You should have already determined your system requirements and purchased the appropriate equipment and software before reading this document.

How This Book Is Organized

This book contains the following chapters.

- Chapter 1 discusses how to install SCSI JBOD storage devices.
- Chapter 2 describes how to maintain SCSI JBOD storage devices in a running cluster.

Installing a SCSI JBOD Storage Device

This chapter describes the procedures about how to install SCSI JBOD storage devices in a Sun^{TM} Cluster environment.

The procedures in this chapter apply to the following SCSI JBOD storage devices:

- Sun StorEdge 3120 storage array
- Sun StorEdge 3310 SCSI storage array
- Sun StorEdge 3320 SCSI storage array
- SPARC: Sun StorEdge D1000 storage array
- SPARC: Sun StorEdge D130/S1 storage array
- SPARC: Sun StorEdge D2 storage array
- SPARC: Sun StorEdge Multipack storage array

Installing a Storage Array

This section contains procedures for installing storage arrays in new clusters and adding them to existing cluster.

If your storage array uses single-ended SCSI specifications, ensure that your bus lengths comply to the following guidelines.

The single-ended SCSI specifications specify that bus lengths are based on speed and number of devices. The bus lengths in the following table outline a typical implementation of the single-ended SCSI specifications for Sun hardware. For details, see your host adapter and storage documentation.

TABLE 1-1 Typical Single-Ended, Wide SCSI Bus Lengths

| Number of Devices ¹ | Maximum Length |
|-----------------------------------|----------------|
| UltraSCSI (40MB/s: FAST-20, Wide) | |
| up to 4 | 3 meters |
| up to 8 | 1.5 meters |
| FastSCSI (20MB/s: FAST-10, Wide) | |
| up to 16 | 6 meters |

¹ Devices include both targets and initiators.

If you exceed these specifications, you might experience SCSI errors. The host adapter or the driver might recover from these errors by retrying the request. If this action does not succeed, the host adapter or the driver might recover by renegotiating to a less demanding mode of operation. In some cases, the host adapter or the driver might not be able to recover from these errors, and I/O might fail. You experience delays in I/O if the host adapter or the driver needs to perform this recovery.

If your configuration uses UltraSCSI and requires the 6-meter bus length, use the host adapter driver's scsi-options property to limit the speed negotiation to FastSCSI operation. Use the following /kernel/drv/glm.conf file as an example to set the scsi-options property.

```
name="glm" parent="/pci@1f,4000" unit-address="2" scsi-options=0x3f8;
```

This example uses specific hardware. Change this example to accommodate the hardware in your configuration. In this example, the scsi-options property sets the following support.

- Disconnect/reconnect
- Synchronous transfer
- Parity
- Fast SCSI
- Wide SCSI

Setting SCSI Initiator IDs

When your cluster configuration contains shared SCSI JBOD arrays, you must ensure the two nodes connected to a shared SCSI JBOD array have unique SCSI initiator IDs.

The installation procedures in this section describe the steps for setting SCSI initiator IDs in a two-node cluster. If your cluster has additional nodes connected to shared SCSI JBOD arrays, apply these steps as appropriate. Some topologies, for example, clustered pairs, use these procedures unchanged. Others, for example the N+1 topology, may require minor changes.

x86 only – On x86 based systems, setting SCSI initiator IDs is a two-step process. You first set the IDs in the BIOS and then in a configuration file. Until both steps are complete, the IDs are not set and the systems might be unable to boot or the nodes might panic. Set the IDs on one node at a time, as instructed in the procedure.

▼ SPARC: How to Install a Storage Array in a New SPARC Based Cluster

This procedure assumes that you are installing one or more storage arrays at initial installation of a SPARC based cluster. If you are adding arrays to a running cluster, use the procedure in "SPARC: How to Add a Storage Array to an Existing SPARC Based Cluster" on page 26.

Multihost storage in clusters uses the multi-initiator capability of the small computer system interface (SCSI) specification. When installing arrays in your cluster, you must ensure that each device in each SCSI chain has a unique SCSI address. The procedure that follows has specific instructions for achieving this requirement. For additional information about multi-initiator capability, see "Multi-Initiator SCSI" in *Sun Cluster Concepts Guide for Solaris OS*.

Note - This procedure uses an updated method for setting the scsi-initiator-id. The method that was published in earlier documentation is still applicable. However, the method changes if your cluster configuration uses a Sun StorEdge PCI Dual Ultra3 SCSI host adapter to connect to any other shared storage. You then must update your nvramrc script and set the scsi-initiator-id by following the steps in this procedure.

▼ x86: How to Install a Storage Array in a New X86 Based Cluster

This procedure assumes that you are installing one or more storage arrays at initial installation of an x86 based cluster. If you are adding arrays to a running cluster, use the procedure in "SPARC: How to Add a Storage Array to an Existing SPARC Based Cluster" on page 26.

Multi-host storage in clusters uses the multi-initiator capability of the small computer system interface (SCSI) specification. When installing arrays in your cluster, you must ensure that each device in each SCSI chain has a unique SCSI address. The procedure that follows has specific instructions for achieving this requirement. Note – On x86 based systems, setting SCSI initiator IDs is a two-step process. You first set the IDs in the BIOS and then in a configuration file. Until both steps are complete, the IDs are not set and the systems might not boot or the nodes might panic. Set the IDs on one node at a time, as instructed in the procedure.

- You need to upgrade to a higher-quality or to a larger storage array.

To upgrade storage arrays, remove the old storage array and then add the new storage array.

To replace a storage array with the same type of storage array, see "How to Replace the Chassis" on page 43.

This procedure defines Node A as the node with which you begin working. Node B is the remaining node.

Before You Begin

This procedure relies on the following prerequisites and assumptions.

- Your cluster is operational and all nodes are powered on.
- Your nodes are not configured with dynamic reconfiguration functionality. If your nodes are configured for dynamic reconfiguration, see the Sun Cluster system administration documentation, and skip steps that instruct you to shut down the node.

1. Install all software that is specific to the storage array or to any new host Steps adapters.

Install the software and patches to all nodes that will connect to the new storage array.

PatchPro is a patch-management tool that eases the selection and download of patches required for installation or maintenance of Sun Cluster software. PatchPro provides an Interactive Mode tool especially for Sun Cluster. The Interactive Tool makes the installation of patches easier. PatchPro's Expert Mode tool helps you to maintain your configuration with the latest set of patches. Expert Mode is especially useful for obtaining all of the latest patches, not just the high availability and security patches.

To access the PatchPro tool for Sun Cluster software, go to http://www.sun.com/PatchPro/, click Sun Cluster, then choose either Interactive Mode or Expert Mode. Follow the instructions in the PatchPro tool to describe your cluster configuration and download the patches.

For third-party firmware patches, see the SunSolveSM Online site at http://sunsolve.ebay.sun.com.

- 2. Move all resource groups and device groups off Node A.
 - # scswitch -S -h from-node
- 3. If you need to install host adapters in Node A, perform the following steps.

a. Shut down and power off Node A.

For the procedure about how to shut down and power off a node, see the Sun Cluster system administration documentation.

b. Install host adapters in Node A.

For the procedure about how to install host adapters, see your host adapters and server documentation.

4. If you installed host adapters in Step 3, or if you intend to use previously unconfigured host adapters, ensure that each device in the SCSI chain has a unique SCSI address by configuring the scsi-initiator-id in the BIOS.

Note – Perform these steps on one cluster node, the node on which you have configured SCSI initiator IDs for the cluster in the past.

a. Access your host adaptor's BIOS settings.

To access the BIOS on the V40z server with X4422A Sun Dual Gigabit Ethernet and Dual SCSI Adapter cards, press Ctrl-C when prompted during reboot.

- b. Verify that internal controller is set to the default value of 7.
- c. Select a unique value for each of the new host adapter's ports.
- d. Set each controller's scsi-initiator-id to that value.
- 5. Connect the storage array to the host adapters on Node A.
 - If necessary, terminate the ports that will connect to Node B.
 - If you have a Netra[™] D130 array, always terminate the ports that connect to Node B.
 - If you have a StorEdge 3310 or 3320 SCSI array, terminate the ports that connect to Node B when using a split-bus configuration.
 - If your storage array is a StorEdge 3310 or 3320 SCSI array, do not power on the storage array until the storage array is cabled to Node A.

For cabling diagrams, see Chapter 3.

Note – Ensure that the bus length does not exceed SCSI bus-length specifications. This measurement includes the cables to both nodes, as well as the bus length that is internal to each storage array, node, and the host adapter. For more information about SCSI bus-length limitations, see your hardware documentation.

- 6. If you installed host adapters in Step 3, or if you intend to use previously unconfigured host adapters, finish configuring the SCSI initiator IDs on the same node on which you configured the BIOS in Step 4.
 - a. Get the information required for the mpt.conf file.

To create the mpt.conf entries, you need the path to your boot disk and the SCSI unit address.

To find this information on the V40z server with SG-XCPI2SCSI-LM320 Sun StorEdge PCI/PCI-X Dual Ultra320 SCSI Host Adapter cards, use the following command:

- b. Create or edit your /kernel/drv/mpt.conf file.
- c. Include the following entries:

```
scsi-initiator-id=6;
name="mpt" parent="/pci@0,0/pci1022,7450@a"
    unit-address="4"
    scsi-initiator-id=7;
```

Note – These entries are based on the foregoing example output of the format command. Your entries must include the values output from your format command. Also, note that the parent and unit-address values are strings. The quotation marks are required to form correct values in the mpt.conf file.

The entries in this example have the following meanings:

| scsi-initiator-id=6; | Matches your setting in the BIOS for the host adapter ports. |
|----------------------|---|
| name="mpt" | Indicates that these settings are for the mpt driver. |
| parent | Is set to the path to your local drive. |
| unit-address | Specifies the unit address of the local drive. In the example in Step a, this information derives from the pci17c2, 10@4 portion of the output. |
| scsi-initiator-id=7; | Sets your node's local drive back to the default SCSI setting of 7. |

- 7. Perform a reconfiguration boot on Node A to create the new Solaris device files and links.
- 8. If necessary, format and label the disks.
- 9. On Node A, verify that the device IDs have been assigned to the disk drives in the storage array.
 - # scdidadm -1
- 10. Move all resource groups and device groups off Node B.
 - # scswitch -S -h from-node
- 11. If you need to install host adapters in Node B, perform the following steps.
 - a. Shut down Node B.

For the procedure about how to shut down and power off a node, see the Sun Cluster system administration documentation.

b. Install the host adapters in Node B.

For the procedure about how to install a host adapter, see your host adapter and server documentation.

- c. Power on and boot Node B.
- 12. Connect the storage array to the host adapters on Node B.

If you added port terminators in Step 5, remove the terminator ports and connect the storage array to Node B.

For cabling diagrams, see Chapter 3.

Note - Ensure that the bus length does not exceed bus-length specifications. This measurement includes the cables to both nodes, as well as the bus length that is internal to each storage array, node, and the host adapter. For more information about bus-length limitations, see your hardware documentation.

- 13. Verify that the scsi-initiator-id is set correctly on the second node.
 - a. Access your BIOS settings.

To access the BIOS on the V40z server with SG-XCPI2SCSI-LM320 Sun StorEdge PCI/PCI-X Dual Ultra320 SCSI Host Adapter cards, press Ctrl-C when prompted during reboot.

- b. Verify that the scsi-initiator-id for each host adapter on the second node is set to 7.
- 14. Perform a reconfiguration boot to create the new Solaris device files and links.

15. On Node B, verify that the device IDs have been assigned to the disk drives in the storage array.

scdidadm -L

16. Perform volume management administration to add the disk drives in the storage array to the volume management configuration.

Next Steps

If needed, finish setting up your storage arrays, including partitions. If you are using Solstice DiskSuiteTM/Solaris Volume Manager as your volume manager, save the disk-partitioning information. You might need disk-partitioning information if you replace a failed disk drive in the future.



Caution – Do not save disk-partitioning information in /tmp because you will lose this file when you reboot. Instead, save this file in /usr/tmp.

2. If necessary, back up the metadevice or volume.

▼ How to Replace the Chassis

You might need to replace a chassis if the chassis fails. With this procedure, you are able to replace the chassis and retain the storage array's disk drives and the references to those disk drives. By retaining the storage array's disk drives, you save time because you no longer need to resynchronize your mirrors or restore your data.

Before You Begin

This procedure relies on the following assumptions.

- You plan to retain the disk drives in the storage array that you need to replace.
- You plan to retain the references to the disk drives.

If a volume manager manages the disk drives, run the appropriate volume manager commands to remove the disk drives from any diskset or disk group. For more information, see your Solstice DiskSuite/Solaris Volume Manager or VERITAS Volume Manager documentation.

vxdisk offline cNtXdY# vxdisk rm cNtXdY

4. Disconnect the SCSI cables from the storage array.

You can disconnect the cables in any order.

5. Power off and disconnect the storage array from the power source.

6. Connect the new storage array to the power sources.

7. Connect the SCSI cables to the new storage array.

How to Disconnect and Reconnect a Node from Shared Storage

▼ Disconnect the Node from Shared Storage

You must maintain proper SCSI-bus termination during this procedure. The process by which you disconnect the node from shared storage depends on whether you have host adapters available on Node B. If you do not have host adapters available on Node B and your storage device does not have auto-termination, you must use terminators.

Note – To determine the specific terminator that your storage array supports, see your storage documentation. For a list of storage documentation, see "Related Documentation" on page 6.

Steps 1. Determine the resource groups and device groups that are running on Node A.

Record this information because you use this information in Step 6 to return resource groups and device groups to these nodes.

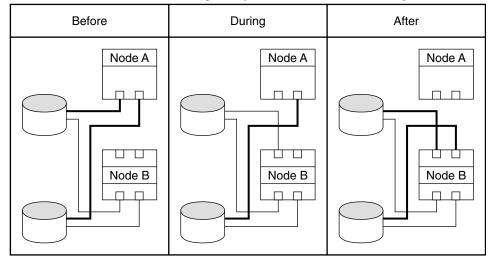

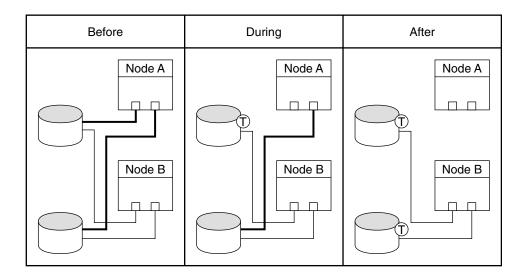

Caution – (*Sun StorEdge Multipack Enclosures Only*) SCSI-reservations failures have been observed when clustering storage arrays that contain a particular model of Quantum disk drive: SUN4.2G VK4550J. Do not use this particular model of Quantum disk drive for clustering with storage arrays.

If you must use this model of disk drive, you must set the scsi-initiator-id of Node A to 6. If you use a six-slot storage array, you must set the storage array for the 9-through-14 SCSI target address range. For more information, see the *Sun StorEdge MultiPack Storage Guide*.

- 7. From any node, update the global device namespace.

If a volume management daemon such as vold is running on your node, and you have a CD-ROM drive that is connected to the node, a device busy error might be returned even if no disk is in the drive. This error is an expected behavior.

scgdevs

8. On one node, verify that a device ID has been assigned to the disk drive.

The new device ID that is assigned to the new disk drive might not be in sequential order in the storage array.

scdidadm -L

9. Perform volume management administration to add the new disk drive to the configuration.

10. If you want this new disk drive to be a quorum device, add the quorum device.

 - # devfsadm -C
- 8. On both nodes, remove all obsolete device IDs.

You need to replace a disk drive if the disk drive fails or when you want to upgrade to a higher-quality or to a larger disk.

- Your cluster is operational.
- Your system is *not* running Oracle Real Application Clusters.

# scstat -q

- If no, proceed to the next step.
- If yes, add a new quorum device on a different storage device. Remove the old quorum device.

3. If possible, back up the metadevice or volume.

For more information, see your Solstice DiskSuite/Solaris Volume Manager or VERITAS Volume Manager documentation.

- 4. (Solstice DiskSuite/Solaris Volume Manager Only) Does your disk drive failure prevent Solstice DiskSuite/Solaris Volume Manager from reading the disk label?
 - If yes, use the disk-partitioning information that you saved. You saved this disk-partitioning information when you performed one of the following tasks.
 - Installed your storage array in an initial cluster as outlined in Step 10 of "SPARC: How to Install a Storage Array in a New SPARC Based Cluster" on page 15
 - Added the storage array to an operational cluster.
 - If no, save the disk-partitioning information now if you have not already done so. Use this information when you partition the new disk drive.
 - # prtvtoc /dev/rdsk/cNtXdYsZ > filename



Caution – Do not save disk-partitioning information under /tmp because you will lose this file when you reboot. Instead, save this file under /usr/tmp.

5. Replace the failed disk.

a. Determine which node owns the device group.

```
# scstat -D
```

b. If you are using VERITAS Volume Manager, remove the disk drives from the VERITAS Volume Manager control on a node that does not have ownership of the device group.

```
\# vxdisk offline cNtXdY \# vxdisk rm cNtXdY
```

c. On a node that does not have ownership of the device group, suspend activity on the SCSI bus.

```
# cfgadm -x replace device cX::disk/cXtYdZ
```

When prompted, type **y** to suspend activity on the SCSI bus.

d. After SCSI bus activity stops, replace the disk and type y at the prompt. After replacing the disk, warning messages might be displayed. Ignore these messages. e. Switch the primary for the device group.

```
# scswitch -z -D disk-device-group -h node
```

f. If you are using VERITAS Volume Manager, remove the disk drives from the VERITAS Volume Manager control on a node that does not have ownership of the device group.

```
\# vxdisk offline cNtXdY \# vxdisk rm cNtXdY
```

g. Suspend activity on the device group's original primary.

```
# cfgadm -x replace_device cX::disk/cXtYdZ
```

When prompted, type **y** to suspend activity on the SCSI bus.

h. When prompted to proceed with the disk replacement, type y to proceed. Warning messages might be displayed. Ignore these messages.

6. On all nodes that are attached to the storage device, run the devfsadm(1M) command to probe all devices and to write the new disk drive to the /dev/rdsk directory.

devfsadm

Depending on the number of devices that are connected to the node, the devfsadm command can require at least five minutes to complete.

- 7. Label the new disk drive by using the format command.
- 8. (Solstice DiskSuite/Solaris Volume Manager Only) From any node that is connected to the storage device, partition the new disk drive by using the partitioning you saved when you installed or added the storage array.

```
\# fmthard -s filename /dev/rdsk/cNtXdYsZ
```

9. From all nodes that are connected to the disk drive, update the DID database and driver.

```
# scdidadm -R deviceID
```

Note – After running scdidadm –R on the first node, each subsequent node that you run the command on might display a warning. Ignore this warning.

10. From any node, confirm that the failed disk drive has been replaced by comparing the new physical DID to the physical DID that was identified at the beginning of this procedure.

If the new physical DID is different, you successfully replaced the failed disk drive with a new disk drive.

```
\# scdidadm -o diskid -l cNtXdY
```

11. Perform volume management administration to add the disk drive back to its diskset or disk group.

For more information, see your Solstice DiskSuite/Solaris Volume Manager or VERITAS Volume Manager documentation.

12. If you want this new disk drive to be a quorum device, add the quorum device.

For procedures about how to add and remove quorum devices, see the Sun Cluster system administration documentation.

▼ How to Replace a Disk Drive With Oracle Real Application Clusters

```
# ls -l /dev/dsk/c4t0d0s2
lrwxrwxrwx 1 root root 40 Jul 31 12:02 /dev/dsk/c4t0d0s2 ->
../../devices/pci@4,2000/scsi@1/sd@0,0:cb4ld
# cat /etc/path_to_inst | grep "/pci@4,2000/scsi@1/sd@0,0"
"/node@2/pci@4,2000/scsi@1/sd@0,0" 60 "sd"
```

If you are using Solaris 10, the node@2 portion of this output is not present. Solaris 10 does not add this prefix for cluster nodes.

3. On one node, identify the failed disk's device ID number.

You will use the device ID number in Step 15 and Step 16.

```
\# scdidadm -L | grep cXtYdZ
```

4. On one node, identify the failed disk's disk ID number.

You will use the disk ID number in Step 17.

```
# scdidadm -o diskid -l cXtYdZ
```

5. Determine if the disk drive that you want to replace is a quorum device.

```
# scstat -q
```

- If the disk drive is *not* a quorum device, skip this step.
- If the disk drive that you want to replace is a quorum device, add a new quorum device on a different storage device and remove the old quorum device.

6. On each node, remove the failed disk from VERITAS Volume Manager control.

```
\# vxdisk offline cXtYdZ \# vxdisk rm cXtYdZ

```
# cfgadm -al | grep cXtYdZ
# ls /dev/dsk/cXtYdZ
```

12. Add the new disk to the storage array.

13. On each node, configure the new disk.

Use the instance number that you identified in Step 2.

```
# cfgadm -c configure cX::sd_instance_Number
# devfsadm

# ls /dev/dsk/cXtYdZ
```

15. On one node, update the device ID numbers.

Use the device ID number that you identified in Step 3.

```
# scdidadm -R DID_number
```

16. Verify that you updated the disk's device ID number.

Use the device ID number that you identified in Step 3.

```
# scdidadm -L | grep DID_number
```

- 17. Verify that the disk ID number is different than the disk ID number that you identified in Step 4.
- 18. On each node, add the new disk to the VERITAS Volume Manager database.

```
# vxdctl enable
```

19. Verify that you added the new disk.

```
\# vxdisk list |grep cXtYdZ|

20. Determine the master node.

```
# vxdctl -c mode
```

21. Perform disk recovery tasks on the master node.

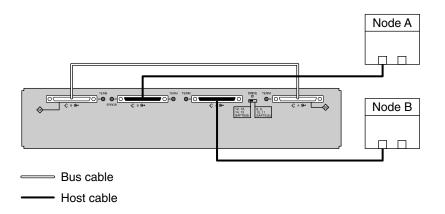


FIGURE 3–1 Cabling a Single-Bus, Multi-Initiator Sun StorEdge 3120 Storage Array

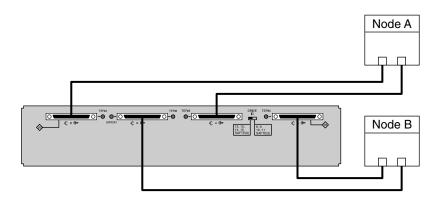


FIGURE 3–2 Cabling a Dual-Bus, Multi-Initiator Sun StorEdge 3120 Storage Array

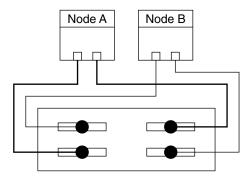


FIGURE 3-3 Cabling a Dual-Bus, Multi-Initiator Sun StorEdge 3310 or 3320 Storage Array

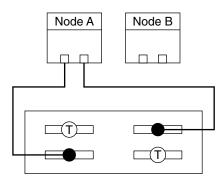

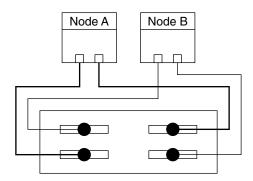


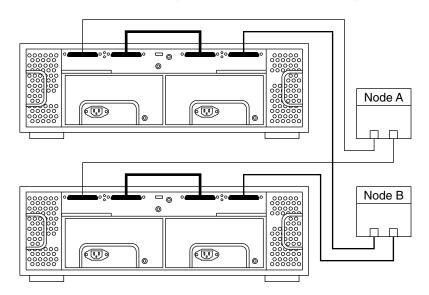
FIGURE 3–5 Cabling a Dual-Bus, Multi-Initiator Sun StorEdge 3310 or 3320 Storage Array: Part 2

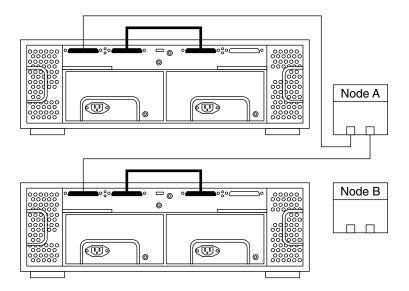


FIGURE 3-7 SPARC: Adding a Sun StorEdge D1000 Mirrored-Pair Configuration: Part 1

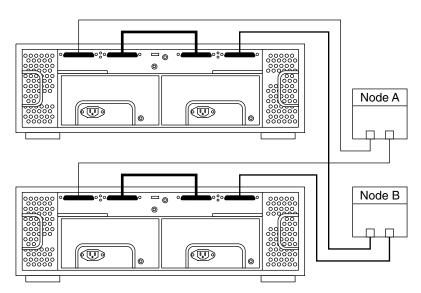
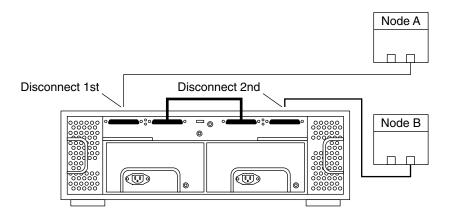


FIGURE 3-8 SPARC: Adding a Sun StorEdge D1000 Mirrored-Pair Configuration: Part 2

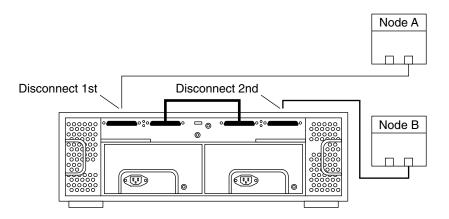

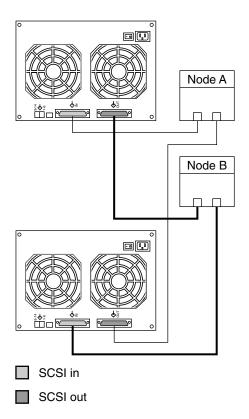

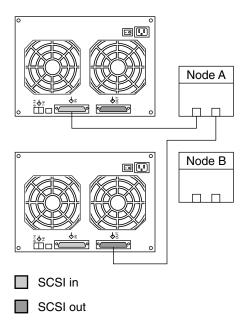


FIGURE 3–12 SPARC: Adding a Sun StorEdge Multipack Mirrored-Pair Configuration: Part 1

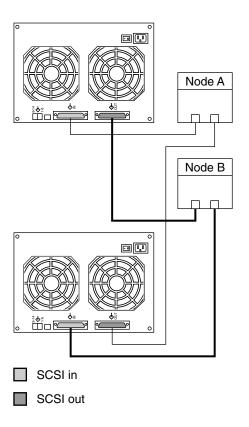


FIGURE 3-13 SPARC: Adding a Sun StorEdge Multipack Mirrored-Pair Configuration: Part 2

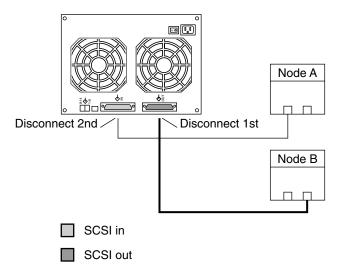


FIGURE 3–14 SPARC: Replacing a Sun StorEdge Multipack Storage Array

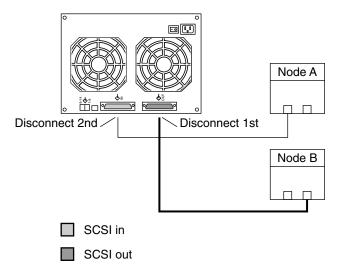


FIGURE 3-15 SPARC: Removing a Sun StorEdge Multipack Storage Array

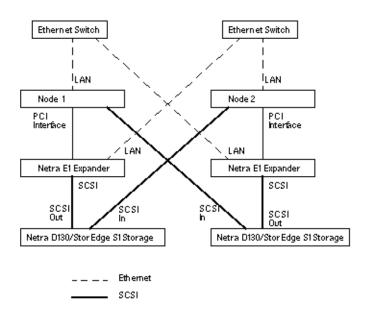

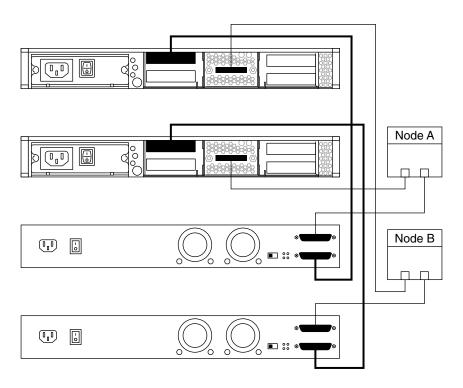

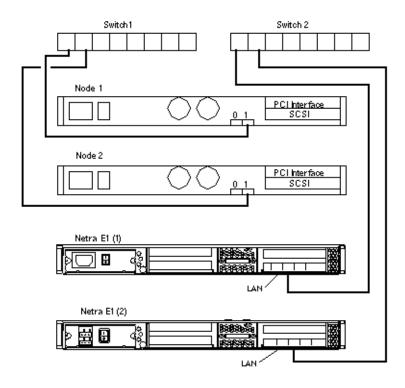
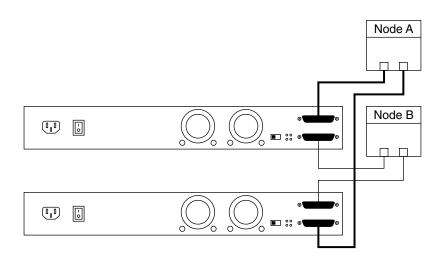


FIGURE 3–18 SPARC: Cabling a Sun StorEdge Netra D130/S1 Mirrored-Pair Configuration With Single-SCSI-Port Hosts and Netra E1 PCI Expanders

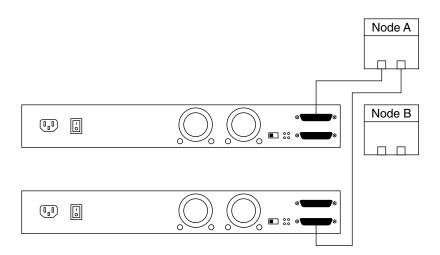
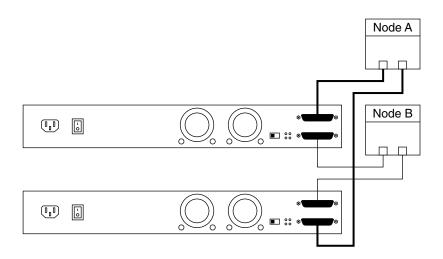


FIGURE 3–20 SPARC: Adding a Sun StorEdge Netra D130/S1 Storage Array Mirrored-Pair Configuration: Part 1

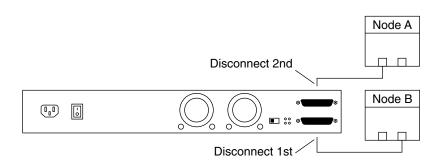


FIGURE 3-22 SPARC: Replacing a Sun StorEdge Netra D130/S1 Storage Array

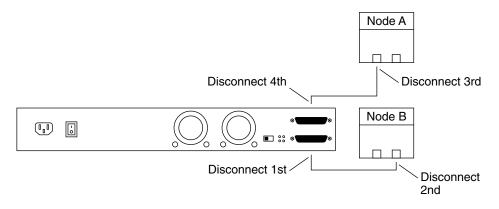


FIGURE 3–23 SPARC: Removing a Sun StorEdge Netra D130/S1 Storage Array

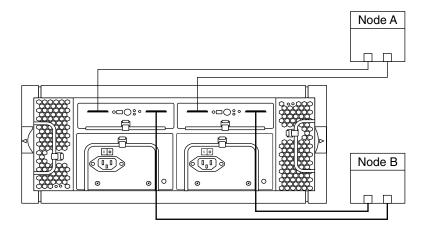


FIGURE 3–24 SPARC: Installing a Sun StorEdge D2 Split-Bus Configuration: An Example

As Figure 3–24 shows, the split-bus configuration requires that the storage array contain two Environmental Service Modules (ESM). Each ESM is connected to two nodes. Each ESM controls half the disks in the storage array and the data is mirrored by using a volume manager.

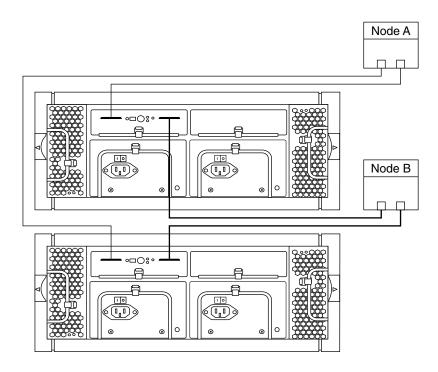


FIGURE 3–25 SPARC: Installing a Sun StorEdge D2 Single-Bus Configuration: An Example

As Figure 3–25 shows, the single-bus configuration requires two storage arrays that each contain a single Environmental Service Module (ESM). The ESM controls all disks on the storage array in which it is installed and the volume manager implements mirroring between the two storage arrays. Each ESM must be connected to two nodes.

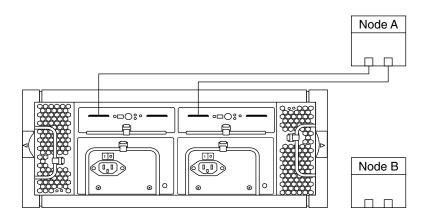


FIGURE 3–26 SPARC: Adding a Sun StorEdge D2 Split-Bus Configuration: Part 1

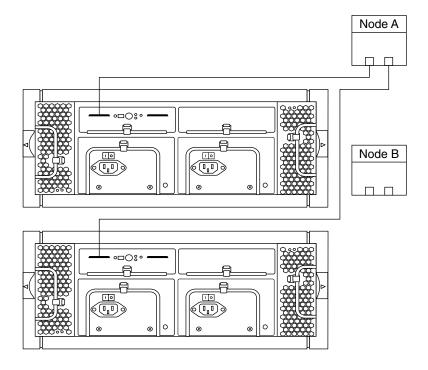


FIGURE 3–27 SPARC: Adding a Sun StorEdge D2 Single-Bus Configuration: Part 1

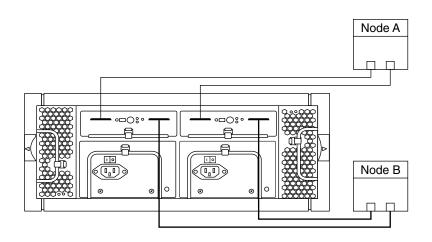


FIGURE 3–28 SPARC: Adding a Sun StorEdge D2 Split-Bus Configuration: Part 2

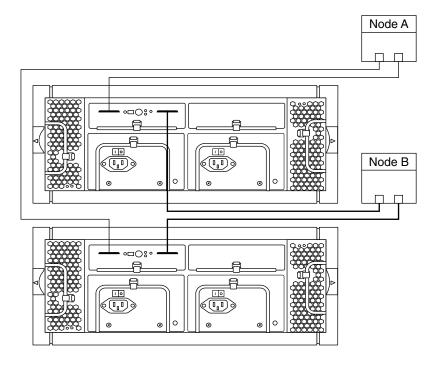


FIGURE 3–29 SPARC: Adding a Sun StorEdge D2 Single-Bus Configuration: Part 2
