

What is the Clintrial software?

The Clintrial software is a comprehensive clinical research system for the collection, management, and review of clinical trials data. The Clintrial software is designed for use by companies that must both:

- Collect clinical data to meet regulatory requirements for conducting clinical trials.
- Analyze data that is collected during clinical trials.

The Clintrial software allows you to unify all of your clinical data collection and management, regardless of source or phase of development (pre- or post-market).

The Clintrial software consists of a set of integrated modules that allow you to create metadata, and to collect, manage, and review clinical data according to your study needs.

• The Clintrial core modules—Essential parts of the basic Clintrial product.

Using the Clintrial core modules, you can efficiently manage clinical data.

For more information, see *Core modules* (on page 4).

 The Clintrial extended modules—Valuable additions to the data management capabilities of the core modules.

You can purchase and install extended modules as needed.


The Clintrial software provides a user interface that allows you to enter, verify, edit, and retrieve clinical data using data-entry windows called study pages, which look like pages from case report forms (CRFs).

Client/server architecture

The Clintrial software uses client/server computer networking technology to store and manage data in an Oracle database.

Most tasks are initiated using the Clintrial modules on clients that are connected to a server. Third-party tools can also reside on clients/servers.


The server computer runs the Clintrial server software and stores the Clintrial metadata and clinical data in an Oracle database.



Core modules

The Clintrial software consists of these interacting core modules:

- Admin module
- Design module
- Enter module
- Manage module
- Retrieve module



About the Admin module

Use the Admin module to perform the system administration tasks. You can:

- Create user accounts and usergroup accounts.
- Manage passwords.
- Set up and manage access rights for users, usergroups, and protocols for all Clintrial software modules.
- Set system parameters.

- Monitor database space.
- Produce auditing reports for users and security.
- Produce reports about system activities.

About the Design module

Use the Design module to design and create the Clintrial database and the study books that you need to enter clinical data. You can:

- Design the clinical database to model your clinical protocol and meet your needs for storing and retrieving data.
- Create online representations of your paper CRFs for data-entry, verification, and editing.
- Create and manage your metadata standards.
- Produce reports about metadata.
- Import/export protocols.

About the Enter module

Use the Enter module to enter clinical data in the database interactively. You can:

- Add subjects to a study.
- Enter clinical data interactively.
- Verify clinical data.
- Edit clinical data.
- Add flags and notes to clinical data.
- Produce reports about clinical data.
- View scanned pages of your paper CRFs.
- Manually create and edit discrepancies, if the Resolve extended module is installed.

About the Manage module

Use the Manage module to perform data management tasks. You can:

- Batch load and apply data-entry checks to clinical data.
- Code clinical data using a coding thesaurus.
- Validate and merge clinical data in the database.
- Make global changes to or delete clinical data.
- Edit records using an Error Log.
- Track the auditing of data.
- Produce reports about metadata objects.

About the Retrieve module

Use the Retrieve module to access and extract clinical data from the database. You can:

- Create queries using:
 - Query By Form.
 - Query By Panel.
 - Ad Hoc Query.
 - Query By SQL.
- Save query specifications in a query library.
- Save query results to a variety of formats, such as SAS or spreadsheet files.

Extended modules

Extended modules, which provide added functionality include:

- Classify module
- Multisite module
- Lab Loader module
- Resolve module

About the Classify module

Use the Classify extended module to work with thesaurus protocols and automatic coding. You can:

- Build and test complex coding algorithms.
- Find, track, and review solutions for values that fail automatic coding.
- Examine the contents of a coding thesaurus protocol, and compare different coding thesaurus protocols.
- Audit the contents of a coding thesaurus protocol.

About the Lab Loader module

Use the Lab Loader extended module to load laboratory data into Clintrial protocols. You can:

- Extend the batch loading capabilities provided in the Manage module.
- Build and maintain a set of lab normal ranges.
- Process loaded lab data.
- Batch load lab data to a source protocol.
- Perform preparatory work on lab data prior to transfer to a clinical data protocol.
- Transfer lab data into a clinical data destination protocol.

About the Multisite module

Use the Multisite extended module to perform interdatabase instance operations. You can:

- Distribute protocols and codelists to multiple sites.
- Replicate clinical and account data between multiple sites.
- Copy functions and base tables.
- Use protocols and codelists in a global environment.
- Share tables and PL/SQL functions across multiple sites.

About the Resolve module

Use the Resolve extended module to manage discrepancy and resolution capabilities that support the

work you perform in other Clintrial software modules. You can:

- Identify, track, and resolve potential or actual discrepancies in clinical data (inconsistent or missing data).
- Check for discrepancies automatically or by manual inspection.
- Record investigation and resolution information.

Enter is accessible through the **Switchboard** module or from the Windows **Start** menu, and is installed when the Clintrial client module is installed.

Clintrial is compatible with several other Oracle products, including:

- Clintrial Integration Solution (CIS).
- Central Coding.

Clinical data management

The Clintrial software provides the tools to store clinical data, ensure data accuracy and consistency, and access data for reports and analysis throughout the phases of clinical trials. You can:

- Model a clinical research study by creating database structures that are stored in an Oracle database account.
- Create data-entry windows, called study pages, which represent pages in paper CRFs.
- Group related study pages in study books that correspond to the CRF for the study.
- Enter, verify, and edit clinical data, or batch load and screen clinical data.
- Code clinical data using the Oracle Central Coding application or the Clintrial Classify extended module.
- Verify and validate clinical data.
- Identify, manage, and resolve discrepancies in the clinical data.
- Audit changes to clinical data and metadata, beginning at a specified point in the data management process.
- Retrieve clinical data for analysis and reports.

Key benefits

The Clintrial software expedites the mandatory approval process for new products and shortens time-to-market by allowing you to do the following:

- Meet the extensive data management requirements of a clinical trial.
- Tailor your clinical data management system to meet your unique data management needs and conform to your SOPs.
- Build checks to ensure data quality.
- Standardize data definitions.

The Clintrial software helps you to conduct clinical trials in accordance with Good Clinical Practice (GCP) guidelines.

How the Clintrial software provides flexibility

You can design your clinical database and organize clinical data to meet your data management needs and workflow. For example, you can:

- Define database objects that are specific to a clinical trial, or create a library of objects to standardize clinical trials.
- Refine and revise your data definitions.
- Establish standard objects, such as panels, to store demographic data that facilitate analysis of similar studies and data pooling.

How the Clintrial software provides security

You can assign rights to users and to studies, to determine the level of access to clinical data definitions and clinical data in studies. For example, you can:

- Assign rights to a data-entry operator to allow that person to enter data in only one study.
- Deny the right to edit or delete data in a study.
- Audit changes to user access.

How the Clintrial software standardizes data

You can standardize the data definitions for clinical data and the study pages that you use to collect data. You can make decisions about database design once, and then store the design to use as a prototype for other clinical trials.

For example, you can define database objects that are common to all of your clinical trials.

You can also standardize clinical data by:

- Requiring data-entry operators to select values from predefined codelists of valid codes for data.
- Translating terms into codes from standard coding dictionaries, using Oracle's Central Coding or Clintrial coding.

Examples of supported standard dictionaries include:

- Medical Dictionary for Regulatory Activities (MedDRA and MedDRAJ).
- Coding Symbols for a Thesaurus of Adverse Reaction Terminology (COSTART).
- World Health Organization Adverse Reaction Terminology (WHOART).
- World Health Organization Drug Dictionary (WHO-DD).
- World Health Organization Drug Dictionary C Format (WHO-DD C).
- Data File for Ethical Drugs (Coding Table) from Iyaku-Joho-Kenkyujo, Inc. (JDrug).

How the Clintrial software ensures data accuracy

You can check data for accuracy, consistency, and logic by:

- Defining valid ranges for clinical data values (range checking).
- Checking data through double-entry (verification).
- Running site-defined checks for certain conditions on clinical data (validation).
- Manipulating data with data-entry processing procedures.

How the Clintrial software audits data

You can set up the Clintrial software to begin auditing changes to clinical data at various points in the data management cycle. For example, auditing can begin as soon as data is entered, or only after data has been merged.

How the Clintrial software helps review data

You can retrieve clinical data from database tables with:

- Query By Form.
- Query By Panel.
- Ad Hoc Query.
- Query By SQL.

For example, you can create a Query By Form and save the query results in a Microsoft Excel spreadsheet for further analysis.

The Clintrial data

You work with two types of data:

- Metadata
- Clinical data

Metadata defines the Clintrial objects and their relationships. A Clintrial object is a data structure such as a panel, an item, or a codelist.

Metadata describes how the data in a study is collected and stored. Controlling metadata is the primary method that is used to standardize clinical data.

You use the Design module to define metadata, and you can use metadata reports to display or print information about metadata that is associated with a clinical study, such as database object descriptions, and metadata structures.

Clinical data is information about a subject that is collected on a CRF during a clinical trial (for example, demographic data, previous medications, or laboratory test results).

You use the Enter, Manage, Retrieve, Lab Loader, and Resolve modules to enter and manage clinical data.

Relationship to the Oracle database

Both metadata and clinical data are stored in the Oracle database:

- Metadata is stored in data dictionary tables.
 - Using the Design module, you create objects that are stored in data dictionary tables.
 - Using the Enter, Manage, and Retrieve modules, you can access the objects and parameters.
- Clinical data is stored in clinical data tables.

Using the Enter, Manage, Retrieve, and Resolve modules, users enter, edit, manage, and query the clinical data in the clinical data tables.

About the Clintrial protocol

A Clintrial protocol is an Oracle account that serves as a logical container to organize:


- Metadata that is used to manage the data in the protocol.
- Clinical data, flags, and notes that are associated with clinical data.
- One or more views of the clinical data that is stored in the protocol.

Example

In the Design module, you set up the protocol account for a study. Then, you define the metadata that:

- Describes the objects (called items) in which to store data.
- Describes how to store data (in objects called panels).
- Sets up an electronic representation of a CRF (in an object called a study book).

In the Enter module, data-entry operators use the study book to enter clinical data into clinical data tables.



How the Clintrial software stores clinical data

In the Design module, you create items and panels to tell the Clintrial software how to store clinical data in Oracle database tables.

About items

An **item** is a Clintrial object that stores a piece of data, such as the data collected in a single field on a study page, or a single field in a batch-loaded file. For example, a study page for concomitant medications might contain the following items:

- **DRUG**—The name of a concomitant medication.
- **DOSE**—The dosage for the concomitant medication.

You define items within panels, and each item corresponds to one column in a clinical data table. For example, the DRUG item would be stored in one column in the clinical data table for the MEDS panel.

About panels

A **panel** is a collection of logically or clinically related items.

For example, the items DRUG and DOSE might be grouped together in a MEDS panel.

Types of clinical data tables

When you install a panel, the following clinical data tables are created:

- Update table—When data is first entered, it is stored in the update table until it is validated.
 Users can verify, screen, edit, code, and validate data in the update table.
- Data table—After data is validated in the update table, it can be merged (moved) to the data table.

Users can edit, code, and validate data in the data table.

• **Audit table**—While auditing is in effect, each time data is changed or deleted, a copy of the data before it was modified or deleted is stored in the audit table.

Data in the audit table cannot be changed.


Note: Data for a record can be stored in the update table or the data table, but not in both.

About records


Clinical data is stored in records in the clinical data tables. A **record** corresponds to one row in a database table. Depending on the panel type, the data that is collected in a study page is stored in one or more records in the database. A database table can contain the following panel types:

- One record per subject (in tables for a Type 1 panel).
- Multiple records per subject (in tables for a Type 2 panel).
- One record per subject visit (in tables for a Type 3 panel).
- Multiple records per subject visit (in tables for a Type 4 panel).
- Subject enrollment records (in tables for a Type 5 panel).
- Records that are not related to a specific subject (in tables for a Type 0 panel).

Types of users

Clintrial users are categorized according to:

- Their roles in clinical data research and clinical data management.
- The types of tasks they perform.

The Clintrial documentation refers to the following types of users. You might use different job titles, or assign tasks and roles in a different way. For example, one person can perform both data manager and designer tasks.

• The Clintrial administrator

- Maintains user accounts and manages security for all of the Clintrial modules.
- Sets system-wide parameters and default user parameters.
- Manages the Clintrial database instance.

Designer

Designs the Clintrial studies.

Programmer

• Uses PL/SQL to build rules, derivations, and data-entry processing procedures.

Data-entry operator

- Enters data from paper CRFs into the Clintrial study books.
- Verifies data.
- Edits unmerged data in the update table.

Data manager

- Batch loads clinical data.
- Manages the clinical data.
- Validates and merges records.
- Makes global modifications.
- Codes data.
- Retrieves clinical data from the database and produces reports.


Medical reviewer

Uses query tools to retrieve data from the database for record review or statistical analysis.

Starting a module

To access the Clintrial software and its online Help topics, you must start a Clintrial module.

Using Switchboard

- Each time you start a different Clintrial module from Switchboard, the Clintrial software uses the database connection information that you provided when you started Switchboard.

Setting a protocol

A Clintrial protocol is a logical container that organizes the objects and clinical data for a clinical study.

- When you first connect to the database, the Set Protocol dialog box appears.

If you do not know the protocol to use, see your Clintrial administrator.

Note: The next time you start the protocol is selected automatically.

Switching databases

- 1 Close all open windows.
- 2 Select File > Connect.

Re-ordering columns in list windows

For windows which display list grid views, such as list of logs in Manage or list of Discrepancies in Resolve, you may use the mouse to drag columns to new positions to tailor the view to your needs. For example, you can change the column order in a Discrepancy window by dragging and dropping the most significant columns to the left portion of the open window.

Changing your password

To change your password, select File > Password.

Using the Oracle database with the Clintrial Core Server software

When installing or upgrading to Clintrial 4.7.1, you may choose to use either a Unicode or non-Unicode database for Oracle 10.2.0.5 or 11.2.0.1. If you plan on using non-English languages or multiple languages, a Unicode database is appropriate.

The Oracle database

The new Oracle database must be created with the following requirements, before you install the Clintrial software:

- The **compatible** parameter must be equal to or begin with **10.2.0**.or **11.2.0**.
- There must be at least one temporary tablespace in the database that holds **temporary contents**.
- If you are a global company and want to use a Unicode database, you must set the **character set** to **Unicode (AL32UTF8)** and set the **nls_length_semantics** to **CHAR** in the Oracle database's **All Initialization Parameters**.

Note: An example of the effect this setting has on data in a Clintrial Unicode protocol is the setting of varchar2(2000) (4000 bytes) for an item (usually a text item) in panel using the Design module. In a language using Western characters (like English or French), where each character takes no more than 2 bytes, this sets the limit at 2000 characters. In Japanese, a character requires 3 bytes or more, so the limit could be as few as 1333 characters (4000 bytes divided by 3).

If an existing Oracle database does not meet the above requirements, you must delete the Oracle database instance and recreate it.

Note: For a list of features that are specific to Oracle 10g or 11g, see the Oracle database *New Features* documentation.

You must also set other database initialization parameters to run the Clintrial software. You can include these parameters in your database creation, upgrade, or adjustment, or you can wait and change the parameters just before you install or upgrade to the Clintrial 4.7.1 software. For more information, see *Required database instance parameters* (on page 38).

Note: Choose a method of creating the database that allows you to manipulate the database parameters. Pre-configured databases might not allow you to do this.

For the recommended space and other parameter settings, see your system administrator.

Recommendations for creating and upgrading the Oracle Database

Review this section if you are creating a new Oracle 10.2 or 11.2 database or upgrading an existing Clintrial database to the Oracle 10.2 or 11.2 software.

Oracle recommends reviewing your Oracle 10.2 or 11.2 documentation before you perform a new installation or an upgrade. Oracle also recommends that you test the Clintrial software and the Oracle 10.2 or 11.2 software before you upgrade or install the software in a production environment.

Note: Clintrial 4.7 does not support Oracle transparent data encryption.

Upgrading an existing Clintrial database to Oracle 10.2.0.5 or 11.2.0.1

Oracle recommends that you upgrade the entire database to Oracle 10.2.0.5 or 11.2.0.1 rather than creating a new instance of the database and using export/import. The *Oracle Migration* guide describes how to upgrade your entire database.

If you choose to use Unicode databases, after you upgrade your existing databases to 10.2.0.5 or 11.2.0.1, you should create new Unicode 10.2.0.5 or 11.2.0.1 databases and export/import your upgraded databases using Oracle Data Pumps to the new 10.2.0.5 or 11.2.0.1 Unicode databases.

If you decide not to use Unicode databases, when using Multisite Distribution, if you export databases from and then import them to a different Oracle release, you must manually recreate all Multisite database links after you upgrade to the Clintrial 4.7.1 software.

Whether or not you use Unicode, if your Clintrial upgrade includes Multisite Replication, you must reschedule the time and the date for replication for all sites. If you do not, the status will not be updated.

For details, see the document entitled *Multisite*, **Chapter 5: Replication**, the section entitled "Scheduling replication".

After your upgrade to Oracle 10.2.0.5 or 11.2.0.1 (Unicode or non-Unicode) invalid packages, functions, and synonyms can be listed in all_object (select owner, object_name, object_type from all_objects where status ='INVALID')

The following is the note from the Oracle 10.2.0.5 readme file:

Note: When the 10.2.0.5 patch set is applied to an Oracle Database 10g Standard Edition database, there may be 54 invalid objects after the **utlrp.sql** script runs. These objects belong to the unsupported components and do not affect the database operation.

Ignore any messages indicating that the database contains invalid recycle bin objects similar to the following:

BIN\$4IzIjWIt9gfgMFeM2hVSoA==\$0

Most of the invalid objects will become valid after running the below SQL*Plus commands.

To upgrade an existing database to Oracle 10.2.0.5 or 11.2.0.1, do the following:

- 1 Run the following SQL*Plus commands:
 - a C:\>SET ORACLE_SID=db_ct47
 - b C:\> sqlplus /NOLOG

- c SQL> CONNECT SYS AS SYSDBA
- d Enter password: SYS_password
- e SQL> SHUTDOWN IMMEDIATE
- f SQL> STARTUP UPGRADE
- g SQL>@ORACLE_BASE\ORACLE_HOME\rdbms\admin\catupgrd.sql
- 2 Check the log files for errors.
- 3 If necessary, rerun the **catupgrd.sql** script after correcting any errors.
- 4 Restart the database:
 - a SQL> SHUTDOWN IMMEDIATE
 - b **SQL> STARTUP**
- 5 Run the **utlrp.sql** script to recompile all invalid PL/SQL packages now instead of when the packages are accessed for the first time.

SQL> @ORACLE_BASE\ORACLE_HOME\rdbms\admin\utlrp.sql

The Oracle 9.2 software and subsequent releases support locally managed tablespaces. If you are upgrading from a previous version of the Oracle software, you can take advantage of this feature by migrating your existing tablespaces.

Several database requirements must be set **prior** to installing the Clintrial software. For more information, see *Installing a new Clintrial database* (on page 36) and *Database storage* parameters (on page 37).

Exporting and importing an entire database

This is the only option to migrate the old Oracle 9.2 or 10.2 database to a Unicode database. You cannot change the Oracle database character set after the database has been created.

Before exporting the database

Before exporting the database, do the following:

- 1 Back up the original database.
- 2 Update the Oracle version to 10.2.0.5 or 11.2.0.1.
- 3 Migrate a Clintrial 4.5 database from Oracle 9 to the new Oracle version.

Note: If you are upgrading a Clintrial 4.6 database, it is already Oracle 10.2. Make sure it is 10.2.0.5.

- 4 If you are converting the database to UNICODE, check the existing database to determine whether it uses **BYTE** or **CHAR**. For more information, see the Oracle Database documentation.
 - If the database is already **CHAR**, skip to Step 8.
- 5 If the database is using **BYTE**, change the **NLS_LENGTH_SEMANTICS** parameter from **BYTE** to **CHAR**.
- 6 Restart the database and make sure the **NLS_LENGTH_SEMANTICS** is **CHAR**.
- 7 Run the **ChangeByteToChar.sql** file against the database. Modify the file if necessary. For more information, see *ChangeByteToChar.sql* (on page 34).

8 For Clintrial 4.5 database, login as **SYS** and execute the following:

```
CREATE OR REPLACE DIRECTORY export_dump_dir AS 'D:\oradump\'; GRANT READ, WRITE ON DIRECTORY export_dump_dir TO sys;
```

Note: Actual commands could be different in Unix and Windows. Please reference Oracle database documentation for specific commands.

- 9 If you are upgrading a Multisite environment, ensure:
 - There are no partially imported protocols.
 - There are no partially imported codelists.
 - There are no panels marked for revision.
 - There are no distributed objects open for revision.
 - All replicated accounts are halted.

- Open a DOS window and go to the folder where you want to store the exported dump file. (e.g. D:\oradump)
- 2 From the command line, type and execute the following:

Before importing the database

Before you import the database, do the following:

- Follow the Oracle database documentation to create a new Unicode database (if applicable).
- If there is a Multisite environment, make sure that the database instance names remain the same in the new database.
- Create the Clintrial tablespaces by running CTTSPACE.SQL.
- Make sure all the data files are auto-extended and have enough space.

Import steps

To import the newly exported database:

- 1 Open a DOS window and navigate to the folder that contains the exported dump file.
- 2 If a folder does not already exist, use the following command to create one:

After importing the database

1 Recompile all invalid objects.

For example:

Note: For more detailed information and step by step instructions, see the Oracle database documentation.

- After the import has finished, check the upgraded database to ensure the upgrade was successful. If necessary, restore the backup, correct the errors and repeat all the steps.
- 3 Run the server **Clintrial Installation Wizard** and select the **Upgrade** option to upgrade the database to Clintrial 4.7.1.

Installing a new Clintrial database

If you are installing the Clintrial software and the Oracle 10.2 or 11.2 database software for the first time (that is, not upgrading from a previous release), Oracle recommends that you do the following:

- 1 Install the Oracle 10.2.0.5 or 11.2.0.1 software.
- 2 Use the Oracle Database Configuration Assistant to create the database.

Note: Oracle recommends that you do not use a pre-configured or starter database for the Oracle 10.2.0.5 or 11.2.0.1 database.

A pre-configured database does not allow you to set the required database parameters **prior** to database creation.

Some of the required parameter settings (such as including the compatible parameter set to **10.2.0** or **11.2.0**) are difficult to reset after you have created the database.


The following information assumes that you are using the Oracle Database Configuration Assistant to create the Oracle 10.2.0.5 or 11.2.0.1 database. The information is presented in the order in which the tool prompts for information.

You must install the Oracle server software before you install the Clintrial server software.

Note: The database character set value and the initialization parameters indicated below are of particular importance. Additional parameter settings that are required by the Clintrial software, can be set during the Oracle installation or after the database is created. For the complete list of database instance parameters that you can set after the Oracle 10.2.0.5 or 11.2.0.1 software installation or upgrade, see Required database instance parameters.

Use the following information to help guide the initial installation or upgrade of the Oracle 10.2.0.5 or 11.2.0.1 database software:

- Create a Custom Database, not a Data Warehouse, General Purpose or Transaction Processing database.
- Ensure that all default Standard Database Components are selected.



 If you are going to create a Unicode database, the Database Character Set should be the AL32UTF8 Unicode character set. If you are not going to use Unicode, the National Character set can be set as desired.

This is set in the Character Set tab.

• Set the following parameters with the values given, so that they are set at database creation.

Use the All Initialization Parameters button to set 'compatible' = 10.2.0 or 11.2.0.

Database storage parameters

The following storage parameters may not be set by the Configuration Manager in the Oracle 10g or 11g software, but should be configured prior to installing the Clintrial software:

- The USER tablespace can be removed because it is not used by the Clintrial software.
- The SYSTEM tablespace must be PERMANENT and online.
 - Set its storage parameter as follows:

Enable Logging: Yes

All other settings can be adjusted for your environment.

- The TEMP tablespace must be of Type TEMPORARY, and the **Set as Default Tablespace** must **not** be checked.
- If you are using MANUAL undo management, create a tablespace for the Rollback Segments (for example, RBS).

This tablespace must be PERMANENT and Online.

• Set its storage parameter as follows:

Enable Logging: Yes

Note: Oracle recommends that the Global Name, the Clintrial Site Name, and the Site Service Name be identical to the database instance name.

You can view the database instance name, which is set during the creation of the database, by using the following command in SQL*Plus:

SQL>SHOW parameter db_name

Restarting the database instance

In the following procedures:

- password> is the password for the SYS user.
- <instance> is the name of the instance (or service name) you connect to.
- On UNIX-based systems and on Windows 2003, enter the following commands:

```
% sqlplus /nolog
```

```
SQL> connect sys/<password>@/<instance> as sysdba
```

SQL> startup

SQL> exit

Alternatively, on Windows 2003 systems, use the **Services** dialog box to restart the Oracle database service.

Preparing the Oracle database server to use the Export/Import utilities with the Clintrial software

To make sure that the Clintrial software can access the Dump Directory and the Log Directory on a UNIX or Linux Oracle database server, create a Windows share on the Linux or UNIX machine.

To do this, you can either set up NFS, or use a utility such as Samba on Linux. Oracle recommends using a utility such as Samba.

Neither Linux nor UNIX can connect to UNC paths. Therefore, you must create a symbolic link from the absolute path to a new path that matches the UNC path.

On a Linux server use Samba to do the following:

- 1 Create a Samba share.
- 2 Add users to the Samba share.
- 3 Create a symbolic link to the shared directory.

For example, if the UNC path is \\linuxdb\ct_dir_dump, enter:

```
In -s < full_pathname_to_directory_in_linux> / linuxdb/ct_dir_dump
```

(where *linuxdb* is the machine name and *ct_dir_dump* is the symbolic link to the shared directory)

When you run the script **ctdirect.sql** during installation or upgrade to set up the directories, you must specify forward slashes in the directory name.

If you attempt to write a log file to a directory to which you do not have WRITE privileges, you receive an error message.

Note: Regardless of the server operating system, allow READ and WRITE access to the physical folder designated as the DATA PUMP directory to every Clintrial user required to do import and export. The directory should be accessible from the Oracle server and from Client PCs. This is mandated by Oracle.

Multisite naming conventions

The Oracle Net Services Names

If you are using Multisite Distribution, or Multisite Distribution and Multisite Replication, the Oracle Net Services Names and the Global Database Names must adhere to the following conventions:

- Unique–Must be unique across all database instances in a Multisite environment.
- **Consistent**—Used to access database instances running the Multisite module must be consistent across all database instances in a Multisite environment.
- Fully qualified—Must be fully qualified.

A fully qualified Oracle Net Services Name would be in this format:

<database_name>.<company_name>.com.
For more information, see the Oracle Master Glossary.

Length–Maximum of 60 characters.

Multisite naming conventions

Note: Oracle recommends that the Global Name, the Clintrial Site Name, and the Site Service Name be identical to the database instance name.

The database instance name, which is set when the database is created, can be viewed by using the following command in SQL*Plus:

SQL>SHOW parameter db_name

The Global Name (Global Name in the Multisite Site browser) is automatically defined during the Clintrial core server installation, and is derived from the instance global name. The instance global name may be viewed by using the following command in SQL*Plus:

SQL>SELECT global_name FROM sys.global_name;

The Clintrial Site Name (Site in the Multisite Site browser) is defined during the Clintrial Core Server installation and captured in the CTINST.log file. It may be viewed by using the following command in SQL*Plus:

SQL>SELECT name FROM cts.database WHERE TYPE = 1

The Clintrial Site Service Name (Service Name in the Multisite Site browser) is defined during the Clintrial Multisite Distribution installation, and is captured in CTCINST.LOG. It may be viewed by using the following command in SQL*Plus:

SQL>SELECT SQLNET FROM cts.database WHERE TYPE = 1

Before installing the server software

Before beginning the installation, check the Oracle Software Delivery Cloud (https://edelivery.oracle.com) or the Download Center (https://extranet.phaseforward.com) for the latest patchest and patches, as well as the accompanying *Release Notes* and *Known Issues* documents, and the latest versions of the documentation.

If you are installing on UNIX or Linux platforms and you have more than one database instance on a server, make sure that the default SID is the database instance for the Clintrial software.

On supported versions of Windows, back up your Oracle database before proceeding with the Clintrial installation. For more information, see the Oracle database documentation

Running a script from a Windows directory

When using SQL*Plus on a Windows server, you need an alias in the current directory, with the shortcut property **Start in** either blank or with the full path. You must do one of the following:

- Change to the installation directory in DOS, and then run SQL*Plus from DOS.
- Create and configure a shortcut for SQL *Plus in the installation directory.

To configure and use a SQL*Plus shortcut:

- 1 Create the SQL*Plus shortcut.
- 2 Right-click the **SQL*Plus shortcut** icon.
- 3 From the pop-up menu, select **Properties**.
- 4 The SQL*Plus Properties dialog box appears.
- 5 Select the **Shortcut** tab.
- 6 Clear the **Start in** field, and then click **OK**.
- 7 Copy the SQL*Plus shortcut to each installation directory. Then, when you run the upgrade script for a module, open SQL*Plus using the shortcut in the installation directory for that module.

Create a Clintrial main installation directory

To create the main installation directory \ct4server\ct47:

- On a Windows server, use Windows Explorer to add the ct4server\ct47 folders to the \$ORACLE_HOME directory.
- On UNIX or Linux systems, enter the following commands:

% cd \$ORACLE_HOME

% mkdir -p ct4server/ct47

Create shared directories for use of the Oracle Data Pump Export and Import utilities

If you are going to use the Oracle Data Pump Export and Import utilities for migration or upgrade, you must create shared directories for the reading and writing of dump files.

Note: You do not have to use these Oracle utilities, which were added in Oracle 10.2. The same Oracle utilities which were used in Clintrial 4.6 are still available. For more information, *Exporting* and importing codelists and protocols in Clintrial 4.7 (on page 112).

Create tablespace data files with the cttspace.sql script

Before you run the installation wizard, you should create tablespace data files for the Clintrial software.

Note: If you have not created tablespaces before you run the installation wizard, it creates them. However, running the **cttspace.sql** script to create these data files gives you more flexibility in how they are created.

Use the **cttspace.sql** script to create these data files. By default, this script prompts for the system password, the path name where the tablespace data files are created, and the data file extension. You can modify this script as follows:

• If all the data files are created in the same location, you can comment out the prompt that asks for the path name, and then insert the path name as a variable.

For more information, see the comments in the cttspace.sql script.

• If all the data files have the same extension, you can comment out the prompt that asks for the extension, and then insert the extension as a variable.

For more information, see the comments in the cttspace.sql script.

Note: You can change the initial sizes of tablespaces and associated storage parameters to meet your data storage needs.

To create tablespaces:

1 Optionally, edit the **cttspace.sql** file.

- If you are using the default tablespace sizes in the **cttspace.sql** file, make sure that you have at least 185 MB of disk space.
- 3 If you have changed the initial tablespace sizes, make sure that you have the appropriate amount of free disk space.
- 4 Start SQL*Plus from the module's installation directory and log on to the database instance.
- 5 Run the **cttspace.sql** script to create the tablespace data files:

SQL> @cttspace

You are prompted to enter language_option.

- 6 Enter **e** or **j** (for English or Japanese). These are the only valid options.
- 7 Press **Enter** to accept the default, or enter the log file name.

You are prompted to enter a connection string.

8 Enter the @ symbol followed by the instance (or service) name to connect to.

You are prompted to enter the Oracle SYSTEM Account Password.

9 Enter the Oracle SYSTEM Account Password.

If you use the default method for typing the path for the tablespace data files, you are prompted to enter the full path.

Caution: You must include the trailing delimiter (such as "\") in the path. Otherwise, the last subdirectory name in the path is included in the file name. For example:

C:\oracle\Database\Files\

The trailing delimiter is specific to the operating system on which the script is running.

10 If you use the default method for typing the file extension of the tablespace data files, you are prompted to enter the file extension.

You can enter the file extension with or without the period.

For example, if the name of the database instance is ora1025b, the file extension could be:

.ORA1025B

In this example, the cttspace.sql script creates the following tablespace data files in the C:\Ora102\Database\Files\ subdirectory:

CT_META_D.ORA1025B

CT_META_I.ORA1025B

CT_DATA_D.ORA1025B

CT_DATA_I.ORA1025B

CT_USERS.ORA1025B

11 When the script has finished creating the tablespace data files, review the log file for Oracle errors.

Shut down the Oracle database

Using the Oracle SQL*Plus utility, shut down the Oracle database instance that you will be using with the Clintrial software.

<password> is the password for the SYS user. <instance> is the name of the instance (service name) you connect to.

• On UNIX or Linux systems, enter the following commands:

% sqlplus /nolog

SQL> connect sys/<password>@<instance> as sysdba

SQL> shutdown immediate

SQL> exit

• On a Windows server, enter the following commands:

C:\ sqlplus sys/<password>@<instance>as sysdba

SQL> shutdown immediate

SQL> exit

Alternatively, on Windows 2003, use the **Services** dialog box to shut down the Oracle database service.

The Oracle service stops, shutting down the database instance.

Restart the Oracle database

Using the Japanese version of the Clintrial Installation Wizard on an English Windows Operating System

If you choose Japanese as the setup language when you start to run the Clintrial Installation Wizard to install or upgrade Clintrial 4.7.1, and it displays the message:

The Japanese won't be displayed properly. Please refer to the user documentation.

you are trying to run the Japanese version of the wizard on an English Windows Operating System.

Use this procedure to view Japanese on English OS:

- 1 From the Windows Control Panel, choose Regional and Language Options.
- 2 Click on Language tab.
- 3 Select the checkbox Install files for East Asian languages.
- 4 Click on **OK** and follow prompted instructions. (If it requires a restart the Windows, do so.)
- 5 Return to the Control Panel's Regional and Language Options.
- 6 Click on Advanced tab.
- 7 Make sure that Japanese code page is selected from Code page conversion tables.
- 8 Select Japanese from the dropdown list under Select a language to match the language version of the non-Unicode programs you want to use.
- 9 Click on **OK** and re-boot Windows.

You may now run the Clintrial Installation Wizard, and the Japanese characters will be displayed correctly on the English OS.

Run the Clintrial installation wizard

Note: The server installation and upgrade wizard is a 32-bit application. If you need to install the server application on a machine with a 64-bit operating system, you should do so from a 32-bit networked computer, and then connect to the server with Oracle credentials.

1 Navigate to the location of the installation files and double-click **CTServerInstaller.exe**.

For the first-time installation, the **Choose Setup Language** window appears.



If you want to choose a language other than English on an English operating system, the proper language pack must be installed and the Windows default language must be changed. For example, if you want to conduct the installation in Japanese, the Asian language pack must be installed and the default language must be changed to Japanese.






This account does not store information. If you have no plans to use CIS, you may leave these fields blank.

- PXFR_SEND system account—contains protocol metadata when the protocol is exported.
- PXFR_RECV system account—contains protocol metadata when the protocol is imported.
- **CXFR_SEND** system account—contains codelists when they are exported.
- CXFR_RECV system account—contains codelists when they are imported. Contains

database-wide information about protocol-specific metadata definitions; for example, item and panel attributes for all installed panels.

17 Click Next.

The **Edit Data** window for the Clintrial accounts of Clintrial extended servers appears.



- 18 Enter and confirm the passwords for the extended server accounts.
 - If you have decided to use the same password for all of the Clintrial extended server accounts, check the box, enter, and confirm the password.
 - If you want different passwords for accounts, enter and confirm the password for each account. You need only enter and verify passwords for extended modules you are installing.

• **CTSRM** Multisite account—created automatically when you install the Distribution (CTC) server component of Multisite.

This account stores information that is used to manage distribution across multiple sites. If you are not installing Multisite Distribution, leave the CTSRM password blank.


• **CTSRP** Multisite account—created automatically when you install the Replication (CTX) server component of Multisite.

This account stores information that is used to manage replication across multiple sites.

- **CTCLASSIFY** Classify account—created automatically when you install Classify.


 This account stores information about Classify-specific objects, such as omissions.
- **REVIEWADMIN** Retrieve account—created automatically when you install Retrieve. This account stores information for Ad Hoc reporting in the Retrieve module.
- Click on the checkbox at the bottom of the window if this database will be used for the Multisite Replication Master Site and replication is being installed.

The **Choose Destination Location** window appears. This is the folder where the installation log files will be stored.







Post-installation actions

If you are using Central Coding

If you are planning to use the Oracle Central Coding application, you must specifically grant permissions via Access Control Lists (ACLs) for the HTTP requests.

To use the Central Coding application with Oracle 11.2, you must explicitly grant permissions via ACLs to enable the HTTP request to connect to the Central Coding server.

- 1 Login to the Oracle Clintrial database as SYS.
- 2 Execute code similar to the following:

```
BEGIN
DBMS_NETWORK_ACL_ADMIN.CREATE_ACL (
acl => 'ct_cc.xml',
description => 'Sample ACL for Central Coding',
principal => 'CTPROC',
is_grant => TRUE,
privilege => 'connect');
end;

BEGIN
DBMS_NETWORK_ACL_ADMIN.ASSIGN_ACL (
acl => 'ct_cc.xml',
host => '<Central Coding Server'');
END;
//</pre>
```

Create a verify function to ensure that passwords meet security standards

You can create a password verification function to ensure that passwords meet the standards contained in the Clintrial system parameters or a database profile. This function can be assigned in the Clintrial application using the Admin system parameters, or be part of an Oracle database profile created for users or usergroups.

The Oracle Database Security Guide describes a method for enforcing password complexity for database user accounts. Briefly, the database administrator creates a password verification function and associates it with a user profile. In the Clintrial application, you also can associate the function using the system parameter in the Admin module. The sample given in the Oracle Database Security Guide associates this function with the DEFAULT profile. However, there are special considerations when applying this methodology to Clintrial.

- Non-user accounts, such as system accounts and the accounts for each protocol, use the DEFAULT database profile. The passwords are assigned during installation or upgrade, and encrypted. The resulting encrypted password strings are not constrained to specific characters, and therefore you cannot expect any verification function which relies on character comparisons, such as checking for the existence of at least one number and one non-number to work correctly. For that reason, Oracle strongly suggests that you do not add a verification function to the DEFAULT profile.
- In the case where the Clintrial PASSWORD_ENCRYPTION system parameter is set to No in the Admin module, an encryption verification function can be created and assigned using the

Admin module. At least one additional profile must be created for use with Clintrial users, and that profile also can be associated with the verification function. For example, the below command creates a new profile. When creating users in Admin, you should create a profile like the below example and set additional profile limits like those in the DEFAULT profile:

CREATE PROFILE CT_USER_PROFILE LIMIT PASSWORD_VERIFY_FUNCTION <function_name>;

In the case where the PASSWORD_ENCRYPTION system parameter is set to Yes, the
verification function should not be associated with any profiles which are used for Clintrial users
in the Admin module system parameters. Similar to the Protocol account case, the encrypted
passwords would not function as expected.

This new system parameter that has been added (PASSWORD_VFY_FUNC) allows the Administrator to specify the name of a password verification function which will be called from Clintrial before the encryption of the password. The function is applied to all Clintrial users created in Admin during creation of the users as well as modification of the password by either the Administrator or the user.

The function must have the same parameters as described in the Oracle database documentation. It does not have to be installed into the **SYS** account. The value of the system parameter should specify the owner and function name, for example, **SYS.CT_VFY_FUNC**. Additionally, execute privileges on this function must be granted to the system account **CTPROC**, using this command:

Grant execute on <function_name> to CTPROC;

For the Clintrial system account **CTSYS**, the function cannot be defined and called until after core server installation has succeeded, so the initial **CTSYS** password supplied during installation is not checked in this way.

Overview

You can upgrade to the Clintrial 4.7.1 software from the Clintrial 4.5 or Clintrial 4.6 software. If you are using a release earlier than the Clintrial 4.5 software, you must first upgrade to the Clintrial 4.5 software and then upgrade to the current release.

The following Clintrial server modules can be upgraded:

- Core server.
- Multisite Distribution server.
- Multisite Replication server.
- Classify server.
- Lab Loader server.

Note: The Ad Hoc Query feature and the Resolve module are upgraded as part of the Core upgrade.

Upgrade options

You can upgrade to the Clintrial 4.7.1 software in one of two ways:

- Upgrade the entire Clintrial 4.5, 4.6, or 4.7 database instance to the Clintrial 4.7.1 database instance, as described in this chapter.
- Export codelists and protocols from the current Clintrial database instance, then import codelists and protocols into a Clintrial 4.7.1 database instance.

For more information, see *Limitations of upgrading by import* (on page 69).

Note: Oracle recommends that you upgrade the entire database instance.

When considering these upgrade options, keep in mind the following requirements:

- Do not export to a temporary tablespace.
 - Oracle recommends that you export using a tablespace that does not exist in the Clintrial 4.7 database instance.
- If you plan to use Multisite Distribution with your existing Clintrial Multisite 4.5, 4.6, or 4.7 configuration, you must upgrade all database instances.

For more information, see the Design section in the Admin and Design guide and the Design Help.

Limitations of upgrading by import

Exporting protocols from a Clintrial 4.5, 4.6, or 4.7 database instance, and then importing them into a Clintrial 4.7.1 database instance by using the Oracle Import/Export utility requires many steps.

Oracle recommends that you upgrade the entire database instance.

If you are using external tables for view protocols, you cannot export or import these protocols.

If you perform a full database export from a non-Unicode database in a Clintrial 4.5 or Clintrial 4.6 application (or a Unicode Clintrial 4.7 on Oracle 10.2.0.4 to Clintrial 4.7.1 on Oracle 11.2), and import to a Unicode database in a Clintrial 4.7.1 application, you must run the prv_sys.sql script to re-grant Select privileges on the SYS tables for the core modules.

If you are using the Multisite module, you must also perform these grants:

grant select on sys.dba_objects to prv$wxrm;
grant select on sys.dba_source to ctsrm;
```

Before you begin the upgrade

Before beginning the installation, check the Oracle Software Delivery Cloud (https://edelivery.oracle.com) or the Download Center (https://extranet.phaseforward.com) for the latest patchsets and patches, as well as the accompanying *Release Notes* and *Known Issues* documents, and the latest versions of the documentation.

If you are installing on UNIX or Linux platforms and you have more than one database instance on a server, make sure that the default SID is the database instance for the Clintrial software.

On supported versions of Windows, back up your Oracle database before proceeding with the Clintrial installation. For more information, see the Oracle database documentation

Before upgrading the database instance

- 1 Verify that the Clintrial software 4.5, 4.6, or an earlier release of 4.7 software is installed.

 If you are using a release earlier than Clintrial 4.5, you must first upgrade to a Clintrial 4.5 or 4.6 release, and then upgrade to the Clintrial 4.7.1 software.
- 2 Back up the database instance.
- 3 Check the Oracle and the Clintrial requirements.
- 4 Upgrade to the Oracle database 10.2.0.5 or Oracle database 11.2.0.1 software.
- 5 Decide if you want to use an Oracle Unicode database. If so, refer to **Preparing to install or upgrade to this release** (on page 23).
- 6 Migrate your Clintrial database to the Oracle 10.2.0.5 or Oracle 11.2.0.1 software.

Backing up your Clintrial database

Back up your Clintrial 4.5, 4.6, or 4.7 database instance at the following stages in the upgrade process:

- Before migrating from an earlier release of the Oracle database software to the Oracle 10.2.0.5 or Oracle 11.2.0.1 software.
- Before running the script to upgrade your Clintrial 4.5, 4.6, or 4.7 server to the Clintrial 4.7.1 core server.

Checking other requirements

Confirm the following:

- Your environment meets the hardware and software requirements for the Clintrial software and the Oracle 10.2.0.5 or Oracle 11.2.0.1 database software.
- You have upgraded to Oracle 10.2.0.5 or Oracle 11.2.0.1 database software.
- Your environment can support a Clintrial server installation.
- All protocol and codelists imports are completed.
- No panels are marked for revision.
- If you are using Multisite Distribution, no protocols or codelists are open for revision.
- If you are using Multisite Replication, all replication accounts are aborted.

Running a script from a Windows directory

If you are running a Windows server, do one of the following:

- Change to the installation directory in DOS, and then run SQL*Plus from DOS.
- Create and configure a shortcut for SQL*Plus in the installation directory.

To configure and use a SQL*Plus shortcut:

1 Create the SQL*Plus shortcut.

- 2 Right click the **SQL*Plus shortcut** icon.
- 3 From the pop-up menu, select **Properties**.
- 4 The SQL*Plus Properties dialog box appears.
- 5 Select the **Shortcut** tab.
- 6 Clear the **Start in** field, and then click **OK**.

Copy the SQL*Plus shortcut to each installation directory, and then, when running the upgrade script for a module, open SQL*Plus using the shortcut.

After checking all the requirements listed in the previous sections, you can migrate from the Oracle 9.2.0.6 software to the Oracle 10.2.0.5 or Oracle 11.2.0.1 software, as described in your Oracle documentation.

Upgrade tips and considerations

The following are some tips and considerations to keep in mind when upgrading to this release of the Clintrial software:

- Carefully read Chapter 2. Ensure that your database objects meet the necessary criteria.
- Consider the impact on any custom changes made to Clintrial software objects outside the Clintrial software. Any changes made outside the Clintrial software could cause the upgrade to fail. For example, dropping tables or changing views to reference external objects could cause the upgrade to fail.
- Check your tables, views, packages, and functions to ensure all are present and valid.
- Check the upgrade log for errors when the upgrade completes. If the upgrade completes successfully, your registry entry will indicate release 4.7. However, there could still be errors written to the upgrade log.

For information on protocols that you need to import for additional Clintrial software functionality, see *Protocols for added functionality* (on page 114).

Upgrading the Clintrial software using the upgrade wizard

Important: When running the server installer for upgrading the Clintrial server, the following requirements must be completed first:

• The Oracle database must be updated to the specified version (Oracle 10.2.0.5 or 11.2.0.1). See *Preparing to install or upgrade to this release* (on page 23) for how to upgrade the Oracle database.

Note: The upgrade only upgrades the following Clintrial servers:

Clintrial English 4.5, 4.6, or 4.7

Clintrial Japanese 4.5

• If you are a global company and want to use a Unicode database, you must set the **character set** to **Unicode (AL32UTF8)** and set the **nls_length_semantics** to **CHAR** in the Oracle database's **All Initialization Parameters**.

Note: An example of the effect this setting has on data in a Clintrial Unicode protocol is the setting of varchar2(2000) (4000 bytes) for an item (usually a text item) in panel by using the Design module. In a language using Western characters (like English or French), where each character takes no more than 2 bytes, this sets the limit at 2000 characters. In Japanese, a character requires 3 bytes or more, so the limit could be as few as 1333 characters (4000 bytes divided by 3).

Running the Clintrial upgrade wizard

Navigate to the location of the installation files and double-click **CTServerInstaller.exe**. For the first-time upgrade, the **Choose Setup Language** window appears.




If you want to choose a language other than English on an English operating system, the proper language pack must be installed and the Windows default language must be changed. For example, if you want to conduct the installation in Japanese, the Asian language pack must be installed and the default language must be changed to Japanese.

2 Select the language you want the wizard to use during setup. This also the language that will be used for the labels and descriptions for codelists and tags.







The first **Edit data** window, which asks for information on the Oracle database, appears.


- 9 Enter the following information:

If there are no tablespaces found in the Oracle database described in the previous window, a dialog will ask whether you want to create default tablespaces. Click on **Yes**.

Caution: if there are no Clintrial tablespaces, the installation will fail.

Otherwise, the second **Edit data** dialog will display prompting for more information on the database instance.




11 Enter the following information:

The Edit Data window for the CISUSER and CTSRP displays.



Verifying your server upgrade to Clintrial 4.7.1

After you have verified your upgrade, see the sections *Running the import/export directory creation script* (see "*Run the import/export directory creation script*" on page 112) and *Set up protocols for added functionality* (on page 114) to continue with the upgrade.

- 1 Start SQL*Plus and log onto the database as SYSTEM.
- 2 Enter the following SQL statement:

SQL> select * from cts.registry;

SQL*Plus returns information about the Clintrial modules that are currently installed on the database.

Post-upgrade actions

Recreating Multisite Distribution database links

If you decide not to use Unicode databases, when using Multisite Distribution, if you export databases from and then import them to a different Oracle release, you must manually recreate all Multisite database links after you upgrade to the Clintrial 4.7.1 software.

Rescheduling Multisite Replication

Whether or not you use Unicode, if your Clintrial upgrade includes Multisite Replication, you must reschedule the time and the date for replication for all sites. If you do not, the status will not be updated.

For details, see the document entitled *Multisite*, **Chapter 5: Replication**, the section entitled "Scheduling replication".

Upgrading Data Discrepancy Forms (DDFs)

You need to perform the tasks below only if you have customized Data Discrepancy Forms (DDFs) in a prior release of Clintrial.

- 1 Upgrade from the installed version of PowerBuilder to PowerBuilder 12.5 on the Clintrial Client computer you wish to use for DDF customization. See your PowerBuilder documentation for upgrade instructions.
- 2 Copy the latest **ctv_rept.pbl** with your changes to a new directory. References to **ctv_rept.pbl** in the rest of this document refer to the one in the new directory.
- 3 Start PowerBuilder 12.5.
- 4 Click the **New** icon.
- 5 In the window that appears, select the **Workspace** tab and click the **Workspace** icon.
- 6 It will ask you for a new workspace file name. Navigate to the directory where you put the copied **ctv_rept.pbl** and type in a name for the workspace, e.g. DDF.
- 7 Click on the **Library** icon.
- 8 Select the **ctv_rept.pbl** in the new directory in the left-side window.
- 9 In the right-side window, double-click on the application in ctv_rept.pbl named default.
 - You will be asked if you want to add this target to your current workspace.
- 10 Click Yes.

You will be asked to select a library and application.

Select the application in ctv_rept.pbl (which is named default in the original ctv_rept.pbl) and click Next.

The next window displays the search path and shows the **ctv_rept.pbl** file.

12 Click Next.

The next window tells you that PowerBuilder applications are now stored in files called Targets.

It asks for a file name for the new Target.

13 You can accept the suggested name (or change it if you prefer) and click Finish.

You will next be told that the application requires migration.

14 Click OK.

The migration messages will appear in the bottom section of the PowerBuilder window.

15 Right-click in this area and choose **Save** to save the messages in case there are any later questions about the success of the migration.

- 16 Choose **File > Close** to close the application and return to the Library window.
- 17 In the left-side window, select **ctv_rept.pbl**.
- 18 From the menu, select Entry > Library > Build Runtime Library
- 19 In the dialog box, make sure Machine Code is NOT checked and the Build Type is Incremental. The Resource Name is typically empty.
- 20 Click **OK**.

If you have a previous version of ctv_rept.pbd in the directory, you will be asked if it is okay to

replace it.

- 21 Click Yes.
- 22 Check the informational messages at the bottom of the PowerBuilder window. There should not be any errors.
- 23 Find the directory on your system where Clintrial 4.7.1 is installed. Rename the **ctv_rept.pbl** and **ctv_rept.pbd** files that are there to indicate they are the original ones and from what patch level of Clintrial 4.7. If you prefer, you can put them in some other directory with the same information.
- 24 Copy the **ctv_rept.pbl** and **ctv_rept.pbd** files that you migrated to PowerBuilder 12.5 from the directory where you were working to the directory where Clintrial 4.7.1 is installed.
- 25 Exit PowerBuilder 12.5.
- 26 Test the Resolve module's use of your DDF.

If you are using Central Coding

If you are planning to use the Oracle Central Coding application, you must specifically grant permissions via Access Control Lists (ACLs) for the HTTP requests.

To use the Central Coding application with Oracle 11.2, you must explicitly grant permissions via ACLs to enable the HTTP request to connect to the Central Coding server.

- 1 Login to the Oracle Clintrial database as SYS.
- 2 Execute code similar to the following:

Create a verify function to ensure that passwords meet security standards

You can create a password verification function to ensure that passwords meet the standards contained in the Clintrial system parameters or a database profile. This function can be assigned in the Clintrial application using the Admin system parameters, or be part of an Oracle database profile created for users or usergroups.

The Oracle Database Security Guide describes a method for enforcing password complexity for database user accounts. Briefly, the database administrator creates a password verification function and associates it with a user profile. In the Clintrial application, you also can associate the function using the system parameter in the Admin module. The sample given in the Oracle Database Security Guide associates this function with the DEFAULT profile. However, there are special considerations when

applying this methodology to Clintrial.

- Non-user accounts, such as system accounts and the accounts for each protocol, use the DEFAULT database profile. The passwords are assigned during installation or upgrade, and encrypted. The resulting encrypted password strings are not constrained to specific characters, and therefore you cannot expect any verification function which relies on character comparisons, such as checking for the existence of at least one number and one non-number to work correctly. For that reason, Oracle strongly suggests that you do not add a verification function to the DEFAULT profile.
- In the case where the Clintrial PASSWORD_ENCRYPTION system parameter is set to No in the Admin module, an encryption verification function can be created and assigned using the Admin module. At least one additional profile must be created for use with Clintrial users, and that profile also can be associated with the verification function. For example, the below command creates a new profile. When creating users in Admin, you should create a profile like the below example and set additional profile limits like those in the DEFAULT profile:

CREATE PROFILE CT_USER_PROFILE LIMIT PASSWORD_VERIFY_FUNCTION <function_name>;

• In the case where the PASSWORD_ENCRYPTION system parameter is set to Yes, the verification function should not be associated with any profiles which are used for Clintrial users in the Admin module system parameters. Similar to the Protocol account case, the encrypted passwords would not function as expected.

This new system parameter that has been added (PASSWORD_VFY_FUNC) allows the Administrator to specify the name of a password verification function which will be called from Clintrial before the encryption of the password. The function is applied to all Clintrial users created in Admin during creation of the users as well as modification of the password by either the Administrator or the user.

The function must have the same parameters as described in the Oracle database documentation. It does not have to be installed into the **SYS** account. The value of the system parameter should specify the owner and function name, for example, **SYS.CT_VFY_FUNC**. Additionally, execute privileges on this function must be granted to the system account **CTPROC**, using this command:

Grant execute on <function_name> to CTPROC;

For the Clintrial system account **CTSYS**, the function cannot be defined and called until after core server installation has succeeded, so the initial **CTSYS** password supplied during installation is not checked in this way.

Installing the Oracle client software

This section applies to customers who are installing the Oracle 10.2 or Oracle 11.2 client software for the first time or upgrading the Oracle client software.

Important configuration information

If you have multiple Oracle Homes on your computer, make sure the Default Oracle Home is set to the Oracle client that matches the version of the Oracle database to which you are connecting. The Default Oracle Home can be changed using the Universal Installer.

Note: If you attempt to use the Clintrial client with the Oracle 11.2 client to connect to an Oracle 9.2 or Oracle 10.2 database, you receive the following error message:

Oracle 11g client is not installed or Oracle 11g is not the Primary Oracle Home on your machine.

You should completely close out of the Clintrial client before attempting the database connection again.

Review the NLS_LANG setting for the Oracle client prior to using the Clintrial software. The Oracle database uses the client's NLS_LANG setting to determine the character set that the client is sending and to determine if character set conversion is necessary. If the NLS_LANG setting is not correct, data integrity and consistency might be compromised.

For example, if you are using the Windows Japanese client, and the SQL scripts or control files you will use to load data into the new or upgraded Clintrial database will be in **ANSI**, then the NLS_LANG setting for the client could be either the default **JAPANESE_JAPAN.JA16SJIS** or **JAPANESE_JAPAN.JA16SJISTILDE**.

If, on the other hand, you are using the Windows Japanese client, and the SQL scripts or control files you will use to load data into the new or upgraded Clintrial database will be in **UTF-8**, then the NLS_LANG setting for the client should be **JAPANESE_JAPAN.AL32UTF8**.

The NLS_LANG equivalents for the Windows English client are:

- ANSI AMERICAN_AMERICA.WE8MSWIN1252
- UTF-8 AMERICAN_AMERICA.AL32UTF8

For more information, on the SQL scripts and control files for loading data, see **Chapter 30: Control Files** in Clintrial 4.7 *Manage, Classify, and LabLoader* guide.

Installing or upgrading the Clintrial client software

Note: There is no upgrade per se for the client to go from Clintrial 4.5 or 4.6 to 4.7. You may leave older clients undisturbed on your computer if desired, or remove them using the Windows Control Panel. You can then install the Clintrial 4.7 Client, using the instructions in Installing or upgrading the Clintrial 4.7 client software.

Note: The client installation and upgrade wizard is a 32-bit application. If you need to install the Client application on a machine with a 64-bit operating system, you should do so from a 32-bit networked computer, then connect to the server with Oracle credentials.

Use this procedure to install or upgrade the client software:

1 Navigate to the location of the installation files and double-click **CT4Setup.exe**. For the first-time installation, the **Choose Setup Language** window displays.




If you want to choose a language other than English on an English operating system, the proper language pack must be installed and the Windows default language must be changed. For example, if you want to conduct the installation in Japanese, the Asian language pack must be installed and the default language must be changed to Japanese.

For more information, see your Windows documentation.


2 Select the language you want the wizard to use during setup. This is also the language that will be used for the labels and descriptions for codelists and tags.

The **Welcome** window for the Clintrial setup program appears.



3 Click Next.


The **Setup Type** window appears.



4 Select **Complete** to install all the modules.


Select **Custom** to choose which modules you want to install.

If you selected $\mbox{\bf Custom,}$ the $\mbox{\bf Select Features}$ window appears.




- 5 Select the components to install.

The **Choose Destination Location** window appears. This is the folder where Setup will install the files.




- 7 Accept the default location, or click **Change** to select a different folder.

The values that you enter, except for the Password, are displayed as default values for these fields the next time you start a Clintrial module.

Overview

You do not need to set any registry entries manually. However, there are several registry entries that you might want to set.

Caution: Do not edit registry entries unless you are an experienced user. If you edit other entries, you could create a Clintrial configuration that could lead to unexpected results. Always back up your registry before making any changes. For more information, see your system administrator.

Much of the Clintrial configuration information is stored in the Clintrial database as system parameters, user preferences, and protocol parameters. However, some configuration information is specific to each computer and is stored in the Windows registry of the client. Most of this client-based information is generated automatically from the following sources:

• Control Panel setting:

For example, the Windows registry of each client uses the values in the Regional Settings Properties dialog box to define the display format of a number, such as the decimal point character, or the number of decimal places.

• Information supplied by users through the Clintrial modules.

For example:

- Database connection information that the user supplies in the Database Connection dialog box is stored in the registry for use at the next database connection attempt from that client.
- Information about site-specific menus is stored in the registry.

Note: Each new client installation uses the Windows registry settings from the previous installation, unless the settings are changed during the installation.

Editing the Windows registry

- 1 Select **Start** > **Run**.
- 2 Enter Regedit and click OK.

The Registry Editor window appears.

3 Expand the HKEY_CURRENT_USER folder, and navigate to the Windows registry key for the Clintrial entries:

HKEY_CURRENT_USER\Software\OracleHS\Clintrial 4.7\CT

4 Create a new registry entry and enter a value, or select an existing entry and modify the value as needed.

Setting registry entries manually

You may want to create and set the following registry settings:

- ct_temp_path key (on page 105).
- ct_help_path key (on page 105).
- ct_user_help_path key (on page 105).

Note: These keys are not created automatically during the Clintrial installation and must be created manually using the Windows Regedit program.

About the ct_temp_path key

When you install the Clintrial client, the ct_path value is set to the location of the Clintrial executables, as specified in the setup program. The default ct_path value is c:\ct47.

You should create and specify the ct_temp_path value if you install the Clintrial software to a folder whose name contains a space. For the ct_temp_path value, you must manually create a folder whose name does not contain a space and edit the Windows registry accordingly. In the Windows registry, create a new string value named ct_temp_path and give it the value of the temporary folder.

Note: Because the previous Oracle Utilities could not export or import to a folder whose name contains spaces, the folder you create for the ct_temp_path value is used when you perform imports of legacy files.

About the ct_help_path key

When you install the Clintrial client, the Help files are installed at the location of the Clintrial client executables, as specified in the setup program. If you change the location of Help files, you must create the ct_help_path value in the Windows registry and point it to that location.

About the ct_user_help_path key

If you create your own protocol-specific Help file, you must create and specify a ct_user_help_path value in the Windows registry to point to the location of the Help file.

About the Ct4user.reg file

The **Ct4user.reg** file, that is installed with all client software, creates the ct_exe_path key and the ct_path key during client installation. You must edit and rerun the Ct4user.reg file if you are:

- Setting up multiple users on a single client (on page 108).
- Installing the Clintrial Client over a network (on page 110).

Note: The registry settings that are established when you run the ct4user.reg file affect only the current Windows user. Each Windows user who wants to run the Clintrial software must run the Ct4user.reg file.

Contents of the Ct4user.reg file

The Ct4user.reg file contents are as follows:

Note: The Ct4user.reg file is delivered with the default values shown (C:\CT47) for ct_path and ct_exe_path. The Ct4user.reg file will contain the new values even if the destination folder is changed.

Running the Ct4user.reg file

Note: Before you run the Ct4user.reg file, modify the values of ct_path and ct_exe_path in the ct4user.reg file. Then, when you run the file, the ct_path and ct_exe_path are set according to the modifications you made.

• Double-click the ct4user.reg file.

The ct_path and ct_exe_path are set in the current Windows user's registry on the client.

Verifying registry settings

Run Switchboard.

If ct_path and ct_exe_path are set correctly, the bitmaps for all installed client modules appear in the **Switchboard** window.

If the module bitmaps do not appear, there is a problem with the registry settings.

For more information, see *When a system administrator installs the Clintrial software* (on page 109).

Setting up multiple users on a single client

Note: To avoid possible conflicts in files that are stored on the client and are used by the Clintrial software, different users of a single client (that is, users who log on to the same client with different Windows user names) must run the Ct4user.reg file and set the ct_path and ct_exe_path.

For each user of a single client:

- Set the ct_exe_path to the folder where the Clintrial software is installed.
- Set the ct_path to a unique folder for each Windows user name.

Caution: If the ct_path is not set to a different folder for each Windows user, conflicts can occur in log files and import/export files.

If multiple Clintrial users log on to a single client, each user must:

- 1 Create a different folder, separate from the folder that contains the Clintrial client software.
- 2 Edit the Ct4user.reg file:
 - Setting ct_path to the folder created in Step 1.
 - Setting ct_exe_path to the folder where the Clintrial software is installed.
- 3 Run the Ct4user.reg file.

For more information, see *Running the Ct4user.reg file* (on page 107).

Example

Dr. Smith and Dr. Jones want to use the Clintrial software on the same client.

Dr. Smith must:

- 1 Log on to the client using his client user account.
- 2 Create a folder for the files.
- 3 Edit the Ct4user.reg file to reflect the locations of the ct_path and ct_exe_path folders.

For example:

```
ct_path:c:\CT47_Dr_Smith ct_exe_path:c:\CT47
```

4 Run the Ct4user.reg file.

Dr. Jones must:

- 1 Log on to the client using the client user account.
- 2 Create a folder for the files, different from Dr. Smith's folder.
- 3 Edit the Ct4user.reg file to reflect the locations of the ct_path and ct_exe_path folders.

For example:

ct_path:c:\CT47_Dr_Jones

ct_exe_path:c:\CT47

4 Run the Ct4user.reg file.

When a system administrator installs the Clintrial software

Depending on your procedures, a system administrator may log on to your client and install the Clintrial software. When you use the Clintrial software, you will probably log on to the client under a different user account than the administrator.

Caution: In this situation, the registry entries for your client user account are not set, and you cannot use the Clintrial software.

- 1 Log on to the client using your own client user account.
- 2 Edit the Ct4user.reg file:
 - Set ct_path to the folder where you will store the Clintrial software-related files.
 - Set ct_exe_path to the folder where the system administrator installed the Clintrial software.
- 3 Run the ct4user.reg file.

For more information, see Running the Ct4user.reg file (on page 107).

About network installation

If you setup a network installation, you must modify the ct_path and ct_exe_path keys and run the Ct4user.reg file on each client using the network installation. For more information, see *Running the Ct4user.reg file* (on page 107).

Caution: Oracle does not recommend network installations of the Clintrial client software because performance is typically degraded in such configurations.

Note: Setting up clients with a network installation does not automatically create desktop shortcuts to the Clintrial software. You must manually create shortcuts to network applications.

Modifying the ct_path and the ct_exe_path keys

For the ct_path key:

• On each client, in ct4user.re file, change the ct_path key so that it points to a location on the client to store log files.

For example:

ct_path:d:\CT47_Dr_Jones

This location is also used as the default folder when importing and exporting protocols, and when batch loading data.

Caution: Do not point the ct_path to a shared location on the network.

For the ct_exe_path key:

• On each client, in ct4user.re file, change the ct_pathkey so that it points to the location of the shared Clintrial installation on the network.

For example:

ct_exe_path:G:\ct47_network_installation

Exporting and importing codelists and protocols

There are two methods of exporting and importing codelists and protocols supported in Clintrial 4.7.1.

The recommended method utilizes Oracle's Data Pump Export and Import utilities (named **expdp** and **impdp** by Oracle). These utilities support all Oracle 10.2 features except for XML schemas and XML schema-based tables. The design of these utilities results in greatly enhanced data movement performance over the original Export and Import utilities. They are available as **Export** and **Import** in the **Design** module.

Note: If you are exporting then importing a non-unicode database to an Oracle 10.2 or 11.2 installation, you are required to use the expdp and impdp utilities.

The second method supported for export and import utilizes the original Oracle utilities (named **exp** and **imp** by Oracle). These are the same utilities supported in Clintrial 4.6, and are now called **Legacy Export** and **Legacy Import**, and are available in **Design**.

For more information, see Chapter 20 in the Clintrial Admin and Design document.

Note: When importing a protocol from Clintrial 4.6, there may be Oracle errors generated in the associated logs with error ORA-39152. Despite these error messages, the protocol has been successfully imported. These error messages may be safely ignored.

Run the import/export directory creation script

To use the Clintrial software to import/export protocols or codelists using Oracle's Data Pump Export (expdp) and Import (impdp) utilities, you must create at least one Oracle directory on the Clintrial server to hold the files.

Oracle provides a script (ctdirect.sql) to assist in this process. The script creates two directories; one for data (CT_DATAPUMP_DIR) and one for log files (CT_DATAPUMP_LOG) and grants rights to the Design users.

Caution: At any of the prompts for an account password, the installation aborts if you enter the incorrect password.

- 1 Start SQL*Plus from the appropriate installation directory and log on to the database instance.
- 2 Run the ctdirect.sql script:

SQL> @ctdirect

You are prompted to enter a connection string.

- 3 Enter the @ symbol followed by the instance (or service) name to connect to.
 - You are prompted to enter the Clintrial CTPROC Account Password.
- 4 Enter the CTPROC Account Password.
 - You are prompted to enter the full path for the directory files for the Clintrial Import/Export.
- 5 Enter the full path for the files.

The script creates or replaces the directory on the core server.

It grants required read and write privileges on the directory.

In addition, Design users are not given direct access to the dump files outside of the Oracle database unless they have the appropriate operating system privileges. This is true for any operating system. This must be in addition to running the above script. If these privileges are not granted, then an error similar to the following will be encountered when running the Oracle **expdp** and **impdp** utilities:



Similarly, the Oracle database requires permission from the operating system to read and write files in the directories.

Alternatively, if different users require different access privileges, data pump directories can be created, one for each group of users.

For more details on the Oracle Data Pump utility, consult your Oracle database documentation.

Issue associated with protocols and codelists imported from Oracle 9i

In some cases, when you try to import a protocol or codelist from Clintrial 4.5, you may encounter an **ORA12899: Value too large for column** error. This is caused because a column that should be imported as a CHAR was imported as a BYTE.

To correct this condition, you must edit the codelist or protocol DMP file using a binary file editor.

- 1 Open the dump file in a binary editor.
- 2 Search for BYTE...INTERPRETED.
- 3 Change BYTE to CHAR.
- 4 Save and close the file.

When you import the DMP file again, the columns should reflect the correct data type.

Note: Using a non-binary editor will corrupt the DMP file.

Set up protocols for added functionality

- **CTL_REFERENCE**—Protocol that adds to Lab Loader functionality.
- **CTRESOLVEREF**—Protocol that stores discrepancy configuration information in the Resolve module.
- **CT_MEDDRA**—Thesaurus protocol that you can use to hold MedDRA dictionary data for use with the Manage module.
- CTG_MEDDRA—Extended thesaurus protocol that you can use to hold MedDRA dictionary data for use with the Classify module.
- **CTG_WHODD**—Extended thesaurus protocol that you can use to hold your WHO-DD data for use with the Classify module.

To set up these protocols, you must use a Clintrial client on which the following components have been installed:

- The Oracle Import utility.
- The Design module.

The Clintrial DMP files must be copied to the server in an accessible directory, for example:

CT_DATAPUMP_DIR

Note: The required DMP files are also included with the ct47_smp.tar file and the respective server TAR files.

For more information about setting up the protocols distributed with the Clintrial software, see *Medika Sample Studies* (on page 117).

Setting up the CTL_REFERENCE protocol

To complete the setup of the Lab Loader module, you must import the CTL_REFERENCE protocol, and then run the script to install the CTL_FUNC package.

- 1 Install the client software, as described in *Installing*, *upgrading*, *and maintaining the client software* (on page 93).
- 2 Start the Design module with the user name CTSYS, for which the default password is CTSYS.
- 3 Import the following protocol export DMP file:

ctl_re_md.dmp

Note: You must name the protocol that you are importing CTL_REFERENCE.

4 From the Lab Loader installation directory, run the ctlinstfunc.sql script:

SQL> @ctlinstfunc

Setting up the CTRESOLVEREF protocol

Importing the CTRESOLVEREF protocol

To complete the Resolve installation, you must import the CTRESOLVEREF protocol.

- 1 Install the client software, as described in *Installing, upgrading, and maintaining the client software* (on page 93).
- 2 Start the Design module with the user name CTSYS.
- Import the following protocol export DMP file, which is located in the ct47\resolve directory on the client and in the ct47_smp.tar file:

ct_reso_md.dmp

You must name the new protocol that you are importing CTRESOLVEREF.

For more information about setting up the Medika Clinical Sample Study, see *Medika Sample Studies* (on page 117).

For more information about importing protocols, see the Design section in the *Admin and Design* guide and the Design Help.

Setting up the CT_MEDDRA thesaurus protocol

If you plan to use the MedDRA dictionary with the Manage module, you must:

1 Import the CT_MEDDRA protocol, including creating the tables.

ct_med_m.dmp

Optionally, log on to the CTPROC account in SQL*Plus and execute the functions in the ct_meddra_util.create_meddra_indexes and ct_meddra_util.create_medra_functions packages, as follows:

SQL> EXECUTE ct_meddra_util.create_meddra_indexes('CT_MEDDRA') SQL> EXECUTE ct_meddra_util.create_meddra_functions('CT_MEDDRA');

The Modify Protocol Parameters dialog box appears.

- 3 From the drop-down list next to the CTG_THES_TYPE parameter, select MEDDRA.
- 4 If the name of the column holding the lower level term text in the LOW_LEVEL_TERM table has been changed from LLT_NAME, enter the correct name in the CTG_MEDDRA_TERM_COL parameter.
- 5 Click **OK**.
- 6 Batch load MedDRA data into the protocol.

3 From the drop-down list next to the CTG_THES_TYPE parameter, select the value WHODD.

Click OK.

Sample protocol-specific help

The Medika Sample Study provides protocol-specific Help for entering or editing data in the MEDIKA study book of the MEDIKA_CLINICAL protocol. In addition, the sample study provides an example of metadata help for one of the study pages.

When the Clintrial client is installed, the protocol-specific Help is also installed. No further setup is required.

You can write similar Help for your own protocols. You can also write Help to describe your internal business practices and system requirements. You can provide step-by-step instructions for processes and procedures and include conceptual information where applicable.

Step 1: Install the Oracle and the Clintrial software on the server

To install the Oracle and Clintrial software on the server, follow the instructions in *Preparing to install or upgrade to the Clintrial 4.7 Server* (on page 23) and *Performing a new installation of the Clintrial 4.7 software* (on page 41).

You can use the Medika Sample Study with or without the Resolve module. If you plan to use the Resolve module with the sample study, you must install the Resolve module on the server. To install the Resolve module, run the ctvinst.sql script as described in *Performing a new installation of the Clintrial 4.7 software* (on page 41). You do not yet need to import the CTRESOLVEREF protocol or set up a protocol for the Resolve module.

For more information, see *Step 3* (on page 120) and *Step 14* (on page 127).

Step 2: Install the Oracle software and the Clintrial software on the client

To install the Oracle and the Clintrial software on the clients, install the client software for all the Clintrial modules that you will use and follow the client installation instructions in *Installing or upgrading the Clintrial 4.7 client software* (on page 96). On at least one client, install the following software, which you will need to set up the Medika Sample Study:

- Oracle utilities, as described in *Installing or upgrading the Clintrial 4.7 client software* (on page 93).
- A third-party tool that allows you to write, compile, and work with PL/SQL

If you use the Resolve module, install the Resolve client software, which you will use to set up the MEDIKA_CLINICAL protocol for the Resolve module in *Step 14* (on page 127). To install the Resolve client software:

- 1 Select the **Custom** option from the client installation wizard.
- 2 Select Extended Modules and Sample Study.

This installs all extended modules and all of the Medika Sample Studies.

You choose the study to work with by opening the proper protocol after installation.

If you do not want to install all extended modules, click **Change**, and check the specific extended modules to install.

Step 3: Import the Resolve and Lab Loader protocols

This section describes the protocols that you can optionally import if you plan to use the Medika or CDISC Medika Clinical Sample Study with the Resolve and Lab Loader extended modules.

Note: Some of the DMP files and other files described in this section are not specific to either Sample Study, but can be used to create protocols that can be used with your data. Files that are not specific to the Medika Sample Study are extracted to additional directory locations.

Importing the CTRESOLVEREF protocol

The Resolve module uses the CTRESOLVEREF protocol to store panels, statuses, and state transitions.

Note: CTRESOLVEREF is used by the Resolve module with all of your data and is not specific to the Medika Sample Study.

If you installed the Resolve module, but have not imported the CTRESOLVEREF protocol:

In the Design module, import metadata and data to the CTRESOLVEREF protocol, using the ctreso_md.dmp file.

At the Resolve module server installation, these files are extracted to the specified server directory.

At client installation, when you select the **Custom** option, and select **Extended Modules** and **Sample Study**, the Clintrial software places the DMP files in the Resolve client directory and in the Sample\Protocols subdirectory, (or sample\CDISC\CDISC_MEDIKA), each of which is below the directory that you specified for the client installation.

Note: When you select Extended Modules, the default is to select all extended modules, as well as the Resolve and Lab Loader protocols. Click Change to modify the default selections.

2 Remain logged on to the Design module.

For more information about using CTRESOLVEREF, see the Resolve section in the *Enter*, *Resolve*, and *Retrieve* guide.

For more information about protocol import, see the Design section in the Admin and Design guide.

Importing the CTL_REFERENCE and LAB_NORMALS protocols

The Clintrial software supplies the following protocols for use with the Lab Loader module:

- The CTL_REFERENCE thesaurus protocol contains lab normal ranges and SI unit conversion factors.
- The LAB_NORMALS Lab Loader source protocol contains clinical data to be prepared and then transferred into the destination protocol MEDIKA_CLINICAL.

Note: You can use the CTL_REFERENCE protocol as imported from the metadata DMP file to batch load your own lab normals data. The CTL_REFERENCE data DMP file and the LAB_NORMALS DMP files are for use only with the Medika Sample Study.

If you installed the Lab Loader module and you have not imported the CTL_REFERENCE and

LAB_NORMALS protocols:

- 1 In the Design module, import metadata and data to protocols named CTL_REFERENCE and LAB_NORMALS, using:
 - ctl_re_md.dmp—Metadata and data DMP file for CTL_REFERENCE
 - lab_normals_md.dmp—Metadata and data DMP file for LAB_NORMALS

At the Lab Loader server installation, ctl_re_md.dmp, and the batch load control files ctl_unit_conversion.ctl and ctl_normal_range.ctl, are extracted to the specified server directory.

During the Clintrial server installation, the ctl_re_md.dmp was placed in the LabLoader-server-dir. At client installation, when you select the **Custom** option, and select **Extended Modules** and **Sample**, the Clintrial software places the ctl_re_md.dmp in the Lab Loader client directory, which is below the directory that you specified for the client installation.

The lab_normals_md.dmp file was placed in the in the LabLoader-server-dir\LabNormals subdirectory.

Note: When you select Extended Modules, the default is to select all extended modules, as well as the Resolve and Lab Loader protocols. You can modify the default selections by clicking Change.

2 Remain logged on to the Design module.

Step 4: Import the thesaurus protocols

This section describes how to import:

ART_THESAURUS and DRUG_THESAURUS—The coding thesaurus protocols that are
used by the CDISC Medika Clinical Sample Study.

Note: If you are going to use the coding feature in the CDISC MEDIKA Sample Study, you must import the ART_THESAURUS protocol.

- CT_MEDDRA—The coding thesaurus protocol that is used to code against the MedDRA dictionary, whether or not you use the Medika Sample Study.
- GCT_MEDDRA and WHO-DD—The optional coding thesaurus protocols that are used to
 code against the MEDDRA dictionary with the Classify module, whether or not you use the
 Medika Sample Study.

Note: Oracle supports the standard drug dictionary metadata WHO-DD format B2. A custom dictionary may be created to support any format.

Importing the ART_THESAURUS and DRUG_THESAURUS protocols

In the Design module, import the sample coding thesaurus protocols. Items in the ADV panel of the MEDIKA_CLINICAL protocol refer to the coding thesaurus protocol ART_THESAURUS. Items in PRVMED and CONMED panels refer to the coding thesaurus protocol DRUG_THESAURUS. If you use a different name for the new coding thesaurus protocol, you must change the **Thesaurus** attribute for coding items in the MEDIKA_CLINICAL clinical data protocol.

1 In the Design module, as the user CTSYS, import metadata and thesaurus data to a protocol named ART_THESAURUS, using the ct_art_thes_md.dmp file.

Note: If you plan to use the coding feature in the CDISC_MEDIKA sample study, you must import the ART_THESAURUS protocol.

2 In the Design module, as the user CTSYS, import metadata and thesaurus data to a protocol named DRUG_THESAURUS, using ct_drug_thes_md.dmp file.

Importing the CT_MEDDRA thesaurus protocol

The Clintrial software supplies the CT_MEDDRA protocol for use with coding to the MedDRA dictionary. CT_MEDDRA contains the panels, panel keys, and views to receive and use batch-loaded data from the MedDRA dictionary.

Note: You can use CT_MEDDRA to code your own data to the MedDRA dictionary and with the Medika Sample Study. You must purchase and load the MedDRA dictionary data to use CT_MEDDRA.

Note: The MEDIKA_CLINICAL sample clinical data protocol codes against the ADV (Adverse Events) panel using the ART_THESAURUS protocol. However, you can substitute the ADVLLT or the ADVPT page sections (based on panels of the same name) on the ADV page template. The ADVLLT and ADVPT panels contain coding targets to code against CT_MEDDRA.

- 1 In the Design module, import metadata and data to a protocol named CT_MEDDRA, using:
 - ct_med_m.dmp—Metadata DMP file for CT_MEDDRA.
 - *.ctl—control files you can use to create batch load files for the MedDRA data, which you then batch load into CT_MEDDRA.

At the Clintrial core server software installation, the DMP file and control files are extracted to the core server installation directory.

2 Optionally, log on to the CTPROC account in SQL*Plus and execute the functions in the ct_meddra_util.create_meddra_indexes and ct_meddra_util.create_meddra_functions packages, as follows:

SQL> EXECUTE ct_meddra_util.create_meddra_indexes('CT_MEDDRA'); SQL> EXECUTE ct_meddra_util.create_meddra_functions('CT_MEDDRA');

3 Remain logged on to the Design module.

Importing the GCT_MEDDRA protocol and GCT_WHODD protocol

The Clintrial software supplies the following thesaurus protocols for use with the Classify module:

- The GCT_MEDDRA thesaurus protocol—holds data from the MedDRA dictionary for use with the Classify module.
- The GCT_WHODD thesaurus protocol—holds data from the WHO-DD for use with the Classify module.

GCT_MEDDRA and GCT_WHODD each contain the panels, panel keys, views, and sample algorithms to use the extended thesaurus protocol functionality provided by the Classify module.

Note: GCT_MEDDRA and GCT_WHODD are used by the Classify module with your data and are not specific to the Medika Sample Study.

You must purchase and load the MedDRA dictionary data to use the GCT_MEDDRA protocol. The Clintrial software supplies the WHO-DD data for the GCT_WHODD protocol.

If you have installed the Classify module and you have not yet imported the GCT_MEDDRA protocol and GCT_WHODD protocol:

- 1 In the Design module, import metadata and data to the GCT_MEDDRA and GCT_WHODD protocols, using the following protocol DMP files:
 - **gct_meddra_m.dmp**—The metadata DMP file for GCT_MEDDRA.

Note: No data is supplied for GCT_MEDDRA. You must purchase and load the MedDRA data dictionary. You must create batch load files for the MedDRA data, then batch load the data to GCT_MEDDRA.

• gct whodd md.dmp—Metadata and data DMP file for GCT WHODD.

During the Classify server installation, these files are extracted to the specified server directory.

At client installation, when you select the **Custom** option, and select **Extended Modules** and **Sample Study**, the Clintrial software places the DMP files in the sample subdirectory, which is below the directory that you specified for the client installation.

Note: When you select Extended Modules, the default is to select all extended modules, as well as the Resolve and Lab Loader protocols. You can modify the default selections by clicking Change.

- 2 Set the CTG_THES_TYPE protocol parameter for the GCT_MEDDRA protocol to MEDDRA, and the parameter for the GCT_WHODD protocol to WHODD.
- 3 Set the CTG_MEDDRA_TERM_COL protocol parameter to specify the name of the column holding the low-level term text in the LOW_LEVEL_TERM table.

If you do not specify a value for the CTG_MEDDRA_TERM_COL parameter, the software will use the default value LLT_NAME as the name of the low-level term column.

Note: The default name of the low-level term column in the standard GCT_MEDDRA protocol is LLT_NAME_ENGLISH. If you change this name in the GCT_MEDDRA protocol, enter the new name in the CTG_MEDDRA_TERM_COL protocol parameter field.

4 Remain logged on to the Design module.

For more information about protocol import, see the Design section in the Admin and Design guide.

Step 5: Import the sample view codelists protocol

In the Design module, as the user CTSYS, import the VIEW_CODELISTS protocol that contains panels upon which the view codelists are based:

M_INVESTIGATOR view codelists—Contains investigator information.

Note: You should import the VIEW_CODELISTS protocol before you import the codelists, so that the panels are available for the view codelists using ct_viewcode_md.dmp file.

Step 6: Import the sample codelists

Before importing the MEDIKA_CLINICAL protocol, import the sample codelists. In the Design module, as the user CTSYS, import the ct_medika_c.dmp codelists import file.

Step 7: Create sample flags

Before you import the sample clinical data protocol, create the following flags in the Design module:

The first flag is used to check data in the VITAL panel of the MEDIKA_CLINICAL protocol. The other two are used by data that is related to the Resolve module.

Note: Create all three flags whether or not you use the Resolve module.

Step 8: Import the CDISC_MEDIKA sample clinical data protocol

In the Design module, as the user CTSYS, import the sample clinical data protocol.

If you are importing the CDISC_MEDIKA sample clinical data protocol, import metadata and clinical data to the CDISC_MEDIKA protocol, using the CDISC_MEDIKA_md.dmp file in the

\\client-dir\\samples\\CDISC\\CDISC MEDIKA subdirectory.

The dictionary protocol (CDISC_SDTM_31) contains panel definitions that are based on the SDTM v3.1. It may be used as a reference library by users when building SDTM-compliant study protocols.

To import this reference library, use the protocol CDISC_SDTM_311_m.dmp file in the \client-dir\samples\CDISC\CDISC STDM 31 subdirectory.

Note: If you are not also importing the MEDIKA_CLINICAL sample study, proceed to steps 13 and 14.

If you are importing the MEDIKA_CLINICAL clinical data protocol, import metadata and clinical data to a protocol named MEDIKA_CLINICAL, using the following protocol ct_med_clin_md.dmp file in the \client-dir\samples\Protocols subdirectory.

Step 9: Create an account for site-specific PL/SQL

Oracle recommends that you create an Oracle account to store site-specific and protocol-specific PL/SQL packages, procedures, and functions used by the Clintrial derivations, rules, and data-entry processing procedures. The sample study includes the grnt.sql script to create this account.

Start SQL*Plus from the module's installation directory and log on to the database instance.

The server module software and verification scripts are placed in directories called one of the following:

\$HOME/ct4server/ct47/ct47_<Clintrial_module>

\$HOME/local/ct4server/ct47/ct47_<Clintrial_module>

Where

\$HOME is the **\$ORACLE_HOME** directory

<Clintrial_module> is one of the following:

- **srv**—core server
- **ctc**—Multisite Distribution server
- **ctx**—Multisite Replication server
- ctg—Classify server
- ctl—Lab Loader server
- ctv—Resolve server
- ctqa—Ad Hoc Query (the Retrieve module)

For example, on a Windows system, the path name and directory name for the core server installation directory could be:

- 1 C:\oracle\ct4server\ct47\ct47_srv
- 2 Run the grnt.sql script from the \\ct47_smp\\Packages directory:

SQL> @grnt

Here are the names of scripts you may run:

- ctpost—core server
- ctcpost—Multisite Distribution server
- ctxpost—Multisite Replication server
- ctgpost—Classify server
- ctlpost—Lab Loader server
- ctvpost—Resolve server
- ctqpost—Retrieve server

You are prompted to enter the name for the log file.

3 Press **Enter** to accept the default, or enter the log file name.

You are prompted to enter a connection string.

4 Enter the @ symbol followed by the instance (or service) name to connect to.

You are prompted to enter the SYSTEM Account Password.

5 Enter the SYSTEM Account Password.

You are prompted to enter the Clintrial CTPROC Account Password.

6 Enter the Clintrial CTPROC Account Password.

You are prompted to enter the CTSITEPROC Account Password to use for the CTSITEPROC account.

7 Enter the CTSITEPROC Account Password.

You are prompted for default tablespace to use for the CTSITEPROC user.

Note: This cannot be the SYSTEM tablespace.

8 Press **Enter** to accept the default, or enter the CTSITEPROC default tablespace.

You are prompted to enter the temporary tablespace for the CTSITEPROC user.

Note: This tablespace must have temporary storage (contents must be TEMPORARY). Also, this cannot be the SYSTEM tablespace.

Step 10: Set PROC_SITE_ACCOUNT

 After creating the CTSITEPROC account, start the Admin module and set the Design system parameter PROC_SITE_ACCOUNT to CTSITEPROC.

Step 11: Run setup_CDISC.sql if you are targeting CDISC_MEDIKA

- 1 Log on as CTSITEPROC.
- 2 Run the setup_CDISC.sql script (assuming that C:\ct48\sampleCDISC\CDISC Medika is the location of the file and the SQL command is run from that folder):

SQL> connect ctsiteproc/ctsiteproc@instance-name;

SQL> @setup_CDISC.sql;

The setup_CDISC script calls the deprocs_CDISC.sql and ctsample.sql packages.

3 Complete steps 13 through 15.

Step 12: Compile CT_SAMPLE and grant EXECUTE if you are targeting the MEDIKA_CLINICAL

The ctsample.sql script:

- Compiles the CT_SAMPLE package, which contains stored functions for use by sample study rules and derivations.
- Includes statements that drop and add a public synonym for the CT_SAMPLE package.
- 1 Log on as CTSITEPROC, and run the script (assuming that C:\ct47\samples\Packages is the location of the file and the SQL command is run from that folder).
- 2 Grant EXECUTE privileges on CT_SAMPLE to CTSITEPROC, using the GRANT_EXECUTE_PRIVS command in the CT_PROC_ACCOUNT package:

SQL> connect ctsiteproc/ctsiteproc@instance-name;

SQL> @ctsample.sql;

SQL> execute ct_proc_account.grant_execute_privs('CT_SAMPLE');

Step 13: Compile DEPROCS and grant EXECUTE.

The deprocs.sql file:

- Compiles the DEPROCS package, which contains data-entry processing procedures that are used by the sample study.
- Includes statements that drop and add a public synonym for deprocs.

While logged in as CTSITEPROC, run the deprocs.sql file as follows (assuming that C:\ct47\samples\Packages is the location of the file and the SQL command is run from that folder):

SQL> connect ctsiteproc/ctsiteproc@instance-name;

SQL> @deprocs.sql;

Step 14: Set clinical data protocol for the Resolve module

If you plan to use the Resolve module with a Medika Sample Study, you must set up the MEDIKA_CLINICAL or CDISC_MEDIKA protocol for the Resolve module, as follows:

Start the Resolve module as a user who has the Full access level for the non-protocol access right Admin System.

Access levels and rights are set and appear in the Admin module.

For example, you can start the Resolve modules as the user CTSYS.

- 2 Set the protocol to MEDIKA_CLINICAL or CDISC_MEDIKA.
- 3 Select Setup > Setup for Resolve.

Step 15: Compile the CT_RESOLVE_USER package

If you use the Resolve module, you may want to customize it so that the investigator number and name from the INVESTIGATORS panel determines the list of investigators in several Resolve dialog boxes for the protocol. To do so, you create a customized version of the CT_RESOLVE_USER package that is delivered with the Clintrial software. The Clintrial software includes the following files that allow you to customize the Resolve module for the sample study:

- sm_ruser.sqh—Package specification for the customized CT_RESOLVE_USER package.
- sm_ruser.sql—Package body for the customized CT_RESOLVE_USER package.

This has been customized for MEDIKA_CLINICAL.

You can add changes for your own protocols.

- **before.sql**—Grants access to the CTSITEPROC account for the INVESTIGATORS_DATA table and INVESTIGATORS_UPDATE table in the MEDIKA_CLINICAL protocol, as required by the CT_RESOLVE_USER package.
- af_ruser.sql—Grants access to the CTSITEPROC account for the INVESTIGATOR_UPDATE table in the CTRESOLVEREF protocol, as required by the CT_RESOLVE_USER package.

To use the customized CT_RESOLVE_USER package:

- 1 After setting appropriate permissions on the before sql and af_ruser sql scripts, if you gave the imported MEDIKA_CLINICAL or CDISC_MEDIKA protocol another name, set the appropriate permission on the sm_ruser sql file and edit it to refer to that name.
- 2 Log on to the CTSITEPROC account (assuming that C:\ct47\samples\Packages is the location of the file and you run the SQL command from that folder).
- 3 Enter the following command:

SQL> @before.sql;

Note: Because this file logs on to the CTPROC account, when it has finished running, you must log back in to the CTSITEPROC account.

4 Log on to the CTSITEPROC account and enter the following commands:

SQL> @sm_ruser.sqh;

SQL> @sm_ruser.sql;

If you find errors in sm_ruser.sql, correct them in your editor and run the file again.

5 Change the public synonym for the CT_RESOLVE_USER package and grant access to it:

SQL> drop public synonym ct_resolve_user;

SQL> create public synonym ct_resolve_user for ctsiteproc.ct_resolve_user;

SQL> grant execute on ct_resolve_user to ct_user;

6 Be sure that the CTSITEPROC account can correctly run all the functions in the CT RESOLVE USER package, run the modified copy of af ruser.sql.

For example:

SQL> @af_ruser.sql;

SQL> alter package ctsiteproc.ct_resolve_user compile body;

Choose Repair if you just want to reinstall Clintrial 4.7.

Choose **Remove** if you want to remove the previous Clintrial 4.7 client installation.

When something is wrong for the previous client installation, it is recommended to use **Remove** to remove the previous client installation and then run the installation again.

Note: There is no upgrade per se for the client to go from Clintrial 4.5 or 4.6 to 4.7. You may leave older clients undisturbed on your computer if desired, or remove them using the Windows Control Panel. You can then install the Clintrial 4.7 Client, using the instructions in Installing or upgrading the Clintrial 4.7 client software.




