## Install and Test Notice

**Important** Install and test this release on a designated development server before installing it on your production environment. Your development environment should mirror your production environment as closely as possible to provide accurate testing results. It is important to validate the installation of this release, and confirm your integrations are working correctly as part of your minimum due diligence. Any problems or questions noted during your development system testing should be resolved before installing this release on your production environment.

## Oracle Application Server 10.1.3.5

Agile PLM 9.3.1.2 supports Oracle Application Server (iAS) 10.1.3.5.0, a patchset to prior releases of iAS 10gR3 delivering fixes to iAS. The Agile PLM application can be installed and started on this updated version of iAS with no apparent issues.

## AutoVue 20.1.1

Agile PLM 9.3.1.2 supports the latest version of AutoVue, called "AutoVue 20.1.1 for Agile PLM".

## Platform Support

Agile PLM now supports the following browsers, with noted restrictions per operating system (OS)

or solution:

- Internet Explorer 9 is supported in Compatibility Mode.
- Solaris 11 is supported for both client OS and server OS.  
*Note:* Oracle Application Server 10.1.3.5 is not certified on Solaris 11.

- Firefox 8 is supported for all Agile PLM 9.x solutions except Recipe & Material Workspace.

## Oracle Agile Product Overview Checklist

After reading the content of this Oracle Agile PLM release document, we suggest performing the following tasks:

- Feature Review:
  - Review the New Features and Resolved Issues sections to make sure you understand the overall product changes in this release.
- Business Process Review:
  - After completing the New Feature and Resolved Issues review, make sure you understand if any of your current business processes are impacted by this release and/or if they might need to be modified and re-evaluated. This is a very important preparation step as you move forward with implementing any Agile release. Make sure all of your key business processes are thoroughly documented and you have an overall business owner who understands each process. Use this list of processes as a checklist against the features and changes in this Agile release. You may want to assign a “weight” to each change in terms of how significant an impact it has to your organization (think about re-training users, changing current integrations, etc.)
- Identify resources to install and test this release.
  - Make sure that a test environment is ready and that tests have been developed to ensure this release performs the functions necessary for your business. Verify that the system can be rolled back in the unlikely event of a failure. Make sure that your testing includes all aspects of the product features, all of your business processes and any integration that you may have (AIS, SDK, ChangeCAST, ACS, etc.). If considering switching to LDAP authentication, come up with a plan to test the LDAP integration. Make sure to cover common scenarios like changing password, removing a user, etc.
- Create an upgrade plan and strategy.
  - For a release, we recommend engaging our Oracle Consulting Organization for your upgrade. Validate the hardware configuration according to the Capacity Planning Guide. If you plan to manage your own upgrade, create a very detailed upgrade plan that includes a scheduled start time, an established number of “dry” runs, a pre-determined rollout date, and a designated team of individuals across your organization with detailed knowledge of product, technology, networking, business process, etc.
- Prepare end-user training.
  - We recommend exposing a number of your power users to the new version well in advance of a production rollout to ensure that your users deeply understand the product functionality. Much of the end user training will actually begin during the testing phase. Use this feedback as a basis for your overall end-user training.

## New Features in Agile PLM Solutions

The following sections list features that have been added to Agile PLM 9.3.1.2.

### Added Support for WebLogic Server 10.3.6

Agile PLM now supports WebLogic Server 10.3.6.

### Report Stability Enhancements

Several settings have been added or modified to enhance the stability of systems that run many reports due to number of users and size of the company's work. These are summarized below.

#### Administrator Systemwide Preferences

**Maximum Reports Executed Simultaneously** – This Preference has always applied to Standard Reports only, now applies also to Custom and Scheduled Reports. The value (10) limits the number of reports that can run in any one node of a clustered environment; this value is the number that can be run simultaneously in a single-node system, and a 4-node cluster (for example) can run 40 reports simultaneously.

**Multiple Report Restriction** – This is a new Preference; its settings and related error messages guard against users attempting to run the same report until their (first) request is completed.

**Maximum Report Results** – This Preference ensures Administrator and Standard Reports leverage the limits it defines (default is 50,000). Warning or Error messages are now thrown when the maximum limit is approached. The system now distinguishes between BOM-specific reports (governed by a setting in Agile.Properties) and non-BOM-specific reports (governed by this Preference).

## **Agile Privilege “Full Search Display” should be restricted**

The Full Search Display privilege mask (which actually applies to Reports) permits the overriding of the Maximum Report Results for Custom Reports. Therefore, its assignment to users is now recommended to be disabled, never used, or at least severely restricted.

These elements of report stability are documented in the PLM Administrator Guide in the chapters on “Systemwide Preferences” and “Privileges and Privilege Masks”.

## **Preference for BOM Table Row Expansion**

A new systemwide Preference called Maximum Rows for Table Expansion brings to the Administrator UI a control that was previously covered by a hidden property (in Propertytable). It governs the amount of BOM rows allowed to display in Web Client, even in Expanded Display, so that very large BOMs do not overload the system. This Preference observes the existing behavior: Agile shall always show the first level BOM rows regardless of the Preference’s value.

## **Export Changes Exclude Affected Items Redlines**

A new filtering option called Redline Content is available when exporting Change objects in the PDX or aXML export formats. The option allows BOM/AML elements on Affected Items (AI) in the Change object to be exported, and to exclude any redlined content of the AI's in the Change.

Root Cause: There is a bad statement that deletes all the properties of the attributes in PageTwo and PageThree during the upgrade.

Resolution: Remove the bad statement in AUT.

Bug ID 12743445: KTU.C: SECOND ARG TO MEMSET() IS NOT A POINTER

Resolution: Closed, not a bug.

Bug ID 12805884: ACTION, REQUIRED REVIEWER, AND SIGNOFF USER INFORMATION IS EMPTY

Root Cause: It removed some rows with affected\_item column is null in change\_history table during the upgrade.

Resolution: Change the script to update the affected\_item to 0 instead of remove them.

Root Cause: Multi-lists 04–15 are not defined in the code level of DataLoad.

Resolution: Add definition to DataLoad code.

Bug ID 12949176: DATALOAD THROWS NULL POINTER WHEN BOM IS LOADED

Root Cause: Code level; calls a method of null object in while loading BOM.
