Preface

Understanding the PeopleSoft Online Help and PeopleBooks

The PeopleSoft Online Help is a website that enables you to view all help content for PeopleSoft Applications and PeopleTools. The help provides standard navigation and full-text searching, as well as context-sensitive online help for PeopleSoft users.

PeopleSoft Hosted Documentation

You access the PeopleSoft Online Help on Oracle's PeopleSoft Hosted Documentation website, which enables you to access the full help website and context-sensitive help directly from an Oracle hosted server. The hosted documentation is updated on a regular schedule, ensuring that you have access to the most current documentation. This reduces the need to view separate documentation posts for application maintenance on My Oracle Support, because that documentation is now incorporated into the hosted website content. The Hosted Documentation website is available in English only.

Locally Installed Help

If your organization has firewall restrictions that prevent you from using the Hosted Documentation website, you can install the PeopleSoft Online Help locally. If you install the help locally, you have more control over which documents users can access and you can include links to your organization's custom documentation on help pages.

In addition, if you locally install the PeopleSoft Online Help, you can use any search engine for full-text searching. Your installation documentation includes instructions about how to set up Oracle Secure Enterprise Search for full-text searching.

See *PeopleTools 8.53 Installation* for your database platform, "Installing PeopleSoft Online Help." If you do not use Secure Enterprise Search, see the documentation for your chosen search engine.

Note: Before users can access the search engine on a locally installed help website, you must enable the Search portlet and link. Click the Help link on any page in the PeopleSoft Online Help for instructions.

Downloadable PeopleBook PDF Files

You can access downloadable PDF versions of the help content in the traditional PeopleBook format. The content in the PeopleBook PDFs is the same as the content in the PeopleSoft Online Help, but it has a different structure and it does not include the interactive navigation features that are available in the online help.

Common Help Documentation

Common help documentation contains information that applies to multiple applications. The two main types of common help are:

- Application Fundamentals

- Using PeopleSoft Applications

Most product lines provide a set of application fundamentals help topics that discuss essential information about the setup and design of your system. This information applies to many or all applications in the PeopleSoft product line. Whether you are implementing a single application, some combination of applications within the product line, or the entire product line, you should be familiar with the contents of the appropriate application fundamentals help. They provide the starting points for fundamental implementation tasks.

In addition, the *PeopleTools: PeopleSoft Applications User's Guide* introduces you to the various elements of the PeopleSoft Pure Internet Architecture. It also explains how to use the navigational hierarchy, components, and pages to perform basic functions as you navigate through the system. While your application or implementation may differ, the topics in this user's guide provide general information about using PeopleSoft Applications.

Field and Control Definitions

PeopleSoft documentation includes definitions for most fields and controls that appear on application pages. These definitions describe how to use a field or control, where populated values come from, the effects of selecting certain values, and so on. If a field or control is not defined, then it either requires no additional explanation or is documented in a common elements section earlier in the documentation. For example, the Date field rarely requires additional explanation and may not be defined in the documentation for some pages.

Typographical Conventions

The following table describes the typographical conventions that are used in the online help.

Bold	Highlights PeopleCode function names, business function names, event names, system function names, method names, language constructs, and PeopleCode reserved words that must be included literally in the function call.
<i>Italics</i>	Highlights field values, emphasis, and PeopleSoft or other book-length publication titles. In PeopleCode syntax, italic items are placeholders for arguments that your program must supply. Italics also highlight references to words or letters, as in the following example: Enter the letter <i>O</i> .
Key+Key	Indicates a key combination action. For example, a plus sign (+) between keys means that you must hold down the first key while you press the second key. For Alt+W, hold down the Alt key while you press the W key.
Monospace font	Highlights a PeopleCode program or other code example.
... (ellipses)	Indicate that the preceding item or series can be repeated any number of times in PeopleCode syntax.

ISO Country and Currency Codes

PeopleSoft Online Help topics use International Organization for Standardization (ISO) country and currency codes to identify country-specific information and monetary amounts.

ISO country codes may appear as country identifiers, and ISO currency codes may appear as currency identifiers in your PeopleSoft documentation. Reference to an ISO country code in your documentation does not imply that your application includes every ISO country code. The following example is a country-specific heading: "(FRA) Hiring an Employee."

The PeopleSoft Currency Code table (CURRENCY_CD_TBL) contains sample currency code data. The Currency Code table is based on ISO Standard 4217, "Codes for the representation of currencies," and also relies on ISO country codes in the Country table (COUNTRY_TBL). The navigation to the pages where you maintain currency code and country information depends on which PeopleSoft applications you are using. To access the pages for maintaining the Currency Code and Country tables, consult the online help for your applications for more information.

Region and Industry Identifiers

Information that applies only to a specific region or industry is preceded by a standard identifier in parentheses. This identifier typically appears at the beginning of a section heading, but it may also appear at the beginning of a note or other text.

Example of a region-specific heading: "(Latin America) Setting Up Depreciation"

Region Identifiers

Regions are identified by the region name. The following region identifiers may appear in the PeopleSoft Online Help:

- Asia Pacific
- Europe
- Latin America

- North America

Industry Identifiers

Industries are identified by the industry name or by an abbreviation for that industry. The following industry identifiers may appear in the PeopleSoft Online Help:

- USF (U.S. Federal)
- E&G (Education and Government)

Chapter 1

Getting Started with PeopleSoft Global Payroll for Spain

Global Payroll Documentation

This section discusses:

- Global Payroll application design.
- Global Payroll documentation structure.
- Documentation roadmap.

Global Payroll Application Design

Because the structure of the Global Payroll documentation is similar to the design of the application, the best way to understand the documentation is to review the design of the application itself.

Global Payroll comprises two complementary parts:

- A core payroll application that includes:
 - A payroll rules engine.
 - A payroll processing framework.
 - Processes and setup steps that apply to all countries.
- Country extensions that include:
 - Statutory and customary objects (payroll rules, payroll processes, reports, additional country-specific pages, and self-service applications).
 - Country-specific rules and elements.

Global Payroll Documentation Structure

Like the application, the documentation for Global Payroll consists of two parts: a core book and separate country extension books.

Core Documentation

Like the core portion of the application, which applies to all countries and enables you to develop rules and process a payroll regardless of location, the core book is country neutral. Thus, while it describes the core set of tools that you can use to develop a payroll, it doesn't discuss the local country rules that have

been set up for you. For information about how the PeopleSoft system has extended core capabilities to meet local requirements, refer to the country extension documentation.

Country Extension Documentation

Just as country extensions in the application address local needs, the country extensions in the documentation cover local functionality. This includes:

- Any core feature with local extensions.
- Country-specific rule setup.
- PeopleSoft-delivered rules and tables.
- Country-specific pages.
- Country-specific reports.
- PeopleSoft Human Resources (HR) Management Systems setup, such as bank definitions, that varies by country.
- Implementation information that varies by country.

Documentation Roadmap

The core and the country extension documentation complement each other; therefore, you should read both sets of documentation.

What to Read When

You can approach the documentation in the following way:

- If a process setup is shared between the core application and the country extension, read the core documentation first and then the country extension documentation.

For example, banking is a feature that you first define in the core application and then often continue in the country extension because most country extensions have some type of banking functionality. You would first read the banking chapter in the core documentation and then the banking chapter in the country extension documentation.

- If a process is set up only in the core application, read the core documentation.
- If a process is set up only in the country extension, read the country extension documentation.

Documentation Audiences

We've identified the following audiences for the documentation:

- Technical

Technical readers who are interested in the technical design of the product should begin by reading the "Introducing the Core Application Architecture" section of the core documentation, as well as the batch processing information that is mentioned in many of the other sections.

See "Understanding the Core Application Architecture (*PeopleSoft HCM 9.2: Global Payroll*)".

- Functional

Functional readers who are interested in defining rules should begin by reading the country-specific functionality described in the country extension documentation. Functional readers can continue to learn about how to use the tools in the core application by reading the sections on defining payroll elements, such as earnings and deductions, in the core documentation.

- Managerial

Managerial readers should begin by reading the introduction sections of both the core documentation and the country extension documentation to get a high-level overview of the Global Payroll product.

Note: To fully understand Global Payroll, technical or functional persons who are involved in the product implementation should read the core documentation and the applicable country extension documentation in their entirety.

PeopleSoft Global Payroll for Spain Overview

PeopleSoft Global Payroll for Spain delivers elements, rules, pages, processes, and reports that work with the Global Payroll core application to form a complete payroll package for Spain. You can define basic and nonbasic earnings, as well as extra period payments and overtime. You can define deductions, such as union fees and garnishments. With PeopleSoft Global Payroll for Spain, you can calculate employer and employee Social Security contributions and *el Impuesto sobre la Renta de las Personas Físicas* (IRPF) calculations. You can process loans and advances. You can track absence and vacation balances for employees. With PeopleSoft Global Payroll for Spain, you can calculate termination pay, generate payslips, and process banking for employees.

Understanding PeopleSoft Global Payroll for Spain

PeopleSoft Global Payroll for Spain

PeopleSoft Global Payroll for Spain is a country extension of the core Global Payroll application. It provides you with the payroll rules, elements, and absence processes needed to run a Spanish payroll.

PeopleSoft Global Payroll for Spain Business Processes

PeopleSoft Global Payroll for Spain supports these business processes:

- Basic and nonbasic earnings.

PeopleSoft Global Payroll for Spain enables you to process basic and nonbasic earnings, such as base salary, seniority, complements (transportation, languages, nocturnal expenses, and festivities), and nonsalary earnings (*pernocta* and *dietas*). You can also create your own earning types and modify calculation rules for delivered earnings.

- Extra periods.

In PeopleSoft Global Payroll for Spain, you can define the details for the extra period payments as part of defining labor agreement information. You can define when extra periods are paid, the earnings that contribute towards the extra period payment, and the percentage of each contributing earning that is included in the payment.

- Other deductions.

Other deductions, such as union fees and garnishments, are managed by PeopleSoft Global Payroll for Spain as part of the payroll process.

- Overtime.

PeopleSoft Global Payroll for Spain enables you to pay overtime hours. Each organization can specify the annual, monthly, or weekly worked hours based on the maximum legal number of hours established by the Spanish government. Overtime (*horas extra*) occurs when an eligible payee works

more than the specified number of hours. In this case, the employer should pay a surcharge on the extra time worked.

- Loans and advances.

PeopleSoft Global Payroll for Spain enables you to process loans and advance payments that are made to employees through the payroll.

- Social Security contributions and benefits.

PeopleSoft Global Payroll for Spain calculates the employer and employee contributions and the employer reductions and generates data for the social security reports TC1 and TC2. It includes functionality to handle Social Security funding base calculations for employees with multiple jobs or who were employed as trainees and apprentices.

PeopleSoft Global Payroll for Spain also enables you to track the disability status of employees and transmit the data to Social Security using an electronic medical report file with an .FDI extension.

- *El Impuesto sobre la Renta de las Personas Físicas* IRPF calculation.

In Spain, the IRPF calculation varies according to the fiscal territory to which the employee reports. PeopleSoft Global Payroll for Spain delivers taxation rates for all the Spanish fiscal territories and the tax calculation process handles calculations for all these fiscal territories. PeopleSoft Global Payroll for Spain also provides you with a mechanism to produce the Model 111, Model 190, and Model 110 reports for all territories.

- Absences.

PeopleSoft Global Payroll for Spain delivers predefined rules for processing absences due to vacation, illness, maternity, work accidents, and other reasons. You can easily modify many of these rules to reflect absence policies that are specific to your organization or to labor agreements that may be in effect for your employees.

- Termination pay.

With PeopleSoft Global Payroll for Spain, termination pay is calculated with the payroll and includes the regular salary, extra periods, unused vacation days, and unpaid overtime. The final payment also takes into account any outstanding loans and advances, severance payment, pre-advice days that are not fulfilled, and job litigation salaries.

- Payslips.

PeopleSoft Global Payroll for Spain enables you to generate payslips that you can adapt to display exactly the information that you require. You also decide how you want to display retro calculations and extra period payments.

- Banking.

With PeopleSoft Global Payroll for Spain, you can define the banks that your organization uses to make payroll payments, as well as the personal banking information required to make these payments effective. This also includes IBAN information, if needed. You can distribute net pay between different banks and bank branches and different beneficiaries. PeopleSoft Global Payroll for Spain supports the CSB34 format for completing bank transfers, and includes reports that enable you to check stored bank information, as well as completed or pending transfers.

- Pension plans.

PeopleSoft Global Payroll for Spain provides functionality that supports both individual and collective pension plans. You can create pension plans, assign them to employees, and generate reports that include payroll results data for pension plans, such as the Model 345.

- Special collectives.

PeopleSoft Global Payroll for Spain provides functionality to manage the relationship between companies and the following special collective groups: displaced persons and expatriates, scholarship holders, preretired, and professionals. This includes functionality to manage payments, social security contributions, taxation, and reporting for each of the special collective types.

Delivered Elements for Spain

Global Payroll defines each business process for Spain in terms of delivered elements and rules. Some of these elements and rules are specifically designed to meet legal requirements, while others support common or customary payroll practices.

This topic discusses:

- Delivered element creation.
- Element ownership and maintenance.

Delivered Element Creation

All of the elements that are delivered as part of the country extension were created by means of the core application, the same application that you use to create additional elements and (in many cases) to configure existing elements that are delivered as part of Global Payroll. Because the tools that you need to redefine or create new payroll elements are fully documented in the core application product documentation, this information does not appear here. Instead, this guide briefly reviews the relationship between the core application (which contains the tools that you need to define your own elements) and the

country extensions (which contain country-specific rules and elements that PeopleSoft Global Payroll for Spain defines).

The core application:

- Consists of a payroll rules engine.

The payroll rules engine is a flexible tool that enables you to define the rules of a payroll system and to run payroll and absence calculations. Global Payroll does not embed payroll-specific logic or computations in application code. Instead, it specifies all business application logic (such as earnings, deductions, absences, and accumulators) in terms of payroll rules. Global Payroll enables you to enter and maintain payroll rules through a set of pages and offers comprehensive features that enable you to work in your preferred language or currency.

- Provides a payroll processing framework.

The payroll processing framework provides a flexible way to define and run payroll and absence processing flows (such as calendars, run types, pay periods, and process lists).

Country extensions:

- Are built using the core application.
- Consist of statutory and customary objects (country-specific payroll rules, elements, payroll processes, reports, pages, and self-service applications).

Element Ownership and Maintenance

This topic describes the PeopleSoft approach to element ownership and what this means for the maintenance of Spanish payroll rules. This information helps clarify which parts of the system you might be required to maintain, what you can modify, and what parts of the system you cannot change.

Element Ownership in Global Payroll

Five types of element ownership are available in Global Payroll:

PS Delivered/Maintained	Elements that Oracle delivers and maintains on an ongoing basis.
PS Delivered/Not Maintained	Elements that Oracle delivers that must be maintained by the customer. This type of element ownership consists primarily of either customary (nonstatutory) rules or statutory elements that customers might want to define according to a different interpretation of the rules. Although Oracle might occasionally update elements that are defined as PS Delivered/Not Maintained, you are not required to apply these updates.
Customer Maintained	Elements that the organization creates and maintains. Oracle does not deliver rules defined as Customer Maintained.
PS Delivered/Customer Modified	Elements that are originally PS Delivered/Maintained over which the customer decides to take control (this change is irreversible).

PS Delivered/Maintained/ Secure Delivered elements that the customer can never modify or control.

Element Ownership in PeopleSoft Global Payroll for Spain

Of the five ownership types described previously, only these two are used to define Spanish elements:

- PS Delivered/Maintained.
- PS Delivered/Not Maintained.

Although PeopleSoft Global Payroll for Spain delivers some elements as PS Delivered/Maintained, the large majority of elements are designated PS Delivered/Not Maintained. This enables you to modify, update, and reconfigure delivered elements to meet your own unique requirements.

Note: In general, PeopleSoft Global Payroll for Spain uses the ownership category PS Delivered/Not Maintained except where the modification of an element might interfere with calculations designed to satisfy strict legal requirements. The value of this approach is evident in the setup of delivered accumulators. Because balance accumulators (for example, those storing taxable gross on a year-to-date basis) must be set up to comply with legal requirements for reporting taxes and contributions, PeopleSoft Global Payroll for Spain defines them as PS Delivered/Maintained (meaning that you cannot modify or directly add new elements to them). However, you can add new elements to these accumulators using delivered specific segment accumulators, which serve as the basic entry point into the system and are not maintained by Oracle.

PeopleSoft Global Payroll for Spain delivers these customer-oriented segment accumulators using the CLI AC NAME naming convention. Therefore, when you define a new earning or deduction, you can assign the element to a segment accumulator (CLI), and the segment accumulator automatically contributes to the correct balance accumulators.

Accumulator	PS Delivered/Not Maintained for segment accumulators. Delivered/Maintained otherwise.	In the tax and social security areas, Oracle delivers the balance accumulators as PS Delivered/Maintained, but the segment accumulators as PS Delivered/Not Maintained.

Element Naming Conventions in Spain

Understanding the naming convention that is developed for Oracle-delivered elements can help you determine the element type, the functional area it serves, and how it is used.

This topic discusses:

- Naming conventions.
- Functional area codes.
- Element type codes (PIN_TYPE).

Naming Conventions

This topic discusses:

- Primary elements.
- Supporting elements.
- Additional clues to the use of Spanish elements.

- Component names (suffixes).

Primary Elements

Primary elements (such as earnings, deductions, absence take, and absence entitlement elements) do not contain functional area codes or element type codes in their names. Primary elements have names that identify their functions and element types without the use of additional codes. For example, the name of the earning element SALARIO BASE identifies this element as a base salary element.

Supporting Elements

For supporting elements (such as variables, formulas, dates, and durations), Oracle uses this naming convention: FFF TT NAME.

- FFF: Functional area code.
See [Functional Area Codes](#).
- TT: Type of supporting element.
See [Element Type Codes \(PIN_TYPE\)](#).
- NAME: Based on a term in Spanish and provides a further means of identifying the element.

For example, in the tax array TAX AR ING A EST:

- TAX represents the functional area (taxes).
- AR represents the element type (array).
- ING A EST (*ingresos anuales estimados*) represents a further means of identifying the element.

Note: This naming convention applies to these element types: accumulators, arrays, brackets, counts, dates, durations, formulas, rate codes, variables, historical rules, fictitious calculation rules, proration rules, rounding rules, writable arrays, and generation control conditions as well as sections and element groups.

Additional Clues to the Use of Spanish Elements

Many Spanish elements contain abbreviations that provide clues to their use in the system (beyond those provided by the functional area codes or element type codes). For example, these duration elements have been defined for Spain: GEN DR PERIODO D, GEN DR PERIODO M, and GEN DR PERIODO A. While the functional area code *GEN* indicates that these elements are used across various functional areas (they have general relevance), and the element type code *DR* identifies them as duration elements, the abbreviations *D*, *M*, and *A* provide additional clues to how each element measures time. The duration element GEN DR PERIODO D measures time in days (*dias*), hence the *D* in the element's name. Likewise, the code *M* reveals that the element GEN DR PERIODO M measures time in months (*meses*). As you become more familiar with the payroll rules created for Spain, these abbreviations will help you to further identify and understand the role played by each element.

This table lists the most common abbreviations used in the names of Spanish elements.

Component Names (Suffixes)

In PeopleSoft Global Payroll for Spain, suffixes are used to name the components of earnings and deduction elements. For example, when you create an earning, deduction, or absence element in Global Payroll, you must define the components that make up the element, such as base, rate, unit, and percentage. The system automatically generates the components and accumulators for the element based on the calculation rule or accumulator periods that are used. The system also names the components and accumulators by appending a suffix to the element's name.

For example, suppose that you define the earning element named EARN1 with this calculation rule:

$$\text{EARN1} = \text{Rate} \times \text{Unit}$$

The system automatically creates two additional elements for the components in the calculation rule:

- Rate element: EARN1_RATE.
- Unit element: EARN1_UNIT.

The system creates suffixes to name the components of the element (_RATE and _UNIT).

In PeopleSoft Global Payroll for Spain, all components and accumulators have:

- Country: ESP
- Separator: _

In Global Payroll, all suffixes fall into one of these types:

- Separator.
- Earnings or deductions component suffixes.
- Earnings or deductions accumulator suffixes.
- Deduction arrears component suffixes.
- Deduction arrears accumulator suffixes.
- Absence entitlement component suffixes.
- Absence entitlement accumulator suffixes.

To view all of the suffixes defined for Spain, use the Element Suffixes component (GP_SUFFIX) in Global Payroll .

For some elements, you need to use a functional area in the naming convention. The three-digit functional area codes are used in naming conventions to identify the functional area where the element is being used.

Archiving Data for PeopleSoft Global Payroll for Spain

PeopleSoft Global Payroll for Spain generates a large amount of result data. To keep the amount of saved data manageable, you should periodically archive it. PeopleSoft PeopleTools delivers an archiving tool called the Data Archive Manager. To aid you in archiving your result data using the Data Archive Manager, PeopleSoft Global Payroll for Spain delivers a predefined archive object (GPES_RSLT_ARCHIVE) and an archive template (GPESRSLT). The delivered archive template uses queries that select data by calendar group ID (CAL_RUN_ID field).

Note: Use extreme caution when making changes to delivered archive objects, queries, or templates. Any modifications can result in the loss of important data.

Chapter 3

Setting Up Country Data

Understanding PeopleSoft Global Payroll Core Functionality in Spain

This topic discusses:

- Retroactivity.
- Payment keys.
- Accumulators.
- Segmentation.
- Triggers.

Retroactivity

Retroactivity is the process of going back in time and recalculating prior calendars because changes were made after the original calculation was run. When retroactive processing occurs for a payee, the system recalculates each element generated for the payee. The difference between these results is the retro delta.

In Global Payroll, two methods are available for calculating retro:

- Corrective
- Forwarding

The most common retro method used in Spain is the corrective method. Using this method, you go back and recalculate the elements of the pay run, updating all accumulators, including balance accumulators and calendar period accumulators. The recalculated pay run replaces the previously calculated run. However, the original pay run calculation remains available for auditing and reporting purposes. Rather than forwarding retro deltas to the current calendar as an adjustment, the system sends any adjustment to Net to be Paid for the recalculation period to manage the banking process.

Note: You can also set up retro with the forwarding method during your implementation if it fits your company's needs.

PeopleSoft Global Payroll for Spain and Retroactivity

PeopleSoft Global Payroll for Spain delivers the corrective method because this is the standard (statutory) way to manage retroactivity in Spain.

- The retro process (RETRO) uses the corrective method without variance.
- Retro overrides are used in PeopleSoft Global Payroll for Spain. They serve the following purposes:
 - To facilitate reporting retro calculations to Hacienda.

The system forwards the tax information for the current period using the IRPF RTR element. This element receives the value from the IRPF AFW element that is forwarded into IRPF RTR in a retro calculation of a month in the same year. In this way, the current month has all of the information affecting taxes. Also, the current tax percentage can be applied to the delta coming from a retro calculation.

- To manage retro across different tax years.

For these cases of retro, the system forwards tax values to the current month but it forwards them to elements other than IRPF FWD because they need to be taxed in a different way. In addition, these tax values are reported separately during yearly reporting. Later, the monthly and year-end reports retrieve those values and print them accordingly.

PeopleSoft Global Payroll also enables you to manage retro from previous years as if they were from the same fiscal year. To accomplish this, modify the value of the variable CLI VR RT A PR FLG (previous year retro flag) with a value that is not *Y*.

Note: Define retro overrides on the Retro Process Overrides page.

- You can define your own retro event.

See "Understanding Retroactive Methods (*PeopleSoft HCM 9.2: Global Payroll*)".

- You can define your own retro triggers according to your company needs.
- You can define your own pay entities according to your company needs, but the common setup in PeopleSoft Global Payroll for Spain is:
 - Calendar period: Starts in January.
 - Fiscal period: Starts in January.
 - Backward limits: Depends on how you set up PeopleSoft Global Payroll for Spain.
 - Forward limits: Two years.

Launching Retroactivity Across Different Tax Years

When the prior period is in a different tax year, your company normally can't collect the tax due and pay it to Hacienda because the prior year is already closed for tax reporting. This applies to both situations of underpayment and overpayment.

The system manages these retro deltas from a previous year based on the value of the variable CLI VR RT A PR FLG (Previous year retro flag). When the value of this variable is *Y*, the default value, the system processes retro deltas coming from a previous year separately from the income of the current year. It reports these retro deltas separately on the Model 111 and Model 190 reports. In addition, the system calculates the IRPF for those retro deltas by applying a fixed percentage (currently at 15 percent) instead of the valid IRPF percentage in the retro period.

If you set the value of CLI VR RT A PR FLG to anything but *Y*, the system processes retro deltas coming from a previous year together with the retro deltas of the current year. It does not manage them separately.

Note: Taxes and social security are calculated differently. Social security calculation is not affected when the retro calculation is across different tax years. The way to calculate retro in this case is the same as the one used in calculating retro in the current year.

Example of Calculating Retroactivity for a Different Tax Year

Assume that both the calendar period and the fiscal period for your pay entity start on January 1. If the retro starts in a different tax year, the fiscal period determines how the retro of taxes is calculated. The following list and table provide the details for this example:

- Launch the calculation for the May 2006 pay period.
- Launch a retro calculation for November 2005.
- Report the tax calculation for the deltas from all the launched retros from November until April in the Model 111 of May 2006.

In the case of the retro for November 2005 and December 2005, the IRPF for the delta is calculated with a 15 percent tax rate. Model 190 will reflect it accordingly.

Note: This table summarizes all the information that you need for your retro calculation. This table is only a suggestion using the common setup parameters that are delivered with PeopleSoft Global Payroll for Spain. You may find that your company's requirements are different and may need to define retro differently during your implementation.

Default retro method	Corrective
Retro process (retro method)	Corrective
Retro process - does it vary?	No

Backward limits:	No limits

Running Corrections in PeopleSoft Global Payroll for Spain

The pure retro process calculates from a target calendar, which receives forwarded tax data regarding deltas and updates the balance accumulators of the recalculated month. You then report the delta from the retro processing for the target calendar through complementary reporting. Thus, if you have already reported social security contributions for a given month and need to recalculate, you use pure retro processing. For example, if a company signs a labor agreement in May but needs to increase salary starting from January 1, then the company must run pure retro processing from January in the

May payroll (target calendar). The company then reports the deltas from the retro calculation in a complementary report within the May FAN file.

Corrections, on the other hand, are cases in which you need to rerun a finalized payroll but have not yet reported to social security for that month. Corrections enable you to report the delta on the regular monthly reporting rather than through complementary reporting. You are thus *correcting* a finalized payroll.

With PeopleSoft Global Payroll for Spain, you can run corrections by using a specific run type or by using Global Payroll core off-cycle functionality. The "Managing Off-Cycle Payments" topics explain both methods in detail.

Managing Reversals through Retroactivity

In some cases, retroactive processing may result in the reversal of payroll results. For example, let us assume that a payee was included in the payroll calculated for August. After you generate and submit all of the tax reports for the August payroll, you discover that the payee actually retired as of August 1st and should not have been included in the August payroll run. You can manage this type of situation through retro processing during the September payroll run. The system accomplishes this by creating a reversal segment for the September payroll run to reverse all of the payroll calculations for the retired payee for the month of August.

You can control whether the system reverses tax calculations in this type of situation using the CLI VR REV DD variable. When the value of this variable is *Y*, the system reverses all payroll calculations, including taxes. If the value of the CLI VR REV DD variable is *N*, the system does not reverse the taxes and other deductions that are specified in override sets 3 and 4 of the retro process definition (RETRO) for Spain as not to be reversed. The system instead forwards these deductions to the DD N REVRTDS deduction for the current payroll month.

Note: You can view which deductions are designated to be forwarded to the DD N REVRTDS deduction in override sets 3 and 4 on the Retro Process Overrides page.

Payment Keys

In PeopleSoft Global Payroll for Spain, you can define payment keys. Options are Company, Contract Number, Department, and Establishment ID. When the payment keys of the current period don't match the payment keys in the retro period, the deltas are managed as a separate gross-to-net calculation in the current calendar period. When a retro is launched that affects more than one calendar period, the deltas that come from each one will be summed only when the payment keys match.

For example, company information is needed for tax reporting purposes. The *Agencia Tributaria* needs to know which company the employee is working and being paid from.

So when retro is launched, you may need to report the tax calculation of the deltas related to the prior company. Or you may need to report the tax calculation of the deltas related to the current company. Which calculation you report depends on which company is declaring the payment to the fiscal territory.

Because PeopleSoft Global Payroll for Spain uses the corrective retro, it does not forward deltas into the current period in most cases. However, regarding tax calculation, the income deltas are transferred to the current period. You should review this during implementation and set up according to your organizational requirements.

Accumulators

In PeopleSoft Global Payroll for Spain, two types of accumulators exist:

- User-defined accumulators (balance accumulators):

Accumulate different elements for any period of time for which you want to accumulate any number of elements.

- Auto-generated accumulators (payment accumulators):

Accumulate a particular element during a defined period.

For user-defined accumulators, four functional areas exist that have specific prefixes:

- Absences accumulators (AUS).
- Earnings and deductions (AJB, FNQ, and GEN).
- Social security (SS).
- Taxes (TAX, RETJ).

For auto-generated accumulators, two functional areas exist that have specific suffixes:

- Absences (ADJU, BAL, ENT, TAKE).
- Deductions (ATR).

In PeopleSoft Global Payroll for Spain, you define accumulators for several earnings and deductions. Accumulators for earnings include those for base salary, seniority pay, *mejora voluntaria*, *complemento absorbible*, and extra period payments. Accumulators for deductions include social security deductions.

Customer-Oriented Segment Accumulators

PeopleSoft Global Payroll for Spain also delivers a set of customer-oriented segment accumulators. When you define an earning or deduction element, you can assign the element to these accumulators. You need to decide which accumulators you need to update, based on the following questions:

- How does the element affect gross?

- Is the element taxable?
- Does the element contribute to social security?

Depending on your answer to these questions, you need to select the appropriate accumulator. The following tables provide details about the customer-oriented segment accumulators:

Compensation:

Accumulator Name	Description
CLI AC SAL BRUTO	Custom gross salary. Add elements that correspond to an employee's compensation.
CLI AC DEDUCCIONES	Custom deductions. Add elements that correspond to an employee's deductions to the gross salary.
CLI AC DEV ABSRBLE	Custom absorbable earnings. Add elements that are going to be absorbed by the net-to-gross process. Note: If an element contributes to the gross salary and is also absorbable, it needs to be added to both CLI AC SAL BRUTO and CLI AC DEV ABSRBLE.

CLI AC ING DIN FJO	Custom fixed taxable base. Add elements that correspond to basic or regular fixed compensation that pay taxes.

CLI AC RDTO IRR70	Custom nonregular income 70. Use this accumulator for irregular income that is affected by 70% reduction.

CLI AC BS HR X E S	Social security structural overtime base. Add elements that correspond to structural overtime compensation that contributes to social security bases.
CLI AC BS HR X NES	Social security nonstructural overtime base. Add elements that correspond to nonstructural overtime compensation that contributes to social security bases.

CLI AC SEG AUS	Absences slicing. Add elements that correspond to absence segmentation.

CLI AC SEG CP	Professional contingencies slicing. Add elements that correspond to professional contingencies segmentation.

CLI AC SDIA INDM	Daily Salary for Severance Pay. You can use this accumulator, if you have set it up in the Labor Agreement component (HR_LABOR_AGRMNT), to calculate the severance payment.
CLI AC SDIA PREAV	Daily Salary for Preadvised Days. You can use this accumulator, if have set it up in the Labor Agreement component, to calculate the preadvised days earning/ deduction.
CLI AC SDIA TRAM	Daily Salary for Job Litigation Salary. You can use this accumulator, if you have set it up in the Labor Agreement component, to calculate the litigation salary.

Segmentation

In Global Payroll, you can segment elements based on different events or changes. Two types of segmentation exist:

- Period segmentation:

The system calculates each element more than once and keeps the results of these calculations separate.

- Element segmentation (also known as slice segmentation):

The system segments only the element selected. Only one gross-to-net result set exists.

PeopleSoft Global Payroll for Spain uses element segmentation in most cases. A slice can occur for many reasons:

- Changes in rate codes.

This can occur due to manual changes or automatic changes due to a salary plan, category, or multiple components change.

- Changes in an employee's annual salary (target compensation)
- Changes to risk code.
- Changes in the social security work center code (SSN).

This normally happens when an employee changes establishments.

PeopleSoft Global Payroll for Spain uses period segmentation for these changes:

- Changes in company (when an employee transfers to a different company).
- Changes in pay group.
- Changes in employees' payroll system.

PeopleSoft Global Payroll for Spain uses the Payroll System field to determine employees' payroll system.

Note: PeopleSoft Global Payroll for Spain delivers segmentation setup and triggers as sample data. You must decide which changes should trigger segmentation for your company. View the delivered segmentation rules and triggers using pages in Global Payroll in your demo installation.

Retroactivity Segment Mismatching

When the system recalculates a segmented period for retro and the segmentation dates of the original calculation don't coincide with those of the recalculation, this is called a segment mismatch, and it affects how the system calculates retro deltas.

When segment dates match and payment keys are the same, the system recalculates the original segments to determine the new values for each segment. It then subtracts the old value from the new value for each pay element to determine the retro deltas. It writes the new results to the output tables.

When segment dates don't match, the system treats the old and new values as if they belong to separate segments. It creates reversal segments for each segment that existed in the prior calculation and creates new recalculated segments. A reversal segment has no results because it does not go through gross-to-net processing. The only results that the system writes to the output result tables are for deltas and balance accumulators. For calculating deltas, the system uses zero for the new values.

The new recalculated segments go through gross-to-net processing and generate new values. While processing recalculated segments, the system cannot use the Use Previously Calculated Value check box functionality to get deltas as it normally does during retro processing because the previously calculated values for every element are resolved to zero. In this case, the system retrieves the previous value through arrays.

See "Element Attributes Page (*PeopleSoft HCM 9.2: Global Payroll*)".

When reading previously calculated values, the system sums the results for all slices and segments previously calculated for the calendar group and stores those values in container elements (RTR AC xxxxx). Then when the system subtracts the previous values from the recalculated values to determine retro deltas, it uses the proportional part of the total previous value, prorated with respect to the current segment days. The proration rule being used is: Active days in the current slice ÷ Active days in the period

Active days in the period is normally defined as the days between the period begin date and period end date, but in the event that an employee changes pay groups in the month, the system uses the period until the effective date of the pay group change. For cases in which contributions are linked to vacations, the system applies the total previous value to the segment in which there is now a termination.

Active days in the period normally means days between Period begin date, and Period End date, but in case employee changes of pay group in the month, then we will consider the period till the effective date of the paygroup change. In case of contributions linked to Vacations we are applying the total previous value to the segment in which there is now the termination

Note: For banking purposes, PeopleSoft Global Payroll manages reversal segments by inserting rows in GP_PAYMENT for the reversal segments as negative amounts. Then, the new calculation inserts the new values. This means that you must select the "Combine Payment" functionality whenever you process reversals.

Whenever you need to generate retro deltas or read previously calculated values, you need to analyze whether you want to use container elements (RTR AC xxxxx). To use container elements you must:

1. Create the container element (RTR AC xxxxx).
2. Update the formula RTR FM MAPPING to map the source element—the element for which you want to retrieve previous values—to the target container element.
3. Update the formulas that make use of the Use Previously Calculated Value check box functionality to use the container element in the case of segmentation mismatching.
4. Update the accumulators that determine the behavior of the container elements in the case of element segmentation: RTR AC SEG TAX and RTR AC SEG SS.

RTR AC SEG TAX (Tax Elements slicing) includes all container elements that should be sliced when the system processes segmentation trigger events that affect taxes.

RTR AC SEG SS (SS Elements to slice) includes all container elements that should be sliced when the system processes segmentation trigger events that affect social security.

The following is an example of how the system calculates the retro delta for the element SS AC BS CCNRM126S:

SS AC BS CCNRM126S - ([SS AC BS CCNRM126S] * RTR VR FLAG + RTR AC BS CCNRM126 * RTR VR REV SS) >> SS VR TC MONTO

The individual components of this calculation are:

- SS AC BS CCNRM126S: The recalculated value.

- [SS AC BS CCNRM126S]: The previously calculated value. It gets the value only for normal retro (without reversal).
- RTR VR FLAG: The system gives this variable a value of 1 in cases of retro without reversal.
- RTR AC BS CCNRM 126: This is the container element that receives the previous value when segment mismatching occurs.
- RTR VR REV SS: The system gives this variable a value of 1 in cases of segment mismatch.

Element Segmentation Mismatching

Element segmentation mismatching is a situation in which retroactive processing results in element segmentation that differs from the segmentation of the previous calculation. This means that for a group of elements no previous value exists for the current executing dates (current calculation slices). The slices that exist for those elements are different than the ones originally calculated. For example, assume that as part of a retro calculation the system inserts a new segmentation trigger on the 20th day of the month (element segmentation affecting Social Security, such as RISK_CODE). The system recalculates elements such as the Common Contingencies base for two slices (1st - 19th and 20th - 31st), but the original calculation was for just one slice (1st - 31st). This represents an instance of element segmentation mismatching.

When element segmentation mismatching occurs, it is necessary to perform a special calculation to obtain the previously calculated value of the affected elements. The system uses the same calculation that it uses to obtain the previously calculated value for retroactivity segment mismatching. The system detects when an element segmentation mismatch occurs and applies “Spanish” functionality to retrieve the previously calculated value using arrays. This enables Global Payroll for Spain to generate Social Security and Tax deltas correctly.

Note: The system also uses previously calculated values to process certain deductions such as loans and garnishments.

The formula RTR FM COMPR SEG checks for element segmentation mismatching associated with the following trigger events (trigger event IDs):

- Compensation (COMPRATE)
- Social Security calculation (RISK_CODE and CATEGORZN)

Note: Trigger event IDs are hard coded. Therefore, if you have defined your own element segmentation trigger events that affect compensation, Social Security, or taxes, you should update formula RTR FM COMPR SEG accordingly.

Forwarding Retro Deltas to Inactive Segments

PeopleSoft Global Payroll creates inactive segments to process retro deltas that are forwarded when the pay entity of the source month does not match the pay entity of the current month. This usually occurs whenever payment keys don't match. PeopleSoft Global Payroll also creates inactive segments when there are pending retro changes for inactive employees. The system requires a target calendar to which it can forward deltas (late terminations process through retro).

The system skips gross-to-net calculation during inactive segment processing. You need to ensure, however, that you manage the retro deltas that get forwarded using the setup variable CLI VR CAL DD

SG I (Calc IRPF DD in Inac. Segment). This variable indicates to the system whether you want to process tax deductions during inactive segment calculation. Valid values are:

- *A (anular)*: Select if you do not want the system to calculate retro tax deductions with negative net values.
- *C (calcular)*: Select if you want the system to calculate retro tax deductions with negative net values.

Triggers

In Global Payroll, triggers are used to detect online changes to data that should result in some type of system action. Examples of common data changes that might use triggers are the hiring of a new payee, a change in pay rate, or a change in job location.

Three types of triggers exist: iterative, segmentation, and retro triggers.

PeopleSoft Global Payroll for Spain delivers triggers as sample data. Review the delivered triggers and adjust existing triggers, or define your own triggers based on your company's needs.

Segmentation Triggers with Earning and Deduction Assignments

In Global Payroll you can define segmentation triggers only for *effective-dated* records, with one exception: you can define segmentation triggers for the *begin and end dated* earning and deduction assignment record GP_PYE_OVRD. This exception enables you to assign an earning or deduction to a payee on the Element Assignment by Payee (GP_ED_PYE) or Payee Assignment by Element

(GP_ED_ELEM) components, and to segment (and prorate) the element when the assignment *begin* date comes after the pay period begin date, the assignment *end* date comes before the period end date, or both.

PeopleSoft Global Payroll for Spain has set up the following earnings so that the system automatically segments and prorates them (using the proration factor defined on the earning definition pages) when the assignment period covers only a portion of the pay period:

If you want to set up additional earnings and deductions to trigger segmentation and proration when they are assigned to payees and the assignment period covers only a portion of the pay period, access the Trigger Definitions component (GP_TRGR_SETUP) and add these elements to the segmentation trigger definition for the GP_PYE_OVRD record.

In the case of deductions or nonbasic earnings, you also need to specify formula GEN FM SEGMNTCN as a post-process formula and specify the proration to use. PeopleSoft Global Payroll for Spain delivers GEN PO DIAS SLICE that you can use or modify, or you can create a new formula to fit your requirements.

Rounding Rules

When you resolve an element that is a numerical value, you often need to round the resulting value. You'll use rounding rules to do this.

After you define a rounding rule element, apply it to other elements. The rounding rule can be applied to any component of an earning or deduction, to the resolved amount of an earning or deduction, or within a formula.

The following table describes the delivered rounding rules that PeopleSoft Global Payroll for Spain provides as guidelines:

Chapter 4

Understanding Basic Earnings

Basic Earnings

This topic discusses:

- Basic earnings in Spain.

Basic Earnings in Spain

In PeopleSoft Global Payroll for Spain, earnings are classified in two ways: basic and nonbasic. Whether an earning is considered basic or nonbasic depends on its frequency and whether it's a fixed amount or a variable amount.

Basic earnings are:

- Paid every month.
- Included in the employee's annual income at the beginning of the year.
- A fixed amount each period (fixed earnings).

Basic earnings include:

- Base salary.
- Seniority.
- Prorated extra periods established by the labor agreement.
- Complements, such as languages, degrees, *mejora voluntaria*, *complemento absorbible*, and public transportation.

Any other delivered earning is considered a nonbasic earning in PeopleSoft Global Payroll for Spain.

Note: The basic earnings discussed here are only the ones that PeopleSoft Global Payroll for Spain delivers as sample data. They are the most common basic earnings required in Spain.

You can also create your own earnings and modify the calculation rules to fit your company's needs. To create your own earnings, use the Earnings component (GP_EARNING).

Processing Considerations for Basic Earnings

Basic earnings have these processing considerations:

- Net to gross and gross to net adjustments.
- Seniority calculation.
- Extra period calculation.
- Termination.

Because of these processing considerations, all basic earnings have the following special characteristics:

Calculation Rule = Unit * Rate

All basic earnings must:

- Be defined with the calculation rule of Unit * Rate, where Unit is the formula GEN FM UNIDADES and Rate is a rate code.
- Be identified by the category BAS at the earning definition.
- Have their own rate code.
- Have the formula GEN FM RATE AN/DAN as a post process formula.
- Have as generation control XTR GC MEN O PXTRA.

PeopleSoft Global Payroll for Spain calculates the earnings for all employees on a daily basis, regardless of the way they contribute to social security (daily or monthly). Therefore, the rate component is always a daily rate. For employees who contribute monthly, the Unit component is 30 days (when they work the whole month) for regular payments or the extra period time frame for an extra period. For employees who contribute daily, the unit component contains the number of days that the employee worked. The unit is the GEN FM UNIDADES formula.

The rate for basic earnings is always a rate code, which retrieves its values from the Job Data - Compensation page. Note that you can enter rate codes with whatever frequency you need. In the case of daily employees, normally you provide daily rates or annual rates. All rate codes are annualized or deannualized to days. So you can think of the unit as the actual number of days worked in a month and the rate as the theoretical amount that an employee is supposed to earn per day.

For employees who are paid based on real worked days and contribute to social security on a daily basis, if they work the entire month, the unit equals 30 for months with 30 days, 31 for months with 31 days, and 28 or 29 in February. The unit equals the number of days worked for employees who don't work the entire month.

For employees whose earnings are calculated monthly (whose social security contribution group is Monthly) and who work the entire month, the unit equals 30 regardless of the number of days that month has. If an employee is sick 10 days, the unit equals 20.

Generation Control = GEN GC MEN O PXTRA

The GEN GC MEN O PXTRA generation control determines whether an earning must be calculated at an extra period an extra period payroll is processed.

Base Salary

Base Salary in Spain

Typically in Spain, an employee's base salary is defined by the labor agreement. However, with HR and PeopleSoft Global Payroll for Spain you can set up employee compensation in different ways to suit your company needs.

The base salary is a basic earning. It is typically calculated as Unit * Rate, where the rate code is established by the labor agreement or in other ways, depending on the setup of your company's compensation. The unit is calculated with the formula GEN FM UNIDADES. The calculated value depends on the type of employee (daily or monthly).

Note: PeopleSoft Global Payroll for Spain uses the GEN RC SAL BASE rate code to specify the base salary. This rate code is linked to the SALBSE rate code defined in HR.

Adjustments to Salary

To calculate an employee's total salary, you may have to consider some adjustments to the basic compensation that are specified in the labor agreement, or that result from an employee's personal agreement.

If the salary in the employee's personal agreement is the same as the amount reflected in the labor agreement, no adjustment is necessary. This salary includes both base salary and complements.

Adjustments may include:

- Gross to net: Make this adjustment if the employee's gross salary defined by the labor agreement for his professional category is different from the gross salary in his personal agreement.

- Net to gross: Make this adjustment if you need to calculate an employee's annual gross salary from an agreed net amount.

Complemento Absorbible

The difference between the real gross defined in employees' personal agreements and the total earnings that they should receive in their professional category must be reflected in an earning element called *complemento absorbible*. In the case of net guarantee, the *complemento absorbible* is the difference between the calculated gross (calculated from the net) and the total earnings based on the professional category of the employee.

The calculation rule for *complemento absorbible* is defined as Unit * Rate, where Unit is the number of days worked in a month and Rate is the rate code GEN RC COM ABS EST. The earning is identified in the Customer Fields area with a value equal to 9-COMPABS.

To calculate the *complemento absorbible*, you must override the variable GEN VR TIPO AJ SAL for that employee using the value *BRUTO* for gross to net adjustment or the value *NETO* for net to gross adjustment. Use the Supporting Elements Overrides page to enter this override.

Seniority

Companies often calculate seniority by subtracting the seniority date from the payroll period end date. This is the PeopleSoft-delivered calculation method, but you can change it to fit your company's needs. If you want to change the calculation method, specify a custom duration or formula to calculate seniority years for a labor agreement on the Labor Agreement - Seniority page or modify the code of formula CLI FM ANTIG DESDE.

Note: Absences can decrease seniority years based on the number of months absent.

You can measure seniority pay in different ways. Typically, you measure seniority in multiples of three years (trienniums) or four years (*cuatrenniums*). You can also measure seniority as a mixture of years.

PeopleSoft Global Payroll for Spain delivers trienniums and *cuatrenniums*, but you can create a different seniority measurement by adding a new earning using one of the existing earnings as a template. If you define a new seniority measurement, add it on the Seniority Earnings page and identify those new seniority earnings with value 5-*ANTIGDAD* in the Custom Field5.

The most common way to determine seniority is to associate an amount with a triennium or *cuatrennium*. For example, an employee could get 18 EUR per month for the first triennium and 21 EUR per month for the second triennium. So if an employee has six years of seniority, he would get 39 EUR per month in seniority earnings.

Another typical seniority calculation method is a percentage over the base salary or base salary plus a complement.

Here's an example:

Assume that you have a programmer who is at Salary Level 4, earning 700 EUR per month. The labor agreement defines seniority as a *cuatrennium* that is 4 percent of the base salary. The programmer has eight years of seniority, which is equal to two *cuatrenniums*. His seniority earnings per month is calculated as:

- Number of *cuatrenniums* x (Percentage x Base) = Seniority earnings.
- 2 (*cuatrenniums*) x (0.04 x 700 EUR) = 56 EUR per month.

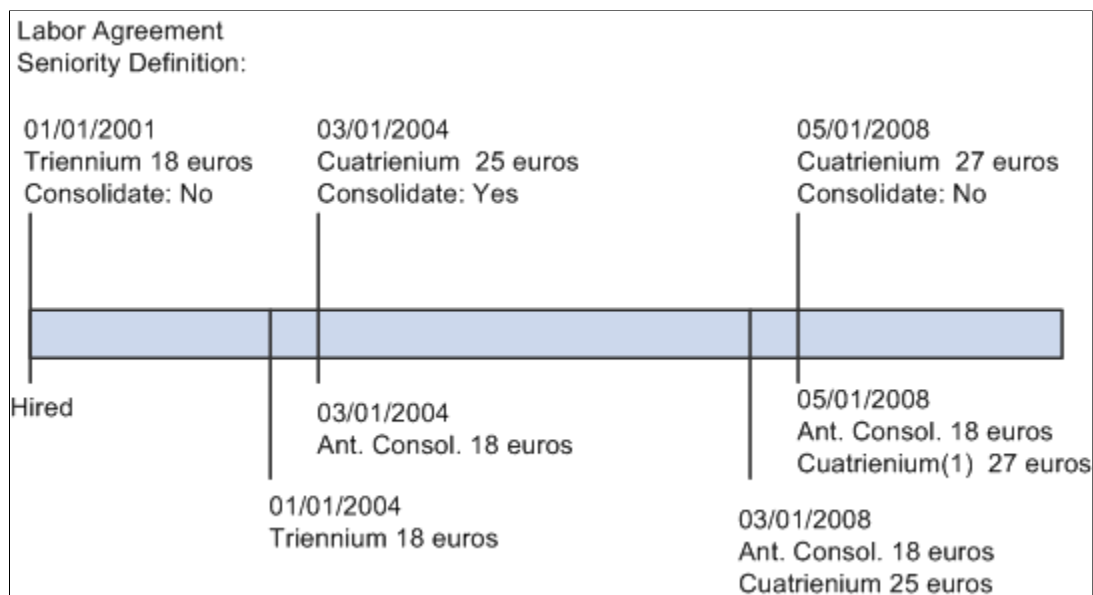
Consolidated Seniority (Antigüedad consolidada)

Sometimes, the labor agreement establishes a change in the measurement of seniority, for example, from trienniums to *cuatrenniums*. When this happens, part of the seniority amount can appear as another earnings element called consolidated seniority (*antigüedad consolidada*). The consolidated seniority element must reflect the total amount that the employee was receiving until the date of the change. This occurs if you select the Consolidation check box when adding a new effective-dated row on the Labor Agreement - Seniority page. If you don't select this check box, the seniority calculation considers only the new values or percentages when calculating the total amount to be paid for seniority.

Complements

Complements in Spain

Complements complete the final gross pay for each employee or group of employees. Complements understood as basic earnings are always calculated as Unit * Rate, where the worked days is in the Unit component of the calculation rule.

Three types of complement earnings exist:

- Personal conditions.
- Work completed.
- The company's situation and results.

Note: The payroll calculation process treats all these complements in the same way.

In this topic, detailed information is provided about personal condition complements, which include language skills, degrees or special skills, *mejora voluntaria*, and transportation. Complements for work completed and company situation are discussed in other topics in this product documentation.

Language Complement

Generally, employees receive a language complement only if they were hired specifically for their language skills and if using those language skills are a tool in their job.

The calculation rule for the language complement element is defined as Unit * Rate, where Unit is the days worked in a month and Rate is a rate code.

Because the language complement is an employee-specific earnings, it must be assigned individually for each employee who qualifies.

The language complement is defined on the Earnings component (GP_EARNING). Accumulators for the language component are discussed in this topic.

Degrees or Special Skills Complement

The degrees or special skills complement is used to compensate employees for their knowledge of a subject or for their skills.

Note: The calculation rule, page setup, and accumulators for the degrees or special skills complement are the same as those for the language complement.

Mejora Voluntaria

Mejora voluntaria is the substitute for the *complemento absorbible*. It is a complement that you manually calculate to pay an employee the difference between the market price and the specific salary reflected in the labor agreement for his category if you have defined compensation at the labor agreement level.

Note: The calculation rule, page setup, and accumulators for the *mejora voluntaria* complement are the same as those for the language complement.

Public Transportation and Distance Complement

The public transportation and distance complement is paid to employees to compensate for the distance between their residence and the company location. The maximum social security exempted is 20 percent of PRIM (*Indicador Público de Renta de Efectos Múltiples*). Depending on whether the employee contributes to social security on a monthly or daily basis, the PRIM amount is calculated either monthly or daily.

Note: *Indicador Público de Renta de Efectos Múltiples* is the a monthly or daily value established annually. A maximum of 20 percent of PRIM is exempt from social security contributions.

Only earnings that are paid in excess of the 20 percent of PRIM must be included in the Social Security base, but the whole amount is taxable. Since July 2004, this ceiling has been established as:

$$20\% \times 479.19 \text{ EUR (SMI)} = 95.826 \text{ EUR/month}$$

Because the public transportation and distance complement is an employee-specific earning, you must assign it individually for each employee who qualifies.

Note: One exception exists that is related to daily employees and the transportation complement. Sometimes, the transportation complement is paid monthly regardless of whether an employee contributes to Social Security on a monthly or daily basis. You can specify how the earning is calculated by assigning a daily or nondaily frequency on the Job Data - Compensation page. Frequencies other than daily generate monthly transportation complements. The TRANSPORTE earning is identified in the Custom Fields area with the value equal to 1-TRNSPRTE.

Extra Periods

In addition to 12 pay periods per year, employees are also eligible for two or more extra period payments, as defined by their labor agreements. Two extra period payments are the statutory minimum; however, a labor agreement may set a higher number. Extra periods are either paid as a lump sum or prorated over the year.

Note: Extra periods are discussed in detail in another topic in this product documentation.

Earnings Calculation

This topic discusses:

Daily Calculation

PeopleSoft Global Payroll for Spain calculates earnings, getting a daily rate. Depending on the way that the employee contributes to social security, the rate is multiplied by 30 for monthly employees or by the number of days in the month for daily employees.

Note: Regardless of how an employee's earnings are calculated, all employees are paid every month.

If you calculate daily employees, you must know the daily values for each earning, as well as the total number of days worked. An employee with a daily calculation type doesn't receive the same gross and net amount every month because different months have different numbers of days. For example, an employee will receive less money in February than in June.

Cases occur in which you might want to manage daily employees as though they were monthly employees. Although an employee is assigned to a daily social security work group, you might want to pay the employee's Social Security contribution on the basic 30-day month. In such a case, you must override the value of variable SS VR TRATA MNSUAL with a value other than *No* for the specific employee.

Conversely, you might want to manage monthly employees as though they were daily employees. In such a case, you must override the value of variable SS VR TRATA DIARIO with a value other than *No*. In addition, you must specify the range of dates for which this override is effective.

PeopleSoft Global Payroll for Spain also calculates earnings for part-time employees. Part-time employees for Spanish payroll are ones who are normally paid based on their hours worked and have their Social Security contribution calculation based on their hours worked. You identify whether an employee is part-time through the Full/Part field on the Job Information page of the Job Data component (JOB_DATA). You can also use the FTE field to identify the employee's full-time equivalent. You can then apply the FTE value to compensation rate codes to determine reduced proportionality.

PeopleSoft Global Payroll for Spain differentiates between two types of part-time employees:

- *Regular part-time employees:*

These are employees who have a reduction in the working hours per day and whose contribution to social security is based on hours. An example is an employee working from Monday through Friday for four hours per day. These employees are always paid for 30 days if they are monthly or paid by the number of days in the month if they are daily.

- *Irregular part-time employees:*

These are employees who have an irregular work schedule where they can work a different number of days each month. Examples include employees who work weekends or weekends and bank holidays only, employees who work just three days per week, and employees who work a different number of days and hours each week. PeopleSoft Global Payroll for Spain uses the work schedule definition assigned to the employee to calculate the actual worked and contributed days for irregular part-time employees.

For regular part-time employees, you must use the supporting element override functionality to specify through the CLI VR RED JORNADA variable the number of working hours per day for the employees. This step is required for regular part-time employees.

Here is an example of how the system calculates earnings for part-time employees. Assume that the monthly gross salary for a full-time employee working eight hours a day is 2000 EUR. For a part-time employee who is in the same professional category as the full-time employee, working six hours a day, the system automatically multiplies the rate by a factor of 6/8 to calculate a monthly gross salary of 1500 EUR for the part-time employee.

Earnings and Accumulators

Each earnings element can accumulate its value over other elements. The following is a list of the accumulators that are used with earnings elements included in the standard solution. Before defining a new element, it's a good idea to understand what each accumulator does.

- Basic earnings (GEN AC DEV BAS S):

The sum of all basic earnings for an employee. Use this base to determine the amount of an extra period or as the base for calculating an hourly rate.

- Nonbasic earnings (TAX AC DIN VAR S):

The sum of all nonbasic or variable earnings for an employee.

- Total earnings (GEN AC SAL BRUTO S):

The sum of all elements considered as earnings for an employee.

- In kind earnings (TAX AC SPC):

The sum of all in kind earnings for tax reasons.

- Salary taxable base (TAX AC BASE S):

The sum of all the taxable salary earnings.

Note: Not all salary earnings are added to the taxable base. For example, *dietas* don't contribute to taxes until an employee reaches a statutory rate that is established each year. So only the *dietas* earnings that are in excess of the statutory rate contribute to the taxable base.

- In kind taxable base (TAX AC SPC): The sum of all the taxable in kind earnings.
- Employee's Social Security common contribution base (SS AC BSE D S and SS AC BSE M S): The sum of all the contribution earnings in common contributions.

When you create a new element, you should define the accumulators to which the element contributes.

This table lists the basic earnings and the accumulators to which each basic earnings type contributes:

Type of Basic Earning	Accumulators
Base Salary	Basic Earnings, Total Earnings, Taxable Base, Social Security Common Contribution Base
Seniority	Basic Earnings, Total Earnings, Taxable Base, Social Security Common Contribution Base
<i>Mejora voluntaria</i>	Basic Earnings, Total Earnings, Taxable Base, Social Security Common Contribution Base
<i>Complemento absorbible</i>	Basic Earnings, Total Earnings, Taxable Base, Social Security Common Contribution Base
<i>Idioma</i>	Basic Earnings, Total Earnings, Taxable Base, Social Security Common Contribution Base
<i>Cualificacion</i>	Basic Earnings, Total Earnings, Taxable Base, Social Security Common Contribution Base
Transport	Basic Earnings, Total Earnings, Taxable Base, Social Security Common Contribution Base (only the excess TRNSPRTE EX)
Prorated extra periods	Basic Earnings, Total Earnings, Taxable Base

PeopleSoft Global Payroll for Spain also provides accumulators that are PS Delivered/Not Maintained. These accumulators make defining new basic earnings easier.

Important! For maintenance reasons, do not update these accumulators. When creating your own accumulators, use these accumulators as models only; use the set of delivered parallel accumulators to customize accumulators.

Compensation Definition

In PeopleSoft Global Payroll for Spain, you can define compensation at these levels:

- The labor agreement.

In this case, you define a specific salary plan for the labor agreement. You can associate the salary grades of the salary plan with every category or subcategory of the labor agreement.

- Your company's own salary plan.

This may have salary steps and grades that are different from the ones in the labor agreement. If you have employees with guaranteed gross or guaranteed net pay, you need to set up the automatically calculated premium section that is part of multiple components of pay.

- Job code.
- Individual employee.

You can specify a different amount from what is stated in the labor agreement directly on the individual employee's job data.

- With a specific rule defined using the functionality of rate code defaulting rules.

Chapter 5

Working with Labor Agreements

Understanding Labor Agreements

In Spain, labor agreements determine several aspects of employee compensation and work conditions including absences, professional categories, and salary scales. Every company is required to have at least one labor agreement and one professional category and every employee must be assigned to a labor agreement.

Labor agreements contain the different professional categories and their respective compensation by using salary plans. The compensation reflects the base salary as well as complementary earnings that employees could receive if they qualify for certain criteria.

Defining Labor Agreements

To define labor agreements, use the Labor Agreement ESP component (GPES_LBR_AGREEMENT).

This topic provides an overview of labor agreement setup and discusses how to:

- Define seniority.
- Define seniority earnings.
- Define extra period data.
- Define extra period earnings.
- Define complementary benefits.
- Set up labor agreement overrides for terminations.

Understanding Labor Agreement Setup

Each company is required to have at least one labor agreement and at least one professional category. Every employee is assigned to a labor agreement and a professional category on the Job Data component (JOB_DATA) in HR.

Before defining labor agreement information on the Labor Agreement component (HR_LABOR_AGRMNT) in PeopleSoft Global Payroll for Spain, you need to set up labor agreements and their associated categories on the Labor Agreement and Labor Agreement Categories pages in HR.

Because of data relationships, defining your data in the following order is important:

1. Define the Social Security scheme on the Social Security Scheme Table component and then the labor agreement on the Labor Agreement component in HR.

Seniority

Calculation Type

Select the calculation type that corresponds to seniority, either *Duration* or *Formula*. A calculation type is required for calculating employee seniority years.

Element Name

Enter the corresponding element for the seniority calculation. PeopleSoft Global Payroll for Spain delivers the ANT DR ANTIGDAD duration.

To customize the way that the system counts seniority, implementers can use one of the following options:

- Define a customer duration and specify that duration in the labor agreement definition.
- Customize the element CLI FM ANTIG DESDE, which retrieves the From date used to calculate the seniority years in the standard duration ANT DR ANTIGDAD.

Seniority Earnings

Click to access the Seniority Earnings page. Use this page to assign seniority earnings to the seniority measurement for a labor agreement.

Consolidation

Select to consolidate the calculation in a single seniority earning. The sum of the previous seniority amounts will be assigned to the ANT CONSOLDA earnings element. This typically occurs when the labor agreement establishes a change in the measurement of seniority, for example, from trienniums to *cuatrenniums*. When this happens, the total previous seniority will appear as another earning called consolidated seniority (*antigüedad consolidada*) if you select the Consolidation check box.

Seniority Segments

Sometimes a labor agreement indicates that seniority be calculated in different ways. Then, seniority is calculated in different segments. Use the Seniority Segments group box to define seniority calculations if segments are used.

Sequence

Indicate the order of the various segments.

Measurement (Years)

Enter the number of years in which you measure seniority. Typical values are 3 (for triennium) or 4 (for *cuatrennium*). PeopleSoft Global Payroll for Spain delivers measurements for trienniums and *cuatrenniums*, but you can also create your own measurements.

Occurrences

Define how many times the occurrence of the seniority will occur. For example, you could pay the first 3 trienniums as 5 percent and the next *cuatrennium* as a flat amount.

Flat Amount

Enter the flat amount of the seniority earnings in a segment. Some labor agreements define seniority earnings as flat amounts, rather than a percentage of some earnings.

Currency

Select the currency in which the seniority flat amount is entered.

Percentage

Enter the percentage of the base earnings in a segment. Some labor agreements define seniority earnings as a percentage of base earnings, rather than flat amounts.

Seniority Base Earnings

Earnings

If the seniority is defined as a percentage, select the earnings elements used as the base to calculate seniority.

Example: Calculating Seniority Over Segments

Assume that a labor agreement establishes that employees will receive seniority earnings according to this schedule:

Number of Years	Seniority Earnings
1–3 (triennium)	6 EUR per month
3–6 (triennium)	6 EUR per month
6–9 (triennium)	9 EUR per month
9–13 (<i>cuatrennium</i>)	12 EUR per month Employees receive seniority earnings after 3 years with the company. During the next three years, employees receive 6 EUR monthly. In addition, for year 7 to year 9, employees receive 12 EUR monthly (6 EUR for the first triennium and 6 EUR for the second triennium.)

Here is what an employee will typically receive for seniority earnings:

- Employees will receive 0 EUR per month from year 0 to year 3.
- Employees will receive 6 EUR per month from year 3 + 1 month to year 6.
- Employees will receive 12 EUR per month from year 6 + 1 month to year 9.
- Employees will receive 21 EUR per month from year 9 + 1 month to year 13.
- Employees will receive 33 EUR per month from year 13 + 1 month to year 17.

Here is how you can set up the seniority earnings in PeopleSoft Global Payroll for Spain:

Sequence 1:

- Measurement = 3
- Occurrences = 2
- Flat Amount = 6 EUR

Sequence 2:

- Measurement = 3
- Occurrences = 1

- Flat Amount = 9 EUR

Sequence 3:

- Measurement = 4
- Occurrences = 99

Flat Amount = 12 EUR

PeopleSoft Global Payroll for Spain delivers trienniums and *cuatrenniums*, but you can create a different seniority measurement by adding a new earning with the same characteristics as one of the existing seniority earnings. If you define a new earning for a new seniority measurement, add it on the Seniority Earnings page. Make sure that you define the new earning with the Category field set to *BAS* and the Custom Field5 field set to *5-ANTIGDAD*. You must also add the new seniority earning to the correct accumulators. Use the definition of the delivered elements TRIENIOS and CUATRIENIOS as a basis, but update these accumulators in the following way:

- Include the following accumulators in the Rate component for the seniority earning:
 - TAX AC ANTIG VLR S
 - CLI AC DEV ABSRBLE
- Include the seniority earning in the following accumulators:
 - CLI AC BASE SS D
 - CLI AC SAL BRUTO
 - CLI AC ING DIN FJO

Measurement (Years)

Enter the number of years in which you measure seniority.
Typical values are 3 (for triennium) or 4 (for *cuatrennium*).

Earnings

Extra Period Definition

Use this group box to define the conditions for extra period payments.

Payment Period

Specify the month in which the extra period amount is paid. For example, if you enter 6, the extra period amount will be paid in June.

Period From

Enter the month of the year when the extra period contribution time frame begins. For example, if you enter 1, the contribution time frame begins in January.

The Period From and Duration fields apply only to extra period payments that are not prorated. For extra period payments that are not prorated, a contribution time frame exists. The

time frame is determined by a beginning period (defined in the Period From field) and a duration (defined in the Duration field).

Duration

Enter the number of months of the contribution period. For example, if you enter 6, the contribution lasts 6 months.

Prorate during the Year

Select to pay the extra period earnings every month as part of the regular pay period, and not as a unique payment. The extra period earnings will be prorated as 1/12 of the extra period payment.

Note: If you select this check box, the Payment Period, Period From, and Duration fields become display-only. Because the extra period payment is prorated over 12 months, the Payment Period field is automatically defined as 0, the Period From field is automatically defined as 1, and the Duration field is defined as 12.

Percent If Salary Adjustment

This field specifies the overall extra period percentage. For example, if you enter 50 percent, the extra period payment is 50 percent of the normal extra period payment, irrespective of the earning percentages that you specify on the Extra Period Earnings page.

This field is used for employees whose salary is adjusted to gross or net only. The employees' gross or net annual salary is defined in their personal agreement and this value is stored in the Target Compensation Rate field on the Job Data - Compensation page.

Termination Earning

Select the earnings element that corresponds to the extra period termination payment specified by the labor agreement.

When employees are terminated, they are paid for the portion of the extra period payment that they have been accumulating. An employee receives proportional compensation, depending on the number of days worked in the extra period time frame.

If an extra period is paid before the end period of the contribution and an employee leaves before the end of the contribution time frame, the system calculates the amount that the employee was overpaid. In this case, the termination earnings are negative.

Use Compensation

If the extra period payment is not prorated, use these options to define how the payment is calculated:

Proration Lump Sum

Select to base the extra period payment on employees' earnings during the contribution time frame. The earnings that contribute

to extra period payments are defined on the Extra Period Earnings page. For example, if the extra period payment is for the January to June time frame, the system calculates the extra period payment by accumulating the specified extra period earnings for each month of this time frame.

Payment Period

Select to base the extra period payment on the employee's contributing earnings for the payment period. For example, if Payment Period is 6 (June), the extra period payment is calculated based on contributing earnings for June.

Other Period

Select to base the extra period payment on employee's contributing earnings from the payment period you designate.

Advanced Payment

Select this check box if the extra period payment is paid to the employees before the contribution time frame end period. The system displays this check box if the payment period is before the end of the contribution time frame. If you don't select this check box, the extra period is paid in the next year.

For example, if you define the contribution time frame as July to December and enter 1 (January) in the Payment Period field, the system needs to know whether the employee is paid in the January before the contribution time frame end period or in the January after the end of the time frame. If you deselect the Advanced Payment check box, the employee is paid in the January of the following year.

Use this group box to define the earnings that contribute towards the extra period payments that you defined on the Extra Period Definition page. All extra periods can have the same earnings or you can vary the contributing earnings for each extra period.

Payment Period

This is the month when the extra period is paid. The system populates this field from the Extra Period Definition page.

Eligible Earnings: Contribution Tab

Earnings

Select the earning elements that you want to make eligible for the extra period.

Earning Percent

Enter the percentage of the earning that contributes to the extra period payment. For example, if you enter 100 in this field, the earning is paid in full in the extra period payment. If you enter 50, 50 percent of the earning amount is used to calculate the extra period payment.

Complementary Benefits

Use the Complementary Benefits page to define the benefits employees receive if they have a work-related injury, common sickness, maternity leave, or risk during pregnancy leave. Employees receive two types of benefits: legal benefits paid by the social security authority (*Subsidio IT*, *Subsidio AT*, *Subsidio RE*, *Subsidio MT*, and *Subsidio CM*) and employer-paid complementary benefits (*Prestación Complementaria IT*, *Prestación Complementaria AT*, *Prestación Complementaria RT*, *Prestación Complementaria MT*, and *Prestación Complementaria CM*). On this page, you define the basis for calculating benefits, and the percentage of the benefits base that an employee receives as benefits. The system automatically calculates the percentage that is paid by the employer and by Social Security.

Benefits Base

Select the accumulator that the system uses as the basis for calculating employees' daily complementary benefits.

If no accumulator is specified, the system uses the following accumulators converted to a daily value:

- SS AC BSE CC NRM S (social security CC contribution base) in case of common sickness, maternity risk, or maternity.
- SS AC BSE CP NRM S (social security CP contribution base) in case of work-related injuries.

If you want to use gross salary as the basis, you could use the accumulator AJB AC DEV BAS S, which stores the total of all daily values for all basic earnings. Or you can define your own accumulator to use for this purpose.

Work Related Injuries

Use this group box to define the total statutory and complementary benefits received for work-related injuries. The difference between common sickness and work-related injuries is that for work-related injuries, the statutory benefit is 75 percent starting from day 1.

To

Define the period for the benefit (usually the number of days up to a certain day). For example, if you enter 4 in the first row, then from days 1–4 (up to day 4) of absence, the employee receives a specified percentage. If you enter 5 in the second row, then for day 5, the employee receives another specified percentage. If you enter 10 in the third row, then from days 6–10, the employee receives another specified percentage.

Percentage

Define the percentage of the benefit base that an employee receives in benefits. For example, if you enter 100, employees receive 100 percent of the benefit base during the specified period.

Note: This percentage is a combination of statutory and complementary benefits. The statutory benefit is based on a percentage of common contingency or the professional contingency bases. The complementary benefit is a percentage of the base that you specified in the Benefits Base field.

Common Sickness

Use this group box to define the total statutory and complementary benefits received for common sicknesses or nonwork-related accidents.

For descriptions of the To and Percentage fields, see the discussion for the Work Related Injuries group box.

Maternity

Use this group box to define the total statutory and complementary benefits received for maternity leave.

For descriptions of the To and Percentage fields, see the discussion for the Work Related Injuries group box.

Paternity

Use this group box to define the total statutory and complementary benefits received for paternity leave.

For descriptions of the To and Percentage fields, see the discussion for the Work Related Injuries group box.

Risk during Pregnancy

Use this group box to define the total statutory and complementary benefits received for risk during pregnancy.

For descriptions of the To and Percentage fields, see the discussion for the Work Related Injuries group box.

Risk during Lactancy

Use this group box to define the total statutory and complementary benefits received for risk during lactancy.

For descriptions of the To and Percentage fields, see the discussion for the Work Related Injuries group box.

Minors Affected by Serious Illness

Use this group box to define the total statutory and complementary benefits received for absence due to minor care.

For descriptions of the To and Percentage fields, see the discussion for the Work Related Injuries group box.

Example: Complementary Benefits

When an employee cannot work due to a common sickness, nonwork-related accident, work-related accident, maternity leave, or risk during pregnancy he or she does not receive any compensation; however, the law requires that the employee receive social security benefits. Employees receive a percentage of the benefits base that depends on the number of days the employee is absent.

This table specifies the statutory percentage of the daily contribution base of the previous pay period that an employee should receive depending on the number of days the employee is absent from work due to a common sickness:

<i>Days</i>	<i>Percentage of Social Security Contribution Base Received</i>
1–3	0%
4–20	60%
21 up to 540 (the legal maximum)	75%

In addition to the statutory percentages, a company can choose to pay additional benefits, known as complementary benefits.

For example, assume that your company has a labor agreement with the following rules for IT benefits (for common sickness or nonwork-related accidents):

- From day 1 through day 10, employees receive 100 percent of the benefits contribution base.
- From day 11 through day 25, employees receive 90 percent of the benefits contribution base.

So the following breakdown of benefits received is:

Days	Type of Benefit	Total Percentage of Benefits Base
1–3	Statutory: 0% Complementary: 100%	100%
4–10	Statutory: 60% Complementary: 40%	100%
11–20	Statutory: 60% Complementary: 30%	90%
21–25	Statutory: 75% Complementary: 15%	90%
26 and on	Statutory: 75% Complementary: 0%	75%

Note: Statutory benefits are calculated as a percentage of the common contingency or the professional Social Security contingency bases. For complementary benefits, your organization can base the calculation on other amounts, using the Benefits Base field. For example, you could use employees' gross salary (as a daily rate) from the previous month as a basis for calculating benefits.

On the Complementary Benefits page, you'll define the periods (number of days) and the corresponding percentages for a benefit. In our example, these parameters would be defined in the following way:

To field = 10, Percentage field = 100.

To field = 25, Percentage field = 90.

Understanding Nonbasic Earnings

Nonbasic Earnings

In PeopleSoft Global Payroll for Spain, two types of earnings exist: basic earnings and nonbasic earnings. Nonbasic earnings are earnings that are paid infrequently, can be fixed or varied amounts, and can not be included in an employee's annual income. The list of nonbasic earnings includes complements, nonsalary earnings, and salary in kind. Examples are pay for holiday work, reimbursements for business travel expenses, and special interest rates for loans.

Complements

This topic discusses:

- Complement earnings.
- Work completed complements.

Complement Earnings

Complements complete the final gross pay for an employee or group of employees. They can be calculated as a flat amount or as a formula.

All of the complements discussed in this topic are treated the same way during the payroll calculation process. They all accumulate their values to salary earnings, taxable base, and the employee's social security contribution base.

Three types of complement earnings exist:

- Personal conditions.
- Work completed.
- Company's situation and results.

PeopleSoft Global Payroll for Spain provides the complements listed subsequently for positive input only. They are not mentioned in the labor agreement component and are not associated with any calculations. You must attach any calculation rules.

Note: Complements for personal conditions are considered basic earnings and are discussed in another topic in this product documentation.

Work Completed Complements

Work completed complements are based on the special requirements of a particular job. Typical work complements include nighttime complements and toxicity or hazard complements.

Generally this type of compensation is a percentage of the salary base. Sometimes it can be calculated as a formula depending on the number of hours worked under those conditions. The elements used for this type of earning are variables.

The rules for nighttime, holiday, and toxicity or hazard complements are based on labor agreements and are subject to change. For example, a new labor agreement may enlarge the time frame of the nighttime complement.

Nighttime Complement

Work performed between the hours of 22:00 and 06:00 is considered nighttime work and must be compensated at a higher rate than normal.

Typically, the calculation rule for the nighttime complement is either a flat amount for each day worked in that timetable or a rate based on a regular hourly value.

For a flat amount, the number of days worked is multiplied by the flat amount defined in the labor agreement. For example, if the flat amount is 20 EUR and the number of late nights worked is four, then a total of 80 EUR is the nighttime complement.

Holiday Complement

If employees work during a holiday, they get some additional compensation. Labor agreements usually specify the amounts to be paid for working on Sundays or on holidays. You can calculate an employee's holiday complement by multiplying the special rate by the number of holidays worked.

Toxicity or Hazard Complement

An employee who works with hazardous or toxic materials or who has a dangerous job gets a hazard complement. The details of the hazard complement are in the labor agreement.

Only the actual days worked in these conditions are paid with this complement.

The calculation rule for the hazard complement element is similar to the nighttime complement—either a Flat amount or the Base time Percentage formula applies.

Note: PeopleSoft Global Payroll for Spain delivers these work-completed complements (such as the nighttime, holiday, and toxicity or hazard complements) as sample data. Enter the value as positive input for every period. You can also modify the calculation rules to fit your company's needs.

Complementary Hours for Part-time Payees

A part-time payee can work hours in addition to the amount specified in a labor contract. The system considers these additional hours as complementary instead of overtime if they:

- Apply only to an unlimited part-time contract with distributed activity or nonconcentrated schedules. This excludes unlimited discontinuous part-time payees, part-time payees with limited contracts, and unlimited part-time payees with concentrated schedules.
- Are the result of an agreement between the company and payee as part of the contract.
- Do not exceed 15% of the scheduled hours specified in the contract.

Note: This percentage can be increased through a labor agreement but it can never be higher than 60%.

Company Situation Complements

Company situation complements are typically related to company profits and incentives and are more subjective than other complements. Sometimes, a labor agreement details these complements for a company's general objectives. Other times, these complements are addressed in a company or employee contract.

The values of these complements are variable and are currently entered into the system by positive input.

Profit Participants Complement

This complement depends on the company's earnings results. It can be defined annually or monthly, for example, depending on the company.

Incentives Complement

The incentive policy must be defined at the beginning of the period that the company considers a measure to appoint different milestones.

The complement can be defined as a total amount when the whole objective is achieved.

For example, a company's goal is to produce 10 million screws within a defined time period. The production of 10 million screws would grant the entire incentive complement. No incentive complement is supplied for missing the production goal.

The complement can also be defined as a percentage dependent upon the grade of achievement.

In our example, assume that the incentive complement is in direct proportion to the number of screws produced. The production of 9 million screws would yield 90 percent of the incentive complement.

You must manually record the incentive amounts into the system using positive input.

Nonsalary Earnings

This topic discusses:

- Nonsalary earning calculation.
- Travel expense earnings.
- *Dietas* earnings.

Nonsalary Earning Calculation

Nonsalary earnings are exempt from taxes and social security contributions in certain situations. Because of this, the system handles nonsalary earnings differently, depending on their amounts.

Each earning has a statutory maximum daily amount exempt from tax and social security contributions, which varies by fiscal territory. Update these rates using the Fiscal Territories component.

See [Understanding Tax Calculation](#).

Any reimbursement over the statutory maximum is subject to taxes and Social Security contributions. Likewise, the entire amount must be accumulated over total earnings, but only the amounts in excess of the statutory maximum must be accumulated over the taxable and social security base.

You calculate these earnings by entering the number of days and the total amount of the complement in the amount through positive input.

As a result of the calculation, PeopleSoft Global Payroll for Spain provides three different elements for every nonsalary earning:

- One earning: Represents the total amount that the employee receives.
- One earning (the name includes the letters EX): Represents the amount that exceeds the maximum taxable exempted.
- One deduction (the name includes the letter EXX): Represents the amount that exceeds the maximum taxable exempted.

Travel Expense Earnings

Travel expenses are compensations for trips, displacements, and general traveling expenses. PeopleSoft Global Payroll for Spain delivers a mileage earning and accounts for its tax and Social Security deductions in excess of the statutory rate.

DietasEarnings

Dietas is compensation that reimburses expenses resulting from business trips. They include these delivered earnings:

- DIETA EXPTR (expatriate traveling maintenance).
- DIETA INT (international traveling maintenance).

- DIETA LCL (domestic traveling maintenance).
- DIET VLO EXP (expatriate traveling maintenance for flight assistants)
- DIET VLO INT (international traveling maintenance for flight assistants).
- DIET VLO LCL (domestic traveling maintenance for flight assistants).
- PRNCTA EXP (expatriate overnight stay).
- PRNCTA INT (international overnight stay).
- PRNCTA LCL (domestic overnight stay).

Salary In Kind

Salary in kind are goods or services provided for the employee at a rate lower than the market price. PeopleSoft Global Payroll for Spain delivers a low interest loan benefit and life insurance as not passed on, and company car as passed on.

Although salary in kind is fully taxable, it may contribute fully or only partially to the Social Security base depending on its source. When a company provides salary in kind as part of normal labor agreement or contract agreement, the salary in kind contributes fully to the Social Security base. If, however, the company provides salary in kind voluntarily then a certain amount of it is exempt from contributing to the Social Security base.

To determine whether voluntary salary in kind is exempt, compare the sum of all the earnings considered as salary in kind to 20 percent of the IPREM (*Indicador Público de Renta de Efectos Múltiples*), which is a statutory rate published by the government each year. If the sum of all a payee's earnings does not exceed 20 percent of the professional minimum salary, not all of the salary in kind contributes to the Social Security bases. Any earnings in excess of 20 percent of the IPREM contribute fully to the Social Security base. When a payee receives more than one earning that is considered salary in kind, you must calculate the individual excess for each earning in proportion to its value.

The different types of salary in kind earnings include housing loans with an interest rate below the legal interest rate, cars, insurance contributions, and contributions to pension plans, for example.

The withholdings for salary in kind can be paid by the employer (withholdings in kind not passed on) or by the employee (withholdings in kind passed on). If it is passed on, the withholding is discounted in the payroll for the employee as a tax deduction (deduction in kind). If it is not passed on, the employer will pay the deduction to the tax institution.

Note: The tax percentage to be applied over the nonexempted amount will be the same as the IRPF tax percentage.

Processing Nonbasic Earnings

Nonbasic earnings are contained in three sections:

- GEN SE DEV VARBL:

Includes complements, such as nighttime complements, holiday complements, toxicity or hazard complements, overtime, profit participants complements, and incentive complements.

- GEN SE DEV OTROS:

Includes *dietas*, overnight stay, mileage earnings and salary in kind.

- AYP SE DEDUCCIONES:

Includes loans and advances.

All of these earnings are included in the payroll calculation (GEN PR CALC NOM) but not in the extra period calculation (XTR PR PAGA EXTRA) because they are not paid as part of an extra period processing.

Note: Basic earnings and various other complements are included in a section called GEN SE DEV BASICOS.

Modifying Delivered Nonbasic Earnings Accrual

There are certain delivered nonbasic earnings such as INCENTIVOS and PRTCPCN BEN that you can modify to accrue over more than one month to prevent the Social Security contributions for those earnings from surpassing the maximum ceiling during the payment month. This topic provides an overview of this modification process and discusses how to view compensation accrued over more than one month.

Earnings Modification

To modify nonbasic earnings to accrue over more than one month:

1. Add the post process formula SS FM BSE CNTB F on the Calculation page for the earning.
2. Remove the contribution base accumulator (SS AC BSE M S) on the Accumulator page for the earning.
3. On the Rounding/Proration page, add the proration rule GEN PO DIAS SLICE to the earning.
4. On the Earnings Name page, select the Payee check box in the Override Levels group box for the earning. This enables you to assign the earnings to payees using the Element Assignment by Payee (GP_ED_PYE) or One Time (Positive Input) (GP_PI_MNL_ERNDED) component.
5. Add a unique value in Field 5 on the Element Name - Custom Fields page. This helps to differentiate nonbasic earnings that accrue over more than one month.

The variable CLI VR M PRORRATEO determines the number of months used to distribute the Social Security contributions for the earning. You set the value for this variable when you assign the associated earning using the Element Assignment by Payee or One Time (Positive Input) components.

Earnings Behavior

The assigned earning behaves differently in the case of segmentation depending on which component you use to assign it. If you use the Element Assignment by Payee component, the system calculates the earning in every slice or segment with a prorated value. The system calculates Social Security contributions according to each of these values. If you use the One Time (Positive Input) component, the system calculates the earning only once and does not prorate the value. The system calculates Social Security contributions based on that calculated value.

Compensation Process Flow

Regardless of the component you use to assign the modified earning, the process flow for compensation accrued in more than one month is the same. The payee receives the total amount of the assigned earning in the payment month. The system calculates the monthly portion of the earning applicable to contribution base calculation by dividing the total amount by the number of months entered (the entered value of CLI VR M PRORRATEO). The pending base is the total amount minus the calculated monthly portion. In subsequent months, the system retrieves the data for the previous month. The pending base retrieved from the previous month becomes the new total amount. The system then subtracts the monthly portion from the new total amount to calculate a new pending base for the next month.

The payroll results for compensation accrued over more than one month depend on two factors: process month and payee situation.

- In the payment month, if the payee is sick, the pending base is the total amount minus the monthly base corresponding to contribution days (healthy days). The monthly contributing base corresponds to healthy days.
- In subsequent months:
 - If the payee does not contribute in the process month, the system stores a row equal to the previous one with one less number of months and with a total amount equal to the pending amount from the previous month.
 - If the payee is sick, the pending base is the total amount minus the monthly base corresponding to contribution days (healthy and sick days). The monthly contributing base corresponds to healthy days.

When calculating the regulatory daily base (BRD), the system considers the Social Security base of the previous month or months in which the contributions of compensation accrued in more than one month as already included.

- When element or period segmentation occurs, the system calculates the proportional part to contribute for each slice and segment. In addition, the system calculates the total pending base minus the monthly corresponding base, but it stores only the data in the last slice of the last segment.
- In the case of a termination, the system uses the total pending amount at the time of termination to calculate the contribution base. The pending amount is equal to zero in subsequent months in the case of a rehire.

Paying Overtime

Understanding Overtime Processing for Spain

PeopleSoft Global Payroll for Spain enables you to pay overtime hours. Each organization can specify the annual, monthly, or weekly hours worked based on the maximum legal number of hours established by the government. Overtime (*horas extra*) occurs when an eligible payee works more than the specified number of hours. In this case, the employer should pay a surcharge on the extra time worked.

Note: Not all organizations pay overtime for extra hours. When implementing the system, consider whether your organization manages overtime as extra hours.

Two types of overtime exist, depending on ordinary or extraordinary circumstances:

Structural overtime (*horas extras estructurales*)

Overtime that an organization requires to:

- Prevent accidents and disasters.
- Repair damages caused by extraordinary circumstances.

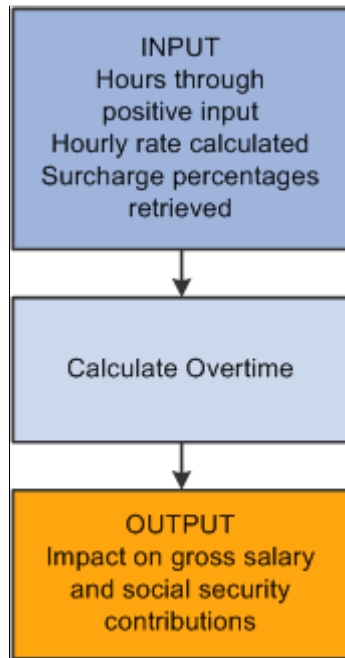
This type of overtime is usually approved by labor unions.

Non-structural overtime (*horas extras no estructurales*) Overtime not related to extraordinary circumstances.

Integrating with PeopleSoft Time and Labor

If your organization uses PeopleSoft Time and Labor, you can:

- Include time and labor data in the pay runs.
- Transmit cost data back to Time and Labor after a pay run.
- Share employee schedules.

Time and Labor identifies and stores the different time units to send the information to Global Payroll. Therefore, Global Payroll receives and manages the units sent by Time and Labor to apply the respective rates for each one.

Depending on whether an organization uses Time and Labor, two ways are available to process time units:

1. If Time and Labor is used, the calculation of the different kinds of hours is performed outside the payroll process. In this case, the payroll triggers the different payments.
2. If Time and Labor is *not* used, enter the number of hours at the overtime rate.

When an organization uses Time and Labor, the number of hours per category come from positive input. Organizations that use another application to calculate the different categories of hours use the positive inputs to store their results. You can also store them manually as positive inputs. In this case, all hours and

entitlements are calculated outside the payroll process. The payroll process calculates only the earnings that are attached to those hours and updates the correct accumulators.

A time entry that is reported in Time and Labor has a Time Reporting Code (TRC) that identifies its type, the applicable units, currency, and other characteristics. In addition, you can assign a task code to each time entry. Using task codes, you can track time by product, location, or some other category.

Time Administration Process

Time entry must be converted to payable time before it can be processed by a payroll system. It can use user-defined rules for overtime, night overtime, and a variety of other rules. Some rules may require absence data. In this case, you must send absence data from Global Payroll to Time and Labor before running the Time Administration process—the process that generates the TRCs that transfer the time unit to Global Payroll.

After the Time Administration process runs, you can launch the pay run. Global Payroll automatically retrieves payable time from Time and Labor during the calculation phase of processing.

When the payroll is finalized, you can launch a process that updates the payable time entries in Time and Labor.

Working with Loans and Advances

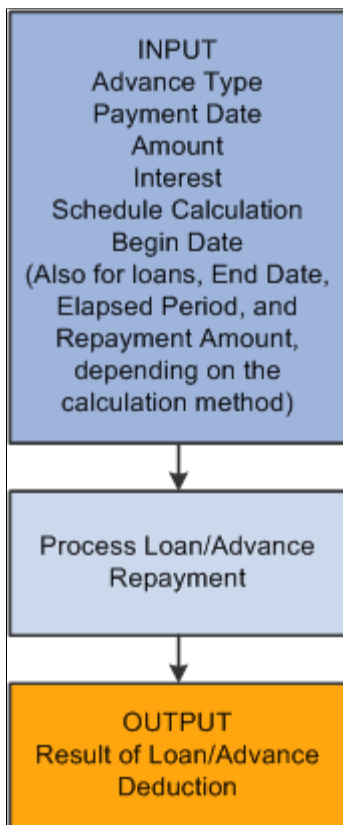
Understanding Loans and Advances

PeopleSoft Global Payroll for Spain enables you to process loans and advance payments made to employees through the payroll. You pay the loan or advance with the employee's pay or in cash for one pay period, and then take repayments from the employee's pay over successive pay periods until the amount is repaid in full. (Advances must be repaid over a single period.) Use the Advance/Loan page to enter details of an employee's loan or advance, and the system records the repayments on the Payment Schedule page.

Understanding Loan and Advance Repayments

If an employee receives an advance, the total amount must be repaid in the same month that the advance was granted, or in the following month. Advances are paid over one period only; that is, they cannot be repaid over several months. Employees may also request an advance payment over an extra period—in this case, PeopleSoft Global Payroll for Spain deducts the advance repayment from an extra pay period.

If an employee is granted a loan, use PeopleSoft Global Payroll for Spain to select one of three calculation types for repayment. Specify the number of periods over which repayment is to be made and let the system determine the end date. Or specify the repayment amount for each period and let the system determine the end date.

You can also enter the type of interest that applies. For example, if the statutory interest rate is 7 percent and you grant an employee a loan at 4 percent, this is 3 percent less expensive than a bank loan. The Spanish government regards the difference between the statutory interest rate and the company interest rate as salary in kind—*salario en especie*—which is calculated in the following way:

Salary in kind = interest repayment amount at statutory rate – interest repayment amount at company rate.

With Global Payroll, you can instruct the system to take into account the number of extra pay periods to which an employee is entitled. Employees in Spain are usually paid over 12 periods, plus the number of extra pay periods stated in the labor agreement. If you want Global Payroll to consider extra pay periods when calculating loan repayments for employees who are paid additional pay periods, the system checks the employee's labor agreement for the number of additional pay periods and calculates the loan repayment accordingly.

Use the Advance/Loan page to enter details of an employee's loan or advance, and the system displays the employee's repayments on the Payment Schedule page.

Sequence number

Enter a sequence number for the advance/loan. (This number helps prevent duplicate key conditions; it does not control the processing sequence.)

Payment Data

Advance Type

Select the advance type that the employee is going to receive: *Advance* or *Loan*.

Statutory Interest

This field appears for loans only. The system displays the statutory interest rate that you defined on the Statutory Rates page.

Payment Date

Enter the date when the loan or advance is to be paid to the employee. The system generates an earning amount for the corresponding payroll period.

Note: If this field is left blank, the assumption is that the payment will be made in cash. The system does not generate the earning and pay it through payroll processing.

Amount

Enter the amount of the loan or advance.

Company Interest

This field appears for loans only. Enter the interest rate that applies to the loan from the employer.

Repayment Schedule**Calculation Type**

Select a calculation type to determine the payment schedule.
Values are:

Elapsed Period: Select if you want the system to calculate the end date and repayment amount for you, according to the number of periods that you specify in the Elapsed Period field. The End Date field becomes unavailable for edit.

End Date: Select if you want to specify the end date of the loan repayments. The Elapsed Period field becomes unavailable for edit.

Flat Amount: Select if you want to specify the flat amount that the employee is to repay each pay period. The system automatically calculates the number of repayment periods. The system displays the Repayment field instead of the Elapsed Period field. The End Date field becomes unavailable for edit.

Note: If you select the advance type *Advance*, the system automatically sets the calculation type to *Elapsed Period*.

Consider Extra Period

Select if you want the calculation to include extra period payments.

Begin Date

Enter the date when the employee begins making the loan or advance repayments.

For extra period advances, the begin date must fall within the extra period in which the repayment will be made.

End Date

Enter the date when the loan or advance repayments are due to end. (You can enter a value in this field only when you select End Date as the calculation type.)

Note: The system generates payments between the begin and end dates and calculates the necessary amount to be deducted.

Elapsed Period

Enter the number of pay periods over which the employee is to repay the loan. You can enter a value in this field only when you select *Elapsed Period* as the calculation type.

The system automatically calculates the end date for you. For example, if you enter the elapsed period as 13, the system calculates the end date as 13 pay periods after the begin date that you entered and the amount to repay.

Note: If you select the advance type *Advance*, the system automatically sets Elapsed Period to 1. This is because advances must be repaid in full in the next pay period.

Repayment

Enter the monthly loan repayment amount that the employee has requested to pay. This amount includes the principal amount of the loan and the interest payment. You can enter a value in this field only when you select *Flat Amount* as the calculation type.

Allow Last Repay Greater

Select to include any loan remainder less than the monthly repayment amount as part of the last scheduled payment. For example, if you assign a loan amount of 3500 EUR to a payee, with a Repayment value of 1000 EUR, the system would schedule three payments of 1000 EUR and one final payment of 500 EUR to repay the loan if the Allow Last Repay Greater check box were deselected. With the check box selected, the system would schedule two payments of 1000 EUR and one final payment of 1500 EUR.

This field is available only if you select *Flat Amount* as the calculation type.

Calculate Loan

This button appears for loans only. Click this button to automatically calculate the loan. The system checks the employee's labor agreement and takes into account the number of extra pay periods to which the employee is entitled.

Payment Schedule Page

Use the Payment Schedule page (GPES_ADVLOAN_SCHED) to view the status of an employee's loan or advance, as well as the repayments that he or she have made.

The page displays the original amount of the loan and advance, the remaining amount to be repaid, and the loan amortization schedule.

Advance/Loan Totals

Sequence Number

Displays the sequence number that you entered on the Advance/Loan page.

Override Repayment

Select to make the fields in the Loan Amortization Table group box editable. This check box is available only for loans, not advances.

Note: If you modify or delete existing repayment rows or add new repayment rows, you must manually calculate the corresponding values in the Interest and Salary In Kind columns that correspond to the amounts in the Capital columns. You must ensure that the sum of the amounts of the fields in the Capital column is equal to the value displayed in the Total Capital field. If it is not, you receive an error when you try to save the component. In addition, be aware that a change to an existing repayment row generates a retro trigger for the corresponding month.

Total Amount

Displays the total amount of the loan or advance, including interest, that was made to the employee. If an employee has several loans, the system displays the details of each loan and the total loan amount, and automatically calculates the remaining loan amount to be repaid.

Total Capital

Displays the sum of the values of the fields in the Capital column of the Loan Amortization Table group grid.

Total Interest	Displays the sum of the values of the fields in the Interest column of the Loan Amortization Table group grid.
Total Salary in Kind	Displays the sum of the values of the fields in the Salary in Kind column of the Loan Amortization Table group grid.
Loan Amortization Table	
Month	Displays the month in which repayments must be made and whether they have been paid. If you selected 04/01/2004 as the begin date on the Advance/Loan page, for example, the system displays 4 as the first repayment. In other words, the first repayment is due in April, the fourth month of the year.
Extra Period	The system selects this check box automatically if a repayment is to be made in an extra pay period.
Year	The system automatically enters the year in which the repayment was paid.
Capital	Displays the capital amount of the loan repayment that the employee has to pay. This amount does not include the interest payment for the loan.
Interest	The system automatically calculates the interest payment that applies to the loan.
Repayment	The system automatically calculates the total loan or advance repayment for that month. This amount comprises the capital and the interest payments.
Salary in Kind	The system automatically calculates the difference between the cost of the loan at the statutory interest rate, and the interest rate that you defined on the Advance/Loan page. This information is used for tax purposes.
Paid	The system selects this check box automatically when a loan or advance amount has been repaid.

Viewing Delivered Loan and Advance Elements

Delivered Loan and Advance Earnings

PeopleSoft Global Payroll for Spain uses these earnings to calculate payments for loans and advances:

Earnings	Description
DEV ADELANTO	Salary advance. Contains the amount to be paid to the employee as advance payment, which the employee must pay back through later payrolls. Custom field 5 contains the label DEV ADLNT0. Only processed for the last segment in the period. No retro calculation.
DEV PRESTAMO	Loan. Used for loan payments. Custom field 5 contains the label DEV PRSTMO. Only processed for the last segment in the period. No retro calculation.
PRSTMO EX	In kind loan taxable excess. Shows the excess interest amount that results when the interest rate is lower than the statutory rate. Calculated by subtracting the loan interest amount from the statutory interest amount on a month-by-month basis.

Delivered Loan and Advance Deductions

PeopleSoft Global Payroll for Spain uses these deductions to calculate repayments for loans and advances:

Deduction	Description
DD ADELANTO	Advance deduction. Used for repayment of advances. Custom field 5 contains the label DD ADELANTO. Only processed for the last segment in the period. No retro calculation.
DD PRST CAP	Loan capital deduction. Used for repayment of the capital portion of a loan. Custom field 5 contains the label DD PRST CAP. Only processed for the last segment in the period. No retro calculation.
DD PRST INT	Loan interest deduction. Used for repayment of the interest portion of a loan. This deduction takes its value from the variable AYP VR IMPTOT INT previously calculated in AYP FM IMPORTE called from DDPRST CAP. Only processed for the last segment in the period. No retro calculation.
LIQ ADLNT0	Deduction for terminated employees. Settles the outstanding advance amount.
LIQ PRSTMO	Deduction for terminated employees. Settles the outstanding loan amount.
PRSTMO EXX	In kind loan taxable excess. Shows the excess interest amount that results when the interest rate is lower than the statutory rate. This deduction is linked to PRSTMO EX and offsets it.

Note: The PeopleSoft system delivers a query that you can run to view the names of all delivered elements designed for Spain. Instructions for running the query are provided in the *PeopleSoft HCM 9.2: Global Payroll* product documentation.

Setting Up Social Security Contributions

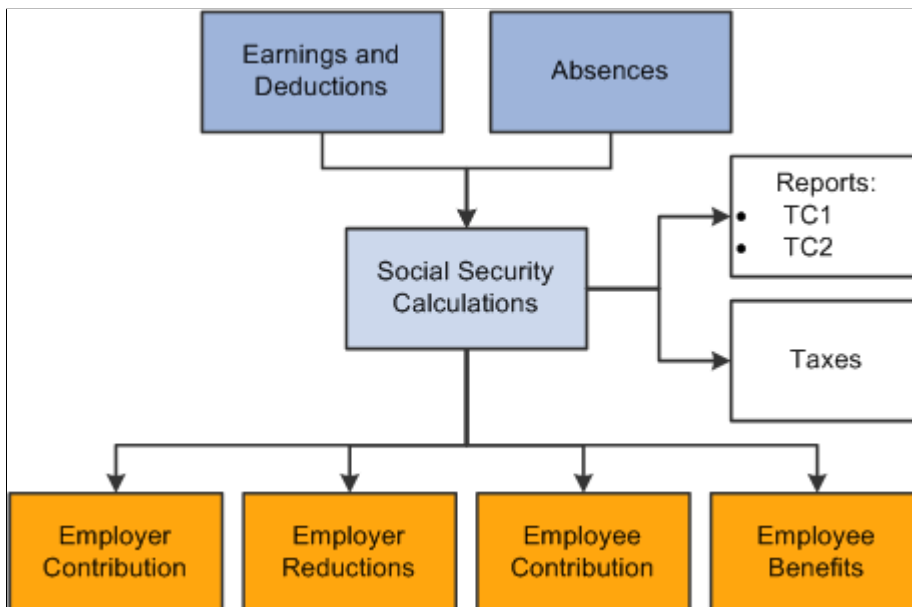

Social Security in the Pay Process Flow

Image: Social security in the pay process flow for PeopleSoft Global Payroll for Spain

This diagram illustrates how social security processing fits into the overall pay process flow of PeopleSoft Global Payroll for Spain. The social security process calculates the employer and employee contributions and the employer reductions, and generates data for the social security reports TC1 and TC2. The next step after social security processing is the tax calculation.



Bases

PeopleSoft Global Payroll for Spain calculates social security contributions and deductions as a percentage of a *funding base*, except in the case of trainees and apprentices, whose contributions and deductions are based on fixed rates. For employees with multiple jobs, the calculation is based on reduced maximum and minimum bases that you define on the Multiple Employment page.

PeopleSoft Global Payroll for Spain delivers accumulators for these funding bases:

- Common Contingencies Base: Used to calculate the common contingencies contribution.
- Professional Contingencies Base: Used to calculate social security contributions for:
 - Temporary Disability (*Incapacidad Temporal (IT)*) and Permanent Disability, Death, and Survival Benefits (*Invalidez, Muerte, y Supervivencia, (IMS)*).
 - Unemployment.
 - Professional training.
 - FOGASA (*Fondo de Garantia Salarial*).
- Structural Overtime Base: Used to calculate social security contributions for structural overtime.
- Non Structural Overtime Base: Used to calculate social security contributions for nonstructural overtime.

Note: PeopleSoft Global Payroll for Spain calculates the common contingencies and professional contingencies bases for trainees and apprentices for use in processing social security benefits. These bases are not required for calculating social security contributions.

Percentages and Rates

PeopleSoft Global Payroll for Spain calculates social security contributions and deductions either as *percentages* of a funding base or on the basis of fixed *rates*, depending on the social security contribution ID assigned to the employee. The social contribution ID defines:

- Social security employee type.
- Contribution type.

For employees with a social security employee type of *regular*, the contribution type is *percentage*. For this type of employee, PeopleSoft Global Payroll for Spain calculates contributions and deductions as a percentage of the common contingencies (CC) base, the professional contingencies (CP) base, or the structural and nonstructural overtime bases. For employees whose social security employee type is trainee, the contribution type is *rate*, which means that contributions and deductions are based on fixed rates. The exact rates or percentages are set by law and can vary from year to year.

Note: View and update the percentages and rates used in the social security calculation on the Contribution page.

General and Special Schemes

The social security system is divided into a general scheme and various special schemes. The general scheme applies to most employees working for others, while special schemes cover the self-employed and some categories of employees, such as sailors, those in the coal mining industry, and housekeeping employees. Currently, PeopleSoft Global Payroll for Spain delivers rules only for the general scheme.

Grant holders (*becarios*) are integrated into the general scheme, but have special rules regarding social security calculation:

- They must be associated with the contribution group number 7.
- They must be assigned a contribution ID of 008.
- They must have an Empl Class (employee class) of *Intern* on the Job Information page.
- The common contingencies base is the minimum base for the general scheme.
- The professional contingencies base is the minimum base for the general scheme.

Becarios do not need to be associated with an official contract type, for purposes of generating the FAN flat file.

Note: Although PeopleSoft Global Payroll for Spain delivers rules for only the general scheme, you can define rules for other schemes using the Scheme, Work Group, and Contribution pages.

Work Groups

All employees who contribute to social security are assigned to government-defined work groups based on their levels of education, professional skills, and job titles. Every year, the government establishes different minimum and maximum funding bases and ceilings for each work group and scheme.

Note: Define the values of the maximum and minimum bases and ceilings for the general scheme on the Scheme page.

Minimum and Maximum Funding Bases

For each work group, the government establishes a minimum and a maximum base to use for calculating the common contingencies funding base. This means that for an employee in a specific group, the social security funding base cannot be greater than or less than the maximum or minimum established for that group. For example, if an employee's earnings subject to social security contributions are so high that the calculated funding base exceeds the upper limit, the actual funding base must be reduced to the upper limit. That is, social security contributions are based only on the portion of a payee's salary that is equal to or falls within the upper and lower limits for each group.

Note: Define the maximum and minimum funding bases for common contingencies on the Work Group page.

Upper and Lower Ceilings

Each year, the government establishes upper and lower ceilings for calculating the professional contingencies base. Just as in the case of the common contingencies contributions, social security

contributions for professional contingencies are based only on the portion of a payee's salary that is equal to or falls within the upper and lower ceilings. The ceilings are the same for all work groups within a scheme.

Note: Define the upper and lower ceilings for professional contingencies on the Scheme page.

Understanding Contribution Calculation

This topic discusses:

- Social security calculation.
- Funding base calculation for regular employees.

Social Security Calculation

PeopleSoft Global Payroll for Spain calculates social security contributions by multiplying a base by a percent (in the case of regular employees) or by retrieving a fixed rate (in the case of trainees and apprentices).

In PeopleSoft Global Payroll for Spain, the system:

- Calculates the social security funding base.
- Normalizes the funding base by comparing the calculated base with government-defined maximum and minimum values.
- Retrieves the percentage used to calculate the contributions of regular employees (or rates in the case of trainees and apprentices).
- Calculates contributions by multiplying a base by a percent (or by assigning a fixed rate in the case of trainees and apprentices).

Note: PeopleSoft Global Payroll for Spain also calculates contributions of the pending vacation balance for terminated employees. This is discussed later in this product documentation.

Funding Base Calculation for Regular Employees

This topic discusses how the system calculates the four funding bases that are required to calculate employees' social security contributions: common contingencies base, professional contingencies base, and bases for structural and nonstructural overtime.

Note: This topic discusses how the system handles regular employees. The calculations are different for trainees, apprentices, and employees with multiple jobs.

Calculating the Common Contingencies Base

The Common Contingencies Base is the sum of various *subbases* that comprise earnings for:

- Nonsick days base plus extra period proration.
- Days when the employee is absent with these types of absence: IT absence, AT absence, maternity or paternity absence, or absence for risk during pregnancy.

For monthly employees who contribute 30 days total regardless of how many days are in a month, the system calculates absences days as 30 nonsick days.

- Absence in which the employee contributes according to his earnings (*cotiza por lo que gana*).
- Absence in which the employee contributes according to the minimum base (*cotiza por la base minima*).

In addition to summing up various subbases to calculate the final amount of the common contingencies base, the system sets the value of the maximum and minimum bases to use in the normalization process when an employee has multiple jobs in different companies.

Calculating the Professional Contingencies Base

The calculation of the professional contingencies base is almost identical to that of the common contingencies base. Here are the key differences between the calculation for the common contingencies base and the professional contingencies base:

- The common contingencies calculation uses the maximum and minimum bases for the employee's work group (as defined on the Work Group page), whereas the professional contingencies calculation uses the upper and lower ceilings defined on the Social Security Scheme page.
- The structural and nonstructural overtime amount is added to the nonsick base for the professional contingencies base.

- Just as the common contingencies calculation uses a minimum hourly rate to calculate the funding base for part-time employees, the professional contingencies calculation uses its own minimum hourly rate.

Note: You can control how the system calculates the professional contingencies base (CP BRD) using the CLI VR CP BRD CLC (CP BRD Calculation) variable.

When the variable has a value of *1* (the default value), the system calculates the CP BRD as: (Professional Contingencies for the previous month – Overtime for the previous month) / Contribution Days + Overtime average for the last 12 months.

If you assign a value to the variable other than *1*, the system calculates CP BRD as: Daily Common Contingencies Base for the previous month + Overtime average for the last 12 months.

Calculating the Overtime Bases

Unlike the common and professional contingencies bases, the bases for structural and nonstructural overtime do not undergo normalization and do not require any special calculations. They are used only as a basis for determining the employer and employee contribution for overtime.

Funding Base Calculation for Employees with Multiple Jobs

When an employee has multiple jobs in different companies, the total social security base must be distributed between jobs to prevent excess contributions being taken from the employee's paycheck.

To trigger the calculation of the base for multiple jobs:

- Specify the date (the effective date) on which the distribution of bases is to begin on the Multiple Employment page.
- Enter a percentage (supplied by Social Security) representing the proportion of the common contingencies base that applies to each job on the Multiple Employment page. The system applies these percentages to the common contingencies ceilings and bases used in the normalization process.
- Enter a percentage (supplied by Social Security) representing the proportion of the professional contingencies base that applies to each job on the Multiple Employment page. The system applies these percentages to the professional contingencies ceilings and bases used in the normalization process.

Base Calculation for Trainees

Social security contributions for trainees aren't calculated as a percentage of a funding base, but by means of fixed rates. Therefore, the system doesn't need to define a base to resolve the contributions or deductions of this category of employees. However, it still calculates both the Common Contingencies and Professional Contingencies bases for use in processing social security benefits.

Calculating the Common Contingencies Base

To calculate the common contingencies base for trainees and apprentices, PeopleSoft Global Payroll for Spain calculates 75 percent of the base using:

- The lower ceiling for full-time employees whose contribution frequency is monthly or daily.
- The minimum hourly rate for part-time employees.

Note: The lower ceiling and the minimum hourly rate used in this calculation come from the Work Group page.

Calculating the Professional Contingencies Base

To calculate the professional contingencies base for trainees and apprentices, PeopleSoft Global Payroll for Spain calculates 75 percent of the base using either the lower ceiling (for full-time employees whose contribution frequency is monthly or daily) or the minimum hourly rate (in the case of part-time employees).

Note: The lower ceiling and the minimum hourly rate used in this calculation come from the Work Group page.

Triggering Calculations for Trainees and Apprentices

To trigger the correct calculation for trainees and apprentices, define the contribution rates to apply on the Contribution page and link the employee to the correct scheme and Social Security contribution ID on the Contract Status/Content page.

PeopleSoft Global Payroll for Spain includes two contribution IDs for training contracts: 005 and 009. Use contribution ID 009 for contracts signed or extended after June 18th 2010 so that the system calculates unemployment benefits for employees with these contracts.

Base Calculation for Part-Time Employees

The calculation of the Social Security base for part-time employees (regardless of whether they are regular or irregular part-time) differs from full-time employees. The reporting of contributions for these employees is done in hours.

When performing normalization, the system calculates the minimum base by multiplying the statutory minimum hourly rate by the actual number of hours worked. The maximum base for part-time employees is the same as the maximum base for full-time employees.

When calculating the part-time employee's professional contingencies, the system calculates the lower ceiling by multiplying the statutory minimum hourly rate by the number of hours worked. The upper ceiling for part-time employees is the same as the upper ceiling for full-time employees.

The system calculates hours differently for regular and irregular part-time employees. For regular part-time employees, the system multiplies the value of the variable CLI VR RED JORNADA by the number

of scheduled working days, which the system extracts from the employees' assigned work schedules. For irregular part-time employees without an overridden value for CLI VR RED JORNADA, the system uses the employee's assigned work schedule to count the exact number of worked hours.

Funding Base Normalization

This topic discusses how PeopleSoft Global Payroll for Spain compares an employee's funding bases with the minimum and maximum amounts defined by the government to calculate both professional and common contingencies contributions for regular employees.

Note: This topic does not apply to trainees or apprentices, whose funding base is defined as a fixed rate.

The system calculates an employee's social security contribution in the following way:

1. Calculates all the subbases that contribute to the main funding base accumulator.
2. Sums all the subbases contributing to the social security funding accumulator.
3. To determine the *common contingencies* base, the system compares the sum calculated in step 2 to the maximum and minimum bases (amounts) defined for each work group on the Work Group page.

To calculate the *professional contingencies* base, the system adds the amount obtained in step 2 to structural and nonstructural overtime and compares the result with the upper and lower ceilings defined on the Scheme page. If the amount is below the minimum base/lower ceiling, it sets the base used for calculating contributions equal to the minimum base/lower ceiling. If this amount is greater than the maximum base/upper ceiling, it sets the base used for calculating social security contributions equal to the maximum base/upper ceiling.

For part-time employees, the system uses a set of reference bases and ceilings derived from the statutory minimum hourly rate.

Example

This example illustrates how PeopleSoft Global Payroll for Spain compares the common contingencies base.

Assume that an employee has a calculated monthly base of 700 EUR, which is the sum of contributing earnings plus extra period proration amount. Assume also that the employee has no absences in the current month, and has social security contributions that are processed monthly.

If the maximum and minimum bases for our employee are 3166.20 EUR and 1016.40 EUR, respectively, then the amount of 700 EUR falls below the minimum base. So 799.80 EUR is defined as the funding base.

Reference Bases and Ceilings

Although social security processing is essentially the same for professional and common contingencies, the two contribution types employ a different set of reference bases or ceilings. When calculating the common contingencies base, the system uses the maximum and minimum bases defined on the Work Group page. When calculating the professional contingencies base, the system uses the upper and lower

ceilings defined on the Scheme page. In addition, when processing part time employees, the system uses a set of reference bases/ceilings derived from the statutory minimum hourly rate.

This table identifies the system pages on which you view, update, or define the current bases and ceilings used to calculate contributions for full-time employees and the minimum hourly rates used to define the reference bases and ceilings for part time employees.

Contribution Type	View, Update, or Define Base/ Ceiling on:	Comments
Common contingencies (full-time employees)	Work Group Page	None
Common contingencies (part-time employees)	Work Group Page	When processing part-time employees, the system calculates the minimum base by multiplying the statutory minimum hourly rate by the real number of hours worked. The maximum base is the same as the maximum for full time employees.
Professional Contingencies (full-time employees)	Scheme Page	None
Profession Contingencies (part-time employees)	Scheme Page	When processing part-time employees, the system calculates the lower ceiling by multiplying the statutory minimum hourly rate by the number of hours worked. The upper ceiling is the same as for full-time employees.

Note: The maximum bases, minimum bases, and minimum hourly rates for common contingencies vary by scheme ID and contribution group. The upper ceiling, lower ceiling, and minimum hourly rate for professional contingencies vary by scheme ID alone.

Retrieving Calculation Percentages and Rates

In the case of regular employees, when the base for calculating social security contributions has been defined, the system retrieves the correct percentage to apply to the base. In the case of nonregular employees (trainees and apprentices), the system retrieves the contribution rate.

PeopleSoft Global Payroll for Spain uses arrays to retrieve the correct percentage or rate. The exact rate or percentage used to calculate each contribution is set by law and can vary according to the scheme ID, contribution ID, and effective date.

Percentages for IT and IMS Contributions

The system calculates *Incapacidad Temporal* (IT) and *Invalidez, Muerte y Supervivencia* (IMS) contributions as follows:

- IT contribution = professional contingencies base × IT percentage.
- IMS contribution = professional contingencies base × IMS percentage.

The system determines the appropriate IT and IMS percentage in one of three ways:

1. If there is an occupational code assigned to a payee, the system uses the percentages defined for that occupational code.
2. If there is no occupational code assigned to a payee, the system uses the percentages defined for the industrial activity declared for the Social Security Number (SSN) employer to which the payee belongs.
3. In certain cases such as sickness, maternity, or unpaid leave, the system uses the percentages associated with occupational code C: *Sickness and special relationships*.

You define IMS and IT percentages for occupation codes on the Social Security Occupation Cd (social security occupation code) page. You define IMS and IT percentages for industrial activities on the Industry Activity Table page.

Contribution Calculation

The final step in the social security process is to determine the actual amount of the contributions either by multiplying the correct percentage by the appropriate funding base accumulator (in the case of regular employees) or by assigning a fixed amount (in the case of trainees and apprentices). The contribution includes these employee and employer contributions:

Entity	Contribution Details
Employee	Common contingencies, professional training, unemployment, structural overtime, nonstructural overtime.
Employer	Common contingencies, professional training, unemployment, <i>Fondo de Garantía Salarial</i> (FOGASA), structural overtime, nonstructural overtime, <i>Incapacidad Temporal</i> (IT) and <i>Invalidez, Muerte y Supervivencia</i> (IMS).

Understanding PeopleSoft HR Data in Social Security Calculation

PeopleSoft Global Payroll for Spain uses a considerable amount of data from HR to calculate social security contributions. This table provides a quick reference to the basic HR information used in social security processing. It lists the pages on which you must enter the required data, as well as the names of the specific fields containing the data.

Understanding Self-Insurance Collaboration Management

PeopleSoft Global Payroll for Spain provides functionality for managing data and reporting for self-insurance companies. Self-insurance companies are companies that are self-insured and voluntarily collaborate with Social Security in the management of benefits provided under the general scheme for temporary illness according to the terms of the collaboration. As defined by the General Law on Social Security (LGSS) Article 77, two types of self-insurance collaboration are available with Social Security:

- Collaboration for work-related injury or occupational disease (AT/EP).
- Collaboration for nonwork-related injury or common disease (non-AT/EP).

Self-insurance companies can collaborate in the management of social security benefits through one or both of these collaborations by assuming payment of the benefit directly to the affected employee on behalf of Social Security. Companies must pay these benefits with the same frequency that they pay salaries. In return, the self-insurance company gets deductions for its required social security contributions.

Collaboration for Work-Related Injury or Occupational Disease (AT/EP)

When a self-insurance company collaborates with Social Security for work-related injury or occupational disease (AT/EP):

- The collaboration affects all employees of the employer social security number (Employer SSN) that you define as having a self-insurance collaboration on the Self-Insurance Data page.
- The company gives healthcare coverage and pays for economic benefits for temporary disability derived from work-related injury or occupational disease (AT/EP).
- The company is not refunded by Social Security for sick pay expenses (SUBSIDIO AT earning).
- When calculating professional contingencies contributions for self-insurance companies, the system specifically considers the following contributions:
 - Work-Related Injuries or occupational disease (AT/EP).
 - Unemployment.
 - Professional training.
 - FOGASA (Fondo de Garantía Salarial).
 - Permanent disability, death, and survival benefits (IMS).
- The system computes an additional contribution quota, called Shared Services Contribution (*Aportación a Servicios Comunes*), which the self-insurance company must report.

The system obtains this quota amount through the following formula expression:

Shared Services Contribution = IMS Contribution × IT Self-Insurance Rate Where The IMS Contribution = the AT/EP contribution base × IMS rate IT Self-Insurance Rate = Amount derived from statutory table

Note: For this collaboration type, the system does not compute or report contributions for temporary disability (IT) rates when computing the professional contingencies contributions. However, PeopleSoft Global Payroll for Spain calculates and stores contributions for IT in the accumulator SS AC ER AUTO IT S for each employee. You can use this value for company reporting, such as reporting to general ledger to track how much money the company saves by being self-insured.

Collaboration for Common Disease or NonWork-Related Injury (non-AT/EP))

When a self-insurance company collaborates with Social Security for nonwork-related injury or common disease (non-AT/EP):

- The collaboration affects all employees of the employer social security number (Employer SSN) that you define as having a self-insurance collaboration on the Self-Insurance Data page.
- The company pays for economic benefits and can give healthcare for temporary disability derived from nonwork-related injury or common disease (non-AT/EP).
- The company is not refunded by Social Security for sick pay expenses (PAGO DELEGADO earning).
- The system calculates a reduction to be applied to the total common contingencies contribution to pay.

The system obtains this amount through the following formula expression:

Regular Situations Joint-Management Deduction = Base x IT Self-Insurance Rate Where Base = Field 111 (Non-AT/EP Contributions) + Field 115 (Employer Only Non-AT/EP Contributions) – Field 209 (Contribution Exempt Situations Deduction) IT Self-Insurance Rate = Amount derived from statutory table

This collaboration type affects the Total Employer Social Security Contributions calculation by reducing the final net to pay to Social Security through the Regular Situations Joint-Management deduction. This collaboration type also affects the RED system FAN File and the TC1 Report.

Understanding Ceilings, Rates, and Other Calculation Values

To view and define ceilings, rates, and other calculation values:

1. View and define social security ceilings.

To view or update ceilings and the minimum hourly rate associated with the general scheme (delivered by PeopleSoft Global Payroll for Spain), use the Scheme page in HR. To define values for other schemes, enter the Scheme page in add mode, and supply the required data.

2. View and define the maximum and minimum social security bases, as well as the minimum hourly rate.

Most common contingency bases are calculated in relation to a maximum and minimum funding base or are derived from a minimum hourly rate (in the case of part-time employees). To view or update the maximum base, the minimum base, or the hourly rate for the general scheme, use the Work Group page in HR. If you are defining values for a different scheme, enter the component in add mode and supply the required data.

3. View and define rates used in the contribution calculation.

When you have reviewed the ceilings and bases used to calculate social security contributions, use the Contribution page in PeopleSoft HR to view or update the contribution rates and percentages for the general scheme. If you are defining values for a different scheme, enter the component in add mode and supply the required data.

4. View key elements used in the social security calculation.

When you have viewed or defined data on the Scheme, Work Group, and Contribution pages, use the Contribution Elements ESP page to obtain information about deductions, key accumulators, and variables used in the social security process.

5. View and maintain information related to contribution reductions.

In some cases, employers may be granted a reduction in the amount of their social security contributions if they hire older employees or employees with qualifying disabilities. Reductions are assigned to employees in three ways: assigning a reduction to the payee's SSN, assigning a reduction to a contract type, or assigning a reduction directly to the employee's contract data using the Contract Status/Content page. You can also define reductions at the Establishment level.

To set up and maintain the correct reduction percentage, as well as the duration of the reduction, use the Reduction and Reduction Data pages.

6. View key elements related to the employer's social security reduction.

When you have viewed, modified, or entered new reduction information on the Reduction and Reduction Data pages, use the Reduction Elements page to obtain information about key accumulators used to calculate and store the amount of the employer reductions.

Reduction ID

The reduction ID identifies the specific reduction rule that applies to an employee. When accessing this page, select an ID and view (or modify) the existing data, or enter a new ID and define the reduction associated with that ID.

Compatible

Select to designate the reduction as compatible with any other reductions assigned to a payee (concurrent reductions). The

system calculates and applies all compatible reductions for a payee.

If you deselect the check box, the system considers the reduction incompatible. The system calculates all incompatible reductions assigned to a payee, but applies only the one that is most beneficial to the employer.

If a payee has both compatible and incompatible reductions, the system applies all compatible reductions, but applies only the incompatible reduction that is most beneficial to the employer.

Reduction Type

The reduction type identifies the categorization for a specific social security reduction to be applied to an employee.

Possible values are:

- *America's Cup Challenge*: Select if the social security reduction is due to the America's Cup Challenge.

Note: You can also override the variable TAX VR COPAMER (America Cup Eligibility) to indicate that an employee is eligible for this tax reduction.

- *Distance Training (CD11)*: Select if the social security reduction is due to a distance training contract.
- *INEM (Box 601 of TC-1) Catastrophe*: Select if social security reductions due to an official declaration of a catastrophe are met by INEM.
- *INEM (Box 601 of TC-1)*: Select if social security discounts are met by INEM.
- *INEM 60 Years Old*: Select if social security reductions are met by INEM due to the partially retired employee being at least 60 years old with at least five years seniority.
- *INEM 65 years Old*: Select if social security reductions are met by INEM due to the partially retired employee being at least 65 years old with at least 35 contributing years.
- *Presence Training (CD10)*: Select if the social security reduction is due to a presence training contract.
- *RD 5/2006*: Select if the reduction appears as part of law RD 5/2006.

Note: You can assign more than one reduction with this reduction type (code CD22) to a given employee. If you do, you are legally required to print the two reductions on two different lines in the FAN file. The system processes CD22 reductions with an effective date greater than or equal to the reference date (setup variable GEN VR REF CD22) according to this requirement and prints them separately in the FAN file.

When you apply this type of reduction to employees with part-time contracts the system needs to calculate them by applying a percentage to the reduction amount equal to the work schedule increased by 30% up to a maximum of 100%. For women returning to work after maternity leave who are eligible for a reduction with special collective, 0016 (field 1269 of the DAT segment in the FAN) and request a work schedule reduction due to child care (GUARDA LEGAL), Social Security requires that the system take into account the original work schedule during the calculation of the amount corresponding to the reduction type with code CD22. To set this up, enter a supporting element override for the specified period for the formula SS FM FCT FTE to define the previous FTE.

- *Research Staff:* Select if the reduction applies to research staff (*personal investigador*).
 - *SS (Box 209 of TC-1):* Select if social security reductions are met by the Social Security agency.
-

Note: In the case of a catastrophe occurring to a company, the reduction is directly applied to all the contributions for the company.

Reason

Enter the reason for the reduction. This field is available only if you select reduction type *INEM* (*Box 601 of TC-1*).

Employers are entitled to a reduction if they hire unemployed people with unlimited contracts before December 31st, 2009.

In this situation, in addition to entering a value in the Reason field, you need to enter the remaining unemployment benefit by overriding the variable SS VR UNEMP BNFT for the hiring month.

Group

Specify the collective to which the reduction applies. The system displays this field only if you select reduction type *RD 5/2006* or *SS* (*box 209 of TC-1*).

Concept

Identify the type of contribution (common contingency, FOGASA, temporary disability, and so on) to which the reduction defined in the Reduction Percentage, From Month, and To Month fields applies (see the following description).

From Month and To Month

Define a reduction with a limited duration. Use the From Month field to identify the first month of the reduction; use the To Month field to identify the last month of the reduction. The actual calendar month on which the reduction begins or ends is based on the contract begin date identified on the Contract Data page in PeopleSoft HR. For example, in the preceding example, the value of the From Month field is 1 and the value of the To Month field is 999. This means that beginning with the month of the initial contract (for example, 1/1/1990), the reduction applies for 999 months. If the start date had been 4 and the To Month date had been 6, the reduction would not begin until April (three months after the contract begin date) and would end after the month of June (five months after the month that the contract started). If you enter 1 in the From Month field and 999 in the To Month field, the system assumes that the duration of the contract is unlimited.

Note: Do not use 0 as the From Month value. Instead use 1.

Percentage to Reduce

View, modify, or define the percentage amount of the reduction that applies to the contribution type identified in the Concept field.

Annual Amount to Reduct

View, modify, or define the exact flat amount of the reduction that applies to the contribution type identified in the Concept field. For monthly employees, the system divides this annual rate by 360 and multiplies the resulting value by the contributed days on the payroll. For daily employees, the system divides the annual rate by the annual calendar days and then multiplies the resulting value by the contributed days on the payroll. For part-time employees, the system reduces the reduction amount based on the FTE value assigned to the employee. The FTE field value represents the reduction of the work schedule.

Employer Contribution

The accumulator that stores the amount of the employer's contribution to social security for each contribution type,

common contingency, permanent disability D & S, professional training, and FOGASA.

To calculate the employer reductions, PeopleSoft Global Payroll for Spain applies the reduction percentages defined on the Reduction Data page to the amount in this accumulator.

Social Security Reduction

The accumulator that stores the employer reductions that are managed by social security for each contribution type (common contingency, permanent disability D & S, professional training, and FOGASA).

INEM Reduction

The accumulator that stores the employer reductions managed by INEM for each contribution type (common contingency, permanent disability D & S, professional training, and FOGASA).

Establishment Reduction

The accumulator that stores the employer reductions managed by INEM in case a catastrophe occurs to a company establishment.

60 Years Old Reduction

The accumulator that stores the employer reductions for employees older than 60.

65 Years Old Reduction

The accumulator that stores the employer reductions for employees older than 65.

Research Stuff Reduction

The accumulator that stores the employer reductions for employees that are categorized as research staff (*personal investigador*).

Extending Social Security Reductions

According to the INEM, "The suspension of the application of reductions implies the suspension of the calculation of the period of the reductions." This refers to periods of absence, such as maternity leave, in which the employee stops contributing to Social Security and the system likewise does not calculate reductions. In these cases, the period of absence should be excluded from the reduction period and therefore the end date of the reduction should be extended. PeopleSoft Global Payroll for Spain enables you to set up reduction extensions at the absence take level. To accomplish this you must:

1. Override the variable SS VR EXT F RED with a value of *S* at the absence take level so that the system extends the reduction duration when an absence event is defined:
 - a. Access the Absence Takes - Supporting Element Overrides page (Set Up HCM, Product Related, Global Payroll & Absence Mgmt, Elements, Absence Elements, Absence Takes, Supporting Element Overrides).
 - b. On the Elements/Dates tab, enter an element type of *Variable* and an element name of *SS VR EXT F RED*.
 - c. Select the begin date as the effective date of this extension setup. Starting from this date, the absence take being updated will extend the reduction calculation. Be aware that if you select a

date in the past, it might affect future retroactivity calculations because the system might produce results that are different than those previously calculated.

- d. On the Values tab, enter a character value of *S*.
2. Confirm that you are storing the value of the User Defined Character 1 result field:
 - a. Access the Absence Takes - User Defined Result Fields page (Set Up HCM, Product Related, Global Payroll & Absence Mgmt, Elements, Absence Elements, Absence Takes, User Defined Result Fields).
 - b. If the configuration type *User Defined Character 1* is not already listed in the User Defined Result Fields group box, add it.

Understanding the Multiple Employment Funding Base

In PeopleSoft Global Payroll for Spain, you can calculate the social security contribution funding base for employees with multiple jobs. You define multiple employment funding bases using the Multiple Employment Data page.

Example: Applying Distribution Percentages to the Standard Bases and Ceilings

In this example, assume that an employee has two jobs with these characteristics:

- Hours and Salary for Job 1:
 - Hours Worked: 5 hours per day.
 - Contribution Group: 2.
 - Base Salary: 1.202,02 EUR per month.

- Additional Salary: 291,49 EUR per month.
- Overtime: 345,58 EUR in current month.
- Number of Extra Periods: 0.
- Hours and Salary for Job 2:
 - Hours Worked: 3 hours per day.
 - Contribution Group: 3.
 - Base Salary: 294,50 EUR per month.
 - Additional Salary: 24,04 EUR per month.
 - Number of Extra Periods: 0 (including base salary).

Assume that the social security calculation generates these maximum and minimum common contingency bases to use in the normalization process for Job 1:

Base	Standard Base Amount
Maximum Base	3166.20 EUR
Minimum Base	843.30 EUR

Assume also that the social security calculation generates these upper and lower professional contingencies ceilings to use in the normalization process:

Ceiling	Standard Ceiling Amount
Upper Professional Contingencies Ceiling	3166.20 EUR
Lower Professional Contingencies Ceiling	728.10 EUR

If the distribution percentage for the common contingency base for Job 1 (provided by Social Security) is 75 percent, the system recalculates maximum and minimum bases for common contingencies in the following way:

Base	Standard Base Amount	Recalculated Base
Maximum Common Contingencies Base	3166.20 EUR	$3166.20 \times 75\% = 2691.27$ EUR
Minimum Common Contingencies Base	843.30 EUR	$843.30 \times 75\% = 632.48$ EUR

And if the distribution percentage for the professional contingency base for Job 1 (provided by Social Security) is 75 percent, the system recalculates the upper and lower ceilings for professional contingencies in the following way:

Ceiling	Standard Ceiling Amount	Recalculated Ceiling
Maximum Professional Contingencies Ceiling	3166.20 EUR	$3166.20 \times 75\% = 2691.27 \text{ EUR}$
Minimum Professional Contingencies Ceiling	728.10 EUR	$728.10 \times 75\% = 546.08 \text{ EUR}$

Note: The maximum and minimum base percentages in these tables are defined on the Multiple Employment Data page.

Self-Insurance Percentages

Use this group box to define the reduction rate percentages for each self-insurance collaboration type. The system factors these percentages when calculating social security contributions for companies with self-insurance that collaborate with Social Security to provide the corresponding benefits or specific contributions.

Effective Date

Enter the date that the self-insurance reduction rate percentages become valid.

Status

Select whether the self-insurance reduction rate percentages are *Active* or *Inactive*.

Percentage for AT/EP

Contains the self-insurance percentage for the work-related injury or occupational disease (AT/EP) collaboration type as given annually by the Ministry of Labor and Social Affairs (MTAS). It is used during the shared services contribution calculation. Oracle delivers and maintains this value.

Percentage for non AT/EP

Contains the self-insurance percentage for common disease or nonwork-related injury (non-AT/EP) collaboration type as given annually by MTAS. It is used during calculation of the regular situations joint-management reduction. Oracle delivers and maintains this value.

Self-Insurance SSN Employers

Use this group box to specify, by employer social security number, the companies with self-insurance and the collaboration types associated with these employer social security numbers.

Social Security Number and Company

Select the employer social security number for the companies that have self-insurance and are collaborating with Social Security to directly provide AT/EP or non-AT/EP benefits to employees. The system prompts you to select from employer social security numbers for Spanish establishments as defined on the Establishment Address page.

Effective Date

Enter the date that the collaboration type for each selected company becomes valid. This is the authorization date.

Status

Select whether the collaboration type for each selected company is *Active* or *Inactive*.

Check AT/EP

Select to indicate that the selected company has a self-insurance collaboration type for work-related injury or occupational disease.

Check non-AT/EP

Select to indicate that the selected company has a self-insurance collaboration type for common disease or nonwork-related injury.

Viewing Delivered Social Security Deductions

This topic discusses delivered social security deductions.

PeopleSoft Global Payroll for Spain defines employee contributions to social security as deductions with a calculation rule of Base * Percentage for regular employees. For trainees and apprentices, the deductions are defined as a flat amount. The deductions that are used to calculate employee contributions due to vacations not taken are defined as a flat amount.

SS CT FWD	Social Security to be forwarded. Used during retro calculation to forward Social Security data to the current month. This value is used just during calculation of tax percentage.
SS DD CC	Employee deduction for common contingencies.
SS DD DSMPL	Employee deduction for unemployment.
SS DD FRM PR	Employee deduction for professional training.
SS DD HS X E	Employee deduction for structural overtime.
SS DD HS XNE	Employee deduction for nonstructural overtime.

Managing Social Security Calculation

Understanding Social Security Benefits

This topic discusses Spanish social security benefits and calculation of benefits.

Benefit Types

Employees in Spain are eligible to receive the following types of benefits:

- Temporary Disability Benefits for Common Sickness and Non-Industrial Accidents (IT) and Extended IT (IT PRORROGADA).

IT (*Incapacidad Temporal*) benefits are available to employees who have contributed to social security at least 180 days in the last five years before the leave date.

- Disability Benefits Due to Work Related Injuries (AT & EP) and Extended AT & EP (AT/EP PRORROGADA).

AT & EP (*Accidentes de Trabajo y Enfermedades Profesionales*) benefits are available to workers who have suffered workplace injuries.

- Maternity/Paternity

These benefits are available to employees who have contributed to social security at least 180 days in the last five years before the date of birth. Because the legal benefits are paid entirely by Social Security, the payment amounts are not calculated by PeopleSoft Global Payroll for Spain. However, the system does calculate the common contingencies (CC) and professional contingencies (CP) bases for the days that employees are absent for maternity or pregnancy risk. These bases are required to calculate complementary benefits that are paid by the employer.

- Risk During Pregnancy or Lactancy:

These benefits are available to any active employee. Because the legal benefits are paid entirely by Social Security, the payment amounts are not calculated by PeopleSoft Global Payroll for Spain. However, the system does calculate the common contingencies (CC) and professional contingencies (CP) bases for the days that employees are absent for risk during pregnancy or lactancy. These bases are required to calculate complementary benefits that are paid by the employer.

- Minor Care (CUIDADO MENOR).

This benefit is available to any active employee with the required contributing period that requests a work schedule reduction of at least 50% to take care of a child affected by serious sickness. The legal benefits are paid by Social Security for the currently worked period. The system does not calculate this benefit as an amount to be paid. Instead, it calculates it as a possible complementary benefit that may be paid by the employer. No Social Security contributions are calculated/reported for the non-worked period. You manage this benefit using the absence take CUIDADO MENOR. To be eligible

for this benefit, an employee needs to be identified as a regular part time employee for the affected period. Therefore the variable CLI VR RED JORNADA should be defined.

Legal and Complementary Benefits

Two types of benefits exist:

- Legal benefits known as *Subsidio IT* and *Subsidio AT*.
- Complementary benefits paid by the employer known as the *Prestación Complementaria IT*, *Prestación Complementaria AT*, *Prestación Complementaria MT*, *Prestación Complementaria RE*, and *Prestación Complementaria CM*.

Note: Employer complementary benefits are defined on the Complementary Benefit page. The system automatically calculates the portion of the benefits that is the legal benefits, *Subsidio*, and the portion that is paid by the employer, *Prestación Complementaria*.

For maternity/paternity, risk during pregnancy or lactancy, or minor care benefits, the system calculates the elements Subsidio MT, Subsidio RE, and Subsidio CM as part of the complementary benefits calculation.

Bases(Base Reguladora Diaria)

In PeopleSoft Global Payroll for Spain, daily legal social security benefits are calculated as a percentage of a daily benefits base (*Base Reguladora Diaria* or *BRD*). The daily bases are derived from the CC and CP funding bases for social security for previous months and divided by the contributing days in that period. This table identifies the social security funding base from which the daily base for each benefit is derived:

Benefit	Social Security Base Used for Benefit Calculation
IT and Extended IT (<i>subsidio IT</i>)	Common contingencies corresponding to the previous month.
AT & EP and Extended AT & EP (<i>subsidio AT</i>)	Professional contingencies base corresponding to the previous month - overtime of that month + overtime average for the last 12 months.
Maternity/Paternity	Common contingencies corresponding to the previous month.
Risk during pregnancy or lactancy	Professional contingencies base corresponding to the previous month - overtime of that month + overtime average for the last 12 months.
Minor care	Professional contingencies base corresponding to the previous month - overtime of that month + overtime average for the last 12 months.

Note: You can override these BRD values.

The system calculates the BRD for part-time employees differently. Instead of using the social security base of the previous month it uses the average of the three or twelve months—depending on the absence—prior to the begin date of the absence.

Normally the system calculates the BRD by dividing the bases of the corresponding period of time by the contributing days in that period. In the case of absences for which the benefit is paid directly by Social Security (maternity, paternity, risk during pregnancy or lactancy, minor care, and extended IT and AT/EP), the requirement is to include calendar days when calculating those benefits for employees with an assigned schedule (irregular part-time employees).

Note: The variable CLI VR MET CLC BRD determines from which contracts and schedule types the system retrieves contribution data when calculating BRD. When CLI VR MET CLC BRD has its default value of 1, the system retrieves contribution data across all contracts and schedule types. If you change the value of CLI VR MET CLC BRD to any value other than 1, the system retrieves contribution data for only a payee's most recent contract or most recent schedule type change. If both a contract and schedule type change occur for a payee, the system uses the most recent of the changes when calculating the BRD. The variable CLI VR OPC CLC BRD determines if the system counts periods affected by certain absences when calculating BRD. For the default value, *A*, the system includes days and bases of unpaid personal leave in the BRD calculation. For any other values, the system does not include days and bases of unpaid personal leave in the BRD calculation.

With complementary benefits, employers can select from the following bases:

- Social security common contingencies base.
- Employees' gross daily salary.
- Any other user-defined daily accumulator.

You specify the base for complementary benefits on the Complementary Benefit page.

Percentages

The percentages used to calculate benefits are set both by the government (in the case of legally mandated benefits) and by employers (in the case of complementary benefits). The percentages used to calculate the IT benefit (*Subsidio IT*) vary depending on the number of days that the employee is on leave, while the amount of the AT and EP benefit (*Subsidio AT*) is currently set at 75 percent of the daily base (the *Base Reguladora Diaria*) for each day of leave. Both maternity/paternity and risk during pregnancy or lactancy are paid at 100 percent of the daily base (*Base Reguladora Diaria*). Minor care is paid at 100 percent of the reduced working time.

Rounding

The variable SS VR OPCALC SUBSD determines how the system rounds IT benefit amounts:

SS VR OPCALC SUBSD Value	Calculation Method
D	BRD = Base Previous Month ÷ Contributed Days (Rounded to two decimal places)
Note: This is the default value.	IT Subsidy = BRD × Percentage × Number of Days (Rounded to two decimal places)

SS VR OPCALC SUBSD Value	Calculation Method
P	$\text{BRD} = \text{Base Previous Month} \div \text{Contributed Days (Rounded to two decimal places)}$ $\text{IT Subsidy Daily Price} = \text{BRD} \times \text{Percentage (Rounded to two decimal places)}$ $\text{IT Subsidy} = \text{IT Subsidy Daily Price} \times \text{Number of Days}$

These two calculation methods can produce slightly different values, so choose the one that works best for your business process.

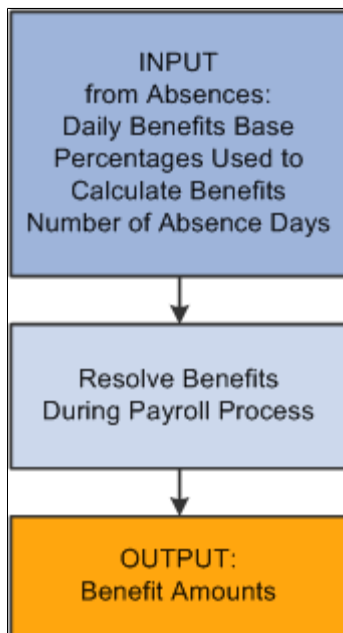
Pago Delegado

Pago Delegado refers to the system whereby an employer pays IT or AT benefits to an employee, but is later reimbursed for these payments by Social Security. That is, the company acts as the direct provider of benefits and is later repaid. In the case of IT, the employer can reimburse, as *pago delegado*, the social security benefits from the 16th day of sickness. In the case of AT, the employer has the right to reimburse from the first day of sickness. This reimbursement isn't a real refund, but rather a discount of the total amount to pay through the social security TCs.

Social Security Benefits in the Pay Process Flow

Image: Benefits in the pay process flow for PeopleSoft Global Payroll for Spain

This diagram illustrates how benefits processing, from the entering of absence data and resolving of benefits during the payroll process that yield the benefit amounts, fits into the overall pay process flow of PeopleSoft Global Payroll for Spain.



As shown in the diagram, benefits preparation takes place during absence processing. The absence processing calculates the daily benefits base (*Base Reguladora Diaria*), the percentages to apply to the base, and the number of days that the employee is on each type of leave. Then, during the payroll process, the benefits setup in absences are resolved.

Understanding Social Security Absence Days Count

PeopleSoft Global Payroll for Spain counts absence days to report to Social Security in cases of sickness, industrial or professional accident, maternity/paternity, or risk during pregnancy or lactancy using the following counters:

Counter	Description
Sick Days Counter	Counts the number of Social Security base days.
Workdays Counter	Counts the number of paid workdays.
Benefits Days Counter	Counts the number of compensation days for Social Security benefits.

The system uses these counters along with the AUS FM DIAS formula for the calculation of an employee's social security contribution base, social security compensation, social security benefits, and company complementary benefits.

Day Counts for Social Security Contribution Base

The system counts Social Security base days for Social Security absences in two segments: healthy days and sick days.

To count the number of healthy days, the system uses the Workdays Counter.

To counter the number of sick days, the system uses the Sick Days Counter. The Sick Days Counter determines the sick days by calculating the difference between the days by frequency and the work days. Thus:

Sick Days Counter = Days by Frequency – Number of Workdays

The days by frequency are the days considered for contribution purposes depending on whether the count is for employees with a daily salary basis or a monthly salary basis. For employees with a daily salary basis, the system uses the actual number of calendar days in the month. For the employees with the monthly salary basis, the system uses 30 days regardless of the actual number of calendar days in the month.

Note: Note these two exceptions regarding the sick days count for employees with a monthly salary base because of the set 30 days. First, if an employee has a full month of absences in February the system adds either one or two sick days depending on the number of days in February for that year. Second, if an employee has one absence in a 31 day month, the system counts 30 healthy days and 0 sick days.

Day Counts for Social Security Benefits

When counting compensation days for Social Security benefits, the system uses the Benefits Days Counter. In this case, the counter considers natural sick days. It counts the exact number of calendar days, including holidays, vacation days, and weekends.

Note: The system does not adjust this counter to 30 days. It always uses the exact number of calendar days in the month. Thus, the benefits days for a whole month of sickness in February or a month with 31 days is equal to the exact number of calendar days.

Day Counts for Company Complementary Benefits

When calculating company complementary benefits, the system uses the Benefits Days Counter. To perform the calculation, the system:

- Calculates the target gross to pay the employee based on the complementary benefits setup data at the labor agreement level.
- Makes an adjustment to avoid paying employee's a higher gross for months with sickness compared to a regular month without absences.
- Makes an adjustment for certain rules to ensure that employees with a monthly salary basis are paid for exactly 30 days when absent the entire month, regardless of the actual calendar days.
- Converts the complementary benefit for day 31 into a negative amount to absorb the Social Security benefit for that day when the employee is on a monthly salary basis.

Note: The system performs this conversion only if the final complementary benefit is greater than or equal to zero.

- Converts the complementary benefit for day 28 and 29 of February into a positive amount to adjust the Social Security benefit for those days when the employee is paid on a monthly salary basis.

Examples

If an employee with a monthly salary basis starts a common sickness (IT) absence on January 11:

- Days by frequency = 30 (just for being a monthly employee and active the whole month)
- Workdays Counter = 10 (exact number of workdays in that month)
- Sick Days Counter = Days by frequency – Worked days = 30 – 10 = 20
- Benefits Days Counter = Sick days = 21 (exact number of calendar days with sickness, from the 11th to the 31st)

If an employee with a daily salary basis starts a common sickness (IT) absence on January 11:

- Days by frequency = 31 (just for being a daily employee and active the whole month)
- Workdays Counter = 10 (exact number of worked days in that month)
- Sick Days Counter = Days by frequency – Worked days = natural sick days = January 11 to January 31 = 21

- Benefits Days Counter = Sick days = 21 (exact number of calendar days with sickness, from the 11th to the 31st)

If an employee with a monthly salary basis starts a common sickness (IT) absence on February 11:

- Days by frequency = 30 (just for being a monthly employee and active the whole month)
- Workdays Counter = 10 (exact number of worked days in that month)
- Sick Days Counter = Days by frequency – Worked days = 30 – 10 = 20
- Benefits Days Counter = 18 days (exact number of calendar days with sickness, from the 11th to the 28th)
- Complementary Benefits Days = natural sick days + 2 (The system extends complementary benefits 2 more days using the payment percentage assigned to day 28).

If an absence due to sickness starts on the last day of a month with 31 calendar days for an employee with a monthly salary basis:

- Workdays counter = 30 days (the exact working days as healthy days).
- Sick days counter = Days by frequency – Worked days = 30 – 30 = 0
- Benefits days counter = 1 day (exact number of calendar days with sickness)

Note: If the absence day is a relapse day or is the last day of an absence that started in the previous month, the Social Security report shows 30 contributed days in the healthy segment (worked segment) but also shows another segment, called the DAT segment, to reflect the compensation (reduction related to *Pago Delgado*). The system cannot show more than 30 contributed days (sum of the healthy and sick segments) in the report. If such a case occurs, you cannot manage the discount in the FAN file. Your company instead needs to ask for reimbursement of that amount from Social Security. No direct way is available to discount that one day with *Pago Delgado* from Social Security.

If an absence due to sickness starts the last day of the month with 28 calendar days for an employee with a daily salary basis:

- The system calculates 27 days for the healthy days segment of the employee's Social Security contribution base and 3 days for the sick days segment.
- The system calculates the Social Security Benefit counter as 1 day.

Calculating Benefits

This topic provides an overview of benefits calculation and discusses how to:

- Calculate legal benefits.
- Calculate complementary benefits.

Understanding Benefits Calculation

When payees are on temporary disability leave (IT), they are eligible for these benefits:

- The legally mandated benefit (*Subsidio*).

PeopleSoft Global Payroll for Spain calculates legal benefits by multiplying the employee's daily base (*Base Reguladora Diaria*) by the number of leave days, and then applying a percentage to this base. The percent applied varies according to the benefit being calculated and the number of days the employee is on leave.

- A complementary benefit (*Prestación Complementaria*) defined by the employer. The calculation for complementary benefits depends on the base that you selected on the Complementary Benefits page.

Calculating Legal Benefits

The legal benefit is calculated by earning elements with a calculation rule of *Unit x Rate x Percent*. The correct percent varies depending on the benefit type and day of the leave (see tables in this topic). The rate is the daily base for IT, AT, or maternity or risk during pregnancy that is taken from the previous period to the begin date of the absence. For new employees hired during the month, the system calculates a theoretical daily base that would apply if the employee had worked for the whole month. The unit is the number of days that the employee is on leave and must be entered on the Absence Event Entry page.

Note: For IT benefits, employees are eligible only when they have contributed to Social Security for at least 180 days in the past five years. The person who enters the absence event must validate that the employee is eligible for the benefit. If an employee is not eligible for the benefit, select the Lacking Period Indicator check box on the Additional Data page of the Absence Event ESP (GPES_ABS_EVENT) component so that the system does not pay the benefit.

IT Legal Benefit

For temporary disability leave (IT), the legally mandated benefit is defined as a percentage of the benefits base—with the percentage varying according to the number of days the employee is on leave. The current percentages (and the benefits base to which the percentages are applied) are shown in this table:

<i>From Day in IT</i>	<i>To Day in IT</i>	<i>Percentage</i>	<i>Benefit Base</i>
1	3	0	0
4	20	60	CC Base
21	540	75	CC Base

Two benefit phases exist. From day 4 to day 15 of the benefit, the employer is responsible for making payments to the employee. Beginning with day 16 and continuing to day 180, Social Security subsidizes the benefit. Although the company serves as the direct provider of the benefit during the entire benefit period, Social Security reimburses the company for any payments made after day 15 under a system known as *Pago Delegado*. This table shows who is responsible for the benefit paid during each phase:

<i>From Day in IT</i>	<i>To Day in IT</i>	<i>Who Pays?</i>
1	3	No benefits paid
4	15	Company

From Day in IT	To Day in IT	Who Pays?
16	540	Social Security

If the IT absence continues after 540 days it can be extended by Social Security. If that happens, enter an end date for the first IT event, and enter a new row for absence event IT PRORROGADA with an original begin date that is the same begin date as the original IT event. This benefit is paid directly by Social Security.

AT Legal Benefit

For employees on disability leave for work-related injury, the current legally mandated benefit is defined as 75 percent of the benefits base throughout the entire benefit period. The current percentage, as well as the benefits base to which the percentage is to be applied, are shown in this table:

From Day in AT	To Day in AT	Percentage	Benefit Base
1	540	75	CP Base

By law, the Mutual Insurance Company is responsible for paying the AT benefit through the entire benefit period. Although the company acts as the direct provider of the benefit, Social Security reimburses the company for any payments made under a system known as *Pago Delegado*. This table shows who is responsible for the benefits paid:

From Day in AT	To Day in AT	Who Pays?
1	540	Social Security

If the AT/EP absence continues after 540 days it can be extended by Social Security. If that happens, enter an end date for the first AT/EP event, and enter a new row for absence event AT/EP PRORROGADA with an original begin date that is the same begin date as the original AT/EP event. This benefit is paid directly by Social Security.

Maternity/Paternity Leave, Risk During Pregnancy or Lactancy, and Minor Care Legal Benefits

Maternity, pregnancy risk, and minor care benefits consist of 100 percent of the daily regulatory base: CC for maternity/paternity, and CP for risk during pregnancy or lactancy and minor care. Social Security is responsible for paying benefits beginning with the first day of leave. As a consequence, this benefit is not processed by PeopleSoft Global Payroll for Spain and these benefits never appear on the payslip. However, the system calculates legal benefits to calculate the complementary benefits for maternity and risk during pregnancy that are defined on the Complementary Benefits page.

This table summarizes the benefit amount and benefit period for maternity:

From Day in MATERNITY/ PATERNITY	To Day in MATERNITY/PATERNITY	Amount
1	Depends on number of children born.	100 % of daily common contingencies base.

This table summarizes the benefit amount and benefit period for pregnancy risk:

<i>From Day in Risk During Pregnancy or Lactancy</i>	<i>To Day in Risk During Pregnancy or Lactancy</i>	<i>Amount</i>
1	No limits	100 % of daily professional contingencies base.

This table summarizes the benefit amount and benefit period for minor care:

<i>From Day in Risk During Pregnancy or Lactancy</i>	<i>To Day in Risk During Pregnancy or Lactancy</i>	<i>Amount</i>
1	No limits	100 % of daily professional contingencies base for the non-worked period.

Part-time Maternity and Paternity

Maternity and paternity leave can be taken on a part-time basis in which an employee works part of the day and is absent for the other part. For part-time maternity and paternity, you enter MATERNIDAD PARCIAL or PATERNIDAD PARCIAL absence events. In addition, you need to enter the number of partial hours for the absence events. If an absence starts or ends in the middle of the month it will cause an element segmentation of the payroll calculation.

Special Maternity Leave Benefits

There are two special cases that affect maternity leave benefits:

- The birth, adoption, or foster care of two or more children simultaneously.
- A working mother does not comply with the minimal contribution period.

For multiple simultaneous births, adoptions or foster care, the payee is eligible for a special subsidy for each additional child after the first. The amount of the subsidy for each additional child is the same as it is for the first child (100% BRD) and is paid in one lump sum six weeks after the birth or adoption. To indicate that a payee is eligible for the multiple maternity subsidy, select MLT in the Absence Reason field and enter the number of children on the Additional Data page of the Absence Event ESP (GPES_ABS_EVENT) component.

For working mothers who do not comply with the minimal contribution period, the system pays a subsidy of either 100% IPREM (Indicador Público de Renta de Efectos Múltiples) or 100% BRD, whichever is smaller. The duration of this subsidy is 42 natural days from the birth. To indicate that a working mother

should receive this subsidy, select the Lacking Period Indicator check box on the Additional Data page of the Absence Event ESP (GPES_ABS_EVENT) component.

Calculating Complementary Benefits

To define complementary benefits (*Prestaciones Complementarias*), set up the following items on the Complementary Benefits page:

- Funding Base used to calculate complementary benefits. This could be:
 - Social Security Common Contingencies or Professional Contingencies base. This is the default base.
 - Employee's gross daily salary.
 - Any other daily accumulator that you have defined.
- Absence period.
- Total percentage to be paid for each period.

The complementary benefit uses an earning element with a calculation rule of *Unit x Rate x Percent*. The correct percent is retrieved by a formula based on the benefit percentages defined on the Complementary Benefits page. The rate is the daily base for IT, AT, and maternity or risk during pregnancy, which is either based on the previous period without absence (if the default base is used) or another base defined on the

Complementary Benefits page. The unit is the number of days that the employee is on leave and must be entered on the Absence Event Entry page.

Then another earning (PRSTCN CMPIT, PRSTCN CMPAT, PRSTCN CMPMT, PRSTCN CMPRE, or PRSTCN CMPCM) gets the difference between the previous earning and the value corresponding to the Subsidio IT, Subsidio AT, Subsidio MT, or Subsidio RE.

Contributions

Element

Displays the element code that appears in the FAN file for the contribution.

Description

The description of the contribution element that appears in the FAN file.

Base

The monetary value of the contribution element.

Percentage

The total contribution percentage that applies to each amount value. This percentage includes both employee and employer contribution percentages.

Employee

The amount that the employee pays for social security contributions for the given element.

Employer

The amount that the employer pays for social security contributions for the given element. Note that contribution amounts for certain elements are the exclusive responsibility of the employer.

Reporting Contracts Fewer Than 7 Days

This topic provides an overview of management of contracts that are fewer than 7 days and discusses how to:

- Exclude interim contracts fewer than 7 days.
- Update relationship type for contracts fewer than 7 days.
- Review modifications to pages affected by contracts fewer than 7 days.

Understanding the Management of Contracts Fewer Than Seven Days

In accordance with the specifications of Additional Provision Six of Law 12/200, an employer's common contingencies quota for Social Security must increase by a fixed percentage, as determined by INSS, for employees whose contracts are temporary and have an effective duration of fewer than seven days. The increase to the common contingencies quota at the time of publication is currently 36 percent. The system stores the value of this percentage increase in the SS VR PCT 7D variable. Employers must include data reflecting this increased common contingencies quota when reporting to Social Security through the RED system FAN File and the TC1 Report.

To determine the effective duration of an employee's contract, the system uses the contract begin date and contract end date on the Contract Status/Content page of the Update Contracts component. When a contract has a duration of fewer than 7 days, the system assigns a value to the SS VR CONTR 7D FLG variable to indicate this fact.

For employees with contracts fewer than seven days, select *Temporary* in the Regular/Temporary field on the Job Information page of the Job component. There are some contracts that are not affected by special extra contribution even if they last less than 7 days, for example, interim contracts 410/510 . Those contracts are identified in the bracket SS BR CNT <7D.

The RED system FAN File and TC1 Report reflect data related to employee contracts that have an effective duration of fewer than 7 days. The TC1 Report includes related key, base, percentage, and quota data under the Other Concepts key. The FAN File includes the additional quota in the line EDTCA11 under the Other Concepts key and updates the amount for line EDTT10 accordingly.

Updating Relationship Type for Contracts Fewer Than 7 Days

Contracts with a duration of less than 1 year have a minimum tax percentage equal to 2 %. Therefore, for contracts fewer than 7 days you must update the employee's tax data relationship type to ensure this minimum tax percentage.

To update an employee's relationship type for contracts with a duration of fewer than 7 days:

1. Select Global Payroll & Absence Mgmt, Payee Data, Maintain Tax Data ESP, Maintain Tax Data.
2. Enter a Relationship Type field value equal to 2 - *Less 1 Year Relationship* in the Payee Data group box.

Understanding Social Security Reports

PeopleSoft Global Payroll for Spain delivers two TC reports for social security:

- TC1.

The TC1 report provides a summary of the totals for all Social Security bases, contributions, benefits to refund, reductions, and discounts referred to for employees included in an employer Social Security number.

- TC2.

The TC2 report provides a list of employees included in an employer Social Security number with their respective Social Security bases, contributions, benefits to refund, reductions, and discounts.

In summary, the TC2 report is a list of employees with their respective Social Security bases and contributions and the TC1 report is a summary of the TC2 report.

Two steps involved in generating these reports:

1. Data Preparation: To prepare data for the reports, the social security section SS SE PREPARAR TC runs the formula SS FM TC WA during payroll process. That sends data to the writable array SS TC WA during the regular payroll process. This writable array stores data in record GPES_SSTC_RSLT for use in the TC reporting process.
2. Reporting Process: To generate the reports, the reporting process reads the data in the writable array (see step 1).

See "Defining Writable Array Elements (*PeopleSoft HCM 9.2: Global Payroll*)".

Liquidation Types

PeopleSoft Global Payroll for Spain manages the following liquidation types during FAN reporting:

- L00: Regular liquidation.
- L02: Complementary liquidation due to litigation salaries. The surcharge for this liquidation type depends on when the litigation salaries are processed with respect to the sentence date. The payroll process sets the surcharge at 20% or 0% and stores it in the Social Security result table.
- L03: Complementary liquidation due to retroactive calculation without surcharge.
- L04: Negative complementary liquidation due to retroactive calculation with surcharge. For L04 payments, the surcharge is not a flat value. Rather, the system determines the surcharge based on the number of months the payment is delayed. The surcharge can be 3%, 5%, 10% or 20%. By default,

the payroll process automatically calculates the L04 surcharge percentage. The system compares the month for which it is calculating L04 payments with the current month and determines the corresponding surcharge percentage.

Note: This type of liquidation results from Social Security benefits or reductions that were originally reported incorrectly.

- **L09:** Complementary liquidation due to retroactive calculation with surcharge. Global Payroll for Spain calculates the surcharge for this liquidation type (currently 20%) and stores it in the GPES_OOD_PYMT_SUR field of the Social Security result table.
- **L13:** Liquidation of contributions due to vacation paid at termination. The system calculates the surcharge associated with this liquidation type based on the main liquidation to which the L13 payment refers.

The default liquidation type for FAN report retroactive payments is *L03*. The FAN Payment Override ESP (GPES_PMTRTO_DEF) and Create FAN Pymt. Overrides ESP (GPES_PMTRTR_OVR) components enable you to override the liquidation type with enhanced flexibility.

You can use the Fan Payment Override ESP (GPES_PMTRTO_DEF) component to indicate that a certain liquidation is being processed out of date. Legal requirement dictate that in this case a company cannot benefit from reductions and cannot request a refund for the money they paid as PAGO DELEGADO. Therefore, if you set up a specific run to be out of date through this component, payroll processing does not generate those lines in the TC result record. The system keeps calculating the company paid benefits (PAGO DELEGADO) and social security reductions. Accumulators for these benefits store values regardless of whether a payment is in period or out of period. In the case of retroactivity, previous values are required. If the system didn't calculate accumulators, the previous values would be 0, and the deltas would be wrong. The system also contains a set of accumulators that store values in cases of payment out of period, with the negative delta values for social security benefits. You should consider all of these accumulators when setting up General Ledger. For example, to store PAGO DELEGADO for IT, we have both SS AC PGO DLGDO PI and SS AC PD IT N PLZO, which stores values when the calculation is out of date.

Select to print only employee contributions in the FAN file.

Enter the amount that you want the system to consider as maximum tolerance for mathematical validation. This field accepts values greater than or equal to 0, but it represents an absolute value.

File Path

Enter the directory in which to store the FAN file.

File Name

Enter the file name to be sent to Social Security. The file name needs to comply with the legal requirements. The file naming requirements state that the file extension must be .FAN and the file name must have 8 characters. The system will check whether the file name follows the naming conventions, and show an error message if it's not named correctly.

Chapter 11

Calculating Taxes

Understanding Tax Calculation

This topic discusses:

- Tax calculation.
- IRPF calculation overview.

Tax Calculation

A person (Spanish or foreign) receiving money in Spain, or a Spanish person working abroad, being eligible to pay taxes in Spain, can be considered from taxes point of view as: -Resident--> Affected by IRPF "Impuesto sobre la renta de las personas físicas" -Non-resident (taxed or not taxed)--> Affected by IRNR "Impuesto sobre la renta de no residentes" -Tax exempt. This information is setup at employee level through the page "Transnational Mobility" under Maintain tax data ESP component

Payees in Spain (Spanish or foreign) and Spanish payees working abroad who are eligible to pay taxes in Spain fall into three main categories:

- Residents who are subject to *Impuesto sobre la Renta de las Personas Físicas* (IRPF).
- Nonresidents (taxed or not taxed) who are subject to *Impuesto sobre la Renta de No Residentes* (IRNR).
- Tax exempt payees.

You define the category for each payee on the Transnational Mobility page of the Maintain Tax Data ESP (GPES_PAYEE_DATA) component.

In the case of IRPF, the withholding amount originates from employee income and reductions and depends on which tax regulations are applicable to an employee. Spain does not have one single set of tax regulations for IRPF. General state tax regulations exist as well as four regions with specific tax calculations. Each tax location is known as a fiscal territory (*Territorios Fiscales*). An employee is associated with one fiscal territory depending on where the employee is living and working. PeopleSoft Global Payroll for Spain calculates the IRPF for all the fiscal territories:

- Hacienda Estatal (state territory).
- Hacienda Foral de Navarra.

- Hacienda Foral de Alava.
- Hacienda Foral de Guipuzcoa.
- Hacienda Foral de Vizcaya.

You assign each payee to one fiscal territory using the Maintain Tax Data page of the Maintain Tax Data ESP (GPES_PAYEE_DATA) component.

Note: The fiscal territories Hacienda Foral de Navarra, Hacienda Foral de Alava, Hacienda Foral de Guipuzcoa, and Hacienda Foral de Vizcaya are known as *historical* territories.

PeopleSoft Global Payroll for Spain provides the different calculation rules and setup data for each fiscal territory. It delivers setup data using tax brackets and calculation variables. You can view and update the tax brackets and other tax data that PeopleSoft Global Payroll for Spain delivers.

IRPF Calculation Overview

To calculate an employee's withholding percentage, the system:

1. Estimates the total annual income.
2. (State territory only) Estimates the social security contribution.
3. (State territory only) Calculates the available reductions.

These include deductions for dependents, any personal deductions due to age or disability, and any spousal garnishments.

4. (State territory only) Subtracts the social security contribution and the available reductions from the total annual income.

Note: The annual income for historical territories is reduced if needed by spousal garnishments and reductions linked to irregular income, which are the starting point for getting the IRPF percentage.

5. Calculates the withholding percentage.

The system generates the withholding percentage based on the previous steps. If needed, you can alter this percentage, but the system uses it only if it is higher than the one it calculated.

Normalization

To prevent large differences between the estimated IRPF tax rate and the real tax contribution needed at the end of the year, a process calculates the withholding percentage multiple times during the year. This process is called normalization. The percentage withholding normalization process accounts for incomes earned and taxes and contributions paid, as well as income, tax, and contribution estimates for the remainder of the contract period or year.

PeopleSoft Global Payroll for Spain delivers a page where you can define the normalization schedule for IRPF calculation.

The Normalization Schedule ESP page is read by the regular payroll process list to determine when to run the normalization process. The exception to this is that the process is always run for new hires in the month that they are hired and for all employees who are compensated on a net to gross basis. You may need more than one schedule if you have different tax calculation dates for different pay entities.

Overriding IRPF Normalization

Even when the normalization schedule indicates that the system should normalize tax rates, it only does so if there have been changes to tax calculation data since the previous tax calculation. Additionally, when the system eventually normalizes tax rates, it does not apply tax rate limits according to Article 87.5. By overriding the variable CLI VR CALCULA TAX, you can force normalization and choose whether the system applies Article 87.5 tax rate limits.

CLI VR CALCULA TAX can be overridden at the pay entity, pay group, payee, or calendar level. If you enter a value for CLI VR CALCULA TAX other than the default value of *0*, the system recalculates the tax rates for all payees affected by the override. For values *1* through *10* and *13*, the system applies tax rate limits according to Article 87.5. For values *11*, *12*, *14*, and *15*, the system does not apply the Article 87.5 tax rate limits.

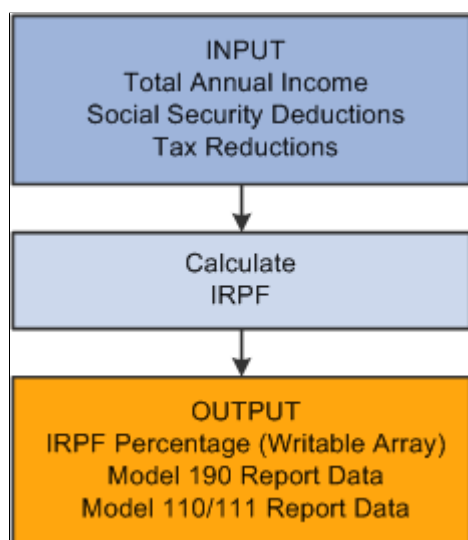

IRNR for Nonresidents

PeopleSoft Global Payroll for Spain provides functionality for you to manage IRNR tax data that the payroll process generates for nonresident workers. This IRNR tax-reporting functionality enables you to create the Model 216 and Model 296 reports. You specify whether a payee is subject to IRNR and whether they are taxed or tax exempt on the Transnational Mobility page of Maintain Tax Data ESP (GPES_PAYEE_DATA) component.

Estimating the Total Annual Income

This topic provides an overview of estimated total annual income and discusses how to:

- Estimate fixed income.
- Estimate salary in kind income.
- Estimate variable income.
- Estimate recurring income from earnings assignments.
- Estimate tax adjustment.
- Estimate irregular income.
- Estimate taxes based on schedule.
- Define custom rules for tax base estimation.
- Set up tax base estimation variables.
- Override estimated tax base values.

Understanding Estimated Total Annual Income

PeopleSoft Global Payroll for Spain calculates IRPF taxes for the state and all of the fiscal territories as a percentage of an employee's taxable income. The percentage of an employee's income that applies to IRPF taxes is based on the employee's annual income, minus reductions due to personal situations, number of dependents, salary level, and disability. You run the process that calculates the tax percentage as part of regular payroll. Whenever information affects an employee's taxes, the employer must recalculate the tax percentage by running the normalization process. The law states that employers must normalize tax percentages for their employees at least once quarterly even if no information changes.

When calculating an employee's tax percentage, either for the first time of the year or through the normalization process, the system estimates the employee's annual income because the actual amount is not available until the end of the year.

The system calculates the estimation of annual income to use as the tax base for IRPF taxes. An employee's total annual income includes fixed income, variable income, and in kind income. This estimation is necessary because the only time you can calculate the true tax base is in the December payroll run when the year is complete. The rest of the year therefore requires an estimation of the tax base for the remaining months.

The system performs the same tax base estimate calculations for all fiscal territories, both state and historical.

PeopleSoft Global Payroll for Spain enables you to control the level of accuracy that you want to have for the tax base estimate defining how you want the system to estimate the annual taxable base during the calculation of IRPF taxes.

The system takes fixed income and benefits income amounts from the Compensation page of the Job Data component (JOB_DATA) and the annual benefits base rate from the Benefits Program Participation page. These values are considered the theoretical annual compensation, so the system uses these values as the starting point of the estimation.

To estimate the variable income Global Payroll Spain use as the base the variable income from last year.

Calculation of Estimated Tax Base

The estimated tax base consists of three parts:

- The amount paid from the beginning of the year through the last month.
- The amount for the current month.
- The amount estimated for the remainder of the year.

Each part of the estimated tax base consists of three different members:

- Fixed income
- In kind income
- Variable compensation

The system performs a separate calculation for each part and stores the results of the tax base calculation details. The system calculates the total estimated tax base using the following equation:

Total Base = Accumulated values year-to-date + current month values + year remainder estimation

Two additional factors that the system considers when estimating the tax base are flexible compensation and the compensation coming from earnings entered through the Earnings and Deduction Assignments menu components. You can set up the system to add these earnings to the corresponding member of the tax base: fixed income, in kind income, or variable compensation based on the nature of the compensation.

The system uses the TAX_WA_RSLT writable array to store the results of the tax percentage calculation, which includes the tax base and other information considered during the calculation. The system stores details in the GPES_TAX_RLST table for each of the different members of the tax base estimate as well as the total tax base value.

You can view the tax base calculation details through the IRPF Calculation Results ESP component.

Estimating Fixed Income

Employees with a net guarantee receive special treatment for tax percentage calculation. The system performs a normalization process each month, regardless of whether the normalization schedule is set up for the employee's pay entity and tax location, because the system needs to perform the net to gross process to calculate the fixed income part of the tax base. The system uses the Target Compensation Rate field value on the Compensation page of the Job Data component as guarantee net and retrieves a gross amount after an iterative process.

For employees who are not net-paid, the system calculates the estimated fixed income using the annual rate. The annual rate comes from the employee's compensation rate and frequency or the target compensation rate, depending on the employee, on the Compensation page of the Job component. The system prorates this value for the remainder of the year or contract by:

1. Calculating an annual value for the compensation by multiplying the entered amount by the entered frequency.
2. Calculating a daily value by dividing the annual amount by the number of days in the year. When determining the number of days in the year, the system includes the number of days of extra periods for which the employee is eligible.
3. Calculating the value of the remaining portion of the year by multiplying the daily amount by the number of days in the remaining portion of the year. When determining the number of days in the remaining portion of the year, the system includes the number of days of the extra periods that are paid during that time period and for which the employee is eligible.

Note: The system does not perform an earning-by-earning estimation. This means that the system counts extra period days as regular days even though the extra period could conceivably pay a different gross amount. The system assumes that payments in regular and extra periods are similar.

The system considers the employee's current job records and accrued seniority earnings, the remaining days in the year, and the pending extra periods in the calculation of estimated fixed income. For seniority earnings, the system uses the effective date data from the Job records.

PeopleSoft Global Payroll for Spain enables you to include future job data events and future seniority events in the year as part of the calculation of estimated fixed income. Use the CLI VR EST FUTURO variable to control this functionality.

With the CLI VR EST FUTURO variable you can specify that the system consider job record data with future effective dates in the estimated fixed income. For example, perhaps an employee's compensation rate in May is 1000 euros but in August this value increases to 1500 euros. To consider job records with future effective dates (future information in the Job record), set the character value of the CLI VR EST FUTURO variable to Y.

With the CLI VR EST FUTURO variable you can also specify that the system calculate future accrued seniority earnings in the year as part of the calculation of estimated fixed income. The system computes the values for each seniority segment using the seniority compensation base elements as of each segment date. For example, if an employee is hired in August 2003 and receives a seniority amount every three years, then in August 2006 the employee is due the increase in seniority earnings. The system thus uses the current seniority earnings amount for January through August and uses the future seniority amount for August through December during the calculation of the seniority portion of the estimated fixed income.

To perform the initial set up of the CLI VR EST FUTURO variable, select Set Up HCM, Product Related, Global Payroll & Absence Mgmt, Elements, Supporting Elements, Variables. Access the CLI VR EST FUTURO variable and set it to the desired character value. The default value of this variable is N. The setting for this variable controls both the future job data and seniority events simultaneously. You can also control this setting by using the supporting element override functionality at the payee level.

Extra Periods and Tax Estimation

For pending extra periods, the system considers extra periods when estimating each member of the tax base through the calculation of pending days to be paid. The system uses a homogeneous distribution of salary along the different payments. The system does not perform an earning-by-earning estimation to determine which earning belongs to which extra period when the tax base using Job compensation data.

If a payee begins working part of the way through the accrual time frame for an extra period, the system prorates the number of pending days to be paid accordingly by dividing the number of days worked in the period by the extra period time frame. For example, let us assume that a payee is hired in November and that payee's labor agreement includes an extra period that is paid in December and accrued from July to December. In this case, the system counts one sixth ($30 \text{ days} \div 6 \text{ months}$) of the extra period when counting the number of days in the estimation period. Therefore, only 5 days would count for the December extra period for this payee.

Determining the End Date for Tax Estimation

The formula CLI FM F FIN EST determines the end date for tax estimation for employees based on the values of the Contract End Date and Contract Expected End Date fields on the Contract Status/Content (CONTRACT1) page. If the Contract Expected End Date field has a value, the system uses that value as the end date for tax estimation. If the Contract Expected End Date field is blank, but the Contract End Date field has a value, the system uses that value as the end date for tax estimation. If both fields are blank, the system uses December 31 as the end date for tax estimation.

In the case where there is a contract end date defined, but no contract expected end date defined, you can override the contract end date by modifying the setup variable CLI VR EST F AÑO. If you change the value of this variable to Y, the system uses December 31 as the end date for tax estimation instead of the contract end date.

Estimating Salary In Kind Income

Although salary in kind is fully taxable, it may contribute fully or only partially to the Social Security base depending on its source. When a company provides salary in kind as part of normal labor agreement or contract agreement, the salary in kind contributes fully to the Social Security base. If, however, the company provides salary in kind voluntarily then a certain amount of it is exempt from contributing to the Social Security base.

To determine whether voluntary salary in kind is exempt, compare the sum of all the earnings considered as salary in kind to 20 percent of the IPREM (*Indicador Público de Renta de Efectos Múltiples*), which is a statutory rate published by the government each year. If the sum of all a payee's earnings does not exceed 20 percent of the professional minimum salary, not all of the salary in kind contributes to the Social Security bases. Any earnings in excess of 20 percent of the IPREM contribute fully to the Social

Security base. When a payee receives more than one earning that is considered salary in kind, you must calculate the individual excess for each earning in proportion to its value.

Examples of different earnings that are salary in kind include housing, loans with an interest rate below the legal interest rate, cars, insurance contributions, and pension plan contributions.

The withholdings associated with the salary in kind can be paid by the employer (withholdings in kind not passed on) or by the employee (withholdings in kind passed on). If a withholding is passed on, it will be discounted in the payroll for the employee as a tax deduction (deduction in kind) (IRPF SPCR). If a withholding is not passed on, the employer will pay the deduction to the tax institution. All the withholdings in kind must be shown in an element IRPF SPC (*Ingresos a cuenta efectuados*) or *In kind withholdings made*.

As a starting point in estimating salary in kind income, the system uses the value in the Annual Benefits Base Rate field on the Benefits Program participation page for estimation of in kind income because this benefits compensation is equal to in kind compensation. You can access this field through the Benefits Program Participation link on the Job Data component.

The system uses the same effective date data from the Job Data component when calculating the estimated in kind income.

Use the CLI VR EST FUTURO variable to indicate whether to include rows of data with future effective dates within the current year in the calculation. Set the character value of the variable to Y to include future data. If you set the variable to N, the system uses the as of date value to perform the estimation of the remaining part of the year. You can set the value for this variable at the element level by accessing it through the Variables component. Select Set up HCM, Product Related, Global Payroll. Elements, Supporting Elements, Variables. You can also set the character value of this variable through the supporting element overrides functionality.

Note: The estimation method that PeopleSoft Global Payroll for Spain uses takes a total annual amount as the base of the estimation. The system does not perform an earning-by-earning calculation

If you enter in kind income through another means, the system might include that in kind income as part of that other category. For example, if you enter the in kind income through the Pay Components group box on the Compensation page of the Job Data component, the system manages the salary in kind as part of fixed income.

Estimating Variable Income

PeopleSoft Global Payroll for Spain enables you to determine at the earning level which calculation method to use for estimating the variable compensation part of the tax base. For example, you might need to change how you estimate the variable compensation because the bonus is following a different schedule compared to last year or a bonus or commission is not being paid anymore this year when it was last year.

You can calculate the variable compensation part of the estimated tax base by using any of these three methods:

- Method 1 is based on last year's values and used for variable compensation that follows last year's schedule.

When you define an earning in PeopleSoft Global Payroll for Spain, you must update some accumulators to define whether the earning is paid and taxable and contributes to social security.

When defining whether the variable earning is taxable, you must assign the CLI AC ING VR1 S accumulator to specific earnings to indicate this estimation method.

This method uses the array TAX AR ING VAR EST to retrieve values from record GPES_TAX2_RSLT, which stores every calculation result. This array adds that part of the variable compensation to each slice between the pay period end date of the previous year and the end date of that same year. For example, if you calculate the estimated variable income for March 2006, the array totals every variable income from April 1, 2005 to December 31, 2005.

- Method 2 is based on last year's values and is used for variable compensation that does not follow last year's schedule.

When you define an earning in PeopleSoft Global Payroll for Spain, you must update some accumulators to define whether the earning is paid and taxable and contributes to social security. When defining whether the variable earning is taxable, you must assign the CLI AC ING VR2 S accumulator to specific earnings to indicate this estimation method.

Use this calculation method when you expect differences in the earnings payment schedule but want to use the previous year's values in the estimation because you do not know the current year's values.

This calculation method uses the previous year's total variable income, rather than a specific period, as the maximum variable compensation (base amount) value for the variable compensation part of the estimated tax base for the current year. Each month the calculation process subtracts the year-to-date variable compensation amount from this base amount to determine the tax base estimation for variable compensation. When the payee reaches the base amount limit, the calculation process does not perform the variable compensation estimation again for the rest of the year. For example, if last year a payee earned 10000 euros and by June of this year the payee has already earned 9000 euros, then the calculation process uses only the remaining 1000 euros as part of the tax base estimation for the variable compensation. When the payee reaches the 10000 euros limit, the system stops calculating the variable compensation estimation and uses the actual data.

- Method 3 is based on current year values and is used for variable compensation for which you know the current year values.

When you define an earning in PeopleSoft Global Payroll for Spain, you must update some accumulators to define whether the earning is paid and taxable and contributes to social security. When defining whether the variable earning is taxable, you must assign the CLI AC ING VR3 S accumulator to specific earnings to indicate this estimation method.

Use this calculation method when you know what is going to be paid this year for earnings of variable compensation. The calculation process estimates the variable compensation part of the tax base based on the information that is already in the system for current-year variable income as entered through payee earnings and deduction assignment. To be able to perform that estimation, you set the variable CLI VR EST ASSIGN to Y.

The system makes no differentiation between fiscal territories when estimating the variable compensation. The system performs the three calculation methods, including the corresponding earnings based on their setup (which CLI VR ING VRx S the earnings contribute to) in each method. The system calculates the variable tax base as a sum of year-to-date value, plus the current month value, plus the estimated value for the remaining months in the year.

Estimating Recurring Income From Earnings Assignments

The above topics explain how the system calculates the estimated portion of each member of the annual tax base (fixed income, in kind income, and variable compensation). You saw that in the case of fixed income and in kind income the starting point of the estimation is the values in the Job Data component. But what happens with other compensation that you do not enter through the Job Data component, compensation that is recurring and that is reasonable to consider as part of the tax base estimation? This other compensation is the type that is entered through the payee earning and deduction assignment functionality. PeopleSoft Global Payroll for Spain enables you to decide whether to consider compensation coming from payee earning and deduction assignments when the system calculates the tax base.

Use the CLI VR EST ASIGN and CLI VR EST ASG SOB variables to control whether to include earnings entered through earnings and deduction assignments as part of the tax base estimation. These variables enable you to include recurring earnings that are not entered through the Job record.

You can override these variables in three ways:

- *Variable definition:* Modify the CLI VR EST ASIGN variable at the variable definition level.

You can define the default value of this Global Payroll variable element during the implementation phase. If you set the default value of the variable to *N*, the system does not perform estimation for the values that you enter through earning and deduction assignments. If you set the variable value to *Y*, the system does perform analysis of earning and deduction assignments as part of the tax base estimation.

- *Earning definition:* Override the CLI VR EST ASG SOB variable at the earning definition level.

You can override the default value of the CLI VR EST ASG SOB variable on the Supporting Element Overrides page of the earnings definition by setting it to *N*, provided that the default value of the variable at the variable definition level is set to *Y*. The system estimates the amounts coming from earning and deduction assignments but bypasses the earnings for which you have set the variable override value to *N*. Oracle recommends that if you are using earning and deduction assignments to override values coming from the Job record, you set the variable value of the earning to *N* at the earning level. Otherwise, the system might count the earning twice—once through the Job Data component and once through the earning and deduction assignment. This override level affects the specific earning for every employee.

- *Supporting element override:* Override the CLI VR EST ASG SOB variable value of a basic or recurring earning for a specific employee.

You can do this by using the supporting element overrides functionality within the components of the Earnings and Deductions Assignments menu by changing the character value of the CLI VR EST ASG SOB variable to *N*. This override level affects that specific entry (earning and payee combination) only.

Earnings are categorized as either fixed, in kind, or variable income at the earning level. When you create earnings in PeopleSoft Global Payroll for Spain you must assign the earning to certain accumulators to define whether the earning is payable and taxable and whether it contributes to social security. Regarding taxes, you include the earning in a different accumulator depending on its categorization. For example, you include fixed income in the accumulator CLI AC ING DIN FJO. This categorization enables the calculation process for the tax base estimate to split earnings entered through earnings and deduction assignments into their appropriate categories for the estimation. The system determines which member of the tax base (fixed, in kind, variable) the earning belongs to by checking which accumulators the earning

is a member of in the earnings definition. The system then adds the earning to the corresponding member of the tax base.

When the take base estimation process reads the earning and deduction assignment and performs the corresponding calculation and frequency conversion, the system performs an earning-by-earning estimation. This means that the system determines the extra periods to which each earning belongs when it calculates the number of days in the year. When the tax base estimation process evaluates an earning, it takes into account whether the earning is included in pending extra periods. To calculate an annual amount, the system multiplies the earning amount by the specified frequency (element frequency or calendar period frequency). Then the system calculates the daily value by dividing the annual amount by the total number of days in the year. When calculating the number of days in the year for an earning, the system again takes into account the extra periods that include that earning. For example, let us assume that an employee who is paid monthly has two extra periods that both include earning A. The total number of days in the year for earning A would be then be 360 for the year, plus another 30 days for each extra period, for a total of 420 days. After the system calculates the daily value for an earning, it calculates the amount for the remaining part of the year by multiplying the daily amount by the remaining number of days. When calculating the remaining number of days, the system once again takes into account the extra periods pending payment.

Note: When the system calculates the number of days in an estimation period, it includes the number of days from extra periods that are paid in the estimation period. If a payee begins working part of the way through the accrual time frame for an extra period, however, the system does not pay the extra period 100%. Instead the system determines the number of worked days. It prorates the number of pending days to be paid by dividing the number of days worked in the period by the extra period time frame. For example, let us assume that a payee is hired in November and that payee's labor agreement includes an extra period that is paid in December and accrued from July to December. In this case, the system counts one sixth of the extra period when counting the number of days in the estimation period. Therefore, only 5 days would count for the December extra period for this payee.

Annualizing Income from Earnings Assignments

The system annualizes earning assignment income based on the value you select in the Frequency Option field on the Element Detail page for the assignment:

- *Use Calendar Period Frequency:* If you select this value, the system assumes that the entered amount for the earning is a monthly amount for the purposes of determining the annual conversion factor. In addition, the system takes into account any extra periods to which the earning applies. For example, if an earning gets paid in two extra periods, the annualization factor is 12 (regular monthly payments) + 2 (extra periods) for a total of 14.
- *Use Element Frequency:* If you select this value, the system determines the annualization factor based on the frequency specified at the earning level. If the frequency option for the earning is *Use Calendar Period Frequency*, the system calculates the annualization factor as explained above.
- *Use Specified Frequency:* If you select this value, the system determines the annualization factor based on the value you enter in the Frequency field on the Element Detail page.

Tax Estimation Adjustment

Normally, PeopleSoft Global Payroll for Spain estimates the tax base for a payee using that payee's job data and assigned earnings and deductions. You can adjust this tax estimation by including compensation

calculated during payroll processing. To enable the inclusion of earnings from payroll processing in tax base estimation, set the value of the variable CLI VR EST FLX AJT to Y.

Estimating Irregular Income

Irregular income occurs due to having a generation period over two years. Irregular income receives special tax treatment because the whole income is added to the annual fixed income, but at the same time 40, 50, or 70 percent of that amount is considered as a deduction as part of the tax calculation process (similar to the available deduction calculation process). Therefore, during tax percentage calculation, the system reduces the taxable base of irregular income by the corresponding percentage.

Estimating Taxes Based on Schedule

Companies can enter compensation for part-time employees from a variety of sources such as the Job component, and earnings assignment. They can enter theoretical compensation and apply the full-time equivalent to determine compensation for part-time employees or they can enter compensation directly that is already reduced based on the schedule. PeopleSoft Global Payroll for Spain has two categories for part-time employees:

- *Regular part-time:* These employees have a daily or weekly recurring schedule. The system treats them as full-time employees, but with a reduced daily schedule. You identify them in the system by overriding the variable CLI VR RED JORNADA with the number of working hours per day.
- *Irregular part-time:* These employees do not have a recurring schedule. They are paid a different amount each month depending on how many days they work.

PeopleSoft Global Payroll Spain provides flexibility in setting up the system for both types of part-time employees.

Note: PeopleSoft Global Payroll for Spain takes into account every schedule assigned to an employee when calculating scheduled hours for the estimation period. This means that the system includes schedule assignment changes when calculating scheduled hours.

Part-Time Factor Calculation

The variable TAX VR FTE FCT determines the part-time factor that the system applies to the estimated tax base. PeopleSoft Global Payroll Spain performs a different calculation of the part-time factor depending on the type of employee. For regular part-time employees this factor is usually just the entered full-time equivalent (FTE), but for irregular part-time employees, the system performs a more complex calculation based on the number of hours defined at the employee work schedule level.

For irregular part-time employees the part-time factor is equal to the number of scheduled hours for the estimation period divided by the total number of theoretical hours for the estimation period. The system retrieves the number of scheduled hours from the schedule definition assigned to a payee. The system retrieves the number of theoretical hours from the labor agreement definition.

Note: To determine the total number of theoretical hours for the estimation period, the system prorates the labor agreement hours associated with the estimation period.

Part-Time Tax Estimation Formulas

There are several formulas you can use to manually affect the calculated tax estimation for part-time payees:

Formula	Description
CLI FM SBR FCT FTE	<p>Overrides the part-time factor.</p> <p>By default, the system calculates FTE depending on the type of employee. For irregular part-time employees it calculates FTE as the number of scheduled hours divided by the number of theoretical hours for the estimation period. For full time and regular part time employees, the system uses the FTE entered in the Job component. You can modify the formula's code to manage calculation of FTE based on your specific requirements.</p>
CLI FM SBR FLX AJT	Affects the calculated tax estimation through the tax estimation adjustment functionality.
CLI FM APL FTE JOB	<p>Determines whether the system applies the FTE factor to the compensation that is entered in the Job component. You can modify the code to define the rules that apply the factor. The default value of the formula is <i>N</i>, which tells the system to assume that the compensation coming from the Job component already includes the FTE.</p> <hr/> <p>Note: The standard solution for this formula assumes that the compensation from ANNUAL_RT in the JOB_DATA table was entered already reduced or already affected by the FTE.</p>
CLI FM APL FTE E&D	Determines whether the system applies the FTE factor to compensation entered through earning and deduction assignment. The default value is <i>Y</i> (yes).
CLI FM APL FTE FXL	<p>Use to apply the FTE factor to flexible compensation.</p> <p>Determines whether the system applies the FTE factor to flexible compensation. The default value is <i>Y</i> (yes).</p>

Defining Custom Rules for Tax Base Estimation

PeopleSoft Global Payroll for Spain provides an alternative way to calculate the tax base by delivering two configurable formulas that your implementation team can use to set up custom requirements for estimating tax base. These configurable formulas are distinct from the delivered tax base estimation formulas so that modification and use of these configurable formulas does not affect the maintenance of the standard delivered formulas.

The configurable formulas are:

- *CLI FM CALC ING A*: Use this formula to write your own code for calculating the estimated tax base without using the delivered calculation method. The code that you enter in this formula overrides the whole tax base. You can use this formula to provide an override to the calculated tax base by assigning the value to the element through any mechanism that Global Payroll core provides to override supporting elements.
- *CLI FM EST OTROS*: Use this formula to include other earnings in the tax base calculation in addition to the ones entered through the Job Data component, through the components in the Earning and Deduction assignment menu, or through flexible compensation.

Custom Designated Estimation

Implementation teams can define the details of the *CLI FM CALC ING A* formula to override the delivered tax base estimation functionality by developing custom requirements for estimating tax base. PeopleSoft Global Payroll for Spain delivers this formula with no value. Implementers can add code to perform the tax base estimate calculation and retrieve a value. To override the calculated value for this formula, users can enter a value into this formula at the payee level as an override. The system then uses the override value rather than the calculated value.

Note: If the value of this formula is anything other than 0, the system assumes that you are using this formula to calculate estimated tax base through your own method rather than the delivered method, or that you are overriding the estimated tax base with a specific value. The system therefore does not use the delivered method to calculate the estimated tax base.

Custom Other Earnings Estimation

Implementation teams can define the details of the *CLI FM EST OTROS* formula if they want to use the delivered tax base estimation rules but have other earnings from other sources (such as from brackets, formulas, or custom compensation records) that they want to include in the estimate besides the ones from the job record or earnings and deduction assignments. These additional earnings are added on top of the tax base members (fixed, in kind, and variable).

To use this functionality, implementers can code the delivered *CLI FM EST OTROS* formula so that the system includes compensation from other sources in the estimated tax base. The system adds the results of this formula to the standard members of the tax base without affecting the delivered standard rules for the calculation.

When coding this formula, implementers may need to update values of the following variables:

- *TAX VR EST AÑO BR*: Use this variable to add value from other compensation to the estimated fixed amount.
- *TAX VR EST AÑO VR*: Use this variable to add value from other compensation to the estimated variable amount.

- *TAX VR EST AÑO SP*: Use this variable to add value from other compensation to estimated in kind compensation amount.

These variables are added to each member of the tax base in the standard formulas. Implementers need to add their calculated amounts to those variables so that the customer design is integrated in the standard design. For example:

$TAX VR EST AÑO BR + New Element1 = TAX VR EST AÑO BR$

$TAX VR EST AÑO VR + New Element2 = TAX VR EST AÑO VR$

$TAX VR EST AÑO SP + New Element3 = TAX VR EST AÑO SP$

Where

New Element1 represents the amount calculated by CLI FM EST OTROS corresponding to fixed income.

New Element2 represents the amount calculated by CLI FM EST OTROS corresponding to variable income.

New Element3 represents the amount calculated by CLI FM EST OTROS corresponding to in kind income.

Setting Up Tax Base Estimation Variables

You can use the following variables to define how you want the system to calculate the tax base estimation:

- *CLI VR EST FUTURO*: At the variable definition level, use this variable to control when the system includes future information from the Job record (annual fixed income and annual in kind income) and future seniority increases in addition to current information.
- *CLI VR EST ASIGN*: At the variable definition level, use this variable to control whether the system includes future information for earnings that are entered through earning and deduction assignments as part of the tax base estimate calculation
- *CLI VR EST ASG SOB*: At the Supporting Element Overrides portion of the earning definition level, use this variable to control whether the system includes the earning in the tax base estimate calculation when the earning is entered through the Earnings and Deduction Assignments components. At the earnings and deduction assignment level, use this variable to control whether the system includes the earning in the tax base estimate of the specific employee.

These variable elements have a definition value as defined through the Variable component (Setup HCM, Product Related, Global Payroll & Absence Mgmt, Elements, Supporting Elements, Variable, Definition). This value is the default value for every employee. You can override the default value at these levels: pay entity, pay group, payee, calendar, element definition, and positive input (using Global Payroll core override functionality).

Overriding Estimated Tax Base Values

PeopleSoft Global Payroll for Spain enables you to override each member of the estimated tax base or the final estimated tax base. Use the following elements to override the value of specific parts of the calculated tax base estimate:

- *CLIFM CALC ING A*: Override the annual income calculation value.
- *CLIVR FIJO SOB*: Override the annual fixed income value.
- *CLIVR SPC SOB*: Override the annual salary in kind value.
- *CLIVR VRBLE SOB*: Override the annual variable income value.

The system uses the override values that you enter instead of the calculated values for the corresponding part of the tax base estimate. You perform these overrides using the supporting element override functionality.

Adjusting Tax Estimation

Element Name

Enter the earning that you want the system to include in the tax estimation process, which is performed based on the resolved amount during payroll calculation. The system uses the accumulators to which the earning is assigned to determine whether the earning counts as fixed income, variable compensation, or in kind income.

Entry Type and Element Name

Select the type and name of the element that represents the value that the system uses to calculate tax estimation. Typically, you would select the automatically assigned rate component of the earning because it normally contains the daily value of the earning.

Frequency

Select the frequency by which the system annualizes the value you enter in the second Element Name field.

After determining the annual value, the system calculates a daily value by dividing the annual amount by the total number of days in the year. When determining the total number of days in the year, the system also considers the extra periods that the earning defined in the first Element Name field belongs to.

Finally, the system calculates the estimation for the remaining part of the year by multiplying the daily calculated amount by the remaining number of days. When determining the remaining

number of days, the system also considers the pending extra periods in the estimation period, but counts only the ones in which the earning is included.

When the specified frequency type is daily, the system uses the value of the Entry Type element name as the daily amount and multiplies it by the remaining days of the estimation period (including extra period days). This bypasses the normal annualization and deannualization processes.

Calculating Tax Percentages

Estimating the Social Security Contribution

When the taxable base has been calculated, the system subtracts the employee's annual social security contribution if the employee is associated with the state territory.

Note: For employees associated with one of the historical territories, the social security contribution is not used in the IRPF calculation.

The system estimates social security contributions as two segments: the actual social security contributions year-to-date and the estimated value for the rest of the year. The amount remaining after subtracting the annual social security contribution from the estimated tax base is the *Rendimiento neto del trabajo* (RNT). To calculate RNT, the system uses the social security contribution accumulator (TAX AC SS CT A) for the actual year-to-date contribution and estimates future contributions. These calculations are made in the formula TAX FM CT SS EST. After the system deducts social security contributions, it applies a second reduction for irregular income to determine RNT.

RNT is subject to deductions for salary level, disability, personal minimum deductions, family minimum deductions (dependents), alimony, and irregular income.

Calculating Available Deductions

For employees associated with the state territory, the third step in the IRPF calculation is the calculation of deductions.

Note: This step does not apply to employees associated with any of the historical territories.

The system calculates the ART18 reduction, the personal minimum reduction, and the familiar minimum reduction.

The ART18 reduction is based on income level, disability, geographical mobility, and worklife extension. The system compares both values to ranges in the system to determine the reduction amounts using the formula TAX FM RD ART 18.

The personal minimum reduction is based on age and disability. The system compares both values to values in the system to determine the reduction amounts using the formula TAX FM RD MN PERS.

The familiar minimum reduction is based on dependents, both children and adults. The system considers the total number of dependents, their ages, their degree of disability, and their level of dependency on the employee. The system calculates these deductions using the formula TAX FM RD MN FAML. The system uses the formula TAX FM FAM NUM to calculate the reduction when a payee has more than two descendants.

The system also calculates a reduction for spouse support garnishments using the array TAX AR RET JUDIC.

Calculating the Withholding Percentage

Once the system has calculated the taxable net base and the personal and familiar minimum reductions, it calculates the withholding percentage. The system employs different formulas, depending on the fiscal territory:

- For the state territory, the system uses the TAX FM CT IRPF EE formula to compare the taxable net base with the income ceilings defined on the Tax Ceiling page and generate the total contribution amount.

The system calculates the contribution using two factors: Quota 1 and Quota 2. Quota 1 is the result of applying a bracket to the total taxable base. Quota 2 is the result of applying the bracket to the personal and familiar minimum reductions. The total contribution quota = Quota 1 – Quota 2.

For payees paying alimony for child support the system uses a special calculation for the total contribution quota.

See [Calculating Garnishment Taxation](#).

After the system calculates the total contribution quota, it determines the withholding percentage using the formula TAX FM PCT IRPF EE. The system applies the active reductions to the contribution and divides that value by the total taxable income to determine the withholding percentage. There are certain limits on the final percentage in the absence of regularization. When you do run the regularization process, the system uses the formula TAX FM REGULARZN to comply with legal requirements.

- For historical territories, the system uses the formula TAX FM HT PCT EE to calculate the Withholding percentage. The formula compares the taxable net base with the Withholding Brackets

for the historical territory. For disabled payees, the system adjusts the percentage by subtracting the Disability Bracket percentage from the Withholding Bracket percentage.

PeopleSoft Global Payroll for Spain delivers and maintains tax brackets. You can view and update tax brackets using the Withholding Segments page.

Payees can increase their percentage using the Tax Percentage Override page. However, if the override is lower than the calculated percentage, the system uses the higher amount. You cannot use the Override Tax Percentage ESP page to reduce the tax percentage.

Calculating Garnishment Taxation

For the state territory, two garnishment types are available that affect tax calculations: child support and spousal support. For the historical territories, the only garnishment that affects tax calculation is the spouse support garnishment.

If a payee has a child support garnishment, the system estimates the annual value for this garnishment (or estimates the value for the remainder of the contract). Then, the system calculates separate contribution amounts for the garnishment and for the remainder of the taxable net base. Like the calculation used for standard state territory withholding, the calculation for payees with child support garnishments is Quota 1 – Quota 2. In the case of garnishment taxation, however, Quota 1 = Quota 1.1 + Quota 1.2 where Quota 1.1 is the result of a bracket applied to the garnishment amount and Quota 1.2 is the result of the bracket applied to the taxable net base.

For example, assume a taxable net base of 22.625,19 EUR and an estimated annual garnishment amount of 2.704,55 EUR. The bracket calculations would be applied to 2.704,55 EUR and 22.625,19 EUR separately generating two contribution amounts, TAX VR CT1 IRPF (Quota 1.1) and TAX VR CT2 IRPF (Quota 1.2). The system then combines these amounts into TAX VR CT IRPF (Quota 1), which is used to calculate the tax percentage.

In addition, when calculating Quota 2 by applying the brackets to the personal and familiar minimum reductions, the system adds a fixed statutory amount.

For the state territory, the system subtracts the spouse support garnishment annual estimation from TAX VR RNT as a special reduction.

For the historical territories, the system subtracts the spouse support garnishment from the annual income to calculate the taxable base.

Understanding Tax Calculation Results

When the system has calculated the taxable income base, the annual tax contribution, and the withholding percentage, you can view the results by pay group on the IRPF Calculation Results ESP component. Use this component to view all information that the system uses to calculate the IRPF percentage, including personal data and financial data. Also use this component to review the earnings and deductions that make up a selected payee's base amount for IRPF tax withholding. You may also find this component useful for explaining IRPF percentage variations to employees.

Note: You can review IRPF data, including withholding percentages after you run the current payroll process. To have IRPF calculations reflect the payroll data computed for the current period, review the IRPF data after running the payroll process.

Understanding IRPF Tax Data Review

You can use the IRPF Tax Data Review ESP component to view the monthly IRPF tax data that the payroll process generates for employees and, if necessary, to manually adjust this data. You can also use this component to view accumulated tax data for the year. In the case of special collectives for whom the payroll process does not calculate IRPF tax data, such as professionals, you can use this component to enter the IRPF tax data for the person. The system stores the data that is viewable through this component in the GPES_TAX2_RSLT table. The report generation processes use this data for the Model 110, Model 111, and Model 190 reports.

PeopleSoft Global Payroll for Spain also provides the IRNR Tax Data Review ESP component for you to view tax data that the payroll process generates for nonresident workers. In addition, IRNR tax reporting functionality is available for creating the Model 216 and Model 296 reports.

Understanding the IRPF Comparison Report

This new SQR report helps you identify changes in IRPF percentages and determine whether these changes are justified or adjustments are needed.

For each payee and month covered by the report, the report lists the following information:

- Month to which the values pertain (1 = January, 2 = February, and so on).

- Information that affects the payee's tax calculation, such as disability, help needed, mobility reduction, family situation, type of working relationship, and number of dependents as of the end of the reported month.
- Amount of taxable earnings (the base amount) on which the IRPF percentage has been calculated.
- The IRPF percentage.
- Social security contribution.
- Legal reductions to the base amount.
- Irregular income.
- Taxes paid from January through the reported month.
- Accumulated taxable base from January through the reported month.

You can generate the report for all payees in selected companies, pay entities, or pay groups, or you can produce the report for specific tax locations or selected employees. You can also have the report include only those payees for whom the difference in the last IRPF percentage and the new IRPF percentage meets or exceeds a certain percentage.

Understanding Employee Withholding Percentage Overrides

The system automatically calculates employees' withholding percentage. However, employees can choose to increase their percentage using the Override Tax Percentage ESP page.

Note: If the override is lower than the calculated percentage, the system uses the higher amount. You cannot use the Override Tax Percentage ESP page to reduce the tax percentage.

Adding IRPF Tax Data Manually

The IRPF Tax Review page enables you to add tax data for payees manually by using the Add a new row button. You would typically do this for payees who are paid through an external system outside of PeopleSoft Global Payroll for Spain, but who you want included in monthly and yearly tax reports.

You can also add IRPF data rows for payees processed by PeopleSoft Global Payroll for Spain to capture income for different perception key and subkey combinations. You can only do this for payees who belong to a calendar group that has been finalized.

You can delete rows only for manually added IRPF data. You cannot delete data rows that are the result of a PeopleSoft Global Payroll for Spain payroll run.

Also update the Normalization Schedule ESP page to calculate withholding while you run payroll. You can also run the IRPF percentage calculation separately by creating a specific calendar and calendar group for the IRPF percentage calculation.

PeopleSoft Global Payroll for Spain provides the following information in accordance with government regulations:

- Fiscal territories and data for tax calculations.
- Minimum annual contribution amounts.
- Total contribution per taxable base.
- Reduction amounts based on personal data (age and disability status), family data (number of dependents, disability status, and degree of dependency), and work situation (contract type and tax location).

PeopleSoft Global Payroll for Spain enables you to calculate tax percentage independently or while running the payroll process. Use the Normalization Schedule ESP page and the Fiscal Territories page to coordinate the tax calculation and payroll process.

Maximum Dependent Age

The maximum age of fiscal dependents.

Non-resident Withholding

Enter the withholding percentage for nonresidents. If the payroll process identifies an employee as a nonresident, it applies this percentage to the employee's withholding instead of the withholding percentage that corresponds to IRPF taxes.

Withholding Bracket

Payee Data

In the Payee Data group box, define the details for an employee as they relate to tax calculation.

Effective Date

You must enter a new effective date every time any information related to tax calculation changes, including data that appears as display-only.

Disabled

Selected if you indicate that the employee is disabled on the Disability page in PeopleSoft HR.

Handicap Percent

If the employee is disabled, the handicap percent appears. This information comes from the Disability page in PeopleSoft HR.

See "Tracking Disabilities (*PeopleSoft HCM 9.2: Human Resources Administer Workforce*)".

Address Type	Select the address type to be used in tax reporting. Values are <i>HOME</i> and <i>MAIL</i> .
Fiscal Territory	Select the fiscal territory to which the employee pays tax. The fiscal territory that you select affects the fields that are displayed on the page. Values are <i>Alava Fiscal Territory</i> , <i>Guipuzcoa Fiscal Territory</i> , <i>Navarra Fiscal Territory</i> , <i>State Fiscal Territory</i> , and <i>Vizcaya Fiscal Territory</i> .
Relationship Type	Define the contract type as agreed between the employee and the company. Values are: <ul style="list-style-type: none"> 1. - <i>General Relationship</i>: For all other situations. 2. - <i>Less 1 year relationship</i>: For contracts with a duration of less than 1 year. 3. - <i>Special Relationship</i>: For special contracts, such as those for special collectives (for example, for consultants).
Family Situation	This field is displayed if you select <i>State Fiscal Territory</i> in the Fiscal Territory field. Select the family situation of the employee, as defined by the government. Values are: <ul style="list-style-type: none"> 1. - <i>With fiscal dependent</i>: The employee has dependents to support. Some dependents are recognized by Hacienda as fiscal dependents. Qualifying someone as a fiscal dependent affects an employee's tax calculation. 2. - <i>With spouse to support</i>: The employee has a spouse to support. 3. - <i>Other situations</i>: The employee does not have fiscal dependents or a spouse to support.

Dependent Data

In the Dependent Data group box, define the details for an employee's dependents as they relate to tax calculation.

Dependent ID	Select the dependent/beneficiary ID for the employee.
Name	Displays the name of the dependent.
Relation	Displays the relation of the dependent to the employee.
Birthdate	The birth date of the dependent.
Adoption Date	Enter the date that a dependent is adopted.
Disabled	This field is displayed if you select <i>State Fiscal Territory</i> in the Fiscal Territory field only. It displays disability information entered for the dependent on the Dependent Data page in PeopleSoft HR. This information is used for calculating an employee's taxes.
Handicap Percent	This field is displayed if you select <i>State Fiscal Territory</i> only. Define the percentage of the handicap for the dependent. This information is used for calculating an employee's taxes.
Reduced Mobility	Indicates reduced mobility for the dependent.
Dependency Percentage	This field is displayed if you select <i>State Fiscal Territory</i> only. Enter a percentage that indicates the level of dependency. For example, 100% means that the person is completely dependent on the employee.
Need Assistance	Indicates whether the dependent needs assistance.

Relationship Types and the Minimum Tax Rate

The system taxes payees with a relationship type of 2. - *Less 1 year relationship* in one of two ways:

- If the calculated tax rate is higher than the minimum rate (2%), the system applies the calculated rate.
- If the calculated tax rate is lower than the minimum rate (2%), the system applies the minimum rate.

For payees with a relationship type of any other value, the system references the Contract Status/Content page to determine the contract duration. The system calculates the contract duration using the values in the Contract Begin Date and Contract End Date fields. If the Contract End Date field is blank, the system uses the contract expected end date as the contract end date.

If the difference between a payee's contract begin and end dates is less than one year, the system taxes that payee as if she had a relationship type of 2. - *Less 1 year relationship*.

If both the Contract End Date and Contract Expected End Date fields are blank for a payee, the system calculates tax for the payee normally.

See "Tracking Workforce Contracts (*PeopleSoft HCM 9.2: Human Resources Administer Workforce*)".

PeopleSoft Global Payroll for Spain enables you to override these normal taxation rules so that you can apply the ceiling of 2% in special circumstances. You can define the way the system applies this limit (2%) to comply with your organization's interpretation of the law. PeopleSoft Global Payroll for Spain applies the same logic for all state and historical territories.

Use formula CLI FM APL LIM 2% to define the conditions under which the system should apply the minimum ceiling. When modifying this formula, you should take into consideration:

- Assign a value other than 0 to the formula CLI FM APL LIM 2% to indicate that the code has been modified.
- New code for formula CLI FM APL LIM 2% needs to assign a value of 2 to the variable TAX VR REL LABORAL to indicate that the check of the minimum ceiling is to be performed.
- New code for formula CLI FM APL LIM 2% needs to assign a value of 2 to the variable TAX VR PCT IRPF for any cases in which you want to apply the limit of 2%. The new code also needs to manage situations in which employees work in Ceuta or Melilla.

For example, assume that you want to apply the minimum ceiling for temporary contracts with a duration of less than one year. In that case, you could modify the formula CLI FM APL LIM 2% in this way:

Select to indicate that the employee is displaced and this transnational mobility requires changes to the employee's payroll calculations. By default, the system deselects this check box.

Fiscal Residence Data

Use the fields in this group box to select the fiscal resident data that the system uses for the employee when you create the Model 296 file.

Country

Select the country where the employee resides. The system reports this value when you create the Model 296 file. If the employee's country of residence changes, you must update this value so that the Model 296 file reports the change.

National ID Type

Select the national ID type that you want the Model 296 file report to use for the employee. You can choose from among the national ID types defined for the employee on the Biographical Details page. If you leave this field blank, the Model 296 file report uses the first national ID type defined for the employee on the Biographical Details page that is associated with the country selected in the Country field. If no national ID type is defined for the selected country, the Model 296 file report does not include the employee's national ID.

Address Type

Select the address type that you want the Model 296 file report to use for the employee. You can choose from among the address types defined for the employee on the Contact Information page. If you leave this field blank, the Model 296 file report uses the first address type defined for the employee on the Contact Information page that is associated with the country selected in the Country field. If no address type is defined for the selected country, the Model 296 file report does not include the employee's address.

Payment Features

Pay Compensation

Select to have the payroll process pay the net pay amount.

Deselect this check box to have the payroll process calculate the net pay amount and then add a deduction to force the net pay amount to zero, thus canceling the employee's compensation.

This is necessary if you want to calculate just the employee's social security contributions or tax withholding. The system uses the DD COMP EXPTR deduction element to store the deduction amount that forces the net pay to zero balance. The system selects this check box by default.

To have the payroll process calculate compensation for displaced and expatriate employees, you must also assign to the employee the applicable earning and deduction elements according to the employee's situation.

Taxes Calculation

Select how the payroll process calculates taxes for the employee. Values are:

- *IRNR (Non-residents Not Taxed)*: Select to designate the payee as a tax exempt nonresident. The system applies a tax percentage of 0% to payees with this designation.

The system reports income for nonresident, untaxed payees on a monthly or quarterly basis (Model 216) and on a yearly basis (Model 296). PeopleSoft Global Payroll for Spain stores monthly income and deductions in record GPES_EXPT_RSLT and extracts data from it during report processing.

- *Not calculate*: Select this value if you do not want the payroll process to calculate taxes for the employee.

When you select this value, PeopleSoft Global Payroll for Spain does not calculate tax deductions for the payee and doesn't include the payee in resident or nonresident reports. The system does, however, store the monthly income for the payee in record GPES_TAX2_RSLT, but with a false, placeholder year so that the system excludes the data during report processing.

- *Pay IRNR (Non-resident Taxes)*: Select this value to have the payroll process calculate IRNR taxes for nonresidents. The system calculates the tax deduction for these types of payees as a fixed percentage. You can modify the fixed percentage in the Non-resident Withholding field on the Calculation Data page.

The system reports taxes for nonresident payees on a monthly or quarterly basis (Model 216) and on a yearly basis (Model 296). PeopleSoft Global Payroll for Spain stores monthly income and deductions in record GPES_EXPT_RSLT and extracts data from it during report processing.

- *Pay IRPF (Regular Taxes)*: Select this value to have the payroll process calculate regular IRPF taxes for employees who are considered residents. The system selects this value by default.

The system reports taxes for resident payees on a monthly or quarterly basis (Model 111/ Model 110) and on a yearly basis (Model 190). PeopleSoft Global Payroll for Spain stores monthly income and deductions in record GPES_TAX2_RSLT and extracts data from it during report processing. The system also retrieves date from this record during tax percentage calculation (payroll process) to get the year to date income and taxes (actual).

Social Security Calculation

Select to have the payroll process calculate social security contributions for the employee and the employer. Deselect this check box if you do not want the payroll process to calculate social security contributions. PeopleSoft Global Payroll for Spain provides functionality to allow reimbursement of the amount paid directly by the employee to the social security agency. The system selects this check box by default.

To have the payroll process calculate social security contributions, you must also assign to the employee the applicable earning and deduction elements according to the employee's situation using the Assign Elements By Payee page.

- Model 111 report (*Modelo de declaración de retenciones e ingresos*). Use this report to declare employee deductions on a monthly basis. For companies with an annual turnover of fewer than 6 million EUR, you can run this report quarterly.
- Model 190 report, an annual summary of deductions.

PeopleSoft Global Payroll for Spain provides functionality to facilitate completion of the Model 111 and Model 110 reporting for historical territories. If you select to generate report data for an historical territory, the process generates a free format file that contains the information that needs to be reported. You can then use this file as a reference when entering reporting data on the official website of the historical territory.

Understanding the Tax Deductions Report

PeopleSoft Global Payroll for Spain provides an additional tax report, the Tax Deductions Report (*Certificado de Haberes*). The system generates the report in one of two formats, depending on whether the employee is a resident or nonresident. For residents, the system generates the Annual Deduction Report (GPESTAX1). For nonresidents, the system generates the IRNR Annual Deduction Report (GPESIRNR).

As an employer, you are obliged to issue the Annual Deductions certificate for every employee before the beginning of the income tax return period.

The report must include fiscal data on the employer and the employee, as well as all of the deductions for an employee, including annual social security deductions and annual tax deductions. Use this document to submit employee income tax returns.

The information in the Tax Deductions Report has the same data as the 190 Model, but for individual employees.

Use the tax process component to determine which accumulators appear on this report.

Common Elements Used to Run Legal Reports

Fiscal Territory	Select the fiscal territory to which the report will be submitted.
Company	Select the company for which the report will be submitted.
Calendar Year	Select the reporting year.
Person ID	Select the ID for the person who sends the report.

File Path	Enter the path where you want the process to store the model file.

Contact Name	Select the contact's name.
Contact Phone	Displays the contact's phone number.

For the state territory, the process generates a flat file that you can electronically import into the official program provided by the tax authorities. For historical territories, the process generates a free format file

that contains a readable summary of the information that you need to report. You can then use this file as a reference when entering reporting data on the official website of the historical territory. The file name that the process generates for historical territories is the file name that you specify plus the letter *S* at the end.

Report Request Parameters

Model

Select the report that you want to run: *Monthly* or *Quarterly*. Your selection determines whether the system displays a Quarter or Month field.

Fiscal Territory

Select the fiscal territory for which you are generating the model file. The system prompts you to select from the available tax locations. Based on your selection, the process properly formats the files that it generates for the state or historical territory.

Note: If you select the *HFA* (Alava Fiscal Territory) value in this field, the Sender Data group box contains the fields Company, Description, and Fiscal Code.

Month

This field appears if you select *Monthly*. Select the year and reporting month.

Quarter

This field is appears if you select *Quarterly*. Select the year and the quarter for the report.

Declaration Type

Select the declaration type of the report for the state territory.

Values are:

- *Direct Debit:* Select when the payment is by direct debit from a customer account.

When you select this value, the Source Bank field becomes available.
- *Negative:* Select when the reported amount is a negative value.
- *Pay In:* Select when the payment will be done through deposit..
- *Tax Agency Account:* Select when the payment is by bank transfer to a Tax Agency account.

Sender Data

Enter the ID of the company's primary point of contact in the Person ID field. The populates the other fields in this group box based on your selection.

Note: If you select the *HFA* (Alava Fiscal Territory) value in the Fiscal territory field, the Company field replaces the Person ID field in this group box. Managing Pension Plans

Understanding the Pension Plan Business Process

A pension plan is a product that enables you to save earnings and accrue capital. Employees can withdraw at retirement or due to disability; beneficiaries can withdrawal due to death of the employee. Pension plans also provide fiscal savings in your *Impuesto sobre la Renta de las Personas Físicas* (IRPF) income tax.

Both the promoter (company) and the contributor (employee) can make contributions to an employee's pension plan. A promoter is the organization that participates in the constitution of funds based on the terms regulated by law. A contributor is the employee for which the pension plan is created.

When the company contributes to an employee's pension plan, the system considers this earning as salary. It is therefore taxable. Depending on the pension plan definition, it can also be contributive. The amount appears as an earning in kind on the affected employee's payslip and in the Tax Deductions report. Earnings in kind are goods or services that employees receive as a benefit for free or for a reduced price.

When employees contribute to pension plans, companies can administer these employee contributions by deducting the amount from employee payrolls. The amount appears as a deduction on the affected employee's payslip.

PeopleSoft Global Payroll for Spain supports the following types of pension plans:

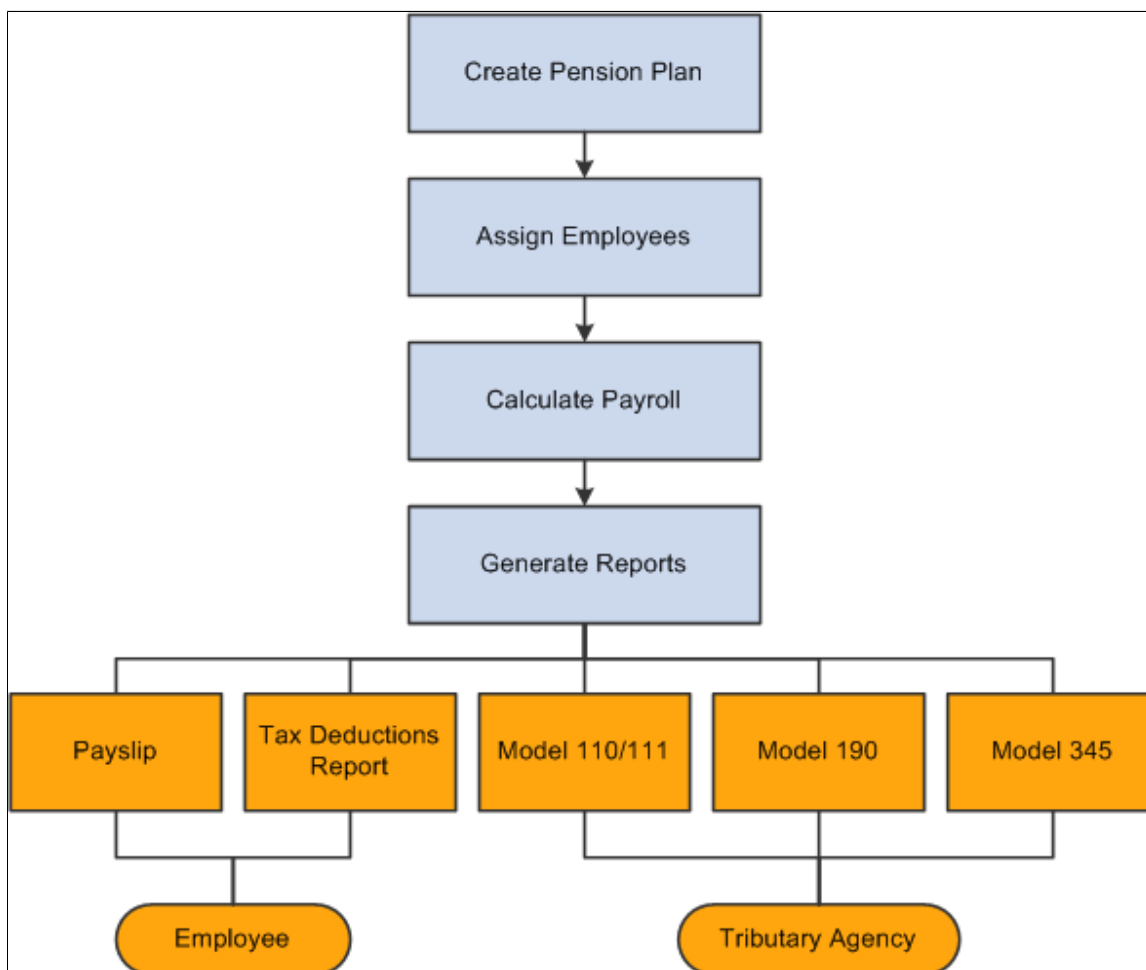
<i>Pension Plan Type</i>	<i>Description</i>
Individual System	<p>A pension plan in which the promoter is an entity and the contributors are persons.</p> <p>In an individual system pension plan the company makes the annual contributions either annually or periodically. These contributions are considered earnings in kind. These contributions are considered earnings in kind. They are tax-free and, when the contributions are not an improvement to retirement benefits or are made by the promoter, they are contributive.</p> <p>Companies can also make deductions directly for the employee using a payroll deduction.</p>

You define whether a pension plan is based on the individual or collective employees through the Pension Plan Type field on the Pension Plan page.

Amount

Enter the monetary contribution amount that you want the payroll process to use for the employee's pension plan contribution during the affected months.

Currency Code

Enter the currency for the contribution amount.

Understanding Model 345 File Generation

The Model 345 file is a report that contains all of the pension plan contribution data pertaining to a selected fiscal territory and calendar year for all employees with collective pension plans when the company is the promoter of the pension plan. Companies must generate and submit this file once at the beginning of each year for the preceding year within the legally established timeframe.

PeopleSoft Global Payroll for Spain enables you to generate the file version of the Model 345 in the required format. You can use the Create 345 Model File ESP component (GPES_RC_TAX_345) to generate a file version of the Model 345 report to reflect the contributions made by the company to employees' pension plans. The file contains each employee who has a pension plan within a selected fiscal territory and calendar year.

The Model 345 application engine process (GPES_TAX_345) also generates a summary page file. The summary report is a text file that states the total companies, total employees, and total contributions that were processed. Companies use this information to manually complete the official model that is presented to the tax office together with the Model 345 file.

To retrieve data, the Model 345 application engine process:

1. Locates every pension plan with a plan type of collective and effective date year equal to the calendar year report parameter.
2. Locates all employees who are assigned to these pension plans for which the effective date year is equal to the calendar year report parameter.
3. Searches for the data required for the Model 345 file for each of these employees.
4. Checks whether to include disability data in the Model 345 file as specified for an employee in the Disability >= 65% field on the Payee Pension Plan ESP page.
5. Generates the Model 345 file and summary page file to the location that you specify in the report parameters.

The process performs these tasks for each company that you list in the Company field on the Reporting Type tab on the Create 345 Model File ESP page.

SPC PP INDIV	Used for individual pension plan types. It is an in kind element for the amount that a company contributes to a pension plan that is defined as contributive. You specify the amount of the contribution through the Payee Pension Plan ESP page when the contributor is company and the retribution type is earning in kind. The payroll process treats the amount as taxable. This earning does not contribute to Social Security because it is related to a pension plan defined as contributive. When you select that check box, the system generates this earning. The payroll process adds the earning amount to the accumulators for the 110, 111, and 190 reports.
SPC2 PP INDI	Used for individual pension plan types. It is an earning in kind element for the amount that a company contributes to a pension plan when the retribution type is earning in kind. You specify the amount of the contribution through the Payee Pension Plan ESP page when the contributor is company. The payroll process treats the amount as taxable. This earning does contribute to Social Security because it is generated when the pension plan is defined with the Pension Plan Contribution check box on the Pension Plan Definition ESP page deselected.
SPC PP COL	Used for collective pension plan types. It is an earning in kind element for the amount that a company contributes to a pension plan when the retribution type is earning in kind. You specify the amount of the contribution through the Payee Pension Plan ESP page when the contributor is company. This contribution is an earning in kind. The payroll process treats the amount as taxable. This earning does not contribute to Social Security because it is generated when the pension plan is defined with the Pension Plan Contribution check box selected. The payroll process also adds the amount to the accumulator for the Model 345 report.
SPC2 PP COL	Used for collective pension plan types. It is an earning in kind element for the amount that a company contributes to a pension plan when the retribution type is earning in kind and pension plan is defined as collective but noncontributive. You specify the amount of the contribution through the Payee Pension Plan ESP page when the contributor is company. The payroll process treats the amount as taxable. This earning does contribute to Social Security because it is generated when the pension plan is defined with the Pension Plan Contribution check box deselected. The payroll process also adds the amount to the accumulator for the Model 345 report. This element affects the payslip, Tax Deduction, and Model 345 reports.

Note: The payroll process distributes earnings and earnings in kind according to frequency or period. If an assignment starts in the middle of a month, the system does not prorate it but instead assigns the whole amount.

Deduction Elements

This table describes the delivered deduction elements associated with pension plan functionality:

<i>Deduction Element</i>	<i>Description</i>
DD PP COLECT	Deduction element for the amount that an employee contributes to a pension plan when the pension plan type is collective and the company manages the contributions. You specify the amount of the contribution through the Payee Pension Plan ESP page when the contributor is employee.
DD PP INDIV	Deduction element for the amount that an employee contributes to a pension plan when the pension plan type is individual. The company manages the contributions but it is not contributing any amount. You specify the amount of the contribution through the Payee Pension Plan ESP page when the contributor is employee.
DD PP SPC	Deduction element for use during payslip printing. It contains the sum of in kind income related to pension plans (individual or collective). This deduction element is needed in case you are printing SPC PP INDIV, SPC PP COL, PC2 PP COL, or SPC2 PP IND earnings. Those earnings are summarized as part of total earnings, so to get the correct net amount to pay you need a deduction to compensate that value.

Managing Special Collectives

Understanding Special Collectives Management

Special collectives are groups of people who require different payroll treatment because they have a special labor relation with the company for which they work. Companies consider the cost related to these people as personnel expenses. PeopleSoft Global Payroll for Spain considers individuals in the following groups to be special collectives:

- Displaced persons and expatriates
- Scholarship holders
- Preretired
- Professionals

PeopleSoft Global Payroll for Spain provides functionality to manage the relationship between companies and these groups. This includes functionality to manage payments, social security contributions, taxation, and reporting for each of the special collective types.

Understanding Displaced and Expatriate Employee Management

Displaced and expatriate employees are workers that are transferred to another country for a period of time. These types of workers can include foreign people working in Spain and Spanish people working abroad. Specifically, a displaced employee is an employee who is temporarily transferred to another country to attend to company business for a period of time less than or equal to one year. An expatriate employee is an employee who is transferred to another country to attend to company business for a period of time greater than one year.

PeopleSoft Global Payroll for Spain provides functionality to manage displaced and expatriate employees. This functionality includes management of social security contributions, taxes, and affected legal documents. Because an employee's payroll conditions can change when affected by transnational geographic mobility, PeopleSoft Global Payroll for Spain provides solutions for various payroll conditions.

PeopleSoft Global Payroll for Spain also provides the IRPF Tax Data Review ESP component (GPES_TAX2_RSLT) that enables you to view tax data that the payroll process generates for displaced employees that are considered resident workers. The system includes these employees in common tax reports, Model 111/110 and Model 190 reports, and pension plan reporting functionality for creating the Model 345 report. For those displaced employees who are considered non-resident workers for taxes purposes, the system calculates IRNR. You can use the IRNR Tax Data Review ESP component to review this IRNR data. The official reports that affect these employees are Model 216 and Model 296.

Maintaining Displaced and Expatriate Employees

To manage displaced and expatriate employees:

1. Define the withholding percentage for nonresidents for each fiscal territory in the Non-resident Withholding field on the Calculation Data page of the Fiscal Territories ESP component.

2. Set up transnational mobility details for the employee on the Transnational Mobility page of the Maintain Tax Data ESP component.

3. Assign the appropriate earning and deduction elements to the employee through the Element Assignment By Payee page.

4. Run the payroll process.
5. Review the IRNR tax data for nonresidents through the IRNR Tax Review page and make adjustments if necessary.

If the displaced employee is considered a resident for taxes purposes, you need to use the IRPF Tax data review page.

6. Create the IRNR tax document Model 216 for nonresidents monthly or quarterly using the Create 216 Model File ESP page (or corresponding Model 111/110 for residents).
7. Create the IRNR tax document Model 296 for nonresidents annually using the Create 296 Model File ESP page (or corresponding Model 190 for residents).

When you run the payroll process, it stores the required statutory IRNR tax report information for nonresidents in the GPES_EXPT_RSLT table. You can use this page to view and adjust the IRNR tax data for specific employees. The report generation processes consider the values on this page when you generate the Model 216, Model 296, and Tax Deduction reports.

Note: If the displaced person is considered a resident, the payroll process calculates regular IRPF taxes. You report IRPF taxes through the Model 110, Model 111, and Model 190 reports.

Search Criteria

Upon accessing the page, select the company, fiscal territory, year, and month for which you want to view or adjust IRNR tax data. Enter the employee ID to narrow the search results. Click the Search button to retrieve the employees based on the search criteria. The system displays employees with IRNR tax data that meet your search criteria.

Earned Income

Use the fields on this tab to review IRNR tax-related data for nonresidents. This tab shows the information that the payroll process generates for each employee that meets your search criteria.

Adjust

Use the fields on this tab to adjust IRNR tax data for an employee. This tab shows the same fields as the Earned Income tab but the fields are editable. The system differentiates between the data that the payroll process generates and the data that you enter manually.

Adding IRNR Tax Data Manually

The IRNR Tax Review page enables you to add tax data for payees manually by using the Add a new row button. You would typically do this for payees who are paid through an external system outside of PeopleSoft Global Payroll for Spain, but who you want included in monthly and yearly tax reports.

You can also add IRNR data rows for payees processed by PeopleSoft Global Payroll for Spain to capture income for different perception key and subkey combinations. You can only do this for payees who belong to a calendar group that has been finalized.

You can delete rows only for manually added IRPF data. You cannot delete data rows that are the result of a PeopleSoft Global Payroll for Spain payroll run.

Understanding Scholarship Holder Management

A scholarship holder is a person who works for a company to acquire experience and professional training under a special labor relation with the company. Scholarship holders can work for a company with a research fellowship, without a research fellowship, or through a separate entity such as an educational center or foundation.

Scholarship holders with fellowships have a unique contractual relation with the company and require special treatment with respect to IRPF taxes and social security contributions. The amounts companies pay to fellowship scholarship holders are not considered salary and are free of IRPF taxation. However, companies must declare this information in IRPF tax reports. PeopleSoft Global Payroll for Spain enables you to declare this mandatory information in the Model 110, Model 111, Model 190, and Tax Deduction reports. Regarding social security contributions, PeopleSoft Global Payroll for Spain provides the necessary contribution ID as part of the social security scheme to account for fellowship scholarship holders. The scheme ID is 0111 and the social security contribution ID is 008. The contribution is maintained on the Contribution page of the Social Security Scheme Table component. You need to identify this employee as an *Intern* in the Empl Class field on the Job Information page.

Note: You can sometimes apply certain social security reductions for this collective (CD24, Bonificación i+d+I) for fellowship scholarship holders.

To manage scholarship holders without fellowships, you can set up these persons as normal employees with a special contract type of *practice* or *training*. No additional setup or processing is required.

In the last case, to manage scholarship holders from a separate entity, you can handle these persons the same way that you would handle persons that another company provides as professionals.

Managing Fellowship Scholarship Holders

To manage fellowship scholarship holders:

1. Set the Empl Class (employee class) field value to *Intern* on the Job Information page.
2. Set the Special Labor Relationship field value to *Fellow Scholarship Holder* on the Job Information page.

3. Enter values for the rate code *BECAIN* (scholarship holder) on the Compensation page.
4. Set the Scheme ID field value to *0111* on the Contract Status/Content page.
5. Set the Social Security Contribution field value to *008* (fellowship scholarship holder) on the Contract Status/Content page.
6. To override compensation entered through the rate code *BECAIN* in step 4 or to enter additional compensation for scholarship holders, assign the earning *BECA INVESTGCN* on the Element Assignment By Payee page.
7. To enter expenses for the scholarship holder, assign the earning *GASTOS BECA* on the Element Assignment By Payee page.
8. Process payroll.
9. Generate the affected reports monthly, quarterly, or yearly as required.

Understanding Preretirement

Preretirement is when employees who have not fulfilled the requirements for normal or anticipated retirement make an agreement with the company. Because preretired employees are not active in the company, the company does not have to pay social security for them.

An employee and a company can agree to a preretirement plan. These agreements are specific to each particular employee. PeopleSoft Global Payroll for Spain includes functionality to manage the following preretirement plan scenarios:

- The company terminates the employee but pays the employee the agreed-upon amount until the employee reaches the retirement age of 65.
- The company agrees to pay a supplemental amount to the employee as a supplemental unemployment benefit or subsidy.
- The employee continues to contribute to social security to maintain privileges, and the company reimburses the employee for this amount.

Companies can classify these amounts as regular or nonregular income depending on each particular situation. PeopleSoft Global Payroll for Spain provides payroll elements for each of these three scenarios for both regular pay and nonregular pay. These elements store the agreed amount to pay to the preretired employee, taking the agreed upon amount from the Compensation page. As regular income, employees pay IRPF taxes as they normally do. As nonregular income, the payroll system applies a reduction of 40% to the IRPF tax base.

Understanding Gradual and Flexible Retirement

Gradual and flexible retirement offers employees a way to make the transition from working life to retirement by reducing the employee labor contract from full-time to part-time. As employees fulfill all conditions for retirement or preretirement, these employees continue working with a part-time contract and reduced salary as long as they still receive a pension subsidy. This reduction in hours can be between 25% and 85%, thus reducing the employee's salary by the same percentage. This enables the employee to continue receiving a partial retirement pension for the remaining working years until retirement age. Gradual and flexible retirement is regulated by law and promoted by government with special treatment of contributions to social security for employer and employee (reductions, exoneration of quotas, and so on) depending on the age of employee.

Employees have two options:

- *Partial Retirement:* The employee can initiate partial retirement simultaneously with a part-time contract after the employee is 60 years old.

For partial retirement before an employee reaches 65 years of age, the company establishes a relief contract with another employee to cover the percentage of work affected by the partial retirement.

- *Flexible retirement:* When the employee starts receiving his or her retirement pension, the employee can work on a part-time contract basis with the retirement pension reduced according to the percentage of hours worked.

In cases in which an extension of working life exists, companies can benefit from some social security contribution reductions that they must assign to eligible employees. These extensions of working life pertain to (a) employees over 65 with at least 35 contributing years or (b) employees over 60 with at least 5 seniority years.

Employees Over 65 with 35 Contributed Years

Employees older than 65 are exempt from contributing to social security except for the temporary disability part within the common contingencies. The social security agency defines this part to be 0.28% for the employee and 1.42% for the employer over the common contingencies base.

Companies must report this situation to the social security agency using the FAN file. Specifically, the company must report the employee and employer contributions as if no reductions applied and also report the employee and employer reductions.

PeopleSoft Global Payroll for Spain provides the necessary contribution ID as part of the social security scheme to account for active employees age 65 or older. The scheme ID is 0111 and the social security contribution ID is 007. The contribution is maintained on the Contribution page of the Social Security Scheme Table component.

In addition to the social security contribution ID for employees who are age 65 or older, you need to define a reduction ID that defines the correct reduction amount on the Reduction Data page of the Reductions ESP component.

To calculate the reduction percentage, you must use the following equation:

$$\text{Total Common Contingency Percentage} - (\text{Employee Common Contingency Percentage} + \text{Employer Common Contingency Percentage}) \div \text{Total Common Contingency Percentage} = \text{Percentage to Reduce}$$

Thus, using the values stated previously from the social security agency, the Percentage to Reduce value for common contingency is:

$$28.3\% - (0.28\% + 1.42\%) / 28.3\% = 93.992932$$

The payroll process and FAN file generation process take into account the new contribution data and reduction data for active employees with part-time status who are age 65 or older. The FAN file generation process also accounts for the reductions in social security contributions.

Employees Over 60 with 5 Seniority Years

For employees over age 60 with 5 seniority years in the company, the employer can reduce the quota to pay to social security. Employers can apply this reduction to common contingencies contributions except in the case of temporary disability. The current percentage reduction is 50% for the first 12-month period and increases by 10% at the beginning of each subsequent 12-month period until reaching 100%.

You need to define a reduction ID to manage this type of reduction to social security contributions through the Reduction Data page of the Reductions ESP component.

To determine the Percentage to Reduce value for the each period of common contingencies without including temporary disability, you must use the following equations:

$$(\text{Common Contingencies Percentage} - \text{Temporary Disability Percentage}) * \text{Reduction Percentage} = \text{Reduced Common Contingencies Percentage}$$

$$\text{Reduced Common Contingencies Percentage} / \text{Common Contingencies Percentage} = \text{Percentage to Reduce}$$

For example:

$$\text{Common Contingencies} = 23.6\%$$

Temporary Disability = 1.42%

Reduction Percentage = 50%

$(23.6\% - 1.42\%) * 50\% = 11.09\%$

$11.09\% / 23.6\% = 46.991525\%$

You must perform these calculations for each common contingency period within the reduction ID. The payroll process and FAN file generation process take into account the contribution data and reduction data. These processes also account for the reductions in social security contributions.

Assigning Preretirement

To manage preretirement:

1. Terminate the employee with pay by assigning the *Termination With Pay* value in the Action/Reason field on the Work Location page of the Job Data component.
2. Assign the agreed-upon compensation amount to the employee in the Pay Components group box on the Compensation page. Select the rate code, compensation rate, currency, and frequency of the compensation. For preretired regular income, select the *PREJUB*, *PJCOSS*, and *PJDSEM* rate codes. For preretired nonregular income, select the *PJJUBI*, *PJCSSI*, and *PJDSEMI* rate codes.

Or, assign the employee the required payroll elements for preretired regular income or nonregular income using the Element Assignment By Payee page. For preretired regular income, assign the employee the following payroll elements: *PREJUBILACN* earning (equivalent to rate code *PREJUB*), *DEV SS PREJ* earning (equivalent to rate code *PJCOSS*), and *BNF DESEMP* deduction (equivalent to rate code *PJDESM*). For preretired nonregular income, assign the employee the following payroll elements: *PREJUBILACN I* earning (equivalent to rate code *PJJUBI*), *DEV SS PREJ I* earning (equivalent to rate code *PJCSSI*), and *BNF DESEMP* deduction (equivalent to rate code *PJDSEMI*).

3. Calculate payroll.

The payroll process calculates the regular income payment as *PREJUBILACN* + *DEV SS PREJ* - *BNF DESEMP*. The process pays this amount as regular income and pays taxes normally. Contributions to social security are zero.

The payroll process calculates the nonregular income payment as *PREJUBILACN I* + *DEV SS PREJ I* - *BNF DESEMP I*. The process pays this amount as nonregular income and reduces the tax base by 40%. Contributions to social security are zero.

4. Generate the affected reports monthly, quarterly, or yearly as required.

Assigning Gradual and Flexible Retirement

To assign an employee gradual or flexible retirement:

1. Access the Job Data component (Workforce Administration, Job Information, Job Data, Job Information).
2. Reduce the employee's contract from full-time to part-time by setting the Full/Part field value to *Part Time*.

This effectively reduces the employee's salary by the same percentage.

3. Reduce the contribution to social security by assigning the employee to the necessary Social Security Contribution and Reduction IDs on the Contract Status/Content page (Workforce Administration, Job Information, Contract Administration, Update Contracts).

Your selections for these fields depend on whether the employee is over 65 with at least 35 contributing years or the employee is over 60 with at least 5 seniority years.

4. Calculate payroll.

If the employee is over 65 with at least 35 contributing years and you assign the corresponding reduction, the payroll process reduces the social security contributions for both the employee and the employer, paying only for temporary disability. The percentage for the employee is 0.28% and the percentage for the employer is 1.42%, as defined by currently applicable laws.

If the employee is over 60 with at least 5 years seniority, the payroll process reduces the social security contribution percentage for the employer according to the period in which the employee falls within the reduction ID definition.

5. Generate the affected reports monthly, quarterly, or yearly as required.

Understanding the Professionals Management Business Process

Professionals are persons who provide a company a service without a labor contract. Professionals are contingent workers, not employees. PeopleSoft Global Payroll for Spain assumes that you do not process their payments through payroll. Instead, the professional provides the company with a bill. The company must pay the professional's bill and withhold a percentage of IRPF tax from the amount paid to the professional. The withholding percentage for IRPF taxes depends on the perception key and subkey that defines the services offered by the professional. The company does not have to contribute to social security for the professional.

Through the IRPF Tax Review ESP component you can enter the amount paid to the professional and the withholding amount applied. You can also specify the perception key and subkey to identify the work that the professional provides. The report generation processes consider the values that you enter on this page when you generate the Model 110 report, the Model 111 report, the Model 190 report, the individual professional's Tax Deduction report, and the Tax Deduction report.

Managing Data for Professionals

To manage data for professionals:

1. Maintain perception key and subkey values through the Perception Keys ESP component.
2. Add the professional into the system through the Add a Person component, identifying the person's organizational relationship as a professional by selecting the Contingent Worker check box on the Organizational Relationships page.

A professional is a contingent worker or a person who provides services to the organization and who does not have a legal employee relationship with the organization.

For contingent workers or persons of interest, you can insert new rows of data for each specific job and salary type that a person might have. You can enter IRPF tax data for any person who is not processed through payroll. The system uses this data when you generate IRPF tax reports.

You can also use the IRPF Tax Review page to enter and maintain the earning income and tax results adjustments for professionals (or other types of employees) for whom you did not calculate payroll.

Search Criteria

Upon accessing the page, select the company, fiscal territory, year, and month for which you want to enter data for professionals. To search for professionals only, select the *Contingent Worker* value in the Org Relation (organization relationship) field. Enter the employee ID to narrow the search results. These filters facilitate budget management and tracing of professional services within a company. Click the Search button to retrieve the professionals based on the search criteria. The system displays a grid with fields that are relevant only to professionals.

Detail of Payees - Adjust

Use this tab to enter amounts for the professional for the selected fiscal period and month. This tab shows the same fields as the earned Income tab but the fields are editable. The system differentiates between the data that the payroll process generates and the data that you enter manually.

Managing Stock Option Income

Understanding Stock Option Income

When payees sell stock that they acquired through stock options, the resulting earned income can fall into three different categories:

- Tax exempt income.
- Irregular income.
- In kind income

Tax Exempt Income

The system considers up to a certain statutory amount of stock income to be tax exempt if the payee selling the stock:

1. Held the stock for at least three years before selling it.
2. Acquired the stocks through a general plan. This means that the issuing company offered options to all employees under the same conditions.
3. Is an active employee of the company that issued the stock options.

Note: Tax exempt stock income is also exempt from Social Security contributions.

Irregular Income

For stock income that does not qualify to be tax exempt, the system treats a portion of it as irregular income if the payee who sold the stock acquired it over an accrual period greater than two years. The system reduces irregular income by a territory-specific percentage before adding it to the total taxable base. The maximum amount of stock income that can be considered irregular income is the statutory Medium Average Salary \times years of income generation. This maximum amount is doubled for payees who:

1. Held the stock for at least three years before selling it.
2. Acquired the stocks through a general plan. This means that the issuing company offered options to all employees under the same conditions.

Note: The system does not reduce irregular income when determining Social Security contributions.

In Kind Income

The system considers any stock income that does qualify as tax exempt or irregular income as in kind income. Payees are responsible for paying any taxes associated with this income. Therefore, in kind stock income fall under the category of *IRPF recuperado*.

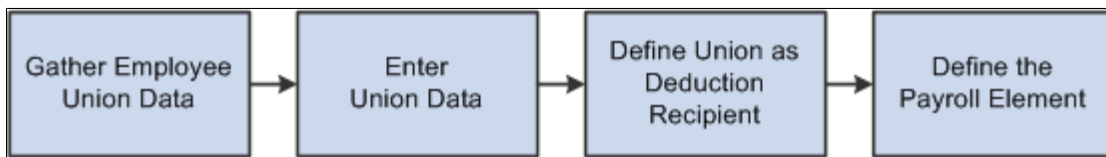
Paying Union Fees

Setting Up Union Fees

PeopleSoft Global Payroll for Spain enables you to pay your employees' union fees as part of the regular payroll processing cycle.

Image: Setup steps for paying employee union fees during payroll processing

This diagram illustrates the four steps required for setting up your system to automatically pay union fees during the regular payroll processing cycle.



To set up union fees:

1. Gather the employee's union data.

If employees want their union fees to be paid by the payroll process, the employee must provide the information necessary to set up the automatic payments. The employee must provide:

- Union code.
- Union date (the date on which the employee was first affiliated with the union).
- The employee's function in the union (if applicable).
- Union fee.
- Fee start and end dates (the initial date on which the fees should be paid through payroll and, if applicable, the date on which the payment of fees should stop). Unless an end date is specified, the system will continue to pay the union fees until an end date is provided.
- Exemptions or free working hours to partake in union activities (if applicable).

2. Enter union data.

When you have the information about an employee's union affiliation, enter that information on the Job Labor page in the Job Data component, (Workforce Administration, Job Information, Job Data, Job Labor).

Note: The Fee Start Dt (fee start date) and Fee End Dt (fee end date) fields can be left blank. If Fee Start Dt is blank, then PeopleSoft Global Payroll for Spain uses 01/01/1900 as the default value. If Fee End Dt is blank, then PeopleSoft Global Payroll for Spain uses 01/01/3000 as the default value.

3. Define the union as the recipient of the deduction.

After associating an employee with a union, you must set up union fee deduction information. Define the union as a recipient of the deduction on the Recipient page (Set Up HCM, Product Related, Global Payroll & Absence Mgmt, Elements, Payroll Elements, Deductions, Recipient). The Recipient page provides detailed information about the third-party recipient for a deduction. The Recipient page enables you to indicate who gets a deduction. This provides a direct relationship between the union and bank account into which the union fee deduction is deposited.

4. Define the payroll element.

If you are defining the general recipient as a general recipient, then link the general recipient to the deduction element that calculates the union fee. To link the general recipient to a deduction, access the Recipient page of the Deductions component (Setup HCM, Global Payroll & Absence Mgmt, Elements, payroll Elements, Deductions) and select the deduction recipient.

If the recipient is defined as an individual recipient, then the final step is to define the payroll element to use as the deduction (union fee) for the employee. Use the Assign Deduction Recipients page (Global Payroll & Absence Mgmt, Payee Data, Net Pay/ Recipient Elections, Add Deduction Recipients, Assign Deduction Recipients) to do this. This associates an employee with an element name (the payroll element for the union fee) and a recipient (the union and, therefore, the appropriate bank account).

Union Fees Rules and Processing Flow

When you have completed the preceding setup steps, the designated union fee to be paid by the employee is deducted during payroll processing and transferred to the identified union bank account. Section GEN SE DEDUCCIONES contains the necessary elements to perform the union fee deduction and occurs only during the regular payroll process (not during extra period processing).

Viewing Delivered Union Fee Deductions

PeopleSoft Global Payroll for Spain delivers the deduction CUOTA SNDCL for union fees. This deduction takes the value of SIN VR IMPORTE DED (this variable receives its value from the array GEN AR PUESTO TRBJ) through the formula SIN FM CUOTA. This deduction contributes to accumulator GEN AC DEDUCCION S.

Note: The PeopleSoft system delivers a query that you can run to view the names of all delivered elements designed for Spain. Instructions for running the query are provided in the *PeopleSoft HCM 9.2: Global Payroll* product documentation.

Working with Absence Rules

Understanding Absence Rules

PeopleSoft Global Payroll for Spain delivers rules for processing absences due to vacation, illness, maternity, work accidents, and other reasons. These rules are designed according to Spanish statutory requirements. You can modify many of these rules to reflect absence policies that are specific to your organization or to labor agreements that may be in force for your employees.

This topic supplements the absence documentation provided in the *PeopleSoft HCM 9.2: Global Payroll* product documentation which you should read before reading this topic on Spanish-specific absence processing.

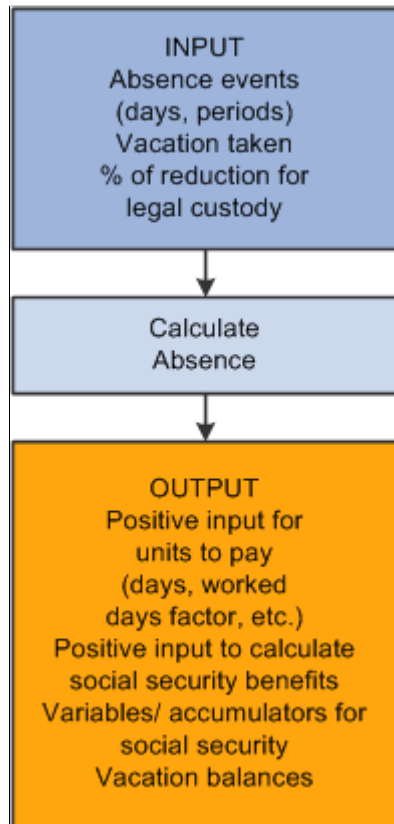

Setting Up Absences

Before you can enter and process absences for Spain, you must complete various setup tasks.

To prepare for absence processing:

1. Define work schedules and assign a schedule to each payee. Note that work schedules have an impact on just irregular part-time employees because the work schedules reflect the worked days that the payroll process counts during processing.
2. Define holiday schedules.
3. Define absence types and reasons.
4. Modify the delivered absence entitlement and absence take elements, and create new absence elements, as needed.

A list of the absence take and absence entitlement elements delivered with PeopleSoft Global Payroll for Spain appears in this topic. Sample values are delivered for many of these elements. You may want to replace some of these values with data that is specific to your organization.

5. Assign absence elements to payees (using eligibility groups) and process lists.

Add absence elements to eligibility groups and process lists.

You must assign absence entitlement and take elements to payees and include the elements in the process lists that you use when you run the absence processes. (This step is not necessary for per-absence entitlement elements.)

Oracle delivers predefined sections and process lists for absence processing. Use these, modify them, or create your own.

6. (Optional) Define rules for self-service absence transactions.

Note: All of these steps are discussed in the Global Payroll core documentation.

User-Defined Fields

The Calculation page that you use to define absence take elements includes four user-defined fields, which populate the system elements TAKE CONFIG1 through TAKE CONFIG4. The TAKE CONFIG fields provide additional instructions to the system during the absence process.

If you are defining your own absence take element, follow the same usage conventions for the user-defined fields to ensure that the system functions properly.

Note: The system elements TAKE CONFIG1 through TAKE CONFIG4 and TAKE CONFIG1 DU through TAKE CONFIG4 DU are used with many of the delivered formulas in PeopleSoft Global Payroll for Spain.

TAKE CONFIG1

TAKE CONFIG1 identifies the effect on extra period payments. This table details the extra period effect according to the delivered values:

Entering Absence Events

Use the Absence Event ESP (GPES_ABS_EVENT) component to enter and update absences, start the Absence Forecasting process, and record information for the FDI medical report text file.

Note: The Absence Event ESP component is identical to the Absence Event (GP_ABS_EVENT) component in the core Global Payroll application, except for the inclusion of the FDI Additional Data page, which enables you to incorporate information that is specific to temporary disability absences. Spanish users should use the Absence Event ESP component in place of the Absence Event (GP_ABS_EVENT) component to enter all absence event data.

Additional Data

Absence Take

Displays the absence take entered on the Absence Event Entry page.

The Additional Data page is mandatory for the following absences if you are reporting FDI using PeopleSoft Global Payroll for Spain:

- *IT*: Temporary disability due to common sickness.
- *AT/EP*: Temporary disability due to industrial accident or professional illness.
- *RIESGO EMBARAZO*: Temporary disability due to risk during pregnancy.

Note: This page is also useful for recording cases of multiple maternity absence. This is represented by the absence take *MATERNIDAD* with an absence reason of *MLT*.

Begin Date and End Date

These fields display the begin and end dates of the absence entered on the Absence Event Entry page.

Note: If you entered two rows with the same absence take on the Absence Event Entry page that are more than 6 months apart, you will receive a warning when you try to save the event. To ensure that the system uses the correct *Base Reguladora Diaria* (BRD), you should enter relapsed absences greater than 6 months apart as separate absence events.

Original Begin Date

This field displays the original begin date of the absence entered on the Absence Event Entry page.

Absence Reason

Select a reason for the absence.

Valid reasons are:

- 1: Common Illness.
- 2: Non-industrial Accident.
- 3: Industrial Accident.
- 4: Professional Illness.
- 5: Professional Illness in Observation Period.
- *NRM*: Maternity (one)
- *MLT*: Multiple Maternity (two or more)

Note: When you select this value, the Number of Children field becomes available.

Note: Not all reasons are available for all absence takes. For example, *NRM* and *MLT* are available only for the *MATERNIDAD* absence take.

Number of children

Enter the number of children associated with the multiple maternity absence.

Lacking Period Indicator

Select to set the social security portion of the absence payment to zero for the absence event. This check box is available only for absence events associated with the absence types DIS (Temporal Disability), MAT (Maternity), or RSK (Risk on Pregnancy). Typically you select this check box for situations in which the employee does not have 180 contributing days for the last 5 years.

FDI Data

Use the fields in this group box to select an injury date and enter information about the different note types that must be tracked in the FDI medical report text file.

Injury Date

Enter the specific date on which the injury or accident occurred.

Note: This field is relevant only for *AT/EP* absence takes.

Type

Select a note type. Valid values are:

- *PB*: Select to record the details of the sick note establishing an employee's temporary disability. This is the first note type recorded for an employee in the case of a temporary disability. By default, the date of the initial sick note (PB) is the same as the absence event begin date displayed at the top of the page.
- *PC*: Select to record the details of a confirmation note establishing the continuation of an employee's temporary disability. The date of a confirmation note should be after the initial sick note date (PB) and before the date of the medical discharge (PA).
- *PA*: Select to record the details of a medical discharge note. This is the last note type recorded for an employee who has experienced a temporary disability. By default, the date of the medical discharge note (PA) is the same as the absence event end date displayed at the top of the page.

Sick Note Date

- If the note type is PB and is not an injury event (absence take AT/EP), the system automatically sets the date to the begin date of the absence event displayed at the top of the page.

If the note type is PB, is an injury event (absence take AT/EP), and has a begin date before the reference date specified in the GEN VR F REF ACC variable, the system automatically sets the date to the day before the begin date of the absence event displayed at the top of the page.

If the note type is PB, is an injury event (absence take AT/EP), and has a begin date on or after the reference date specified in the GEN VR F REF ACC variable, the system automatically sets the date to the begin date of the absence event displayed at the top of the page.

In any case, you can edit the value of this field.

Note: The variable GEN VR F REF ACC determines the value of the reference date used by the system to determine whether the absence begin date represents the first day of company paid benefit (*Pago Delegado*) or the sick leave date. For absences entered before the reference date, the system uses the absence begin date as the first day of company paid benefit. For absences entered on or after the reference date, the system uses the absence begin date as the sick leave date.

- If the note type is PA, the system automatically sets the date to the end date of the absence event displayed at the top of the page.
- If the note type is PC, the Date field becomes available for data entry and you must enter the date of the confirmation note.

Number

This field applies only to confirmation notes (note type *PC*) and enables you define the order of a series of notes. For example, enter *1* for the first confirmation note, *2* for the second confirmation note, and so on.

Note: Because confirmation notes are the only notes that can be received more than once over the course of a temporary disability, this field does not apply to other note types.

Discharge Reason

Select the reason for a medical discharge.

This field is available for data entry only when the note type is PA.

Sending ID

Displays the identifier of the communication. This needs to be a unique identifier.

The system generates this ID when you run the Create FDI File process on the Create FDI File ESP page.

Note: The sending ID enables you to track the transfer of data to the social security agency.

Area Identifier Code

Enter the ten-digit area identifier code. If you enter a code in this field, you do not need to enter values in the State, Registered State, or Physician ID fields.

State

Enter the two-digit code that represents the state portion of the ten-digit ID of the physician overseeing the treatment of the disabled employee.

If you do not enter a value in this field, but enter a value in the Registered State and Physician ID fields, you will receive a warning when you click Save.

Registered State

Enter the two-digit code that represents the registered state portion of the ten-digit ID of the physician overseeing the treatment of the disabled employee.

If you enter a value in this field and no values in the State and Physician ID fields, the system will assign the remaining 8 digits of the physician ID during FDI file generation using a standard number provided by Social Security.

Physician ID

Enter the six-digit code that represents the physician-specific portion of the ten-digit ID of the physician overseeing treatment of the disabled employee.

Confirmed

This check box is automatically selected when the medical note data is confirmed and sent to the social security agency. This enables you to determine what medical information has been sent and what information is pending.

Note: To set the status of a note to confirmed, you must click the Confirm button on the FDI Confirmation ESP page of the FDI Confirmation ESP (GPES_FDI_SEND) component.

Modified

Select to indicate that you have modified information related to a note after the note has been confirmed and sent to the social security agency. When you select the Modified check box, the system deselects the Confirmed check box and you can reprocess and resend the medical note data on the Create FDI File ESP page.

Note: You can also unconfirm the data contained in an FDI medical report text file by clicking the Unconfirm button on the FDI Confirmation ESP page of the FDI Confirmation ESP (GPES_FDI_SEND) component.

Economic Data / FDI Data

Use the fields in this group box to record information about the disabled employee's work status and social security contributions. The system populates these fields automatically when you click the Search button. The values are retrieved from the record GPES_CNTRB_RSLT, which contains data generated by the payroll process and stored using the writable array SS WA CNTRB.

If the values don't exist or if you want to report values that are different from the ones that are stored in the system, you can enter or update them manually.

Days/Bases Override

Specify how the system uses the data in the Economic Data / FDI Data group box. Values are:

- *No:* This value makes the fields in the Economic Data / FDI Data group box unavailable for editing. The system populates these fields only with previously calculated values.
- *Yes:* This value makes the fields in the Economic Data / FDI Data group box available for editing. The system uses the values you enter in these fields for both FDI Reporting and payroll processing when calculating Social Security bases and subsidies.

Note: If you select this value and retroactive processing occurs, the system will not update Social Security bases and subsidies accordingly because it will continue to use the values you enter in the Economic Data / FDI Data group box.

- *FDI Only:* This value makes the fields in the Economic Data / FDI Data group box available for editing. The system uses the values you enter in these for FDI Reporting only, however. It uses the calculated values during payroll processing.

Full/Part Time

Indicates the full-time or part-time status of the employee.

Contribution Days

Shows the number of days that the employee made social security contributions in the month prior to the absence. In the case of part-time employees, the Contribution Days field shows the number of contribution days in the 3 months prior to the start date of the absence.

Common Contingency Base

Shows the social security contribution base in the month prior to the absence. In the case of part-time employees, the Common Contingency Base field shows the contribution base for the 3 months prior to the start date of the absence.

Contribution Overtime

Shows the social security average daily contribution base due to overtime in the 12 months prior to the begin date of the absence.

Understanding the FDI Medical Report Business Process

According to order TAS/339 of 2004, organizations participating in the Sistema RED (social security online service) must track and communicate the disability status of employees to the social security agency either by entering disability data on the official Social Security Website or by transmitting the data using an electronic medical report text file with an FDI extension. To support this requirement, PeopleSoft Global Payroll for Spain provides application pages, processes, and reports that enable organizations to collect and track information about temporary disabilities and to report this information to the responsible authorities.

FDI Medical Report Business Process Steps

In a typical situation involving a disabled or injured employee, the organization receives, collects, and communicates information in the following order:

1. An employee experiences a temporary disability.

2. The employee sends a sick note to the organization to establish his or her disability status. The organization records this information as well as other data needed to create the FDI medical report file.
3. The organization generates and sends the FDI medical report file to the social security agency.
4. As long as the disability continues, the employee sends the organization a note once a week to confirm his or her disability status. The organization records this information in the database for use in creating the FDI medical report file.
5. The organization generates and sends the FDI medical report file.
6. A medical discharge occurs.
7. The organization receives a discharge notice indicating that the temporary disability is over and records this information in the database for use in generating the FDI medical report file.
8. The organization generates and sends the FDI medical report file.

Note: In the scenario described here, the company is expected to transmit medical note data to the social security agency within a specified time frame. For example, the company has 5 days to process and send sick note data to the agency following receipt of a sick note.

This field identifies the version of the Winsuite software used by the social security agency for reporting. As this software is updated, you must update the file version.

Sick Note

Specify the time limit (in days) for transferring sick note data to the social security agency following receipt of the note from an employee. If you select the Add Security Period check box on the Create FDI File ESP page (discussed below), the system compares the date on which the file with the sick note data is transferred to the agency (system date) to the absence begin date. If the number of days between the file transfer date and the absence begin date exceeds the time limit for sick notes, the system marks the employee as Late on the Create FDI File ESP page.

Medical Discharge

Specify the time limit (in days) for transferring medical discharge data to the social security agency following receipt of a discharge note from an employee. If you select the Add Security Period check box on the Create FDI File ESP page (discussed below), the system compares the date on which the file with the medical discharge note data is transferred to the agency (system date) to the absence end date. If the number of days between the file transfer date and the absence end date exceeds the time limit for medical discharge notes, the system marks the employee as Late on the Create FDI File ESP page.

Confirmation Note

Specify the time limit (in days) for transferring confirmation note data to the social security agency following receipt of the note from an employee. If you select the Add Security Period check box on the Create FDI File ESP page (discussed below), the system compares the date on which the file with the confirmation note data is transferred to the agency (system date) to the confirmation date you entered on the Additional Data page. If the number of days between the file transfer date and the confirmation date exceeds the time limit for medical discharge notes, the system marks the employee as Late on the Create FDI File ESP page.

FDI File Name

Sending ID

This field displays the sending ID used to track and confirm transmission of the FDI medical report text file to the social security agency. The system automatically generates it by combining the user ID and run Control ID.

FDI File Name

Enter a name for the FDI medical report file.

The system automatically appends the official FDI extension to this name.

Date From and Date To

Specify the period for which you want to retrieve disability data for the FDI medical report text file.

When you click Search, the system retrieves note data from the Additional Data page with dates that fall between the specified From Date and To Date, and that satisfies any other search criteria you have defined.

File Path

Specify the path to the location where you want the system to deposit the FDI medical report text file.

Add Security Period

Select to have the system check the date on which you transfer medical information to the social security agency against the official time limit for sending such information. For example, organizations should send sick note data to the agency within five days of receiving a note from an employee. If this time limit is exceeded, the system marks the employee as late in the Employee Details group box, but continues to process the data.

If you apply the security period check, you must define the time limit for each note type on the Social Security Data page (discussed previously).

Sick Note

Select to include sick note (PB) data entered on the Additional Data page in the FDI medical report file.

Medical Discharge

Select to include medical discharge (PA) data entered on the Additional Data page in the FDI medical report file.

Confirmation Note

Select to include confirmation note (PC) data entered on the Additional Data page in the FDI medical report file.

Filter By

Use the values in the Filter By drop-down list box to limit the population of employees whose temporary disability data is included in the FDI medical report text file.

Valid values are:

- *None*: Select if you want to generate report data for all employees with temporary disability records who fall within the specified time period.
- *Company*: Select if you want to generate report data for employees with temporary disability records in a specific

company or group of companies. You must then specify the company or companies in the Company field.

- *Employee*: Select if you want to generate report data for specific employees with temporary disability records. You must then specify the employees in the EmplID field.
- *SSN*: Select if you want to generate report data for employees associated with a specific company and employer social security number. You must then specify the company and employer social security number in the Company and Social Security Number fields.

Search

Click to retrieve the list of employees who meet the filter criteria.

Employee Details

Use the Employee Details group box to include employees in, or exclude them from, the FDI medical report text file.

Select All

Click to include all of the listed employees in the FDI medical report text file.

Unselect All

Click to exclude all of the listed employees from the FDI medical report text file.

Late

This check box is automatically selected when you report sick, confirmation, or medical discharge data outside of the time limit for transmitting the data specified on the Social Security Data page.

Note: The system automatically checks whether you are processing the note data within the time limit when you click the Search button on the Create FDI File ESP page. However, you must select the Add Security Period check box to enable this time period check.

Run

Click Run to launch the GPES_FDI application engine process that creates the FDI medical report text file.

Note: The FDI Confirmation ESP page enables you to confirm transmission of text files to the social security agency and identify those that must still be sent. Note that the system does not automatically transmit FDI medical report text files to the social security agency. You must transmit them manually after generating the files using the Create FDI File ESP page.

Sending ID

This ID identifies an FDI medical report text file.

It is created when you process FDI medical report data on the Create FDI File ESP page.

Note: To determine what sending ID to use when confirming or unconfirming an FDI medical report file, access the Create FDI File ESP page and record the ID that corresponds to the population of employees whose medical information you are processing.

Confirm

Click to confirm that you have sent the FDI medical report text file to the social security agency.

Unconfirm

Click to unconfirm an earlier transmission of FDI medical report data. You can then update the data on the Additional Data page of the Absence Event ESP component, and regenerate the FDI medical report by rerunning the Create FDI File ESP process.

Note: The system automatically displays the confirmation status of an employee's FDI medical report file on the Additional Data page of the Absence Event ESP (GPES_ABS_EVENT) component when you click the Confirmed or Unconfirmed button.

Overriding BRDs and Relapse Days for Absence Events

PeopleSoft Global Payroll for Spain enables you to override daily benefits base (*Base Reguladora Diaria*) (BRD) and relapse days for a specific social security absence event.

Companies must report absences events to Social Security through the mandatory FDI report. As part of this communication, companies must include values for contribution days, common contingencies base and, if applicable, contribution overtime. You can have absence event processing automatically determine these three values when calculating the BRD, or you can manually enter or override values on the FDI Additional Data page of the Absence Event ESP component. You might need to enter values for a BRD, for example, in cases in which you have an employee with a temporary disability that is a relapse of a previous one for which you do not have a value in the system.

Before performing the BRD calculation, the absence processing analyzes whether a value is in the Common Contingencies Base field on the FDI Additional Data page. If no value is in the field, the absence processing calculates the BRD and determines these data values. However, if an existing value is in this field, the absence processing does not perform the BRD calculation because the primary value that it needs to calculate already exists.

Overriding BRDs for Absence Events

To enter BRD override values to report to Social Security for an absence event:

1. Select Global Payroll & Absence Mgmt, Payee Data, Absence Event ESP, FDI Additional Data.
2. Click the Search button to retrieve the calculated values for the Contribution Days, Common Contingency Base, and Contribution Overtime fields.
3. Enter or override monthly values for the Contribution Days and Common Contingency Base fields.
4. If required, enter or override the Contribution Overtime field value. (Note that in some cases, this value is a daily average of the last 12 months.)
5. Click Save.

Overriding Relapse Days for Absence Events

PeopleSoft Global Payroll for Spain also enables you to override relapse days for absences that you must report to Social Security.

To override relapse days for a social security absence event:

1. Select Global Payroll & Absence Mgmt, Payee Data, Absence Event ESP, Absence Event Entry.
2. Click the Details link for the absence event to access the Absence Event Input Detail page.
3. Enter the number of relapse days in the Decimal 4 field on the Absence Event Input Detail page. The system retrieves the information by the element EVT CONFIG 4 DC.

4. Click OK.
5. Click Save.

Calculating BRDs in Absence Relapses

When an employee's temporary disability is a relapse of a previous temporary disability, the system must continue to calculate the employee's Social Security legal benefits. When performing the calculation, the system must use either the BRD associated with the initial temporary disability or the BRD associated with the new temporary disability.

This feature enables you to choose which BRD you want the system to use to calculate the Social Security legal benefits for the employee during an absence event relapse, either the initial BRD or the new BRD.

PeopleSoft Global Payroll for Spain delivers four variables, one for each absence type, to direct the system how to calculate the BRD when an employee has a relapse absence event for a temporary disability. The following table describes the variables:

Variable	Description
CLI VR RECAIDA IT	This variable indicates to the system how to calculate the BRD for Social Security legal benefits in relapse cases for non-work-related injury or common disease (IT).
CLI VR RECAIDA AT	This variable indicates to the system how to calculate the BRD for Social Security legal benefits in relapse cases for work-related injury or occupational disease (AT/EP).
CLI VR RECAIDA MAT	This variable indicates to the system how to calculate the BRD for Social Security legal benefits in relapse cases for maternity.
CLI VR RECAIDA RE	This variable indicates to the system how to calculate the BRD for Social Security legal benefits in relapse cases for risk during pregnancy.
CLI VR RECAIDA CM	This variable indicates to the system how to calculate the BRD for Social Security legal benefits in relapse cases for absence due the care of a minor affected by serious illness.

The default value of these variables is *A* (meaning previous, anterior), which calculates the BRD by dividing the amount of the worker's contributory base for the month prior to the original begin date of the disability by the number of days to which the contribution refers. To calculate the BRD with the daily base related to the month before the last absence instance, you must change the value of the variable to *N* (meaning new, *nuevo*) on the Definition page of the Variables component. To access this page, select Set Up HCM, Product Related, Global Payroll & Absence Mgmt, Elements, Supporting Elements, Variables.

The system uses these variables in the SS FM BRD RECAIDA formula to calculate the Social Security legal benefits for relapse cases. Depending on the variables value, the system uses either the initial BRD or the new BRD in the calculation.

Absence Entitlements

This table lists the delivered absence entitlements in PeopleSoft Global Payroll for Spain.

Absence Entitlement	Description
VACACIONS	Vacations: The annual entitlement is defined in the Contract Data table. The default vacation entitlement is provided from the Labor Agreement level. You can use the default or override it on the Contract Data page. A portion is assigned by corresponding days according to pay periods (1/365 of the total entitled days for payees with a daily pay frequency, 1/360 of the total entitled days for payees with a monthly pay frequency). This portion is 1/366 in a leap year. The system retrieves the vacation entitlement data using the GEN AR PUESTO TRBJ array. The accumulator AUS AC VAC ANOANT stores vacation not taken at the end of the year and is generated during December's payroll process. Depending on your company's vacation policy, you should add the value of this accumulator to the affected elements for the new year.
PERM PAGADS	Additional paid time off (PTO): The additional PTO entitlement is for the entire year (or the proportional part of the year for new hires) given at the beginning of the year. Entitled days are stored in the Labor Agreement table, and the system retrieves the additional PTO data using the GEN AR CONVENIO array. PTO that is not taken by the end of the year is lost.

Note: Absence take rules use earnings and deduction elements, elements that retrieve units for positive input, and elements that retrieve percent for positive input. The user-defined field system elements TAKE CONFIG1 through TAKE CONFIG4 are used in each of the absence take rule definitions.

Additional Guidance for Delivered Absence Takes

When establishing an absence event for Legal Custody, in addition to entering an absence event using the *Guarda Legal* absence take you must:

- Enter a new row of data for the employee in the Job Data component to change the employee to part-time for the period of Legal Custody.
- Update the employee's compensation using one of two options:
 1. Maintain compensation according to the full time schedule and enter an FTE that is less than 1. The system reduces compensation by applying the FTE.
 2. Reduce the employee's compensation and keep FTE equal to 1.
- Specify the working hours that the system should use during the payroll process using one of two options:
 1. Override the variable CLI VR RED JORNADA with the real working hours per day. In this case, the system pays for the whole month (30 days every month for a monthly employee) manages the employee as regular part time.
 2. Assign a work schedule to the employee. In this case, the system pays for the actual workdays according to the schedule and manages the employee as irregular part time.

For the *Guarda Legal* and *Jornada Reducida* absence takes, the percentage of reduction must be specified in the EVENT CONFIG1 field as a decimal (percentage of reduction in decimals), for example, 50% = 0.5 and 40% = 0.4.

For the *Maternidad Parcial*, *Paternidad Parcial*, and *Cuidado Menor* absence takes, the nonworking number of hours must be specified in the Partial Hours field, and you must ensure that you check it for all days following the Details link.

For the *Guarda Legal*, *Maternidad Parcial*, and *Paternidad Parcial* absence takes, the system automatically generates segmentation triggers for the begin and end dates. The triggers are defined for the GPES_ABS_TRIGR1 and GPES_ABS_TRIGR2 tables.

In addition to the 12 pay periods in a year, employees are eligible for two or more extra period payments, as defined by their labor agreements. Typically, most employees get extra period payments in June and December. Two extra period payments are the statutory minimum; however, a labor agreement may set a higher number. The amount of the extra period payment is also defined in the labor agreement.

Extra period payments can be prorated or paid as a single payment. For example, the labor agreement can specify that the first extra period payment be paid every month and prorated as 1/12 of the total amount of the extra period payment. The labor agreement can also state that the second extra period payment is to be paid as a single payment in December.

Calculating Extra Periods

The base for calculating extra periods is defined in the labor agreement. For each extra period, you define:

- The payment period and contribution timeframe.

The payment period is the month when the extra period payment is paid to the employees. The contribution timeframe is the period over which an amount is withheld. The contribution timeframe is defined with the Period From and Duration fields on the Extra Period Definition page. Prorated extra periods are automatically paid monthly throughout the year.

- Earnings that are included in the extra period calculation, and the percentage of each earning.

Not all earnings contribute towards the extra period—only those on the Extra Period Eligible Earning page are included in the selected extra period. You can define extra period payments that are based on different earnings. For example, you might have two extra periods, one based on the employee's base salary and a second period based on the base salary plus the transportation earning.

- Whether the payment is prorated or paid as a single payment.

Prorated extra periods are always based on the compensation for the processing period. Extra period payments that are not prorated are calculated in one of two ways:

- Based on the employee's compensation during the payment period.

For example, if you define the extra period as January to June and the payment period is June, the system uses the employee's monthly compensation for June to calculate the extra period amount.

- Based on the employee's compensation for each month of the contribution timeframe.

For example, if you define the extra period as January to June, the system uses the employee's monthly compensation for the months January to June to calculate the extra period amount.

- For employees whose salary is adjusted to gross or net, you need to define an overall extra period percentage.

This percentage is needed to get the target monthly salary from an annual amount. The annual amount is paid over 12 months plus the extra periods. You need to know whether one extra period is equal to a regular payroll or just a part of it. If a labor agreement defines two extra periods, one defined at 100 percent and another defined at 50 percent, the factor used to find the monthly salary is $1/12 + 1.0 + 0.5$.

Absence Processing

When the extra period is calculated, the system checks an employee's absence history and reduces the extra period payment for certain types of absences taken during the contribution time frame.

Two ways are available for managing the effect of absences in an extra period payment, depending on the calculation method selected in the Calculation Options group box on the Extra Period Definition page.

- If you select *Proration Lump Sum*, the extra period payment is calculated during the regular payroll process but the withheld amount takes into account the unpaid days.
- If you select *Payment Period Compensation*, the system stores in an accumulator the absence days that should be subtracted from the extra period payment (AUS AC D N PG XTRA).

When processing the extra period, the process determines the daily rate within the extra period timeframe for each earning and multiplies it by the extra period timeframe days minus the unpaid days.

The system checks the Take Config1 field in the absence take definition to determine whether the absence affects the extra period payment.

In the case of advanced extra periods (those extra periods with payment dates that are prior to the time frame end date), you can have absences that occur after the extra period has been paid. Those absence days need to be deducted at some point. PeopleSoft Global Payroll for Spain provides a variable, CLI VR PRC DTO XTR (extra period deduction process option), to accomplish this. This means that those absences that occurred between an extra period payment period and the extra period time frame end date will be deducted in the next extra period process. Values for the CLI VR PRC DTO XTR are PXTRA (default value—deduct from the next extra period process) and MENSUAL (deduct from the current regular period).

Example of a Calculation for Prorated Extra Periods

The labor agreement can specify that one of the extra period payments be prorated over the 12 regular payments during the year.

Note: Only one extra period payment can be prorated over the course of the year. If your requirements define more than one prorated extra period, you can use the Percent if Salary Adjustment and Earning Percent fields to set that up.

Assume that the labor agreement specifies three extra period payments a year: a flat amount to be paid in June and December and a prorated amount to be paid in 12 regular payments (monthly). The extra period payments are 1200 EUR each.

The prorated amount is calculated in the following way:

$$1200/12 = 100 \text{ EUR per month}$$

In the case of the prorated amount, an element called Prorated Extra Periods appears in the monthly payslips with a value equal to 100 EUR. This amount is accumulated over the gross and the taxable base but not over the social security base because the value of extra periods is considered in the social security base through the extra period proration.

Prorated extra periods are calculated by summing all eligible earnings and dividing by the duration (the extra period time frame), in days, to obtain a daily rate. For daily employees the duration is 365 or 366 days, and for monthly employees it is 360. This daily rate is then multiplied by the working days in the month. A prorated extra period is paid as a unique earning.

Partial Payments for Extra Period Earnings

When employees join a company in the middle of an extra period time frame, they are paid for only the portion of the time frame that they work. The system calculates the partial payment for the extra period earnings using a formula (XTR FM PXTR DVNGDA). The formula calculates a factor by dividing the number of worked days (during the extra period time frame) by the total number of days in the extra period time frame.

The calculation of the factor depends on an employee's social security contribution group type. Depending on whether his contribution group type is calculated daily or monthly, the calculation varies. Here are some formulas:

- Daily contribution groups:

The time frame is in calendar days. For example, for the time frame from January to June, the calculation is the sum of all the calendar days in the months from January to June:

$$(31 + 28 + 31 + 30 + 31 + 30) \text{ divided by } 181.$$

In this example, the factor is $181/181 = 1$

Now assume that an employee is hired on January 15, rather than January 1. The time frame is:

$$(17 + 28 + 31 + 30 + 31 + 30) \text{ divided by the total number of days from January 1 to June 30, which is } (167/181).$$

In this example, the factor is $167/181 = .9226$.

- Monthly contribution groups:

Assume that you have an employee who is on a monthly payroll and his hire date is January 15. In this case, the days that must be considered month by month are 30, and you must calculate the proration for that month (January) in which the employee has not worked fully. So the calculation is:

$(16 + 30 + 30 + 30 + 30 + 30) \text{ divided by } (30 \times 6)$

In this example, the factor is $166/180 = .9222$.

Processing Extra Periods for Terminations

The system processes extra period pay in two ways when a termination occurs in a month that corresponds to an extra period payment:

- The system calculates the extra period for the terminated employee during the calculation of the extra period itself.

Later, the regular payroll process calculates termination pay (including loans, advances, vacations, and so on).

- The system calculates the amount corresponding to the extra period during regular payroll processing as part of termination processing.

The corresponding amount for extra periods is paid through the LIQ PXTR XXX earnings as part of the regular payroll calculation. You exclude the terminated employee from extra period calculation.

Calculating the Annual Tax Base during Inactive Segment or Correction Calendar Processing

The system uses the XTR AC LIQ PGDO (Extra period paid at terminn) accumulator to store the amounts corresponding to extra periods that are liquidated in a certain month. XTR AC LIQ PGDO receives the delta with respect to the previous calculation and forwards it to the current month when retro processing occurs. The system subtracts this amount (delta of extra period liquidation) from the rest of the retro deltas if they are forwarded to an inactive segment or a correction calendar. This prevents the system from counting extra periods twice during the calculation of the annual tax base.

Extra periods are calculated and processed in two ways, depending on the type of extra period. Prorated extra periods are calculated in the normal process list, and extra periods that are not prorated are calculated in a separate process list (XTR PR PAGA EXTRA). The type of extra period (prorated or not) is defined when you specify the extra period for the labor agreement.

Note: The PeopleSoft system delivers a query that you can run to view the names of all delivered elements designed for Spain. Instructions for running the query are provided in the *PeopleSoft HCM 9.2: Global Payroll* product documentation.

Terminating Employees

Understanding Terminations

This overview discusses:

Termination Management

When an employee is terminated, the company pays the employee for any vacation days not taken, for days of the month worked, and for the proportion of the extra period payment earned. The company also subtracts the pending loans or advances repayments.

Often an employee termination can occur under nonstandard conditions. For example:

- An employee or employer might preadvise of the termination with fewer days than the law requires.
- An employee's severance pay might be different from the amount set by law.
- An employee might not agree with the termination reason and pursue litigation.

As demonstrated in these examples, employee terminations are not always straightforward. For such cases in which the termination process has exceptions, the company must determine nonfulfilled preadvise days, severance pay, and litigation salary so that the payroll process can calculate the desired results for termination pay. PeopleSoft Global Payroll for Spain provides functionality that enables you to manage termination information and calculations for these nonstandard conditions.

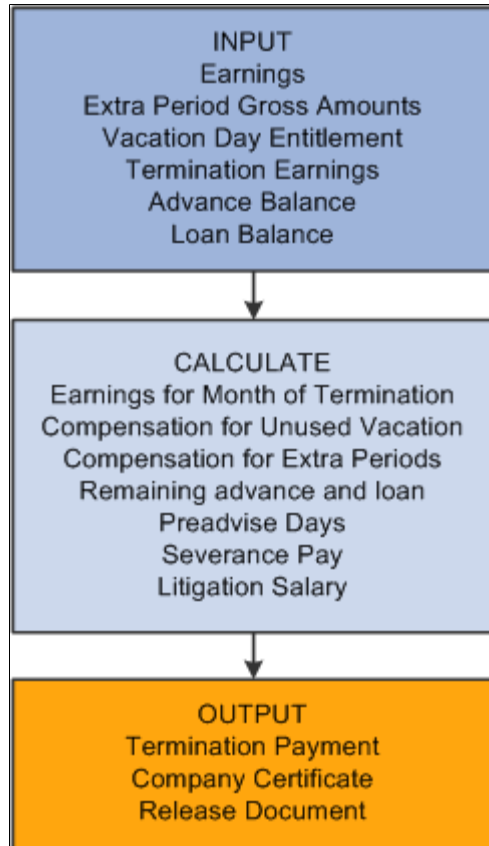
To terminate an employee, use the Job Data component (JOB_DATA). The system calculates termination pay using the same process list as the regular payroll. You can create specific calendars for termination processing or run termination processing within the calendar group that corresponds to the regular payroll. To ensure proper calculation of termination pay, you must first:

- Administer termination pay criteria through the Labor Agreement component.
- Define statutory severance days through the Statutory Rates ESP component.
- Define nonstandard conditions involving nonfulfilled preadvise days, nonstatutory severance, or litigation salaries through the Manage Terminations ESP component, when applicable.

Terminations in the Pay Process Flow

This diagram shows how the input of various data such as earnings, vacation, advance, and loan balances are used to calculate termination pay, termination letters, and company certificates involved with terminations and the overall pay process flow of PeopleSoft Global Payroll for Spain:



Preadvised Days Nonfulfilled

A preadvise period is the legal number of days that the employee and the employer have to communicate the end of a labor relation before the effective date of the termination. The minimum number of days for a preadvise period depends on various data such as contract type, termination reason, requirements that were established in the employee's labor agreement, and so on. Employees are penalized if they do not fulfill the number of preadvise days and compensated if the employer does not fulfill the number of preadvise days. These amounts are added or deducted from the employee's termination payment as applicable.

Use the Labor Agreement ESP - Terminations page to define the daily salary for preadvise days that the payroll process uses for terminations of labor agreements. Use the Termination Management ESP page to define the number of nonfulfilled preadvise days and who failed to notify within the minimum number of preadvise days.

Severance Pay

Severance pay is a fixed amount of money that the company must pay the terminated employee based on the type of contract that the employee has with the company, less the amount that the employee owes the company for items as loans and advances. If an employee is dismissed for reasons other than disciplinary,

the employee has a right to receive severance pay. This amount depends on the number of worked years, daily salary as of the termination date, and termination reason. The employer pays the employee this amount at the end of the labor relation. However, the employee has the right to appeal the severance pay amount through litigation.

Severance pay for terminated employees can be determined by one of the following methods:

- Statutory rates can determine the number of days by year to pay for severance and the maximum number of periods to pay for severance, depending on the termination reason.
- The labor agreement for the employee can improve the number of statutory days and the maximum number of periods to pay for severance.
- The employer and the employee can reach an agreement by which the number of days by year, the maximum number of periods for severance pay, or both is greater than the statutory rate.
- The employer and the employee can reach an agreement for a specific amount of severance pay that is greater than the statutory rate.
- A judge can impose an amount for severance pay.

Use the Severance Days page in the Statutory Rates ESP component to define statutory days and periods for severance pay as defined by the social security general treasury (Tesorería General de la Seguridad Social [T.G.S.S.]). Use the Labor Agreement ESP - Terminations page to define the daily salary for severance pay and override the statutory values that the payroll process uses for terminations of labor agreements. Use the Termination Management ESP page to override calculated values for severance pay.

Job Litigation Salary

Litigation salary is the salary that the company is required by law to pay the terminated employee if the employee appeals the termination. If an employee appeals termination and the appeal goes to court, that employee has a right to receive job litigation salary for the period between the termination date and the final resolution date of the litigation regardless of the ruling. The job litigation salary is equivalent to the employee's regular salary. If the employee and the company reach a friendly agreement before the appeal goes to court, job litigation salary is not needed.

Use the Labor Agreement ESP - Terminations page to define the daily salary for job litigation that the payroll process uses for terminations of labor agreements. Use the Termination Management ESP page to enter the job litigation information.

Pre-advised Daily Salary

Manage Terminations ESP

Termination Date

Displays the last date that the employee is active in the company. The system obtains this value from the employee's job data record.

Termination Reason

Select the reason why the employee was terminated. The number of statutory days that the system uses when it calculates severance pay depends on the termination reason that you select. T.G.S.S. defines and supplies companies with the valid termination reasons and statutory values.

Based on your selection, the system displays the appropriate statutory values as defined by law in the Statutory Values column of the Severance Pay group box. You must maintain the statutory values for each termination reason on the Severance Days page. The system also uses your selection when calculating indemnification days to pay the employee.

Seniority Pay Calc Date (seniority pay calculation date)

Displays the initial date that the system considers when calculating the employee's severance pay, indemnification days, and job litigation salary. The system obtains this value from the hire date of the employee's job data record.

Currency Code

Select the currency code for the termination pay.

Comment

Enter any additional comments about the processing of the employee's termination. This field is for information purposes only.

Pre-advised Days Non-Fulfilled

Use this group box when the employee or employer has failed to notify the other within the minimum number of preadvice days.

Nbr Pre-advice Days (number preadvice days)

Enter the number of days by which the employee or employer has failed to meet the legal number of preadvice days that are required at the end of a labor agreement. These nonfulfilled preadvice days increase or reduce the employee's last payment depending on whether the employee or the employer committed the violation, as specified in the Who Pre-advises field. You must enter a positive value.

Who Pre-advises

Select who has to fulfill the preadvice days that you have specified in the Nbr Pre-advice Days field. Values are:

- *Employee:* Select this value if the employee does not fulfill the preadvice period. The payroll process deducts the calculated amount from the employee's last payroll payment by writing the value to the DD PREAVISO deduction element.

Note: The DD PREAVISO earning reduces the tax base but not the Social Security base.

- *Company:* Select this value if the employer does not fulfill the preadvice period. The payroll process adds the calculated amount to the employee's last payroll payment by writing the value to the DEV PREAVISO earning element.

Note: The DEV PREAVISO earning contributes to the tax base but not to the Social Security base.

Severance Pay

To overwrite the severance pay, select the Overwrite Severance Pay check box. Then use the Severance Pay group box to modify the days of indemnification by year of service or the total amount to pay as indemnification. The values that you enter in these fields overwrite the days or amount that the payroll process determines. Values for days of salary by worked year and maximum number of periods vary depending on the contract type and termination reason.

Overwrite Severance Pay

Select to overwrite the severance pay values that the system calculates during the processing of the employee's payroll during the termination period. If you select this check box, the

fields in the Severance Pay group box become available for edit. Use these fields to make the necessary overrides.

Days/Year

Displays the number of indemnification days by year that the payroll process considers when calculating the employee's severance pay amount. The system automatically determines the indemnification days by year and displays the value in the Statutory Values column. The system determines the statutory value based on the number of indemnification days by year that is mandatory by law for the specified termination reason.

You define these values by termination reason on the Severance Days page.

To override the statutory value that the system determines, enter a value that is greater than the statutory value. When using this override, you must clear the Severance Pay Amount field. Note that the employee is taxed for the severance pay amount that corresponds to the number of days by year that are over the statutory value.

Max. Periods (maximum periods)

Displays the maximum number of periods for indemnification that the payroll process considers when calculating the employee's severance pay amount. The system automatically determines the maximum periods and displays the value in the Statutory Values column. The system determines the statutory value based on the minimum number of periods mandatory by law for the specified termination reason. You define these values by termination reason on the Severance Days page.

To override the statutory value that the system determines, enter a value that is greater than the statutory value. When using this override, you must clear the Severance Pay Amount field.

Severance Pay Amount

Use this field to override the amount that the system would automatically calculate by multiplying the Days/Year value by a daily salary. Enter the amount of the employee's severance pay.

When using this override, you must clear any override value from the Days/Year and Max. Periods fields.

If you instead want to use the severance pay amount that the system calculates, then you must leave this field blank.

Note: The employee is taxed for the severance pay amount that is over the statutory value.

Appealed

If the employee disagrees with the employer about termination or severance pay, select the Appealed check box. Then use the Appealed group box to enter the job litigation information related to the dispute.

Appealed

Select this check box if the employee does not agree with the termination reason or severance pay and lodges an appeal against the termination. If you select this check box, the fields

in the Appealed group box become available for edit. Enter the necessary appeals data into these fields. Deselect this check box to indicate that the end of the labor relation is effective and that no further action concerning the former employee is required.

Conciliation Date

If applicable, enter the date that the employer and employee reach an agreement in mediation, arbitration, and conciliation (*Servicio de Mediación Arbitraje y Conciliación* [SMAC]) court. This field is for information purposes.

Sentence Date

If applicable, enter the date on which the judge of the SMAC court dictates a resolution between the employee and the employer. This occurs if the two parties cannot reconcile. Thus you need enter this date only if no conciliation date exists.

Final Date for Job Lit. Salary (final date for job litigation salary)

Enter the final date that the payroll process uses to calculate job litigation salary for the employee. This value can be the conciliation date, the sentence date, or another date upon which the employee and employer reach an agreement. The payroll calculation process considers this date the last date to calculate job litigation salary, using it to determine the number of days in which litigation is involved. Leaving this field blank causes the job litigation salary to be zero and the employee's final payment does not change. If the employer deposits the maximum statutory amount for severance pay, leave this field blank so that this salary will not be paid.

Note: The system uses the rehire date of the payee as the first day of the litigation salary period.

Sentence Job Lit. Salary (sentence job litigation salary)

Enter the amount that the judge imposes as job salary that is due to the employee during the litigation period. For example, if the termination date is January 19 and the final date for job litigation salary is January 24, then the job litigation salary is based on the 20th through the 24th, which is the litigation period. This amount overrides the amount that the payroll process calculates for job litigation salary. The payroll process distributes this amount across the months and days of the affected payroll period to properly pay for contributions and taxes. In case of litigation salaries, contributions are reported under L02 payment type in the FAN File.

If you enter a value for this field, you must also enter a value for the Final Date for Job Lit. Salary field.

Sentence Severance Pay

Enter the amount that the judge imposes as severance payment. This amount overwrites the severance pay amount that the payroll process calculates. The employer must pay this amount to the employee less the amount already paid upon termination.

Unemployment Benefits

Enter the amount that INEM has paid to the employee during the job litigation period. You can deduce this amount based on the net amount to pay as job litigation salary for the affected

period. If you enter a value for this field, you must also enter a value for the Final Date for Job Lit. Salary field.

Terminating Employees in Self-Insurance Companies

If an employee leaves a self-insurance company while on temporary disability (IT or AT/EP), the employee is entitled to continue receiving the economic benefits for the temporary disability until the end of the sickness event. The self-insurance company must therefore continue managing the cost of the temporary disability.

For the payroll process to include terminated employees who were absent on the termination date, you must terminate the employee with an Action/Reason field value of *Terminated with Pay* (TWP action) or similar action with a payroll status value of *Terminated With Pay* on the employee's job data record. This sets the Payroll Status field value for the employee to *Terminated With Pay* and makes the employee eligible for payroll processing. You can determine which actions have this payroll status by viewing the Payroll Status field value for the action definition on the Action page of the Action Reason component.

When the employee's temporary illness ends, you must then update the employee's payroll status to *Terminated* by selecting the *Terminated* (TER action) in the Action/Reason field so that the payroll process no longer includes the employee.

Note: Although self-insurance companies must continue to manage the cost of temporary disability for terminated employees who are on temporary disability, these companies do not have to manage the cost of complementary benefits. The payroll process therefore does not calculate complementary benefits earnings for terminated employees.

Processing Termination Pay

Termination Payment Calculation

Termination payments are calculated in the payroll and not as a separate process. The final payment to an employee must include all money due to that employee. This compensation includes the regular salary, extra periods, unused vacation days, and unpaid overtime. The final payment must also consider any outstanding loans and advances, nonfulfilled preadvise days, severance pay, and litigation salary.

To calculate termination pay, the payroll process calculates:

- The regular earnings and deductions that are due for the month of termination.
- The compensation for the unused paid vacation days.

To do this, the system multiplies the daily rate (FNQ FM VAL D VAC) by the number of remaining paid vacation days.

- The unpaid extra period earnings.

Employees must be paid for the extra pay periods to which they contributed during the year. To calculate the compensation amount, the system multiplies the daily rate by the number of days accrued until the termination date. The system calculates the daily rate by taking into account the definition of the extra period. If an extra period has been paid in advance, the system generates an extra period earning with a negative value to deduct the amount paid for which the employee is not eligible.

- The amount owed for loans and advances, independent of each other.

This amount is automatically deducted from the last payslip.

- The amount for nonfulfilled preadvise days, severance pay, and litigation salary.

For PeopleSoft Global Payroll for Spain, the payroll process generates termination payments based on the last day that an employee works, which is one day prior to the termination date. The termination date is equal to the effective date of the TER (termination) action on the employee's JOB_DATA record (Job Data component). The system also populates the Contract End Date field with that date, which PeopleSoft Global Payroll for Spain uses for processing.

When you enter a TER action, the system can invoke the JOB retro trigger to process the employee's termination pay. To ensure that the payroll process uses the date one day prior to the termination date for termination payment processing, the delivered JOB retro trigger for terminations offsets the termination date by -1 for actions that equal TER. This can be set by the Offset Days field value on the Trigger Definitions – Field Values page.

Terminations and Extra Period Processing

The system processes extra period pay in two ways when a termination occurs in a month that corresponds to an extra period payment:

- The system calculates the extra period for the terminated employee during the calculation of the extra period itself.

Later, the regular payroll process calculates termination pay (including loans, advances, vacations, and so on).

- The system calculates the amount corresponding to the extra period during regular payroll processing as part of termination processing.

The corresponding amount for extra periods is paid through the LIQ PXTR XXX earnings as part of the regular payroll calculation. You exclude the terminated employee from extra period calculation.

Note: Neither of these ways substitute for the termination payroll. These choices to process termination pertain only to processing extra periods.

To allow for a flexible setup, PeopleSoft Global Payroll for Spain provides the CLI VR FNQ P PXTRA variable (pay extra period in termination), with the default value of *N* (don't execute the extra period). This means that, by default, terminated employees will not be included in the extra period calculation during a payment month that is an extra period. The system also provides an informational message stating that the employee was not included in the extra period calculation because he or she is terminated in such a period. Values for the CLI VR FNQ P PXTRA are *Y* (pay the extra period payment) and *N* (don't pay the extra period payment).

In the case that an extra period is paid in advance (extra periods with a payment date earlier than the extra period time frame end date) and in the case of the termination pay calculation, different situations may arise:

- The extra period was not paid, so pending extra periods are paid as part of the current period compensation, deducting the absence days affecting the extra period payment during the termination calculation.
- The extra period was already paid and the termination date is later than the extra period payment date but earlier than the extra period time frame end date.

The extra period is paid but now those days paid in advance but not worked need to be discounted. The amount to be discounted can be calculated within the current compensation at termination time, or within the compensation paid at such an extra period.

This is designed to be open, setting the value of the variable CLI VR PD VLR PXTR (compensation paid to pay extra period). Values for this variable are *PAGADO* (paid extra period compensation) and *ACTUAL* (current period compensation). The default value is *PAGADO*. Thus, the system calculates this deduction value using the previously paid daily price.

- The extra period was already paid, but absence days pending are to be discounted (absence days that occurred after the payment date but before the extra period end date).

Those days will be discounted in the following extra period calculation (if you have it set up like this). Due to the termination, the absence days will be discounted in the termination pay.

Vacation Balance Calculation for Terminated Employees

Beginning in 2003, Social Security requires new treatment for vacations owed to terminated employees. The pending vacation days that the employee has at the time of termination must be distributed as part of the termination pay.

The vacation balance is calculated depending on the type of vacation days agreed upon in the employee's contract data. The most common types of vacation days are natural days and work days. Natural days includes all days in a month, including weekends and holidays. Working days are the days that the employee actually works and don't include weekends and holidays. The vacation balance calculation is different for each vacation days type.

Note: Two other types of vacation days are also used in Spain—weeks or months. Calculation for all vacation types is discussed in this topic.

Calculating Pending Vacation Balance for Natural Days Vacation Type

To calculate compensation due to a pending vacation balance for employees with the natural days vacation type, use this formula:

Daily rate \times Vacation balance (natural days)

Calculating Pending Vacation Balance for Work Days Vacation Type

To calculate the work days vacation type, you first convert an employee's daily rate to a work days daily rate. Then you can get the amount to be paid for vacation not taken by multiplying the work days daily rate times the vacation balance.

The formula to calculate the work days daily rate is:

Work days rate = Daily rate \times 360 / (Annual work hours by Labor Agreement / 8)

Note: This conversion rule is an example that considers the annual number of working days equal to Annual work hours by Labor Agreement / 8, because the most common work schedule is eight hours per day. You can adapt this rule to your specific requirements, modifying the element FNQ FM CONV VAC D.

To calculate compensation due to a pending vacation balance for employees with the work days vacation type, use this formula:

Work days rate \times Vacations balance (work days)

Calculating Pending Vacation Balance for Weekly or Monthly Vacation Type

If the employee has a weekly or monthly vacation type, these vacation types must first be converted to natural days. In the case of a weekly vacation type, the system calculates the natural days by multiplying natural days by 7. In the case of a monthly vacation type, the system calculates natural days by multiplying natural days by 30.

Calculating Social Security Contributions for Vacation Pay of Terminated Employees

When the pending vacation days have been calculated, you need to calculate Social Security contributions. For you to do so, the vacation pay has to be distributed to the terminated employee. To distribute the vacation pay, you need to determine whether the number of vacation days to pay is equal to, less than, or greater than the number of days from the day after the termination date to the last period day. For example, if an employee's last day is April 27 and the period end day is April 30, you need to determine whether the number of vacation days to pay is equal to, less than, or greater than three days.

If the number of vacation days to pay is equal to or less than the number of days from the day after the termination date to the last period day, a calculation must be made to get the Social Security base, contributions, and reductions (if applicable) that correspond to those days in the current month. This separate calculation will generate a complementary liquidation in the same month that the regular Social Security liquidation occurs. If this is the case, a new section in the TC2 report needs to be generated.

If the amount of vacation days to pay is greater than the number of days from the day after the termination date to the last period day, you need to go to the following month to continue contributing for those extra pending vacation days (the difference between the total number of pending vacation days and the days after the termination date and last period day). Another calculation must be made that will generate another complementary liquidation.

Example of Vacation Pay Distribution

Here is an example of how vacation pay is distributed for a terminated employee:

Assume that an employee has a vacation type of natural days, with a value of 24 natural days per year. The employee is terminated on April 27 and had taken 2 vacation days since the beginning of the year. The vacations entitlement up to the termination date is calculated in the following way:

Assuming 30 days each are in January, February, and March, and 27 days are in April (up until the employee's termination), you get this result:

- $(30 + 30 + 30 + 27 / 360) \times 24$ (natural days) = 7.8 days
- Round out 7.8 days = 8 days (vacation entitlement)
- $8 - 2$ (vacation days taken) = 6 (vacation balance)

The vacation days are distributed in the following way:

In the termination month of April, the employee will contribute 27 contributed days to Social Security and 3 vacation days to complete the maximum 30 contributed days for a monthly employee. The pending 3 vacation days will be contributed for May to complete all the pending vacation days.

Generating a Unique TC2 Report for Pending Vacation Balances

Because the distribution of pending vacation pay can affect more than one pay period, you must generate a unique TC2 report to show all the different periods. The code for complementary reports for pending vacations is L13.

Calculation for Nonfulfilled Preadvised Days

The payroll process uses the following equation to calculate the amount for preadvised days nonfulfilled:

Nonfulfilled Preadvise Amount = Number of nonfulfilled preadvised days * Daily rate for the preadvised salary

This amount is added or deducted from the employee's termination payment as applicable.

Severance Pay Calculation

The system contains all of the logic to determine the severance pay amount based on the legal rules for seniority days to pay per year of service. The payroll process calculates the amount to pay the employee in indemnity through the following equation:

Severance pay = Number of Days * Daily Salary for Indemnity

Where

Number of Days = Minimum value of {(Days by Year * Number of Worked Years) or (Maximum Number of Periods * 30)}

The payroll process determines the number of days to pay by taking the lesser value of either (a) the multiplication of days by year of service by number of worked years, or (b) the maximum number of periods by 30. The resulting values vary depending on contract type and termination reason. Note that the Days by Year value is prorated if the year is not complete.

If the employee is in probation period when he is terminated, the employee does not receive severance pay. The system uses the value in the Probation Period field on the employee's labor agreement to make this determination.

Job Litigation Salary Calculation

The system calculates job litigation salaries as part of the regular payroll process. The payroll process differentiates between whether an employee is in a regular period or period for job litigation salary. When the system makes this differentiation, it determines which elements the payroll process needs to resolve. When calculating job litigation salary, the payroll process calculates payroll for the periods affected by job litigation, considering only the earnings elements that are defined for job litigation salary. To calculate job litigation salary, the payroll process uses the following equation:

Job Litigation Salary = Units * Rate

Where

Units = Number of days to pay for job litigation salary

Rate = Daily gross salary for days of job litigation

Calculation of job litigation salary is the same as normal workdays except for the calculation of daily salary. The system calculates daily salary in one of two ways:

- If the employee and employer come to an agreement during litigation, the system calculates the daily salary for job litigation through the following method:

1. When a termination occurs, the system stores the job litigation daily salary in the termination results table through an accumulator. This accumulator determines which earnings contribute to the job litigation salary.
 2. When the system calculates job litigation salary, it retrieves the value from the previously mentioned accumulator using a historical rule, and then the system multiplies this value by the number of days to pay in the litigation period.
- If the judge imposes an amount for job litigation salary, the system divides this amount across the number of days that are considered part of the job litigation period to obtain the daily job litigation salary.

If this is the case, you can overwrite the amount that the system obtains from the relevant accumulator by entering the amount imposed by the judge on the Termination Management ESP page. The sentence amount imposed by the judge overrides any amount the payroll process calculates. The system divides the amount imposed by the sentence across each month affected by the job litigation salary to correctly calculate the social security contributions and taxations.

Job litigation salary earnings are applicable to both social security contributions and IRPF taxation. Employers must therefore report litigation salary to social security. When you run the payroll process for the employee during the month of the job litigation sentence, the system calculates all job litigation salary as retroactive pay (if the salary corresponds to past periods) for all payroll periods that are part of the job litigation period, including prorated extra periods, and applies the related social security contributions and taxations to each affected month. Social security contributions corresponding to litigation salaries are reported under a specific code (L02) in the TC2 report.

If the judge determines that the employee was wrongfully terminated and that the employer must rehire the employee, the readmitted employee must return the payment amount received for severance pay to the company, and must return the unemployment benefits received for the period affected by job litigation directly to the national employment institute (*Instituto Nacional de Empleo* [INEM]). The process considers the readmitted employee's salary for the period affected by job litigation as normal worked days.

Understanding the Termination Letter

The termination letter establishes an employee's termination conditions, indicating the end date of the contractual relationship (the sign date) and the total termination compensation (including the respective monthly compensation). It must be signed by the employee to indicate that he or she agrees to the termination conditions.

The termination letter can be printed only after the termination payment has been calculated (so that net to pay and the different components and amounts are included). The termination letter can be presented to the employee with the regular payslip. After you issue the termination payment, you can print the regular payslip and the termination letter with the termination compensation included in both.

Even though the organization issues the termination letter, it is written in the employee's voice and includes the following information:

- Employee name.

- Company name.
- Hire and end date.
- Employee professional category.
- Total termination compensation, including social security contributions and tax deductions.

Note: You must define the payslip template with the elements that you want to include in the printed payslip

- Employee signature.

Understanding the Company Certificate

There are five different variations of the Company Certificate report:

- INEM Company Certificate report.
- Company Certificate report for temporary disability.
- Company Certificate report for maternity or paternity.
- Company Certificate report for risk during pregnancy or lactancy.
- Company Certificate report on demand (INSS).

INEM Company Certificate Report

The INEM (*Instituto Nacional del Empleo*) Company Certificate report can be issued to an employee by an organization at the end of the contractual relationship. INEM uses the company certificate report to calculate employee unemployment benefits based on contributions for the last 180 days, as detailed in the certificate. Companies must give this report to an employee when the employee is terminated so that the employee can acquire an unemployment salary. The basic information that this report provides consists of the contributions that correspond to the last 180 days prior to the termination and the contributions that are paid for vacations at termination.

The report needs to contain the termination reason, the reason description, and an official code provided by the INEM code table. You need to ensure that action reasons table contains the right codes to be used during INEM Company Certificate reporting.

The INEM Company Certificate report contains the contract frames (*distribución de las jornadas de trabajo en contratos a tiempo parcial*) for part-time employees. In addition, the report contains a box for job litigation salary information. This cell includes:

- The start date for the job litigation salary, which is the date of the employee's termination.
- The end date of the job litigation salary which, depending on litigation results, is the conciliation date, the sentence date, or the final date for job litigation salary.
- The number of days considered for job litigation salary.

Within the contribution period of the last 180 days, if job litigation salaries exist, then the system includes this data in the INEM Company Certificate report. INEM requires this information to be within the report.

Company Certificate Report for Temporary Disability

The purpose of the economic benefit for temporary disability is to cover the loss of earnings that occurs when the worker, due to illness or accident, is temporary unable to work and requires Social Security medical assistance. Among the necessary documents for processing the benefit is the Company Certificate Report for temporary disability.

In addition to the company, employee, and termination data presented on the basic report, the report for temporary disability also contains:

- Temporary disability data including the last confirmation note (*último parte de confirmación abonado por la empresa*).
- Contributions in the month prior to the temporary disability, depending on the type of employment:
 - Part-time employees: contribution bases for the 3 months prior to the temporary disability.
 - Full-time employees: contribution bases for the month prior to the temporary disability.

Note: When you generate the Company Certificate report for temporary disability for an active employee, it does not display termination data.

Company Certificate Report for Maternity or Paternity

Economic benefits for maternity or paternity are subsidies granted to workers, regardless of gender, who take advantage of their legally established periods of leave in the case of maternity, paternity, adoption, or fostering. Among the necessary documents for processing the benefit is the Company Certificate Report for maternity or paternity.

In addition to the company, and employee data presented on the basic report, the report for maternity or paternity also lists the contributions made prior to the onset of maternity or paternity, depending on the type of employment:

- Part-time employees: contribution bases for the 12 months prior to the onset of maternity or paternity.
- Full-time employees: contribution bases for the month prior to the onset of maternity or paternity.

Company Certificate Report for Risk During Pregnancy or Lactancy

The risk during pregnancy or lactancy economic benefit covers the loss of income that occurs when:

1. A worker as her work contract suspended because of a risk during pregnancy or lactancy.
2. The risk requires that she be given an alternative job that is more compatible with her situation.
3. It is technically or objectively impossible to provide a suitable alternative job.

Among the necessary documents for processing the benefit is the Company Certificate Report for risk during pregnancy or lactancy.

In addition to the company, and employee data presented on the basic report, the report for risk during pregnancy or lactancy also lists the contributions made prior to the risk, depending on the type of employment:

- Part-time employees: contribution bases for the 3 months prior to the risk for pregnancy or lactancy.

- Full-time employees: contribution bases for the month prior to the risk for pregnancy or lactancy.

Company Certificate Report (INSS)

Active (not terminated) employees can request an INSS (*Instituto Nacional de la Seguridad Social*) Company Certificate report on demand with information relative to their contributions. In addition to company and employee data, this report displays the month, year, number of contributed days, contribution group and Social Security bases for the last six months worked.

- The Company Certificate report (INEM).
- The Company Certificate report on demand (INSS).

Generate Report

As Of Date

Enter the date on which you want the system to base the report results. This field is available only if you select the Active employees option in the Filter group box.

If you use the Automatic Search group box to search for employees, the system populates this field automatically, and you cannot edit it.

Last Assignment Start Date

Use this field to override the starting date determined by the system based on your selection in the Hire Date Option field.

Reason

Enter the reason for the report generation. This reason determines the type of report that the system generates.

If you use the Automatic Search group box to search for employees, the system populates this field automatically, and you cannot edit it.

Values are:

- *AT/EP (Accidentes de Trabajo y Enfermedades Profesionales)*: Results in the generation of the Company Certificate report for temporary disability.

Note: This report includes termination information for terminated payees.

- *INEM (Instituto Nacional del Empleo)*: Results in the generation of the INEM Company Certificate report.
- *INSS (Instituto Nacional de la Seguridad Social)*: Results in the generation of the INSS Company Certificate report.
- *IT (Incapacidad Temporal)*: Results in the generation of the Company Certificate report for temporary disability.

Note: This report includes termination information for terminated payees.

- *In Maternity*: Results in the generation of the Company Certificate report for maternity or paternity.

Note: This report includes termination information for terminated payees.

- *In Pregnancy Risk*: Results in the generation of the Company Certificate report for risk during pregnancy or lactancy.

The payroll process calculates the pending vacation days for terminated payees as part of the termination calculation. The Company Certificate report process uses the information about regular contributions and pending vacation days at termination. It inserts the pending vacation days and the Social Security bases such as the Common Contingencies base and the Professional Contingencies base for those pending vacation days into the Company Certificate report.

Create Termination Letters Page

Use the Create Termination Letters page (GPES_RC_FNQ2) to run the Create Termination Letters report (GPESFNQ2) that generates a termination letter for the employees listed.

Delivered Termination Earnings

Extra period termination earnings that are considered to be part of the termination process must be specified in the Termination Earning field on the Extra Period Definition page.

An employee who is entitled to extra periods in July and December, for example, would be paid the earnings LIQ PXTR JUL and LIQ PXTR DIC.

Note: PeopleSoft Global Payroll for Spain delivers sample earnings that are defined as PeopleSoft Delivered/Not Maintained. If you want to create your own termination elements, first define them on the Earnings page and then list them on the Extra Period Definition page.

Example of Termination Earnings Calculation

Assume that an employee has a total gross annual compensation of 50.000 EUR. The labor agreement specifies that the employee receive two extra period payments: one paid on June 15 and the other on December 15. Your company has a monthly payroll, so in addition to the 12 regular payments, two other payments exist, making a total of 14 payments in a year. To get the gross compensation for the monthly payment, you make this calculation:

$$50.000/14 = 3571.43 \text{ EUR}$$

Assume that the employee joined the company on March 1 and that the time frame for the June extra period is six months (from January to June). The extra period payment date is June 15. He will earn 4/6 times the gross compensation of the payment because he has been working for four months.

Remember that the payment date does not alter the result, so the extra period calculation takes into consideration the days worked up to June 30, regardless of the payment date. For example, if the payment date is June 15 and the time frame end date is June 30, the system calculates the days worked from May 15 to June 30.

The result for a monthly employee who joined the company in mid-May (using a month with 31 days) is:

$$((17+30) / 180) * 3571.43 = 0.261111 * 3571.43 = 932.54 \text{ EUR}$$

The result for a daily employee is:

$$((17+30) / 181) * 3571.43 = 0.259669 * 3571.43 = 927.39 \text{ EUR}$$

Now consider the example of an employee hired March 1 and terminated May 31.

If the employee is paid monthly, the result is:

$$((30 + 30 + 30) / 180) * 3571.43 = 0.5 * 3571.43 = 1785.72 \text{ EUR}$$

If the employee is paid daily, the result is:

$$((31 + 30 + 31) / 181) * 3571.43 = 0.508287 * 3571.43 = 1815.31 \text{ EUR}$$

This amount is paid through the earning element for the June extra period that is specified in the Termination Earnings field on the Extra Period Definition page.

Delivered Termination Earnings

This table lists the delivered termination earnings:

Earning	Description
DEV PREAVISO	Preadvised earning. This is the amount to add to the employee's last payment for preadvice days not fulfilled by the employer. Define preadvice days not fulfilled for an employee termination on the Termination Management ESP page.
INDMNCN	Termination indemnity. This is an existing element that stores the severance pay that is paid to a terminated employee. The calculation rule for this earning element has been modified from Amount to Unit * Rate, as defined on the Earnings - Calculation page.
INDMNCN SENT	Sentence indemnity. This is the amount of severance pay that the judge imposes during job litigation, as defined on the Manage Terminations ESP page.
LIQ PXTR DIC	December extra period termination. This is used for December extra period termination payment. The execution of this earning is conditioned to generation control FNQ GC LIQ DEV.
LIQ PXTR JUN	July extra period termination. This is used for July extra period termination payment. The execution of this earning is conditioned to generation control FNQ GC LIQ DEV.
LIQ PXTR SEP	September extra period termination. This is used for September extra period termination payment. The execution of this earning is conditioned to generation control FNQ GC LIQ DEV.
SAL TRAMIT	The amount calculated as job litigation salary.
VAC NDSFRTDS	Terminate vacation days paid at termination. This is used to store the amount corresponding to vacation days that are paid at termination.

Delivered Termination Deductions

This table lists the delivered termination deductions:

Deduction	Description
DD PREAVISO	Preadvised deduction. This is the amount to subtract from the employee's last payment for preadvice days not fulfilled by the employee. Define preadvice days not fulfilled for an employee termination on the Termination Management ESP page.
DD DESEMPLEO	Unemployment benefits. This is the amount subtracted from an employee's job litigation salary for unemployment benefits accrued during the litigation period of an appealed termination.
DTO PXTRA AUS	Absence on extra period already paid. This deduction is generated in case an advance extra period is paid, and then an absence occurs after the extra period has already been paid.
LIQ ADLNT0	Advance termination. This is used for advance termination payment. Customer field 5 contains label 'LIQ ADLNT0' (See FNQ FM AYP VAL).
LIQ PRSTMO	Loan termination. This is used for loan repayments (Capital part) termination payment. Customer field 5 contains label 'LIQ PRSTMO' (See FNQ FM AYP VAL).
LIQ V SS CC	Vacation treatment for social security common contingency. This is used to calculate an employee's common contingencies contributions due to vacations not taken at the time of termination.
LIQ V SS DS	Vacation treatment for social security unemployment. This is used to calculate an employee's unemployment contributions due to vacations not taken at the time of termination.
LIQ V SS FP	Vacation treatment for social security professional treatment. This is used to calculate an employee's professional training contributions due to vacations not taken at the time of termination.

Note: The PeopleSoft system delivers a query that you can run to view the names of all delivered elements designed for Spain. Instructions for running the query are provided in the *PeopleSoft HCM 9.2: Global Payroll* product documentation.

Understanding Gross and Net Guarantee

Gross and Net Guarantee Overview

When you calculate an employee's total salary, you need to consider some adjustments to the base salary that are specified in the employee's personal agreement. These adjustments may come from an employee's contract. Typically, employee compensation in Spain is defined by a labor agreement. However, you can define compensation in different ways using PeopleSoft HR.

For employees whose personal agreement defines a net or gross amount, the system compares the employee's contract with the compensation defined for the employee (usually in the labor agreement). If these two amounts are the same, no adjustment is necessary. This salary includes both base salary and complements.

Compensation Setup - Gross to Net

A gross to net adjustment is necessary when the annual gross salary stated in an employee's personal agreement is different from the gross salary reflected in the employee's labor agreement (if compensation is defined at the labor agreement level). This agreed value is stored in the Target Compensation Rate field on the Job Data - Compensation Page.

See "Understanding Job Data (*PeopleSoft HCM 9.2: Human Resources Administer Workforce*)".

The system calculates and displays the estimated difference between the negotiated gross and the sum of all earnings that the employee would receive by default based on his or her professional category, job code, or other default criteria. This amount is known as the absorbable complement (*complemento absorbible*).

Compensation Setup - Net to Gross

This type of adjustment applies when an employee's personal agreement states a net amount. This agreed net amount is stored in the Target Compensation Rate field on the Job Data - Compensation page.

The system calculates and displays an estimated absorbable complement as the difference between the targeted net compensation and the sum of all net earnings that the employee would receive by default based on his professional category, job code, or other default criteria. The targeted compensation rate is the net guarantee to the employee.

Note: In both cases, this topic refers to the estimated absorbable complement because it doesn't consider seniority. The actual amount is calculated during the payroll process and is reflected in the earning element COMP ABSRBLE.

Calculation - Gross to Net

The system calculates an absorbable complement as the difference between the negotiated gross and the sum of all basic earnings calculated for the employee during the payroll calculation (including, for

example, seniority earnings) that are defined as absorbable. Absorbable means that increases in the value of the earning are absorbed by the absorbable complement.

Note: To specify that an earning is absorbable, you must include the rate component of the earning EARNING_VLR as a member of the accumulator AJB AC DEV BAS S.

Calculation - Net to Gross

The system uses an iterative process to calculate the gross amount from the net amount guarantee and an estimated gross amount. The difference between the calculated gross amount and the sum of all basic earnings defined as absorbable and calculated for the employee is assigned to the absorbable complement.

Note: To specify that an earning is absorbable, you must include the rate component of the earning EARNING_VLR as a member of the accumulator AJB AC DEV BAS S.

Gross to Net Calculation Method

To determine the absorbable complement for a gross to net calculation, the system:

1. Calculates the agreed monthly gross income based on the employee's gross guarantee.

The system retrieves the agreed gross from the Target Compensation Rate field on the Job Data - Compensation page and calculates the daily value, taking into account the number of regular and extra periods. If the Target Compensation Rate field is blank, the system uses the value in the Annual Rate field on this page.

2. Calculates the total daily value of the absorbable earnings specified for the employee on the Job Data - Compensation page.

This calculation takes into account extra periods defined in the labor agreement and absences.

3. Calculates the difference between the agreed daily gross amount calculated in step 1 and the monthly gross amount calculated in step 2.

The system calculates the difference using the daily value for both amounts and then multiplies the difference by the number of days worked. This amount is stored in the absorbable complement earning COMP ABSRBLE.

Note: To specify that an employee's earnings must be adjusted gross to net, assign a supporting element override to variable GEN VR TIPO AJ SAL with a value of *BRUTO*.

Example

Assume that the employee has the salary details in the following table:

Salary detail	Values
Agreed annual income	40.334,00 EUR
Earnings defined in the labor agreement for the employee's professional category	Base salary: 750 EUR/month Complement: 500 EUR/month
Extra periods (defined in the labor agreement)	Extra Period 1: Earnings: Base salary and Complement Earnings Pct: 100% Pct if Salary Adjustment: 100%
	Extra Period 2: Earnings: Base salary and Complement Earnings Pct: 100% Pct if Salary Adjustment: 100%

To calculate the absorbable complement, the system:

1. Calculates the agreed monthly income by dividing the annual value by the total number of payments in the year:

$$40.334,00 \div 14 \text{ (12 months + 2 extra periods)} = 2.881,00 \text{ EUR per month}$$

2. Determines the monthly income based on the labor agreement:

$$\text{Total monthly income per labor agreement: } 750,00 + 500,00 = 1.250,00 \text{ EUR/month.}$$

3. Calculates the difference between the agreed monthly gross amount and the monthly gross amount according to the labor agreement:

$$2.881,00 - 1.250,00 = 1.631,00 \text{ EUR per month}$$

This is the amount of the monthly adjustment or absorbable complement that the employee receives in addition to the base salary and annual complement stated in the labor agreement. This amount is calculated as $\text{Unit} * \text{Rate}$, where Unit is the number of worked days in the period. and Rate is the monthly amount divided by 30 for monthly employees or the number of days of the payment period for daily employees.

Note: The system always considers extra periods in the gross to net calculations to obtain the annual gross.

Net to Gross Calculation Method

To calculate an employee's gross salary from an agreed net amount, the system needs the following information:

- All basic earnings that the employee receives based on professional category or the salary plan. This information is on the Job Data - Compensation page.
- The total number of periods.
- An estimate of the gross salary. This figure is used as the starting point for the iterative calculations. By default, the system calculates the estimated gross by annualizing the net amount and increasing the result by 30 percent to cover statutory deductions. You can override this percentage to get a more accurate starting point for the calculation by changing the value of the variable AJN VR TAX PCT EST. For example, to set the percentage to 20 percent, you would assign 1.20 to the variable.

Note: The net to gross process considers only social security and tax deductions. Other deductions, such as loans and advances, garnishments, and union fees, are not included in the calculation loop because they are applied to the net.

To obtain the annual gross salary, the system:

1. Calculates the estimated gross salary.
2. Calculates the net amount from the estimated gross.

To accomplish this, the system:

- Divides the estimated annual gross by the total number of periods to calculate all the monthly gross earnings.
 - Subtracts the tax deductions from the monthly gross. The system calculates the IRPF deduction for that income.
 - Subtracts the social security contribution from the monthly gross.
3. Determines the difference between the calculated net and the actual net.

The system uses this formula to calculate the difference:

Agreed Net – Calculated Net = Difference

If the difference is 0,05 EUR or less, the estimated gross amount is considered to be accurate and the calculation is complete. If not, the process continues to step 4.

Note: You can define the acceptable variation between the agreed net and the calculated net by customizing the variable AJN VR TOLERANCIA. PeopleSoft Global Payroll for Spain delivers the value of the variable as 0,05 euros, but you can change this value during implementation.

4. Calculates a new estimated gross amount.

Using the difference calculated in step 3 and the following formula, the system calculates a new estimated gross amount:

New Estimated Gross = Estimated Gross + Difference + (Difference * (1 - (Calculated Net / Estimated Gross)))

5. Recalculates the net from the new estimated gross (repeat step 2).

The system repeats step 2 to recalculate the net from the new estimated gross. Steps 2 through 5 are iterative and can occur up to five times. If the difference between the calculated net and the actual net (calculated in step 3) is more than 0,05 EUR after five attempts, the system ends with the fifth calculation.

Note: This iterative process is required because changing the estimated gross can affect the seniority amount, the prorated extra period, the absorbable complement, and social security contributions. More important, the tax percentage can change, producing a different deduction.

Note: To specify that an employee's earnings must be adjusted net to gross, assign a supporting element override to variable GEN VR TIPO AJ SAL with a value of *NETO*.

Note: The IRPF percent is calculated every month for net to gross employees, even if the corresponding normalization schedule doesn't set it up.

Example

According to his contract, Jose earns a monthly net payment of 1.500,000 EUR. His labor agreement stipulates 14 periods per year. Following the preceding steps, the system:

1. Calculates the estimated gross amount: $1500 * 1,3 = 1950$ (Net amount increased by 30 percent).
2. Resolves all basic earnings and calculates the absorbable complement, taking into account the estimated monthly gross amount and the total of all basic earnings.

3. Subtracts the tax deductions from the total monthly gross.

Assuming a tax rate of 12,12 percent, this deduction is 236,34.

4. Subtracts the social security contribution from the monthly gross.

Assuming that after the system calculates the social security base, the contribution is 53,30. The monthly net is $1950 - 236,34 - 53,30 = 1660,36$.

5. Determines the difference between the calculated net and the actual net: $1660,36 - 1500,00 = 160,36$ EUR.
6. Because the difference is greater than 0,05 EUR, the system calculates a new estimated gross and repeats this process until this value is within an accepted range of the actual net.

Extra Period Calculation

With PeopleSoft Global Payroll for Spain, you define the earnings that contribute to an extra period and the percentage of each earning. For example, you can define an extra period that consists of 100 percent of the monthly base salary and 50 percent of the employee's monthly transport complement.

For employees whose salary is adjusted gross to net or net to gross, you also define the extra period value as a percentage of the agreed monthly salary. If you define the percentage as 100, the employee's extra period is equal to the agreed monthly salary, regardless of the earnings defined in the extra period. If the extra period is 60 percent of the agreed monthly salary, the system calculates the absorbable complement based on this reduced monthly amount.

You define the percentage using the Percent if Salary Adjustment field on the Extra Period Definition page.

See [Extra Period Definition Page](#).

To calculate the absorbable complement for the employee's extra period, the system:

1. Multiplies the agreed monthly salary by the percentage adjustment specified for the extra period (Percent if Salary Adjustment field on the Extra Period Definition page). This gives the gross extra period amount.
2. For each earning defined for the extra period, the system multiplies the earning amount by the percentage defined for that earning in the labor agreement (Earning Percent field on the Extra Period Eligibility Earnings page).
3. Calculates the total of all the earnings calculated in step 2.
4. Calculates the difference between the extra period amount calculated in step 1 and the total earnings for the extra period calculated in step 3. This is the absorbable complement for the extra period.

Note: For net-to-gross adjustments, the calculation of extra periods is part of an iterative process. For each iteration, the resulting net amount is compared with the agreed net amount. If it does not match, a new gross salary is calculated and the resulting net amount recalculated until it matches the agreed net amount.

Calculation Example

This example explains how the system calculates the employee's salary and extra periods when the extra periods are not based on 100 percent of earnings:

Note: To make understanding the calculation easier, this example uses monthly values. However, the system actually uses daily values in the calculations.

Salary details	Values
Agreed annual income	50.750,00 EUR

Salary details	Values
Earnings defined in the labor agreement for the employee's professional category	Base salary: 500 EUR/month Transport complement: 200 EUR/month
Extra periods (defined in the labor agreement)	Extra Period 1: Earnings and Earnings Pct: Base salary 50%, Transport 40% Pct if Salary Adjustment: 50%
	Extra Period 2: Earnings and Earnings Pct: Base salary 100%, Transport 50% Pct if Salary Adjustment: 100%
	Extra Period 3: Earnings and Earnings %: Base salary 80% Pct if Salary Adjustment: 100%

To calculate the monthly agreed salary, the system:

1. Divides the agreed annual salary by the total number of payment periods, taking into account the extra periods:

$$50.750 / 14,5 (12 + 0,5 + 1 + 1) = 3.500 \text{ EUR /month}$$

2. Calculates the monthly salary according to the labor agreement:

$$\text{Total monthly income per labor agreement: } 500 + 200 = 700 \text{ EUR/month.}$$

3. The system then calculates the difference between the agreed monthly gross amount and the monthly gross amount according to the labor agreement:

$$3.500 - 700 = 2.800 \text{ EUR}$$

This is the amount of the monthly adjustment or absorbable complement that the employee receives in addition to the base salary and annual complement stated in the labor agreement.

To illustrate how the system calculates the extra periods for this employee, consider extra period 1 as an example. The system:

1. Calculates the gross extra period amount by multiplying the agreed monthly salary by the percentage adjustment (50%) specified for the extra period:

$$3.500 * 0,5 = 1.750,00$$

2. Calculates the value of all the earnings included in the extra period by multiplying the earning by the earning percentage:

$$\text{Base salary} = 250 \text{ EUR } (500 * 0,5) \text{ and Transport} = 80 \text{ EUR } (200 * 0,4)$$

3. Calculates the total of the earnings for the extra period: $250 + 80 = 330$ EUR
4. Calculates the absorbable complement by subtracting the total earnings (step 3) from the gross extra period amount calculated in step 1:

$$1.750 - 330 = 1.420,00 \text{ EUR}$$

Thus the employee's extra period is made up of earnings for base salary and transport and the absorbable complement.

This table summarizes the calculations of all extra periods for this employee:

Period	Earnings	Amount per Month	Earnings Percentage	Earnings Amount	Extra Period Amount
1	Base	500	50%	250	1.750 (250 + 80 + 1.420) = 50% of agreed monthly salary
	Transport	200	40%	80	
	Absorb. Complement			1.420	
2	Base	500	100%	500	3.500 (500 + 100 + 2.900) = 100% of agreed monthly salary
	Transport	200	50%	100	
	Absorb. Complement			2.900	
3	Base	500	80%	400	3.500 (400 + 3.100) = 100% of agreed monthly salary
	Absorb. Complement			3.100	

The employee's annual salary is summarized in the following way:

$$\text{Regular periods} = 12 * 3.500 = 42.000 \text{ EUR}$$

$$\text{Extra periods} = 1.750 + 3.500 + 3.500 = 8.750 \text{ EUR}$$

$$\text{Total Annual Salary} = 42.000 + 8.750 = 50.750 \text{ EUR}$$

Managing Off-Cycle Payments

Understanding Off-Cycle Processing

This topic discusses:

- The off-cycle process.
- Types of off-cycle transactions.

The Off-Cycle Process

Off-cycle payroll processing refers to processing payments and making corrections to finalized results outside of the normal payroll schedule. Off-cycle transactions are typically made to correct prior payments or to make early termination payments that can't wait until the next scheduled on-cycle payroll.

Types of Off-Cycle Transactions

The four types of off-cycle transactions are:

1. Manual payments

Manual payments enable you to enter payments that you have calculated and paid outside of the payroll system. Examples include paying a new hire with a manual check because his or her pay details were not entered in time for the normal pay run.

2. Corrections

Corrections enable you to correct results of any finalized payroll. Examples include recalculation due to a sickness not entered in the system on time or unpaid overtime.

3. Additional payments

Additional payments enable you to enter onetime payments that fall outside the normal payroll process. Examples include onetime bonuses and expense reimbursement.

4. Advances

Advances enable you to pay payees before their normally scheduled pay run. Examples include salary due on termination.

Recording Manual Payments

Manual payments are payments that you record for items that you calculate and pay outside of the system, such as cash and check payments. In Spain, manual payments might correspond to advances, expenses, or special payments such as bonus or a commission paid outside the regular cycle.

When you are entering manual payments for Spanish payees, Oracle recommends that all calculations be manually calculated outside the system and then entered. You need to carefully consider the following areas when entering manual payments:

- Selecting the target period ID when you are adding a new off-cycle request.

Oracle recommends that you select the target period that coincides with a previous finalized calendar or the current open calendar.

- Specifying calendar control information on the Manual Payment Detail page.

The selection of the payment date directly affects how elements are accumulated. For example, if you have an accumulator that accrues based on period end date, the payment date may not update the accumulator balances at the right time.

The period begin date and period end date are provided by default from the target period ID. Oracle recommends that you not change these dates because the delivered Spanish rules are designed to calculate using whole periods and may not automatically segment if a partial period is entered.

- Selecting processing controls on the Manual Payment Detail page.

The run type is provided by default from the calendar paid, and Oracle recommends that you use the default. To ensure that the payee's manual payment is processed by the system, you must select the Allow Duplicates check box on the run type; otherwise, the payee may not be processed again if the system detects that they have already been processed in the period.

The option that you select in the Element Selection group box indicates the elements to process with the off-cycle transaction. If using the *Limited Element Set* value, you need to ensure that all elements calculate independently of pre-posting or post-processing formulas because these do not resolve during off-cycle processing.

Note: Manual payments are used to record monetary values only; absence accumulators are not updated when you use this method.

Processing Payroll Corrections

The payroll corrections functionality of off-cycle payroll processing enables you to change finalized results for specific employee and calendar combinations due to such things as user error or missing information.

A common cause of missing information is that your company might run payroll before the end of the month to ensure that employees receive their money by the last day of the month. Because of the early payroll run information might be missing from the remaining days of the month that you need to report to Social Security, such as terminations, hires, sicknesses, and overtime.

PeopleSoft Global Payroll for Spain provides two options for reporting the missing information to Social Security in a FAN file.

- One option is to wait until the next payroll and run retroactive processing of payroll as part of the payroll calculation for the subsequent month to correct the payroll and pay for differences. You must report this retroactive processing information in a complementary FAN file when generating the FAN file for the subsequent month. Because you are reporting the information late, Social Security charges a surcharge. PeopleSoft Global Payroll for Spain calls this running a pure retroactivity.
- To avoid paying the accompanying surcharge for the complimentary FAN file report, you can use off-cycle processing to make payroll corrections for the affected payroll. You can run a correction in one of two ways:
 - Run off-cycle processing to make payroll corrections for the affected payroll so that you can report the information to Social Security using the latest payroll run.

This is called correcting a payroll. By running the payroll correction before the subsequent payroll run, you can avoid generating a complimentary FAN file and its accompanying surcharge.

- Run a special run type *CORRECCION* to produce the same effect.

Note: Technically, a payroll correction is a retro calculation in which the system behavior is changed to deliver Social Security and tax data in a different way using PeopleSoft Global Payroll for Spain elements.

This topic discusses:

- Corrections using the *CORRECCION*. run type.
- Corrections using Global Payroll Core off-cycle functionality.
- Setup variables for corrections.
- Additional correction scenarios.

Corrections Using the *CORRECCION* Run Type

To run a payroll correction using a special calendar with a specific run type of *CORRECCION*:

1. Run the regular payroll for the month, finalize it, and pay it.
2. Enter new data that affects that payroll run.
3. Create a correction calendar using the Calendars component (GP_CALENDAR) or the Automatic Calendar Creation component (GP_AUTO_CAL).

The system automatically runs a correction for all the employees affected by pending changes, provided that for the calendar and calendar group you:

- Select for the calendar the same period ID as the period ID of the calendar to be corrected.

(This informs the system to perform a correction calculation rather than a true retroactivity calculation)

- Select for the calendar a run type of *CORRECCION*.
 - Select for the calendar the payee selection option of *All Payees with ...*
 - Select for the calendar the additional criteria option of *Pending Retroactive Changes*.
 - Select for the calendar group the Process retro triggers check box for the off-cycle calendar group.
4. Run the payroll for the correction calendar to perform the correction calculation.
 5. Run the banking process for the off-cycle calendar group to pay employees the difference between the regular payroll calculation and the correction payroll calculation.
 6. Generate monthly legal reports.
 7. Generate payslips:
 - If you select the original calendar group, the system generates one payslip that corresponds to the first payroll calculation.
 - If you select the new target calendar group, you can select whether you want to print recalculated values or differences between the new calculated values and the original calculation.

Example of Processing a Payroll Correction Using the CORRECCION Run Type

The following example illustrates how to process a payroll correction for PeopleSoft Global Payroll for Spain. Assume that you run the regular payroll for January on January 25. To do so, create the corresponding calendar and calendar group called ENE PAYROLL. On January 30th, finalize the January payroll and run the banking process for the calendar group ENE PAYROLL.

On February 2, the payroll administrator receives positive input about overtime for EMP1 that corresponds to the January payroll calendar. (Note that in this example we assume that a retro trigger is defined for GP_PI_MNL_DATA.) On February 5 the payroll administrator realizes that no reduction was entered for employee EMPL2 and enters the reduction at the contract data level. (Note that in this example we assume that a retro trigger is defined for CNTRCT_DATA_ESP. In both of these cases the system generates a retro trigger for each of these employees that will cause retroactive processing for January the next time that you run the payroll process. You can check which employees are affected by retro calculations on the Review Triggers page by selecting Global Payroll & Absence Mgmt, Absence and Payroll Processing, Prepare Payroll, Review Triggers.

On February 15 the payroll administrator wants to run a correction of January payroll to consider all the changes that happened after it was run. He doesn't want this correction to cause Social Security complementary reporting. (Note that because the payroll administrator is still on time to generate the FAN file for January, the company does not have to submit a complementary FAN file to Social Security and does not incur the corresponding surcharge.) The payroll administrator creates a calendar group containing just one calendar with the necessary conditions for running a payroll correction.

The payroll administrator runs the new calendar group and, after checking results, finalizes the payroll run. To pay differences, the payroll administrator runs the banking process for the calendar group ENE CORRECCION. The process generates a banking file that contains just the delta between the first payroll run and the correction calculation.

When the payroll administrator or another user runs tax or Social Security reports, the system uses the recalculated values. For the FAN file, the report includes modifications that were made in February affecting January in the regular report, not a complementary report.

The payroll administrator can generate payslips for January, printing one payslip for the ENE PAYROLL calendar group that corresponds to the first payroll calculation for January and another payslip for the ENE CORRECCION calendar group that corresponds to the delta calculation between the first calculation and the correction calculation. When printing payslips, payroll administrators can select to print the recalculated values or the values that correspond to the delta calculation between the first calculation and the correction calculation.

Corrections Using Global Payroll Core Off-Cycle Functionality

PeopleSoft Global Payroll for Spain delivers off-cycle configurations for correcting off-cycle requests that are related to the following situations: new hires, new terminations (for terminations after the first payroll run), and payroll correction. Define configurations for off-cycle requests on the Off-Cycle Configuration page.

To run corrections using core Global Payroll off-cycle functionality:

1. Run the regular payroll for the month, finalize it, and pay it.
2. Enter new data that affects that payroll run.
3. Create an off-cycle request.

Select Global Payroll & Absence Mgmt, Absence and Payroll Processing, Off Cycle, Off Cycle on Demand and then perform the following steps:

- a. Select as the target period ID the period that you want to correct.
 - b. Create a request by providing the information about the off-cycle processing that you want to run.
 - c. List the employees for whom you need to enter data to correct the finalized payroll in the Corrections - List Payees and Calendars grid.
 - d. Access the Correction Request Details page to enter the calendar to correct.
 - e. Click the PI Calendar to Correct link to enter the positive input into the finalized payroll that you want to correct.
 - f. Click the Absence Event Entry link to enter absences affecting the finalized payroll that you want to correct.
 - g. Provide a supporting element override in the target calendar by accessing the supporting element overrides, clicking the Target Calendar link, and entering a value 1 for the variable CLI VR CORRECCION.
4. Create a calendar group on the Off Cycle On Demand page.
 5. Click the Calculate button on the Off Cycle On Demand page to run the off-cycle processing and perform the off-cycle calculations.
 6. Click the View Status and Results link to check processing results.

- Finalize the off-cycle processing so that you can pay the delta.

Setup Variables for Corrections

Global Payroll for Spain includes two setup variables that enable you to control how the system processes tax deductions and tax percentage calculation during corrections calendar calculation:

Setup variables	Explanations
CLI VR CAL DD SG I (Calc IRPF DD in Inac. Segment)	<p>Because correction calendars do not include a gross calculation, processing tax deductions for correction calendars generates negative net values. The value of this variable determines whether the system calculates tax deductions for correction calendars.</p> <p>Valid values are:</p> <ul style="list-style-type: none"> <i>A (anular)</i>: Select if you do not want the system to calculate retro tax deductions with negative net values. <i>C (calcular)</i>: Select if you want the system to calculate retro tax deductions with negative net values.
CLI VR CAL TAX PCT (Recalc tax pct flag)	<p>This variable determines whether the system processes tax percentage calculation for correction calendars.</p> <p>The default value for the variable is <i>Y</i>, which indicates that the system performs tax percentage calculation during correction calculation to account for retro deltas being forwarded to the calendars. This results in more accurate tax deductions.</p> <p>If you change the value of the variable to <i>N</i>, the system uses the last calculated tax percentage when calculating taxes linked to retro deltas correction target calendars.</p>

Note: These setup variables also affect how the system processes inactive segment calculation.

Additional Correction Scenarios

This topic provides examples of correction scenarios that you can manage using Global Payroll for Spain.

Example of a Correction Affecting a Month with Retro

Assume that you have run a May payroll for an employee. This payroll process includes retro processing for April due to a salary increase that was made effective as of April, and overtime entered retroactively for April.

For the May payroll run, the system:

- Calculates the IRPF RTR deduction to compute taxes for retro deltas.

- Applies current recalculated tax percentages to the retro deltas.

After finalizing and paying the May payroll, you realize that there was additional overtime that needs to be paid in May. You enter the additional overtime as positive input and create an off-cycle correction calendar to process it. This off-cycle correction recalculates the May payroll and includes the added overtime.

- Retro deltas that were executed during the first run of the May payroll.
- The most recent results for the May calendar.

Example of a Correction Affecting a Month without Retro and Previous Months with Retro

Assume that you have run a May payroll for an employee that does not include any retro processing. After finalizing and paying the May payroll, you are informed that the employee should have received both a salary increase effective for April and overtime for April. Because you have not yet processed the legal reports, you decide to run a correction calendar for May to process the retro changes for April.

During the correction process, the system:

- Takes the salary increase into account for the recalculation of the May payroll.
- Recalculates the tax percentage for May.
- Forwards the retro deltas for April to the correction calendar because it is the calendar that triggered the retro processing.
- Generates negative net pay for the correction calendar because it processes only the tax deductions that are linked to the retro deltas.
- Stores the retro deltas to the corresponding tax result record.
- Recalculates the tax percentage to account for the impact of the retro deltas on the tax base. The system calculates the new taxable base using the last calculated base (recalculation for May) plus the retro deltas being forwarded to the correction calendar.

Note: The value of the CLI VR CAL TAX PCT setup variable must be *Y* for the system to recalculate the tax percentage.

When you run the official reports, the system takes into account the last calculation for May and the retro deltas from April.

Example of a Correction Affecting a Month with Retro and Previous Months with Retro

Assume that you have run a June payroll for an employee that includes retro processing affecting May due to a salary increase that was effective in May and overtime entered retroactively for May. The system calculated retro deltas during this June payroll calculation. After finalizing and paying the June payroll, you are informed that the salary increase should have been effective for April and for an increased amount, and that there was additional overtime that should have been entered for April. Because you have not yet processed the legal reports, you decide to run a correction calendar for June to process the retro changes for April and May.

During the correction process, the system:

- Takes the salary increase into account for the recalculation of the June payroll.
- Maintains the values of the retro deltas associated with the original June calendar and forwards the new retro deltas from both April and May to the correction calendar.
- Generates new results for the extra period.
- Generates negative net pay for the correction calendar because it processes only the tax deductions that are linked to the retro deltas.
- Stores the retro deltas to the corresponding tax result record.
- Recalculates the tax percentage to account for the impact of the retro deltas on the tax base. The system calculates the new taxable base using the last calculated base (recalculation for June) plus the retro deltas being forwarded to the correction calendar.

Note: The value of the CLI VR CAL TAX PCT setup variable must be *Y* for the system to recalculate the tax percentage.

When you run the official reports, the system takes into account the last calculation for June and the retro deltas from both April and May.

Making Additional Payments

Use the additional payments functionality that is part of off-cycle processing to make onetime unscheduled payments that are processed outside of the normal on-cycle payroll. Examples include onetime bonuses, awards, and expense reimbursements. These transactions are similar to manual payments in many respects; however, the system calculates the amount for additional payments.

You need to consider the following areas when entering additional payments:

- When you are selecting the period paid, Oracle recommends that you select the previous finalized calendar or the current open calendar.
- Use this method to record monetary values only. Absence accumulators will not be updated.

Issuing Advance Payments

Advance processing is the processing of on-cycle calendars ahead of their regular schedule. Use the advance functionality of off-cycle processing when you want to pay an employee before his or her normal on-cycle pay run. Examples include payments for early terminations (for which the termination payment needs to be paid immediately and not in the next on-cycle pay run), full period advances, and partial period advances.

Observe the following guidelines when making advance payments:

- Always select the next open calendar, because skipping calendars may update accumulators incorrectly.
- Absence accumulators calculate automatically for the calendar group selected.

PeopleSoft Global Payroll for Spain delivers an off-cycle configuration for advance payments off-cycle requests that you can use for advance terminations. Define configurations for off-cycle requests on the Off-Cycle Configuration page.

You can use either the element description (that was created when the element was created), or you can create your own description to appear on the payslip. Values are. *User Text* and *Element*.

Description

If you selected *User Text* for the Take description from field, enter your description of the element here.

Lines Before

Enter the number of empty lines to appear on the payslip before this element.

Lines After

Enter the number of empty lines to appear on the payslip after this element.

Understanding the Payslip Process

The Create/Print Payslips ESP page launches a job (GPESPSLP) containing three processes in sequence:

1. The GPES_PAYSLIP Application Engine process gathers information and creates an intermediate table.
2. The SQR GPESPYS1 prints the payslip report and provides self-service related information if ePay is licensed.
3. The GP_EPAY Application Engine process uses the payslip report and self-service related information provided by the prior processes in this job to create self-service payslips for each payee. If ePay is not licensed, this process reports that ePay has not been licensed and will finish successfully.

Note: When running the GPESPSLP job, you can use the following type and format options with ePay: *None* and *None* (becomes Web and PDF by default), *Web* and *PDF*, or *File* and *PDF*. If using *File* and *PDF*, do not use a custom output destination from the Process Scheduler Request page.

Understanding Segmentation and Payslips

Segmentation occurs when employees' details change during a payroll period and the change requires the system to recalculate certain elements (element segmentation) or all elements (period segmentation). When the system segments an employee's pay, this affects payslips. Oracle delivers an SQR report that manages segmentation as explained in this table.

Note: You need to review how you want to manage segmentation and show the results in your organization's payslips.

Segmentation Event Definition	Segmentation Type	Impact on Payslip
CATEGORZN	Element	The system generates one payslip. For compensation, social security contributions, and bases, each slice is listed on a separate line.
COMPANY	Period	The system prints a separate payslip each segment.
COMP_RATE	Element	The system generates one payslip. Where an earning has multiple slices, each slice is listed on a separate line.
F/P TIME	Period	The system prints a separate payslip each segment.
HIRE/TERM	Period	The system prints a separate payslip each segment.
PAY_GROUP	Period	The system prints a separate payslip each segment.
PAY_SYSTEM	Period	The system prints a separate payslip each segment.
RISK_CODE	Element	The system generates one payslip. For social security contributions and bases, each slice is listed on a separate line.
TAX_LOCNT	Element	The system generates one payslip. IRPF deductions are listed on separate lines.

Payslips and Reversals

Segmentation can affect retroactive processing when the system recalculates a segmented period and the segmentation dates of the original calculation don't match the segmentation dates of the recalculation. When segment dates and payment keys match, the system recalculates the original segments, subtracts the old value from the new value for each payroll element to determine retroactive deltas, and writes the new results to the output tables. When segment dates don't match, the system treats the old and new values as if they belong to separate segments. It creates reversal segments for each segment that existed

in the original calculation and creates new recalculation segments. The reversal segments have no results because they do not go through gross-to-net processing. The new recalculated segments do go through gross-to-net processing and generate new values. The system writes these new values to the output result tables. For the purposes of calculating deltas, the originally calculated values are effectively zero.

When segments don't match during retroactive processing, the system applies special rules to payslip generation:

- The system overrides the Retro Type defined on the Payslip Setup page to *Multiple Payslips*. Therefore, if the retroactive processing includes more than one month, the system generates one payslip for regular pay and separate payslips for each month that has retroactive pay.
- The payslip for the month in which the segments don't match lists recalculated values instead of deltas.

Payslips and Corrections

Occasionally you need to rerun a finalized payroll to incorporate late changes. If you want those late changes to be included in monthly legal reports, you can run a correction calendar. Correction calendars recalculate the affected payroll run and provide a new set of results that the system includes in legal reporting such as the Model 111 or the FAN file. In regard to banking, the system generates a delta net amount to be paid that represents the difference between the recalculated net and the previously calculated net. When you select a calendar group for payslip generation, the system detects whether the calendar group is a correction. If it is, the system enables you to choose one of two printing options:

- Print the deltas that the system calculated during the correction.
- Print the recalculated values that resulted from the correction calculation.

Banking Setup

In PeopleSoft Global Payroll, the majority of banking setup starts in the core application and continues with processing in PeopleSoft Global Payroll for Spain. Oracle strongly recommends that before reading this topic, you read the banking feature in the Global Payroll core documentation.

Before running the banking process for Spain, you must set up basic banking information in the core application and within the PeopleSoft Global Payroll for Spain country extension. You must:

- Define bank information, such as bank name, address, and ID.
- Define Electronic Funds Transfer (EFT) formats.
- Identify source banks and link source banks to pay entities.
- Define employee bank accounts and net pay election.
- Define deposit schedules.
- Define recipients.
- Define the banking file.

Note: You perform this setup step within the PeopleSoft Global Payroll for Spain country extension.

After you run payroll, funds are sent to the source bank along with instructions for payments. The bank needs the following information:

- The name of each employee who is going to be paid.
- The amount that each payee is to receive.
- The name of the banking institution where the wages are to be sent.

This information is extracted from the core application based on a list of payees corresponding to those in the selected payroll run. The system creates a file with lines for each payee, containing a name, the bank account number, and the payment amount. This file is sent to the bank, which then distributes the funds.

IBAN Setup

The International Bank Account Number (IBAN) is an account number that uniquely identifies a bank account and is assigned according to International Organization for Standardization (ISO) standards so that it can be used across national borders. PeopleSoft applications can include this information at the bank account level.

As of January 1, 2004, IBAN must be used for all transfers out of Spain and for special transfers.

Part of banking setup includes IBAN definition. To set up IBAN functionality, you must select the IBAN Enabled field on the IBAN Country Setup page. When the IBAN feature is enabled, the system displays the IBAN field on the Source Bank Account page and the Edit IBAN link on the Maintain Bank Accounts page for the country that you indicated.

Note: The *PeopleSoft HCM 9.2: Application Fundamentals* product documentation discusses the IBAN setup in detail.

Understanding Banking Setup for PeopleSoft Global Payroll for Spain

The majority of the banking setup for PeopleSoft Global Payroll for Spain take place in the PeopleSoft Global Payroll core application. In the Global Payroll for Spain country extension, however, you define the banking file, which enables you to set the parameters that drive the generation of the EFT payment file. PeopleSoft Global Payroll for Spain delivers a sample banking file: File ID CSB34. This file is set up to generate the same file structure as the one currently prepared following the Norm 34–1. You can create additional banking file IDs to maintain different parameters.

Understanding the Banking Process

To perform the banking process for PeopleSoft Global Payroll for Spain, you must:

1. Finalize the payroll run on the Calculate Absence and Payroll page.

This provides the data for the banking process.

2. Run the core Global Payroll Banking Process (GP_PMT_PREP) on the Run Payment Prep Process page to prepare banking payments.

The system populates the GP PAYMENT output table and sets the GP status to *P* (prepared).

The GP PAYMENT table contains one entry for every net pay distribution from every payment included in a given calendar run. The GP PAYMENT table provides the basis on which a company pays its payees.

3. Finalize the core Global Payroll Banking Process (GP_PMT_PREP) on the Calculate Absence and Payroll page.

The process sets the payment status for the selected payees to *F* (finalized) in GP PAYMENT.

4. Run the EFT generation process for Spain on the Create EFT Payment File ESP page to create a flat file to send to the bank.

The EFT generation process (GPESBNK5) selects the payees with a payment status of *F* (finalized) from GP PAYMENT and generates the flat file containing the transfers to be made. At the end of this process, the system sets the GP status to *T* (transferred).

Note: If you select the Rerun Indicator check box on the Create EFT Payment File ESP page, the EFT generation process includes payments with a status of *T*.

Transfer Types

During the EFT generation process, the system categorizes each transfer to determine the block of the banking file in which it should be placed. The value of the Country Code field on the Maintain Bank Accounts page determines whether transfers for payees are national or international. The Taxes Calculation field on the Transnational Mobility page determines whether transfers for payees are for residents or nonresidents.

Create EFT Payment File ESP Page

Use the Create EFT Payment File ESP (create electronic file transfer payment file) page (GPES_RC_BNK5) to create a flat output file to send to the bank.

This EFT payment file contains the payment details for each employee. It is sent to the bank so that funds can be transferred to employees' accounts. The file includes the employee name, beneficiary name, date, and amount of payment. You can also select whether to override an employee's payment. At the end of this process, the system updates the GP_PAYMENT table by setting field PMT_STATUS from *F* (finalized) to *T* (transferred).

Processing SEPA Payments for Spain

PeopleSoft Global Payroll for Spain enables you to process payments using the Single Euro Payment Area (SEPA) formats and standards through an integration with PeopleSoft Financial Gateway. If you process payments using SEPA, you must set up and process banking using a different set of steps.

This topic discusses how to:

- Set up SEPA processing.
- Process SEPA payments.
- Send SEPA payments to PeopleSoft Financial Gateway.

Setting Up SEPA Processing

Before you can process SEPA payments using Global Payroll for Spain, in addition to the normal banking setup you must:

1. Ensure that an active SEPA application package is defined for Spain on the Banking Country Setup page.
2. Ensure that a SEPA SQL statement is defined for Spain on the Banking Preparation Definition page.
3. Define payment process settings on the Installation Settings page.
4. Set up Integration Broker for both Global Payroll for Spain and Financial Gateway.
5. Set up banks for Spain in your PeopleSoft Financials system.

Processing SEPA Payments

You process payments for SEPA using the same Global Payroll Banking Process (GP_PMT_PREP) that you use for non-SEPA banking. When a row of data exists for Spain on the Banking Country Setup component, however, GP_PMT_PREP executes SEPA logic.

Global Payroll for Spain uses the delivered CORE_BANK:SQL application package to process SEPA payments. The system references the banking preparation definition for Spain and for each defined sequence processes the SEPA SQL statement using the country, calendar run ID, and employee ID range selected on the Run Payment Prep Process run control page. The system loads the results into the GP_PAYMENT_FG record.

Note: This new SEPA logic supersedes the country-specific processes that you would normally run in PeopleSoft Global Payroll for Spain for non-SEPA banking. Therefore, when processing SEPA payments for Spain, you do not have to run the EFT generation process (GPESBNK5).

Delivered Sequences

PeopleSoft Global Payroll for Spain delivers two Banking Preparation Definition sequences. They are:

- Employee SEPA
- Recipient SEPA

Sending SEPA Payments to PeopleSoft Financial Gateway

You send generated SEPA payment details from PeopleSoft Global Payroll for Spain to PeopleSoft Financial Gateway. Financial Gateway then dispatches the payments to banks in compliance with SEPA rules and standards. You send SEPA payments to PeopleSoft Financial Gateway using the Payment File Generation page. This page enables you to:

- Identify the rows of GP_PAYMENT_FG that are to be prepared to be sent to Financial Gateway.
- Insert the prepared payment rows into staging tables and publish them to Financial Gateway through Integration Broker using the PAYMENT_REQUEST message.
- Generate Oracle Business Intelligent Publisher (BI Publisher or BIP) reports.

Understanding Garnishments

Garnishments in Spain

When a payee owes money to a third party for court-ordered obligations, such as child support, the employer might be required to deduct part of what is owed before the payee receives payment. The court order establishes the amount of the deduction and how it is deducted from a payee's salary. The deduction, known as a garnishment, is taken every month, according to the *Ley de Enjuiciamiento Civil*, articles 607 and 608. Article 607 pertains to garnishments to be applied to income received due work. It requires that the size of the deduction depend on a payee's earnings and the number of dependents, and establishes a guaranteed net. Article 608 pertains to alimonies (spouse or child support) that can be deducted directly from the net.

The size of the deduction depends on the payee's earnings and the number of dependents.

Use the Assign Court Order ESP (GPES_GRN_DATA) component to assign garnishment deductions to a payees.

Delivered Garnishment Deductions

This table lists the delivered garnishment deductions:

Garnishment Deduction	Description
RETJ JUDCL	This deduction represents an amount, ordered by court, to be paid for any cause except child support (RETJ ALIM) or spousal support (RETJ CNYG).
RETJ CNYG	This deduction represents an amount, ordered by court, to be paid to a former spouse after a divorce settlement. This deduction affects the calculation of the tax withholding percentage and the net calculation.
RETJ ALIM	This deduction represents an amount, ordered by court, to be paid for child support. This deduction affects the calculation of the tax withholding percentage and the net calculation.

Garnishment Deduction	Description
RETJ CNYG ND	<p>This deduction represents an amount, ordered by court, that is paid (outside of payroll) to a former spouse after a divorce settlement. This deduction affects only the calculation of the tax withholding percentage.</p> <p>Use this deduction instead of the RETJ CNYG deduction when you do not want to discount the deduction from the net but still want to enter the deduction so that it affects tax calculations.</p>
RETJ ALIM ND	<p>This deduction represents an amount, ordered by court, that is being paid (outside of payroll) for child support. This deduction affects only the calculation of the tax withholding percentage.</p> <p>Use this deduction instead of the RETJ ALIM deduction when you do not want to discount the deduction from the net but still want to enter the deduction so that it affects tax calculations.</p>

PeopleSoft Global Payroll for Spain enables you to enter more than one court-ordered garnishment for the same payee with overlapping timeframes. In this case, the system applies the garnishments in a specific order:

1. The system applies any alimony established by the court.
2. The system applies any other types of garnishments in the order determined by the Priority Number field on the Assign Court Order page.
3. If a payee has multiple garnishments with the same priority, the system applies first in, first out logic and deducts the oldest garnishments first.

You can always stop or cancel a court order by entering a value in the End Date field on the Assign Court Order page.

In the case of retroactive processing the system does not recalculate the value of garnishment deductions. Instead, it maintains the previously calculated value.

Note: The PeopleSoft system delivers a query that you can run to view the names of all delivered elements designed for Spain. Instructions for running the query are provided in *PeopleSoft HCM 9.2: Global Payroll* product documentation.

Court Order

Court Order ID

Enter the unique code for the court order. This is the user key that the system uses for accumulators that determine the recovered amount and pending amount to deduct.

Description

Enter a description of the court order.

Start Date

Enter the date on which the court order takes effect.

End Date

Enter the date to stop the court order.

Priority Number

Set the priority for the garnishment. If more than one court order is assigned to a payee, the priority numbers determine the order

in which they are calculated. The lower the priority number, the higher priority the court order has.

Calculation Type

Select the method by which the system calculates the court order. Values are:

Amount: Select to calculate the court order as a fixed amount that can be deducted either one time only or once per month between the start date and end date.

Based on Ranges of SMI (based on ranges of *salario minimo interprofesional*): Select to calculate the court order as a fixed amount to be deducted as soon as possible, but with respect to article 607 of *Ley de Enjuiciamiento Civil*.

Percentage: Select to calculate the court order as a percentage of a specific element.

Other: Select to calculate the court order using a set of rules that you define.

Note: The value that you select in this field affects the fields and group boxes that are available on the rest of the Assign Court Order page.

Court Order Calculation

Use the fields in this group box to define how the system calculates the court order.

Note: The fields that are available in this group box depend on the value that you select in the Calculation Type field.

Amount	Enter the monetary amount of the court order.
Currency Code	Enter the currency of the amount.
Percentage	Enter the percentage that the system applies to the specified base element to determine the amount of the court order deduction.
Base Element Type	Enter the type of element that the system uses for the base amount when applying the value you enter in the Percentage field. Values are: <i>Accumulator</i> , <i>Earnings</i> , <i>Formula</i> , and <i>Variable</i> .
Element Name	Enter the element that the system uses for the base amount for the court order.
Amount Type	Select <i>Formula</i> to specify the type of element that the system uses to calculate the court order amount.
Element Name	Enter the formula that the system uses to calculate the court order amount.

Guaranteed Amount Type

Select the type of element the system uses to determine a guaranteed minimum net amount. Values are: *Accumulator*, *Formula*, and *Variable*.

Element Name

Enter the element that determines the guaranteed minimum net amount for the court order. For example, if the court order guaranteed the *salario minimo interprofesional* (SMI), you could enter the variable REJ VR SMI GARANT in this field because it represents the SMI for payees.

Periodicity

Enter the frequency of the court order deduction. Values are:

One time: Select to deduct the court order amount only once.

If you select this value, the system does not calculate the garnishment after the date you enter in the End Date field.

Recurrent: Select to deduct the court order amount monthly between the start date and end date. If you select this value, the system stops deducting the garnishment amount after the date you enter in the End Date field. The system might still calculate the deduction for an unrecovered amount that corresponds to a previous month.

Consider Extra Period

Select to include the court order in extra period processing.

Alimony Details**Alimony**

Select to designate the court order as a pension for a spouse or children. This means that the deducted amount will affect the payee's tax calculation because it reduces the payee's withholding percentage.

Type of Alimony

Specify whether the alimony is for *Spouse Support* or *Children Support*.

Discount from Payroll

Select to indicate that the court order is managed by the payee outside the PeopleSoft Global Payroll for Spain system.

Note: If you do not select this check box, the system does not perform net validation on the court order.

SMI Scale Range

Use the %Scale1 through %Scale5 fields to enter the percentages that the system applies to the five ranges of SMI. The system populates these fields with default regulatory values. You can reduce the values, but only by 10-15%.

Note: The SMI Scale Range group box appears only if you select the Based on Ranges of SMI value in the Calculation Type field.
