PS02	General	There is some text for eg in section 2 which is in italics. Is there a reason for it ? Can we have a section that explains the conventions followed ?		
PS03	Section 2 : Use case 2	The heading should read " SIP UAC sends a UDP INVITE request" The TCP currently mentioned should be replaced by the UDP.		
PS04	Section 2 : Use case 3	The spec states that the " proxy might add some information to indicate that this message was a proxy" What is the condition when this information would be added? What is the name of the header ?		
PS05	Section 2 : Use case 3	In this case it is mentioned that the "proxy adds some information that the request was a proxied request" Is that different from the previous use case ?		
PS06	Section 2 : Use case 7	Is the need for this use case to be discussed ? Or do we still need to figure out how we will achieve this ?		
PS07	Section 2? : Use case Startup/Configuration	What is the motivation behind having the use case 3 where there is no CLB ?		
PS08	Section 3? : Design	The spec says that the proxy is implemented as a "layer" between the connector and container. I think we are are overloading the term "layer" here.		
PS09	Section3 : Diagram showing the interaction with other subsystems	Can we show that the loadbalancer.xml is only for configuring the CLB; and the domain.xml is for configuring everything else including proxy.		
PS10	Section 3: Proxy Lifecycle	What is the interface exposed by the proxy which would determine if the proxy is to be enabled or not ?		
PS11	Section 3:	It is not clear what the		

	Administration interface	administration interface is ? Is it the domain.xml ? Or the loadbalancer.xml ?		
PS12	Section 3 : runtime for use case 3	Can we describe the heading better ? Also the LoadBalancerProxyHandler is a class ? If yes then we need to specify that/		
PS13	Section 3	The flow chart description appears before the preceding diagram		
PS14	Section 3	What do the two tables with the request header and lines describe ? I guess the intent is to show the headers being added. But we need to set the context somewhere		
PS15	Interfaces	Should this table not be a part of the Section 4.1 ?		
PS16	Interfaces	Have the Proxy APIs and CLB APIs been defined ? The Proxy API should be described by this document right ?		
PS17	Section 5	You need to specify the location and name of the jar file in which the proxy classes would need to be packaged. Also the proxy classes would need to be in the same jar file as the CLB right ?
