Release Notes

Overview

This document contains information on the issues that have been fixed in RDM since the previous release.

RDM Fixes

A 'BUG' fix is a modification to the base Oracle Retail RDM code (for example, a defect fix, performance enhancement, functional enhancement, and so on).

Each BUG fix included in this patch has a corresponding BUG document in the \Sir Docs folder titled <BUG#.doc> (for example, "BUG123456.doc"). BUG documents should be fully reviewed before this patch is implemented.

To assist you in the patch application process, there is also a BUG module cross-reference spreadsheet in the same folder (SIR MODULE XREF 10.3.10.xls) which lists and allows sorting. Also in the \Sir Docs folder is the 10.3.10 dev_issues.doc, which is a document that summarizes all of the bugs that have been fixed in conjunction with this patch.
