# Overview

This document contains information on the changes that have been made to Store Inventory Management (SIM) since the previous release. The document is organized according to the functional areas affected by changes.

## Item lookup

- Corrected the ‘item/location lookup’ screen that displays primary supplier of the item/location.
- Corrected the ‘item lookup’ screen that displays numbers of department, class, and subclass with the description.
- The following issue was corrected:
  - When the ‘Include Non-Ranged’ option is unchecked, the ‘lookup’ screen shows ranged items only.

## Stock counts

- The following issue was corrected:
  - Added deleted or inactive items (stock on hand [SOH] greater than zero) to non-unit-and-amount stock counts.
- Fixed the file created at the end of the stock count process so that the file allows items with a count quantity to have decimals.
- Fixed the stock count quantities in the SOH table to use the difference between the count and the snapshot when a stock count is done, and the stock count file is exported.
- Fixed the following issue in unit and amount stock counts by department:
  - If the variance value is not null and the variance percent/SUOM is null, a stock count re-count or authorize is triggered.
- Corrected the ‘AdHoc Stock Count’ screen so that it displays the numbers of the department, class along with their name.
- Corrected the ResaFileParser that runs as part of sim\_import\_resa\_posu so that it properly handles voids with position and negative records for same item.
- Fixed the Done button in the ‘Not on File’ screen.

## Returns

- Improved the wireless suppliers so that they are first sorted by primary supplier and then the rest of the suppliers for an item.
- Corrected the item unavailable quantity when RTV is in pending.
- Improved the ‘RTV’ screen by fixing the following issue:
  - When the warehouse/supplier is not selected, the alert message displays when the user clicks the Add Item button.

### Direct delivery

- Improved the system by ensuring that the suppliers are sorted by primary item/location/supplier followed by the rest of the suppliers.

### Purchase order

- Fixed the SIM consume method regarding an ASNIn message. The consume method now handles decimal values.

### Advanced shipping notice (ASN)

- SIM now handles the processing of UPC codes when they are sent in via an ASN. The system also looks up the transaction level item.

### Product group

- Fixed the system so that the LOV button in the 'Product Group Detail' screen is displayed when the hierarchy option is selected.
- Modified the 'Expected Delivery Date' and the 'Expiration Date' labels. They have been changed to 'Days Before Delivery' and 'Days Before Expiration'.
- Improved the 'Product Group' screen so that when the user clicks the cancel button, all fields including the LOV button become blank.
- Improved the 'Product Group' screen so that when the user clicks the add-to-group button, the department, class, and subclass LOV buttons become blank.

### Publisher

- The system has been improved so that the following occurs:
  - When an item request is created in ISO for an item that does not have each (EA) as its unit of measure (UOM), the item that is sent to RMS now has a default value of 4 decimals.

### Transfers

- The system has been corrected so that when it accepts a transfer request, the respond message subject line and body display 'ACCEPTED'.

### Translation

- Translation issues regarding English to French have been resolved.
