In this update we've made enhancements in Logistics Machine Learning.

Logistics Machine Learning



In 22A users can incorporate environmental factors into their Machine Learning-based ETA predictions, making predicted ETAs responsive to live events, such as port congestion, airport delays, and extreme weather, etc. Including these factors increases the accuracy of the order delivery lead times and helps users identify at-risk shipments in route.

New agent workflows allows users to easily invoke Machine Learning as part of their standard OTM workflows and run Machine Learning processes in a lights-out automated fashion. Users are now able to take actions instantly on any unplanned delays.

New in 22A is the Oracle Analytics Server (OAS) Data Visualization. Data Visualization provides the capabilities to generate configurable visual analytics – such as maps, charts, or graphs - for existing BI subject areas in Transportation Intelligence, Global Trade Intelligence, Logistics Network Modeling and Logistics Machine Learning.

In 22A there are 4 prepackaged Data Visualization dashboards for Logistics Machine Learning, helping customers gain deeper insight into data quality, model accuracy, and prediction accuracy.

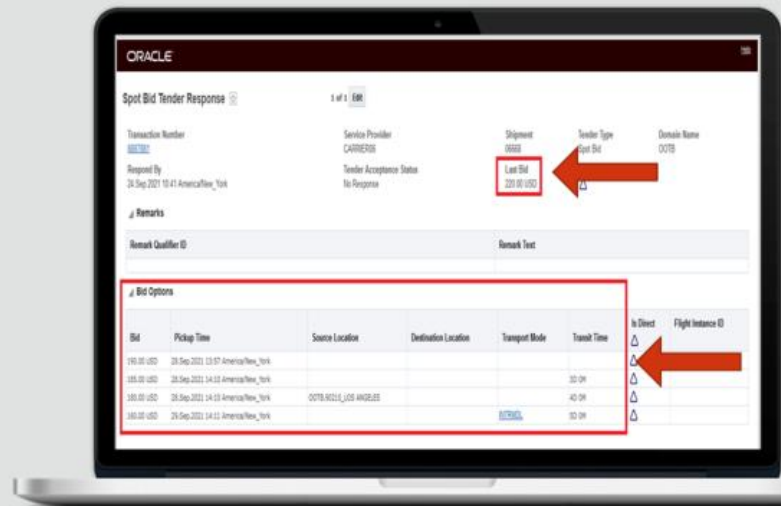
- New Spot Tender Manager for Service Provider to enter conditional bids
- Planner View Enhanced to display Service Providers with optional bids



Transportation capacity continues to be a significant challenge for shippers and logistics service providers. To augment capacity, many transportation specialists are forced to send shipments to the spot market, which can be expensive and time consuming. To aid our customers facing this issue, we've continued to enhance OTM's Spot Bid Tendering functionality. Complementing the Spot Tender Manager UI and other Workbench capabilities, OTM 22A introduces the concept of optional or conditional bids.

Oracle Transportation Management

- New View All Bid Options provides overview of all Service Providers and their optional bids



Optional bids give shippers the ability to reduce their spot market cost by allowing service providers to supply multiple bid options in their response. The service provider can offer a bid against the shipment exactly as specified by the shipper, but can also provide conditional bid options which give the shipper opportunities to save money.

In this example, the carrier has bid \$220 to move a shipment. However, the carrier has also offered different options to the shipper, enabling them to reduce their cost if they are willing to accept certain conditions, such as a change to the pickup date, a slightly longer transit time, sourcing the shipment from a different location, or even using an alternate mode.

Oracle Transportation & Global Trade Management 22A extends existing REST API capabilities to include sending outbound business objects following the same REST resource formats available for processing your inbound messages. Customers can select the REST Notify communication method for the following actions: Send Interface Transmission, Send Integration agent action, and the Send Integration process. The Send Integration process, combined with a saved query or condition enables customers to send multiple outbound transactions in a single transmission.

This feature provides customers with the opportunity to take advantage of the lightweight, easier to work with REST JSON format to support outbound integration requirements.
